WHEREAS by section 8 of "The Weights and Measures Act, 1878," it is provided that the Board of Trade shall from time to time cause such new denominations of standards, being either equivalent to or multiples or aliquot parts of the imperial weights and measures ascertained by the said Act as appear to them to be required in addition to those mentioned in the Second Schedule to the said Act to be made and duly verified, and that those new denominations of standards when approved by His Majesty in Council shall be Board of Trade standards in like manner as if they were mentioned in the said Schedule:

And whereas by "The Weights and Measures (Metric System) Act, 1897," it is provided that the Board of Trade standards which may be made under section 8 of "The Weights and Measures Act, 1878," shall include metric standards derived from the iridio-platinum standard kilogram deposited with the Board of Trade and numbered 18:

And whereas it has been made to appear to the Board of Trade that new denominations of tandard weights derived from the standard kilogram aforesaid are required, and they have caused the same to be made and duly verified:

Now, therefore, His Majesty, by virtue of the power vested in Him by the said Acts, by and with the advice of His Privy Council, is pleased to

approve of the new denominations of standard weights specified in the Schedule hereto, and doth direct that the same, on and after the first day of April 1914, shall be Board of Trade standards in like manner as if they were mentioned in the Second Schedule to "The Weights and Measures Act, 1878."

THEREAS by Order in Council, dated the 24th day of March 1902, His late Majesty, in pursuance of the powers conferred by the provisions of section 373 of the Merchant Shipping Act, 1894, did make the regulations for the registry, lettering, and numbering of British sea fishing boats set forth in the Schedule thereto, and did direct that such regulations should come into force on the 1st May 1902:

And whereas it appears to His Majesty desirable to amend the said Order in Council in manner hereinafter appearing:

And whereas the provisions of section 1 of the Rules Publication Act, 1893, have been complied with:

Now, therefore, His Majesty, in exercise of the powers vested in him by the above-mentioned Act and otherwise by and with the advice of his Privy Council, is pleased to direct that:

The said Order in Council, dated the 24th day of March 1902, shall be and is hereby amended by inserting after the word "fishing" in paragraph 17 (2) of the Schedule to the said Order, the following words, that is to say, "and that in the case of fishing boats being sailing boats with motor power, the mizzen sail shall be marked in addition to the mainsail with the letters and numbers prescribed by sub-section 1 of this regulation.

- 3. The Cyprus Telegraphs Order, 1904, shall be and the same is hereby revoked in so far as it relates to Wireless Telegraphy.

WHEREAS it is provided by the Slave Trade Act, 1876, that any person, being a subject of His Majesty, or of any Prince or State in India in alliance with His Majesty, who commits upon the High Seas or in any part of Asia or Africa which may be specified in that behalf by an Order of His Majesty in Council, any of the offences defined in sections 367, 370, and 371 of the Indian Penal Code or abets within the meaning of Chapter V. of the said code the commission of any such offence, shall be dealt with in respect of such offence or abetment as if the same had been committed in any place within British India in which he may be or may be found:

And whereas by an Order in Council of Her late Majesty Queen Victoria, dated the 30th day of April 1877, it was provided that the said Act should apply to the several parts of Asia and Africa therein specified:

And whereas it is desirable to apply the said Act to certain territories in the neighbourhood of Aden to which the said Act has not been applied hitherto:

Now, therefore, in pursuance, and by virtue of the said Act, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

- 1. This Order may be cited as The Slave Trade Offences (India) Order in Council, 1913.
- 2. The Slave Trade Act, 1876, shall apply to the territories of the Kaiti, Wahidi, Behan, Audali and Beda tribes near Aden, and to the territories of the Mahri tribe of Kishin and Socotra.

Now, therefore, His Majesty, by virtue and in exercise of the powers by The Foreign Jurisdiction Act, 1890, or otherwise in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered as follows:—

- 1. This Order may be cited as "The Persia Order in Council, 1913," and shall be read as one with the Persia Order in Council, 1889 (hereinafter called the Principal Order), and this Order, the Principal Order, the Persia (Judicial Fees) Order in Council, 1898, and the Persia (Regulations) Order in Council, 1901, may be cited together as the Persia Orders in Council, 1889 to 1913.
- 2. From and after the date of this Order the definition of British subject in the Principal Order is hereby repealed, and the following definition is substituted therefor:—"British subject" includes a British protected person.


