(Alteration during the progress of the Provisional Order with the above name or short title of the Diversion of Renfrew Road and of Glasgow Corporation Tramways thereon; Compulsory purchase of lands, &c.)

Tramway No. 5 with the centre line of the diversion of Renfrew Road as shown on the said deposited plans, and terminating in the Burgh of Renfrew by a junction with Renfrew Road at a point 120 yards or thereabouts east of the Millburn Bridge, in substitution for that portion of the diversion of Renfrew Road and the tramways of the said Corporation thereon, commencing at the point first above mentioned and terminating by a junction with Renfrew Road at the east end of the bridge carrying that road over the Glasgow and Renfrew District Railway near Deanside Station.
