PRESENT,

The King's Most Excellent Majesty in Council.

**W**HEREAS by section one hundred and four of the Explosives Act, 1875, it is enacted that His Majesty may, by Order in Council, declare that any substance which appears to His Majesty to be specially dangerous to life or property by reason either of its explosive properties or of any process in the manufacture thereof being liable to explosion, shall be deemed to be an explosive within the meaning of the said Act, and the provisions of the said Act (subject to such exceptions, limitations, and restrictions, as may be specified in the Order) shall accordingly extend to any such substance in like manner as if it were included in the term "explosive" in the said Act:

And whereas acetylene, when liquid or subject to a certain degree of compression, or when in admixture with air or oxygen, is specially dangerous to life or property by reason of its explosive properties:

And whereas the provisions of section one of the Rules Publication Act, 1893, have been complied with:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order and declare, and be it ordered and declared, as follows:—

Acetylene, when liquid or when subject to a pressure above that of the atmosphere capable of supporting a column of water exceeding two hundred and fifty inches in

height, and whether or not in admixture with other substances, or when in admixture with atmospheric air or with oxygen gas in whatever proportion and at whatever pressure, and whether or not in admixture with other substances, shall be deemed to be an explosive within the meaning of the said Act, subject to the following exception; that if it be shown to the satisfaction of the Secretary of State that acetylene, declared to be explosive by this Order when in admixture with any substance, or in any form or condition, is not possessed of explosive properties, the Secretary of State may, by Order, exempt such acetylene from being deemed to be an explosive within the meaning of the said Act.

And whereas by section forty-three of the Explosives Act, 1875, it is provided that His Majesty, from time to time, by Order in Council may prohibit, either absolutely or except in pursuance of a licence of the Secretary of State under the said Act, or may subject to conditions or restrictions the manufacture, keeping, importation from any place out the United Kingdom, conveyance, and sale, or any of them, of any explosive which is of so dangerous a character that in the judgment of His Majesty it is expedient for the public safety to make such Order:

And whereas it is in the judgment of His Majesty expedient for the public safety that acetylene, when an explosive within the meaning of this Order, shall be prohibited:

And whereas the provisions of section one of the Rules Publication Act, 1893, have been complied with:

Now, therefore, in pursuance of the above-

mentioned provision of this Act, His Majesty is pleased, by and with the advice of His Privy Council, to order and prescribe that acetylene, declared to be an explosive by this Order, shall be prohibited from being manufactured, imported, kept, conveyed, or sold.

Provided that nothing in this Order shall apply to acetylene in admixture with air when such admixture takes place only in a burner or contrivance in which the mixture is intended to be burnt.

Provided also that nothing in this Order shall be held to apply to an admixture of acetylene and air which may unavoidably occur in the first use or recharging of an apparatus, properly designed and constructed with a view to the production of pure acetylene.

This Order shall come into operation from the date of its publication in the London Gazette, and as from that date the Orders in Council relating to acetylene gas dated 26th November 1897, and 15th May 1900, are hereby repealed. Provided that nothing in this repeal shall affect the Orders of the Secretary of State dated the 28th March 1898, the 29th September 1905, and the 6th August 1912, made under the said Order in Council dated the 26th November 1897, and such Orders shall have effect as if made under this Order.

"And whereas by His late Majesty's Order in Council, bearing date 13th May 1901, we are empowered to award to an Officer of Your Majesty's Navy dismissed the Service by sentence of Court Martial a Compassionate Allowance not exceeding the lowest rate of half-pay of his rank, at our discretion:

"And whereas Commissioned Warrant and Warrant Officers of Your Majesty's Navy, not being eligible for half-pay, are debarred from receiving any benefit under the terms of the above-mentioned Order in Council, when dismissed the Service by sentence of Court Martial:

"We beg leave humbly to submit that Your Majesty may be graciously pleased, by Your Order in Council, to authorise us, at our discretion, to award to Commissioned Warrant and Warrant Officers, in such circumstances, compassionate allowances at rates not exceeding

the pension for which they would be eligible, in ordinary circumstances, at the date of their dismissal.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

I. To receive full pay at the rate of 17s. a day while re-employed or undergoing courses of instruction.

II. To be under the same conditions as regards pension, &c., in case of death or injury as would be applicable in the event of their called upon to serve in time of war or emergency.
