By the Lords of His Majesty's Most Honourable Privy Council.

HEREAS it is provided by Section 2 of the Customs (Exportation Prohibition)
Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914,

that any Proclamation made under Section one of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by a Proclamation, dated the 10th day of November 1914, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section one of the Exportation of Arms Act, 1900, and Section one of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain Warlike Stores was prohibited:

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect:—

That the Proclamation, dated the 10th day of November 1914, should be amended by making the following additions to the same:—

(1) That the exportation of the following articles should be prohibited to all

foreign ports in Europe and on the Mediterranean and Black Seas other than those of France, Russia (except Baltic ports), Belgium, Spain, and Portugal:—

Clover and grass seeds; Motor vehicles of all kinds and their component parts.

(2) That the exportation of-

Fish (whale) oil, viz., train, blubber, sperm or head matter, should be prohibited to all destinations abroad.

Now, therefore, their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

His Majesty the KING has been graciously pleased to award the Edward Medal of the Second Class to James Kennedy, of the Earnoch Colliery, Lunark, in the following circumstances:—

On the 2nd of June 1914, about 1.50 p.m., a miner named Neil McKillop was engaged in taking down head coal when the coal fell, pinning down his foot. Kennedy at once went to his assistance and continued to make every effort to release him, notwithstanding two further falls, which occurred at short intervals, completely smothering McKillop. Others having come to his assistance, they managed after three hours' work to release the imprisoned man, who was unfortunately found to be dead.

Kennedy in his endeavour, at first unaided, to save McKillop's life ran grave risk of being himself smothered.

Also to Joseph Cook, of the Blackhouse Colliery, Durham, in the following circumstances:—

On the morning of the 31st of January 1914, Cook was underground in the Blackhouse Colliery, near the bottom of an old shaft filled with rubbish. Water had accumulated in it, and the weight of the debris so increased burst out the pack walls at the shaft bottom. Seeing the danger, he rushed inbye to warn two shifters named Wilson and Coates, who were working there; they had no way of egress except past the bottom of this shaft. Before the three could get out, the debris filled up the road from floor to roof for a distance of thirty-

five yards, completely cutting off their escape. The three men were eventually released after twenty-two hours' confinement.

By his action Cook ran the risk not merely of a long imprisonment, but of suffocation, which must have resulted had the debris proceeded much further.

ROYAL WARRANT instituting a new Decoration, entitled "The Military Cross."

GEORGE, R.I.

GEORGE THE FIFTH by the Grace of God of the United Kingdom of Great Britain and Ireland, and of the British Dominions beyond the Seas King, Defender of the Faith, Emperor of India, To all to whom these Presents shall come Greeting; Whereas We have taken into Our Royal consideration the distinguished services in time of War of Officers of certain ranks in Our Army; And whereas We are desirous of signifying Our appreciation of such services by a mark of Our Royal favour We do by these Presents for Us Our heirs and successors institute and create a Cross to be awarded to Officers whose distinguished and meritorious services have been brought to Our notice.

Firstly: It is ordained that the Cross shall be designated "The Military Cross."

Secondly: It is ordained that The Military Cross shall consist of a Cross of silver having on each arm Our Imperial Crown and bearing in the centre the letters G.R.I.

Thirdly: It is ordained that no person shall be eligible for this Decoration nor be nominated thereto unless he is a Captain, a Commissioned Officer of a lower grade, or a Warrant Officer in Our Army, or Our Indian or Colonial Military Forces, and that The Military Cross shall be awarded only to Officers of the above ranks on a recommendation to Us by Our Principal Secretary of State for War.

Fourthly: It is ordained that Foreign Officers of an equivalent rank to those above mentioned, who have been associated in Military operations with Our Army, or Our Indian or Colonial Military Forces shall be eligible for the Honorary award of The Military Cross.

Fifthly: It is ordained that the names of those upon whom We may be pleased to confer this Decoration shall be published in the London Gazette, and that a Register thereof shall be kept in the Office of Our Principal Secretary of State for War.

Sixthly: It is ordained that The Military Cross shall be worn immediately after all Orders and before all Decorations and Medals (the Victoria Cross alone excepted), and shall be worn on the left breast pendent from a riband of one inch and three-eighths in width, which shall be in colour white with a purple stripe.

Seventhly: It is ordained that The Military Cross shall not confer any individual precedence, and shall not entitle the recipient to any addition after his name as part of his description or title.

Eighthly: It is ordained that any person whom by an especial Warrant under Our Royal Sign Manual We declare to have forfeited The Military Cross shall return the said Decoration to the Office of Our Principal Secretary of State for War, and that his name shall be erased from the Register of those upon whom the said Decoration shall have been conferred.

Lastly: We reserve to Ourself, Our heirs and successors full power of annulling, altering, abrogating, augmenting, interpreting, or dispensing with these Regulations, or any part thereof, by a notification under Our Royal Sign Manual.

For very valuable work on several occasions between the 19th October and 23rd November in observing the fire of our batteries and furnishing valuable reports, though under very heavy shell fire from the enemy's guns.

Lieutenant John Dopping Boyd, 1st Battalion, The Queen's (Royal West Surrey Regiment).

For gallant leading of his men on the 31st October, and for consistently good work during the campaign.

Captain Cyril Darcy Vivien Cary-Barnard, 2nd Battalion, The Duke of Edinburgh's (Wiltshire Regiment).

On the 16th November showed conspicuous gallantry and promptitude, on his own initiative, in dislodging, with the aid of about 30 men, a company of Germans who had occupied a trench in our line.

Second Lieutenant Francis Graham, 51st Battery, Royal Field Artillery.

When the Officers of a party of the South Lancashire Regiment were disabled, he took command, and succeeded in holding an important part of our trenches until relief arrived and drove out the enemy who had effected a footing, the situation being thus saved by his prompt action.

Lieutenant The Honourable Julian Henry Francis Grenfell, Ist'(Royal) Dragoons.

On the 17th November he succeeded in reaching a point behind the enemy's trenches and making an excellent reconnaissance, furnishing early information of a pending attack by the enemy.

The Reverend Percy Wyndham Guinness, B.A., Chaplain to the Forces, 3rd Cavalry Brigade.

On the 5th November, at Kruistraat, when Major Dixon, 16th Lancers, was mortally wounded, he went on his own initiative into the trenches, under a heavy fire, and brought him to the ambulance, and on the afternoon of the same day, being the only individual with a horse in the shelled area, took a message, under heavy fire, from the 4th Hussars to the headquarters of the 3rd Cavalry Brigade.

Second Lieutenant Richard Lambert, Intelligence Corps.

For conspicuously gallant conduct in obtaining very valuable information, under most difficult and dangerous conditions.

Lieutenant (Temporary Captain) Donald Swain Lewis, Royal Engineers and Royal Flying Corps.

For valuable information repeatedly furnished to the Royal Artillery in regard to the position of the enemy's guns. His direction of our artillery fire, whilst flying, has constantly led to direct hits on the enemy's batteries and the silencing of their guns.

Lieutenant Noel Yvon Loftus Welman, 1st Battalion, The Duke of Cambridge's Own (Middlesex Regiment).

For gallant conduct at La Boutillerie on 30th October, when the heaviest attack was launched by the enemy on the platoon which he commanded, eleven of the enemy were killed on the parapet and two others in front, Lieutenant Welman accounting for three of the number himself.

Captain Gerald Charles Balfour Buckland, 2nd Batallion, 8th Gurkha Rifles.

Near Festubert, on 23rd November, displayed great gallantry in leading a counter attack which led to decisive results. He then, although wounded, returned and brought up reinforcements.

Captain Robert Foster Dill, 129th Duke of Connaught's Own Baluchis.

At Hollebeke, on 31st October, when wounded by a shell, continued to fight his machine gun section until one gun was put out of action and the whole detachment of the other gun was killed.

Captain Lionel Douglas Vernon, 37th Battery, Royal Field Artillery.

Near Neuve Chapelle, on 1st November, although severely wounded, laid a telephone wire to the forward trenches and continued to observe throughout the day, and by this act enabled the Battery Commander to range accurately on the enemy's trenches.

THE NATIONAL HEALTH INSURANCE (OUTSTANDING RESERVE VALUES) AMENDMENT ORDER, 1914, DATED DECEMBER 31, 1914, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COM-MITTEE UNDER SECTION 78 OF THE NATIONAL Insurance Act, 1911 (1 & 2 Geo. 5, c. 55).

Whereas by the National Health Insurance (Outstanding Reserve Values) Order, 1914, made by the National Health Insurance Joint Committee (in this Order called "the Joint Committee") under Section 78 of the National Insurance Act, 1911 (in this Order called "the Act"), it is provided that for the reasons more particularly set forth in the recitals to the said Order there shall, for the purpose of ascertaining under Section 43 of the Act the outstanding reserve values of certain classes of insured persons, be deemed to have been written off the amount of the reserve values under sub-section (4) of Section 55 of the Act a sum ascertained by multiplying, in the case of a man, one-half of one per cent., or, in the case of a woman, one per cent., of the appropriate reserve value by the number of quarters terminating after the date of the entry into insurance of the insured person and before certain other dates therein specified:

And whereas it appears to the Joint Committee necessary and expedient for financial reasons that the amount to be deemed to have been written off the amount of the reserve values under sub-section (4) of Section 55 of the Act shall be calculated in the case of women in the same manner as in the case of men, and that the said Order should be amended accordingly:

And whereas by sub-section (1) of Section 40 of the National Insurance Act, 1913 (in this Order called the "amending Act"), any Order ance Commissioners, in pursuance of the powers or Special Order made under the principal Act or

that Act may be revoked, varied, or amended by an Order or Special Order made in like manner as the original Order:

Now, therefore, the Joint Committee, in pursuance of the power conferred on them by Section 78 of the Act and by sub-section (1) of Section 40 of the amending Act and of all other powers enabling them in that behalf, with the consent of the Treasury, hereby order as follows:—

- 1. This Order may be cited as the National Health Insurance (Outstanding Reserve Values) Amendment Order, 1914, and shall be read as one with the National Health Insurance (Outstanding Reserve Values) Order, 1914.
- 2. Paragraph (1) of Article 1 of the National Health Insurance (Outstanding Reserve Values) Order, 1914, shall be read as though for the words "a sum ascertained by multiplying, in the case of a man, one-half of one per cent., or in the case of a woman, one per cent., of the appropriate reserve value" there were substituted the words "a sum ascertained by multiplying one-half of one per cent. of the appropriate reserve value."

A PROCLAMATION

RELATING TO TRADING WITH THE ENEMY.

GEORGE, R.I.

WHEREAS by Our Proclamation dated the 9th day of September, 1914, called the Trading with the Enemy Proclamation, No. 2, certain prohibitions, as therein more specifically set forth, were imposed upon all persons therein referred to:

AND WHEREAS by Our Proclamation dated the 8th day of October, 1914, the Trading with the Enemy Proclamation No. 2 was amended as therein more specifically set forth:

AND WHEREAS by Our Proclamation dated the 5th day of November, 1914, it was declared that the aforesaid Proclamations, amongst others, should apply to the state of war existing between Us and the Sultan of Turkey:

AND WHEREAS it is desirable to extend the scope of the prohibitions contained in the aforesaid Proclamations in the manner hereinafter appearing:

Now, THEREFORE, We have thought fit, by and with the advice of Our Privy Council, to issue this our Royal Proclamation, declaring, and it is hereby declared, as follows:—

- 1. Notwithstanding anything contained in paragraph 6 of the Trading with the Enemy Proclamation No. 2 transactions hereafter entered into by persons firms or companies resident carrying on business or being in the United Kingdom.
 - (a) in respect of banking business with a branch situated outside the United Kingdom of an enemy person firm or company, or
 - (b) in respect of any description of business with a branch situated outside the United Kingdom of an enemy bank, shall be considered as transactions with an

shall be considered as transactions with an enemy:

Provided that the acceptance payment or other dealing with any negotiable instrument which was drawn before the date of this Proclamation shall not, if otherwise lawful, be deemed to be a transaction hereafter entered into within the meaning of this paragraph.

- 2. The power to grant licences on Our behalf vested by paragraph 8 of the Trading with the Enemy Proclamation No. 2 in a Secretary of State, or the Board of Trade, may also be exercised by the Lords Commissioners of Our Treasury.
- 3. If the Governor in Council of any British possession shall issue a Proclamation extending the provisions of this Proclamation to transactions by persons firms or companies resident carrying on business or being in that possession such first mentioned Proclamation shall have effect as if it were part of this Proclamation.
- 4. This Proclamation shall be read as one with the Trading with the Enemy Proclamation No. 2, and with Our Proclamation dated the 8th day of October amending the same.

Given at Our Court at Buckingham Palace, this Seventh day of January, in the year of our Lord one thousand nine hundred and fifteen, and in the fifth year of Our Reign.

 - "Any such certificate shall be operative throughout the United Kingdom, but may be revoked by the registration officer who granted it or by the registration officer of any district in which the holder is for the time being resident."
- 2. This Order may be cited as the Aliens Restriction (Armenians, etc.) Order, 1915.
