His MAJESTY THE KING has been pleased to approve of the grant of the Medal for Distinguished Conduct in the Field to the undermentioned Warrant Officers, Non-commissioned Officers, and Men, for acts of gallantry and devotion to Duty :—

8545	Acting-Serjeant	Ashby, E.	2nd Battalion, Oxfordshire and Buckinghamshire Light Infantry	For conspicuous gallantry and ability from 1st to 8th November, in reconnoitring on numerous occasions quite close to the enemy's position. Has constantly undertaken dangerous work and always successfully accomplished it.
5333	Corporal ...	Askew, W. J.	2nd Battalion, Coldstream Guards	For conspicuous courage and great ability on 23rd October at Zonnebeke, when he voluntarily took out a patrol to hold ground 300 yards in front of our trenches, and placing his small party in pairs, 150 yards apart, he held up the enemy's attack for 3 hours, and then succeeded in retiring under heavy fire from both flanks.
7775	Acting-Corporal	Badcock, G.	1st Battalion, Royal Berkshire Regiment	For gallant conduct in defence of the forward trenches with a few men on 13th November, when the 6th Infantry Brigade were engaged in taking up another position, he held on to his post so tenaciously that the enemy were led to believe his position was held in force.

9736	Acting-Corporal	Baldwin, R. ...	2nd Battalion, Worcestershire Regiment	For gallant conduct in continually rendering most valuable assistance in superintending the collection of the wounded, whilst exposed to heavy rifle and artillery fire.
9954	Private ...	Banner, J. W. ...	2nd Battalion, Worcestershire Regiment	For gallantry in rendering valuable assistance to his unit at a critical period under a heavy fire.
8145	Private ...	Barclay, W. ...	1st Battalion, Scottish Rifles	For gallantry on 24th October near La Boutillerie, in bringing a wounded comrade into cover of the trenches under a heavy fire.
10564	Private ...	Barnett, L. ...	2nd Battalion, Coldstream Guards	For conspicuous gallantry on 5th November in Reutel Wood, when he went out voluntarily with a small party to enfilade a trench, the fire from which was causing many casualties. The risk was very great on this occasion, and he was severely wounded.
20101	Serjeant ...	Barnfield, J. L. ...	Royal Army Medical Corps, Special Reserve	For conspicuous gallantry in leading his stretcher-bearers in a fearless manner under fire in darkness, collecting the wounded, especially at La Boutillerie on 24th October.
12075	Corporal ...	Barry, F. ...	59th Field Company, Royal Engineers	For conspicuous ability and gallantry during the operations around Ypres from 6th to 20th November, especially in the arduous and trying work of re-trenching our second line, in close proximity to the enemy.
7548	Acting-Company-Quarter-master-Serjeant	Barton, J. ...	2nd Battalion, Essex Regiment	For leading his platoon in a conspicuously gallant manner on 13th October when in independent command.
7440	Private ...	Beale, A. ...	2nd Battalion, Royal Sussex Regiment	For gallant conduct on 10th September at Courchamps, where the casualties were very heavy from shell fire, he managed to continue attending the wounded although one of his fingers was then blown away.
5396	Serjeant ...	Bennett, J.	2nd Battalion, Leinster Regiment	For gallantry and coolness in handling a machine gun on 20th October, under a heavy fire, and by his ability securing an unbroken supply of ammunition for the troops throughout the day.
25354	Driver ...	Bianchi, F. ...	23rd Field Company, Royal Engineers	For conspicuous courage near Ypres on 9th November, in voluntarily remaining alone for two hours with the horses, under continuous high explosive shell fire. Fifty horses were killed or wounded in his immediate vicinity.

Black, R. ...	1st Battalion, South Wales Borderers	For gallantry on 31st October in assisting to collect unattached men and bringing them to the trenches under a heavy fire, and again on 2nd November, in gallantly assisting to extricate men who had been buried by a shell, under heavy fire.

H. ...	3rd Battalion, Coldstream Guards	For conspicuous gallantry in continually undertaking dangerous duties, especially on 9th November at Polygon Wood, when he assisted another man to clear a house occupied by German snipers. He also obtained valuable information the next day whilst on reconnaissance duty.
10223	Corporal ...	Bradford, W. ...	2nd Battalion, Highland Light Infantry	For conspicuous gallantry on 14th November, after both Officers had been killed, he rendered great services by his good example to the men, whereby the trenches were held the whole day, notwithstanding heavy casualties.
3681	Company-Serjeant-Major	Bradish, A. ...	2nd Battalion, Worcester Regiment	For gallantry and ability during the advance through a very difficult country under heavy fire. Rendered valuable assistance to Company Commander.
9740	Private ...	Carrington, R. H. ...	1st Battalion, Leicestershire Regiment	For conspicuous gallantry on 14th December at Rue Du Bois, when he saved the lives of two men who had been buried in a fire trench, being necessarily exposed to the enemy's machine-gun and rifle fire whilst doing so. Has shown remarkable bravery on previous occasions.
11681	Corporal ...	Chambers, A. G. ...	5th Field Company, Royal Engineers	For gallant conduct on 11th November. When his officer was killed he took command of the small party engaged in driving the enemy out of a wood, being met with very heavy machine-gun fire.
4516	Serjeant ...	Clark, E. J. ...	15th Hussars ...	For very conspicuous ability and gallantry on 11th November at Herentage-Chateau. In conjunction with 30 Turcos under their serjeant, he held the Chateau against the German attack for two hours until our line was restored. The enemy's loss was over 100 on this occasion.
8767	Private ...	Clarke, J. ...	1st Battalion, Shropshire Light Infantry	For very gallant conduct in going out in daylight for a distance of 100 yards in front of his trench, crossing a barbed-wire fence and rescuing a wounded comrade, under rifle fire.
7422	Private ...	Clarkson, J. ...	1st Battalion, Leicestershire Regiment	For gallant conduct at Vailly on 23rd September, in assisting to bring into cover a mortally wounded officer, under heavy shell and rifle fire.
24369	Second-Corporal	Clifford, F. W. ...	3rd Section, 2nd Signal Company, Royal Engineers	For gallant conduct on 30th October, in remaining at his post working his instrument whilst the house he was in was being shelled. On several occasions during the day he went out under constant shell fire and sniping and repaired the telephone line.
8715	Private ...	Clifford, M. ...	2nd Battalion, Leinster Regiment	For gallantry on 20th October, in carrying messages under heavy machine-gun fire.
5291	Private ...	Cline, J. R. ...	6th Dragoon Guards ...	For great gallantry on the night of 31st October, in taking up a position of great danger on the left of our line, which was out of touch with all other troops, and conveying information of the enemy's movements. His action was instrumental in preventing a body of our troops from being surrounded.

28089	Corporal ...	Cremetti, M. A. E.	4th Signal Troop, Royal Engineers (Motor Cyclist);	For conspicuous gallantry on 31st October, during the attack on Wytschaete - Messines, in taking messages under a dangerous fire, showing great resource and never failing to achieve his object.
37911	Bombardier	Crompton, J. W. ...	71st Battery, Royal Field Artillery	For gallant conduct on 21st October, in remaining in attendance on a mortally wounded comrade under shell fire. He was wounded an hour later whilst on duty in the observing station.
20623	Lance-Corporal	Curtis, W. J. ...	5th Field Company, Royal Engineers	For gallantry on 11th November, in remaining at his post, after his Officer had been killed under a very heavy machine-gun fire, until compelled to fall back owing to shrapnel fire assailing his trench from the rear.

Curzon, H. ...	2nd Battalion, King's Royal Rifle Corps	For gallant conduct on 31st October (then a private), in attempting to carry a wounded Officer under heavy rifle and machine-gun fire; and again on 7th November, at Klein Zillebeke, when he obtained valuable information as to enemy's movements. Has been conspicuous for coolness and gallantry on all occasions.
10129	Corporal ...	Cyster, P. G. ...	1st Battalion, Bedfordshire Regiment	For gallantry on 10th November, in assisting to recover one of our abandoned machine guns.
62389	Gunner ...	Davidson, J. ...	71st Battery, Royal Field Artillery	For gallantry on 22nd October, in remaining with a mortally wounded Officer and attending to him whilst the building in which he lay was being subjected to a very heavy high-explosive shell fire.
8055	Lance-Corporal	Davies, T. ...	1st Battalion, Liverpool Regiment	For gallant conduct on 28th October, in going into a house in front of our lines and doing excellent work for two days, sniping the enemy in their trenches 80 yards away.
5018	Acting-Corporal	Day, H. ...	1st Battalion, Royal Berkshire Regiment	For gallant conduct on 15th November, in leaving his trench under fire to obtain water for a wounded man. He was immediately wounded himself, but brought back the water to his comrade.
2853	Lance-Corporal	Delaney, W. ...	1st Battalion, Irish Guards	For conspicuous gallantry and devotion to duty during the fight for Reutel Ridge on 26th October, when his untiring efforts were used to rescue the wounded, who no doubt owe their lives to his gallant behaviour.

Being left behind by his company, in a crisis he joined a French battery with four other men, and under the orders of the Commander he assisted in leading the other four men in an attack on a house, capturing two Germans and driving away the remainder.
5754	Acting-Company-Serjeant-Major	Durrans, W. B. ...	1st Battalion, Lincolnshire Regiment	For gallantry on 14th November at Hooge, when he rallied his men in an emergency, although wounded. Has done consistently good work throughout the campaign.
8420	Private ...	Edom, R. ...	1st Battalion, Scots Guards	For gallantry and ability from 27th October to 11th November near the Menin Road, when he carried out very useful reconnaissance duty. Was conspicuous in keeping down the fire of enemy snipers until wounded.
409	Serjeant ...	Edwards, B. P. ...	12th Lancers ...	For gallant conduct on 20th November in endeavouring to rescue a soldier in front of the enemy's trenches. He succeeded in bringing him almost into safety, but the man was killed at that moment.
7235	Bandsman	Edwards, E. ...	1st Battalion, Loyal North Lancashire Regiment	For gallant conduct near Ypres from 31st October to 14th November, when he showed the greatest devotion to duty in attending on the wounded under fire. His gallantry was also particularly noticeable at Gheluvelt on 31st October.
7380	Acting-Serjeant	Edwards, H. ...	2nd Battalion, Oxfordshire and Buckinghamshire Light Infantry	For gallantry and ability on 11th November. In a counter attack he captured a house which enabled the enemy's trenches to be enfiladed. Has been previously noted as a very capable leader in the field.
4283	Serjeant-Major	Elliott, C. J. M. ...	1st Battalion, Royal West Surrey Regiment	For gallantry on 31st October in taking messages and arranging the supply of ammunition, under a heavy fire. Was wounded and is a prisoner of war.
8525	Serjeant ...	Ellis, G. ...	2nd Battalion, Worcestershire Regiment	For conspicuous gallantry and ability on 31st October at Gheluvelt, in the control of his men during the very critical engagement which resulted in the recapture of the village.
9102	Acting-Corporal	Enticott, J. ...	3rd Hussars ...	For gallantry on 30th October near Klein Zillebeke, in remaining in an exposed position under a heavy fire, after his troop had retired, and obtaining useful information.
M.S. 273	Acting-Corporal	Flowers, E. W. ...	Army Service Corps ...	For gallantry and coolness at Ypres in voluntarily assisting to save the Transport Lorries under heavy shell fire. His action was quite successful.

Forwood, H. ...	3rd Battalion, East Kent Regiment	For very conspicuous gallantry on 20th October at Chateau de Flandre, when he continued to serve his Maxim gun until the same was buried by a shell and all the gun team killed or wounded, and, notwithstanding that he had received five wounds himself, managed to report the situation to his head-quarters.

1017	Private ...	Harford, C. ...	15th Hussars ...	For conspicuously gallant conduct on 27th and 28th October. When acting as a despatch rider near Veldhoek, he carried five messages to the firing line, during which period he had two horses killed and one wounded.

Harridine, C. ...	1st Battalion Irish Guards	For conspicuous courage on 1st November at Zillebeke, in voluntarily undertaking a dangerous journey without any apparent prospect of getting safely through.
