PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 12th day of February 1915, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas we consider it desirable that the Officers of Your Majesty's Naval Service acting as Battalion Commandants in the Brigades of the Royal Naval Division, and the Commanders in command of the Battalions of the Royal Naval Division at the Crystal Palace Depôt, should receive Command Money at the rate of 5s. a day:

"And whereas we further consider that the Lieutenant-Commanders acting as Adjutants and Second in Command to the Battalions of the Royal Naval Division should receive an allowance at the rate of 2s. 6d. a day:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the payment of these allowances accordingly, with effect as from the dates on which the Officers concerned took up their duties.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

ADMIRALTY, February 19, 1915.

The following Memorandum has been furnished by the Admiral Commanding the East Coast Mine-sweepers, detailing the recent mine-sweeping operations off Scarborough.

From the 19th to the 31st December sweeping operations were conducted by the East Coast Mine-sweepers with the object of clearing the minefield which had been laid by the enemy off Scarborough.

At the beginning there was no indication of the position of the mines, although owing to losses of passing merchant ships it was known that a minefield had been laid.

In order to ascertain how the mines lay it

was necessary to work at all times of tide with a consequent large increase in the element of danger. The following officers are specially noticed for

their services during the operations:

Commander Richard H. Walters, R.N., A.M.S. Staff, was in charge of the whole of the minesweeping operations from 19th to 31st December. During this period a large number of mines were swept up and destroyed. By the 25th December a channel had been cleared, and traffic was able

to pass through by daylight.

Commander (now Captain) Lionel G. Preston, R.N., H.M.S. "Skipjack," on the 19th December, proceeded at once into the middle of the area where the mines had exploded to give assistance to the damaged trawlers. He anchored between the trawlers and the mines which had been brought to the surface, and proceeded to sink

Lieutenant Godfrey Craik Parsons, "Pekin," displayed great skill and H.M.S. devotion to duty in continuing to command his group of trawlers after having been mined in Trawler No. 58 on 19th December. On this day his group exploded eight mines, and brought to the surface six more, Trawler No. 99 being blown up and Nos. 58 and 465 damaged, all in the space of about ten minutes.

Lieutenant H. Boothby, R.N.R., "Pekin." When Trawler No. 99 ("Orianda") in which he was serving was blown up by a mine on the 19th December, Lieutenant Boothby successfully got all his crew (except one who was killed) into safety. Lieutenant Boothby was again blown up on 6th January 1915, in Trawler No. 450 ("The Banyers").

Lieutenant C. V. Crossley, R.N.R., H.M.S.

"Pekin." Whilst sweeping on 19th December, three violent explosions occurred close under the stern of his ship, Trawler No. 465 ("Star of Britain "). He controlled the crew, and himself crawled into a confined space near the screw shaft, discovered the damage, and temporarily stopped the leak summerory to some to keep the water down and save the ship.

The manual R. N. T. R., Trawler stopped the leak sufficiently to enable the pumps

Skipper T. Tringall, R.N.T.R., Trawler "Solon," No. 55, on his own responsibility went to the assistance of the Steamer "Gallier," which had just been mined on the night of 25th December. It was low water at the time and dark, and the "Gallier" was showing no lights, so had to be searched for in the mine field.

Skipper Ernest V. Snowline, R.N.T.R., Drifter "Hilda and Ernest," No. 201, carried out his duties as Commodore of the Flotilla of Lowestoft drifters under Chief Gunner Franklin, R.N., in a most satisfactory manner. He kept to his station in heavy weather, standing by the S.S. "Gallier" after she had been damaged by a

Lieutenant W. G. Wood, R.N.R., Trawler "Restrivo," No. 48, did excellent work in going to the assistance of damaged trawlers on 19th December, and performed the risky duty of crossing the mine field at low water when sent to bring in the "Valiant," which had been disabled by a mine.

Skipper George W. Thornton, R.N.T.R., Trawler "Passing," No. 58, displayed great coolness and rendered valuable assistance to Lieutenant Parsons in controlling the crew when No. 58 had been mined.

Sub-Lieutenant W. L. Scott, R.N.R., Drifter Principal," went alongside the Trawler Garmo" in a dinghy to rescue a man at considerable risk to himself and his boat, as the vessel was floating nearly vertical at the time, with only the forecastle above water. She turned completely over and sank a few minutes after he left her.

Skipper Thomas B. Belton, R.N.T.R., Drifter "Retriever," No. 223, kept to his station, marking the safe channel for shipping when all other drifters were driven in by the weather.

ADMIRALTY MEMORANDUM on the combined operations by H.M. Ships and Naval Scaplanes. on the 25th December 1914.

On the 25th December 1914 an air recon-"Eager," No. 202, kept to his station in heavy | naissance of the Heligoland Bight, including Cuxhaven, Heligoland, and Wilhelmshaven, was J made by naval seaplanes, and the opportunity was taken at the same time of attacking with bombs points of military importance. The reconnaissance involved combined operations by light cruisers, destroyers and seaplane-carriers, under Commodore Reginald Y. Tyrwhitt, C.B., and submarines acting under the orders of Commodore Roger Keyes, C.B., M.V.O.

The vessels detailed for the operations arrived at their rendezvous before daylight, and as soon as the light was sufficient the seaplanes were hoisted out and despatched. The following Air Service officers and observers took part in the

The seaplane-carriers were commanded by:-Squadron Commander Cecil J. L'Estrange Malone.

At the beginning of the flight the weather was clear, but on nearing the land the seaplanes met with thick weather, and were compelled to fly low, thus becoming exposed to a heavy fire at short range from ships and shore batteries. Several machines were hit, but all remained in the air for over three hours, and succeeded in obtaining valuable information regarding the disposition of the enemy's ships and defences. Bombs were also dropped on military points. In the meanwhile German submarines, seaplanes, and Zeppelins delivered a combined attack upon the light cruisers, destroyers, and seaplane-carriers, but were driven off.

Flight Commanders Kilner and Ross and Flight Lieutenant Edmonds regained their ships. Flight Commander Oliver, Flight Lieutenant Miley, and Flight Sub-Lieutenant Blackburn became short of fuel, and were compelled to descend near Submarine E.11, which with other submarine vessels was watching inshore to assist any seaplane that might be in difficulties. Lieutenant-Commander Martin E. Nasmith, commanding E.11, although attacked by an airship, succeeded, by his coolness and resource, in rescuing the three pilots. Flight Commander Hewlett, after a flight of 3½ hours, was compelled to descend on account of engine trouble, but was rescued by a Dutch trawler, landed in Holland, and returned safely to England,

His Majesty the KING has been graciously pleased to approve of the grant of the Victoria Cross to the under-mentioned Officers and Men for their conspicuous acts of bravery and devotion to duty whilst serving with the Expeditionary Force:—

Lieutenant-Colonel Ernest Wright Alexander, 119th Battery, Royal Field Artillery.

For conspicuous bravery and great ability at Elouges on 24th August 1914, when the

flank guard was atacked by a German corps, in handling his battery against overwhelming odds with such conspicuous success that all his guns were saved, no withstanding that they had to be withdrawn by hand by himself and three other men. This enabled the retirement of the 5th Division to be carried out without serious loss.

Subsequently Lieutenant-Colonel Alexander (then Major) rescued a wounded man under a heavy fire, with the greatest gallantry and devotion to duty.

6535 Drumme William Kenny, 2nd Battalion, The Gordon Highlanders.

For conspicuous bravery on 23rd October, near Ypres, in rescuing wounded men on five occasions under very heavy fire in the most fearless manner, and for twice previously saving machine guns by carrying them out of action.

On numerous occasions Drummer Kenny conveyed urgent messages under very dangerous circumstances over fire-swept ground.

Lieutenant James Anson Otho Brooke, 2nd Battalion, The Gordon Highlanders.

For conspicuous bravery and great ability near Gheluvelt on the 29th October, in leading two attacks on the German trenches under heavy rifle and machine gun fire, regaining a lost trench at a very critical moment. He was killed on that day.

By his marked coolness and promptitude on this occasion Lieutenant Brooke prevented the enemy from breaking through our line, at a time when a general counter-attack could not have been organised.

Captain John Franks Vallentin, 1st Battalion, The South Staffordshire Regiment.

For conspicuous bravery on 7th November at Zillebeke. When leading the attack against the Germans under a very heavy fire he was struck down, and on rising to continue the attack was immediately killed.

The capture of the enemy's trenches which followed was in a great measure due to the confidence which the men had in their Captain, arising from his many previous acts of great bravery and ability.

Lieutenant Frank Alexander de Pass, late 34th Prince Albert Victor's Own Poona Horse.

For conspicuous bravery near Festubert on the 24th November, in entering a German sap and destroying a traverse in the face of the enemy's bombs, and for subsequently rescuing, under heavy fire, a wounded man who was lying exposed in the open.

Lieutenant de Pass lost his life on this day in a second attempt to capture the aforementioned sap, which had been re-occupied

by the enemy.

No. 11340 Private Henry Howey Robson. 2nd Battalion, The Royal Scots (Lothian Regiment).

For most conspicuous bravery near Kemmel on the 14th December 1914, during an attack on the German position, when he left his trench under a very heavy fire and rescued a wounded Non-commissioned Officer, and sub-

sequently for making an attempt to bring another wounded man into cover, whilst exposed to a severe fire: In this attempt he was at once wounded, but persevered in his efforts until rendered helpless by being shot a second time.

8185 Private James Mackenzie, late 2nd Battalion, Scots Guards.

For conspicuous bravery at Rouges Bancs on the 19th December, in rescuing a severely wounded man from in front of the German trenches, under a very heavy fire and after a stretcher-bearer party had been compelled to abandon the attempt.

Private Mackenzie was subsequently killed on that day whilst in the performance of a

similar act of gallant conduct.

Lieutenant Philip Neame, Royal Engineers.

For conspicuous bravery on the 19th December, near Neuve Chapelle, when, not-withstanding the very heavy rifle fire and bomb-throwing by the enemy, he succeeded in holding them back and rescuing all the wounded men whom it was possible to move.

10694 Private Abraham Acton, 2nd Battalion, The Border Regiment.

6423 Private James Smith, 3rd Battalion, The Border Regiment (attached 2nd Battalion).

For conspicuous bravery on 21st December, at Rouges Bancs, in voluntarily going from their trench and rescuing a wounded man who had been lying exposed against the enemy's trenches for 75 hours, and on the same day again leaving their trench voluntarily, under heavy fire, to bring into cover another wounded man.

They were under fire for 60 minutes whilst conveying the wounded men into safety.

No. 3556 Lance-Corporal Michael O'Leary, 1st Battalion, Irish Guards.

For conspicuous bravery at Cuinchy on the 1st February 1915. When forming one of the storming party which advanced against the enemy's barricades he rushed to the front and himself killed five Germans who were holding the first barricade, after which he attacked a second barricade, about 60 yards further on, which he captured, after killing three of the enemy and making prisoners of two more.

Lance-Corporal O'Leary thus practically captured the enemy's position by himself, and prevented the rest of the attacking party from being fired upon.

CLASP TO VICTORIA CROSS.

Lieutenant Arthur Martin Leake, Royal Army Medical Corps, who was awarded the Victoria Cross on 13th May 1902, is granted a Clasp for conspicuous bravery in the present campaign:—

For most conspicuous bravery and devotion to duty throughout the campaign, especially during the period 29th October to 8th November 1914, near Zonnebeke, in rescuing, whilst exposed to constant fire, a large number of the wounded who were lying close to the enemy's trenches.

His Majesty the KING has been graciously pleased to approve of the appointment of the undermentioned Officers to be Companions of the Distinguished Service Order, in recognition of their gallantry and devotion to duty whilst serving with the Expeditionary Force:—

Lieutenant Richard Lawrence Bond, 23rd Field Company, Royal Engineers.

For gallantry on the 10th January 1915, when leading the first party of Royal Engineers in the successful attack on the Railway Embankment at Cuinchy.

Captain The Honourable John Beresford Campbell, Reserve of Officers, 1st Battalion, Coldstream Guards.

For gallantry in the operations at Givenchy, 21st to 23rd December 1914, when he handled his Company with great efficiency.

Second Lieutenant The Honourable Richard Coke, 1st Battalion, Scots Guards (formerly Captain, Reserve of Officers, Scots Guards).

For gallantry and resource in the action at Cuinchy on the 1st January 1915, when he led his Company with great promptitude into the fight on the embankment at a critical moment.

Lieutenant Douglas Stewart Davidson, 1st Battalion, The Royal Scots Fusiliers.

For conspicuous gallantry and ability on the 11th November 1914, on the Ypres-Menin Road, in commanding his Company with great success after his senior Officer had been killed.

Second Lieutenant Charles Henry Dowden, 2nd Battalion, King's Royal Rifle Corps.

For conspicuous courage and marked ability on 9th January 1915, in reconnoitring near Cuinchy quite close to the enemy's position, and obtaining valuable information.

During the attack next day he was wounded in the head, but continued at his post until

all his men were killed or wounded.

Lieutenant Frederick John Harington, 2nd Battalion, The Prince of Wales's Own (West Yorkshire Regiment).

For conspicuous gallantry on the 18th December 1914, when, accompanied by four men (all of whom were shot) he carried out a very successful attack on the enemy with bombs, under very heavy fire.

Captain Claude Alexander Lafone, 2nd Batallion, The Devonshire Regiment.

£ ...

For conspicuous gallantry on the night of 18th December 1914, near Neuve Chapelle, in capturing a trench from the enemy.

Lieutenant Geoffrey Claude Langdale Ottley, late 2nd Battalion, Scots Guards.

For conspicuous gallantry in endeavouring to take a portion of the enemy's trenches after a previous effort had failed.

In this attempt he was severely wounded, and has since died.

Lieutenant Frank Crowther Roberts, 1st Battalion, The Worcestershire Regiment.

On the 3rd January 1915, Lieutenant Roberts, with twenty-five men of the 1st Battalion, Worcestershire Regiment, attacked and captured by surprise, with complete success, a German sap-head situated about sixty yards in front of our lines near Neuve Chapelle.

Captain William Watson, 2nd Battalion, The Border Regiment.

For conspicuous gallantry on several occasions between 18th and 24th October 1914, in handling his machine guns under very heavy fire with great success.

He was twice buried by shell fire, and during the battle at Ypres was twice wounded,

but continued at his post.

Captain Alan Campbell Ross, 20th Deccan Horse.

For conspicuous gallantry at Festubert on 21st December 1914, during an attack on the enemy's position, in assisting to rescue a wounded Indian Officer under a most destructive fire.

Captain Felton Vesey Holt, The Oxfordshire and Buckinghamshire Light Infantry and Royal Flying Corps.

For gallantry on 22nd January 1915, in engaging single-handed a group of twelve German aeroplanes which were attacking the town of Dunkirk. He was subsequently joined by two of our own biplanes, which resulted in one of the German machines being brought down, and its pilot and observer being captured.

His Majesty the KING has been graciously pleased to confer the Military Cross on the undermentioned Officers:—

Captain William Francis Mary Loughnan, Royal Army Medical Corps.

For gallantry on many occasions in Flanders, in assisting to rescue the wounded whilst exposed to heavy fire.

Lieutenant Leonard Castel Campbell Rogers, late 1st Battalion, 7th Gurkha Rifles.

For conspicuous gallantry at Festubert on 24th December 1914, in assisting in the rescue of a severely wounded man who had been lying in front of the enemy's trenches for 48 hours.

Lieutenant Rogers was mortally wounded on this occasion and died the following day.

Lieutenant Edward Lionel Musson, Manchester Regiment, attached 4th (Uganda) Battalion, The King's African Rifles.

Whilst on reconnaissance duty on the 20th December in the operations against German East Africa, near Mbuvuni, although severely wounded, Lieutenant Musson, with a few men, attacked a hostile German patrol with such success that only one man escaped.

His Majesty the KING has been graciously pleased to approve of the award of the Distinguished Conduct Medal to the undermentioned Warrant Officers, Non-commissioned Officers, and men for acts of gallantry and devotion to duty whilst serving with the Expeditionary Force.
