FOREIGN OFFICE, February 23, 1915.

IIS Majesty's Government have decided to declare a blockade of the coast of German East Africa as from midnight, February 28th—March 1st. The blockade will extend along the whole coast, including the islands—i.e. from latitude 4° 41' South to latitude 10° 40' South.

Four days' grace from the time of the commencement of the blockade will be given for the departure of neutral vessels from the blockaded area.
