At the Council Chamber, Whitehall, the 2nd day of March 1915.

By the Lords of His Majesty's Most Honourable Privy Council.

WHEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section one of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas by a Proclamation dated the 3rd day of February 1915, and made under Section 8 of the Customs and Inland Revenue

Act, 1879, and Section one of the Exportation of Arms Act, 1900, and Section one of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain Warlike Stores was prohibited :

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect :—

That the Proclamation dated the 3rd day of February 1915 should be amended by making the following amendments in and additions to the same :—

- (1) That the heading of "draw plates, jewelled, for drawing steel wire" in the list of goods the exportation of which is prohibited to all destinations abroad other than British Possessions and Protectorates should be deleted, and there be inserted in its place "Draw plates, jewelled, for drawing steel wire, and diamonds prepared for use therein."
- (2) That the following articles should be added to the list of goods the exportation of which is prohibited

to all destinations abroad other than British Possessions and Protectorates :—

Paraffin Wax ;
Prussiate of Soda.

Now, THEREFORE, Their Lordships, having taken the said recommendation into considera-

tion, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, and all other persons whom it may concern, are to take notice and govern themselves accordingly.
