# PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 18th day of March 1915, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Scaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas the rates of pay, and the conditions of payment, authorized by Your Majesty's Order in Council, bearing date the 8th day of August 1911, for Probationary Second Lieutenants, Royal Marines, are not applicable under existing circumstances:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to authorize the grant of pay at the rate of 7s. 6d. a day during the period of Hostilities to Probationary Second Lieutenants, Royal Marines, when embarked or appointed to the Royal Marine Brigades or Batteries

"We further beg leave to recommend that the pay of Second Lieutenants, Royal Marines,

entered temporarily for the period of Hostilities, be increased from 5s. to 7s. 6d. a day, as from the 24th November 1914, such increase having been granted to Second Lieutenants appointed to Your Majesty's Army under similar circumstances, and that these Officers be granted pay at the rate of 8s. 6d. a day, when promoted to the rank of Lieutenant.

"The Lords Commissioners of Your Majesty's

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

# WAR OFFICE, March 27, 1915.

The President of the French Republic has, with the approval of His Majesty the King, bestowed the decoration "Grand Officier" of the Legion of Honour on Major-General (temporary Lieutenant-General) Sir Archibald James Murray, K.C.B., K.C.M.G., C.V.O., D.S.O., Colonel of the Royal Inniskilling Fusiliers and Deputy Chief of the Imperial General Staff. in recognition of his distinguished service with the British Army in the Field.

### WAR OFFICE, March 27, 1915.

His Majesty the K1NG has been graciously pleased to approve of the appointment of the undermentioned Officers to be Companions of the Distinguished Service Order, in recognition of their gallantry and devotion to duty whilst serving with the Expeditionary Force:—

Captain Arthur James Glover Bird, Royal Engineers (No. 4 Company, 1st King George's Own Sappers and Miners, Indian Army).

For conspicuous ability, gallantry, and great initiative during the past five months. His great energy and zeal in organising the work of barricade construction at all critical points immensely increased the power of our resistance.

His very effective work was most noticeable during the critical period in the firing line, from 19th to 23rd December 1914.

Lieutenant (temporary Captain) George Ivan Carmichael, Royal Artillery and Royal Flying Corps.

For conspicuous gallantry, daring, and

ability throughout the Campaign.

On the 11th instant he destroyed the rails at Menin railway station by dropping a bomb, weighing 100 lb., thereon from a height of only 120 feet.

On the return journey his engine was damaged by a bullet which necessitated his flying at a height of less than 200 feet.

Captain Carmichael has also rendered valuable services in observing Artillery fire.

Lieutenant Edmund Hume Moore, M.B., Royal Army Medical Corps, attached 2nd Battalion, The Leicestershire Regiment.

For conspicuous gallantry on 23rd February 1915, near Richebourg L'Avoue, in going out with another Officer and a stretcher-bearer to within 150 yards of the enemy and attending to a severely wounded soldier. The stretcherbearer was then wounded, and Lieutenant Moore remained in attendance on him, undoubtedly saving his life.

On the next day this Officer again went with the greatest gallantry to the assistance of a wounded man under the aimed fire of the enemy. He dressed the man's wounds, and was immediately afterwards wounded himself.

Major George Chambers Pollard, 1st (The Newcastle) Northumbrian Field Company, Royal Engineers (Territorial Force).

For conspicuous gallantry on the night of 9th-10th February 1915, in assisting to carry a severely wounded Officer into cover whilst exposed to continuous heavy fire.

Major Pollard has been exposed almost daily to heavy rifle and shell fire in attending to his duties, and has shown a fine example of self-sacrifice and devotion to duty in all difficulties and dangers.

Lieutenant (temporary Captain) George Frederick Pretyman, Somerset Light Infantry and Royal Flying Corps.

For great gallantry, ability, and initiative, on numerous occasions, especially on the 12th instant. The clouds being low he had to fly very low for a considerable period all along the German positions to ascertain their move-

ments, being exposed the whole time to a very heavy fire.

On the 13th instant he blew up the centre of a train at Don station, damaged a building outside which a battalion of the enemy were

forming up, and drove off a German aeroplane.

# WAR OFFICE, March 27, 1915.

His Majesty the KING has been graciously pleased to confer the Military Cross on the undermentioned Officers in recognition of their gallantry and devotion to duty, whilst serving with the Expeditionary Force:—

Lieutenant T. W. Clarke, M.B., Royal Army Medical Corps, Special Reserve.

For conspicuous gallantry and great devotion to duty during the past six months. On the 5th instant, at Neuve Eglise, when the 14th Field Ambulance dressing station was destroyed by shell fire (one Officer and five men being killed and nineteen wounded therein), Lieutenant Clarke continued to attend on the wounded with great gallantry until he collapsed from his own wound—which he received from the first shell.

Lieutenant R. Egerton, 2nd Battalion, Princess Victoria's (Royal Irish Fusiliers).

For gallantry, ability, and useful reconnaissance work, on many occasions at great personal risk.

By the gallant leading of his platoon at St. Eloi he prevented the advancing enemy from taking an important position, and later for rendering very material assistance in the reconnaissance prior to our counter-attack.

2nd Lieutenant H. Ellse, 1st Battalion, The King's Royal Rifle Corps.

For gallantry on 18th February 1915, at Givenchy, when he crept up after dark to within 15 yards of the enemy's position, and, with the assistance of two men, threw German bombs into the German trenches, an action which caused general alarm all along their line.

Has also performed good work in reconnoitring the enemy's trenches.

Captain W. E. Fleming, 41st Dogras, Indian Army.

For gallantry, ability, and zeal in the performance of his very important duties.

He developed with great ingenuity the use of the bomb gun in his capacity as Divisional Bomb-gun Officer, and brought this new service to a high state of efficiency in his area.

Has been constantly under fire whilst directing the massed fire of trench howitzers between 11th December 1914, and 7th February 1915.

Lieutenant W. R. Freeman, The Manchester Regiment and Royal Flying Corps.

For gallantry, ability, and very valuable work performed.

Located the position of German batteries on 10th instant, and conveyed the information by wireless messages from his aeroplane to our Artillery, and, although his propeller and planes were pierced by the enemy's bullets, he remained aloft for more than five hours during the day.

Captain R. Laing, 1st Battalion, Seaforth Highlanders (Ross-shire Buffs, The Duke of Albany's).

For conspicuous gallantry, ability, and coolness.

On 20th December 1914, at a critical moment he organised a bomb party and cleared the enemy out of his trench, and then attacked and drove them from several traverses belonging to the regiment on his left.

Captain N. A. Morgan, 2nd Battalion, The Leicestershire Regiment.

For conspicuous gallantry in going out in the open under fire to assist the Medical Officer and a stretcher-bearer in the rescue of a wounded man on 23rd February 1915, at Richebourg L'Avoue.

He remained until the man's wounds were dressed, and meanwhile his stretcher-bearer was wounded in the neck. Both wounded men were brought into cover—the enemy being only 150 yards distant and firing the whole time.

Lieutenant P. G. J. Mostyn, 2nd Battalion, The Royal Welsh Fusiliers.

For gallantry, ability, and devotion to duty, especially on the 9th instant, when two men of his patrol were wounded, he remained with the seriously wounded man, and eventually carried him a distance of 150 yards into cover, whilst exposed to a very heavy fire.

On the 6th and 8th instant he performed gallant services in reconnoitring the enemy's trenches near Bois Grenier, obtaining valuable information

information.

Lieutenant B. V. Mair, Lieutenant R. H. R. Manchester Parminter, Regiment.

For conspicuous gallantry on 20th-21st December 1914. These two Officers led the attacks on the enemy's trenches, and, during two heavy counter-attacks by the enemy, maintained their positions in the centre and right of the line with such marked determination that complete success was attained by the Battalion Commander.

Lieutenant V. V. Pope, 1st Battalion, The Prince of Wales's (North Staffordshire Regiment).

For the gallantry, skill, and dash with which he led his Company in the attack on the German position at Lepinnette, on the night of the 11th-12th instant.

Captain E. K. Squires, Royal Engineers (No. 21 Company, 3rd Sappers and Miners, Indian Army).

For conspicuous gallantry, ability, and devotion to duty at Givenchy, on 20th-21st December 1914, when he continued to carry on his sapping operations for four hours after he had been wounded.

Second Lieutenant (temporary Captain) L. A. Strange, The Dorsetshire Regiment and Royal Flying Corps.

For gallantry and ability on reconnaissance and other duties on numerous occasions, especially on the occasion when he dropped three bombs from a height of only 200 feet on the railway junction at Courtrai, whilst being assailed by heavy rifle fire.

Lieutenant M. C. M. Wills, 2nd Wessex Field Company, Royal Engineers (T.F.).

For gallantry, initiative, and good work performed.

Carried out reconnaissance duties of an enterprising nature on the nights of 9th and 12th February 1915, and in daylight, on the 10th idem, performed similar valuable services, after our successful counter-attack (in which his brother, Captain R. B. M. Wills, was killed).

Second Lieutenant J. A. H. Wood, 4th Battalion, The East Surrey Regiment, attached 2nd Battalion.

For gallantry, skill, and daring on the night of 15th-16th February 1915, in the guidance of the attacking party near Ypres, and for a similar act of gallantry on the next night, when he voluntarily led the 84th Brigade in the operations.

# CIVIL SERVICE COMMISSION, March 26, 1915.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the consent of the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS RESPECTING OPEN COMPETITIVE EXAMINATIONS FOR THE SITUATION OF FEMALE LEARNER IN LONDON IN THE DEPARTMENT OF THE POSTMASTER-GENERAL.

# These Regulations are liable to alteration from time to time.

- 1. The limits of age for this situation are 14 and 16. If an examination begins in one of the first four months of any year, Candidates must be of the prescribed age on the first day of January in that year. If an examination begins in one of the second four months of any year, Candidates must be of the prescribed age on the first day of May in that year. If an examination begins in one of the last four months of any year, Candidates must be of the prescribed age on the first day of September in that year.
- 2. Candidates will be required to satisfy the Civil Service Commissioners—
  - (a) That they are unmarried or widows.(b) That they are duly qualified in respect

of health and character.

(c) That they are natural-born or naturalised British subjects.

3. At each Examination the number of Candidates to be selected will be such as the Postmaster-General may from time to time fix.

4. The Examination will be in the following subjects, viz.:—

1. English Composition (including Writing and Spelling).

2. Arithmetic (first four rules, Simple and Compound, including English and Metric Weights and Measures, Reduction, Vulgar

Fractions and Decimals, excluding Recurring Decimals).

3. Geography.

Candidates must pass in Writing and obtain such an aggregate number of marks as to satisfy the Civil Service Commissioners.

- 5. No Candidates will be admited to exam ination who does not, at such time as may be fixed by the Civil Service Commissioners, produce an undertaking, signed by her Parent or Guardian, that she will, if successful, reside either with her parents or guardians or with relations or friends approved by such parents or guardians.
- 6. Candidates must be at least 5 feet in 'eight.
- 7. Persons who may have accepted a situation as Learner in any London office will not be eligible to compete. Other persons holding situations in the Civil Service must obtain the written permission of the authorities of their Department to attend the Examination before the commencement of the Competition.
- 8. Persons who have entered upon or completed a course of education or training for the occupation of teacher, on account of which grants are payable from the Exchequer, will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.
- 9. Application for permission to attend an Examination must be made at such time and in such manner as may be fixed by the Civil Service Commissioners.
- 10. A fee of 4s. will be required from every Candidate attending an Examination.
