WAR OFFICE, April 15, 1915.

His Majesty the KING has been graciously pleased to approve of the promotion to the rank of Major-General of Colonel (temporary Brigadier-General) Havelock Hudson, C.B., C.I.E., for distinguished service in the field, with effect from the 18th February 1915, inclusive, and supernumerary to the establishment of Major-Generals, Indian Army.

WAR OFFICE, April 15, 1915.

His Majesty the KING has been graciously pleased to approve of the appointment of the undermentioned Officers to be Companions of the Distinguished Service Order, in recognition of their gallantry and devotion to duty whilst serving with the Expeditionary Force :---

Major Henry William Newcome, 47th Battery. Royal Field Artillery.

For the excellent work performed throughout the campaign, especially on the 10th and 11th March 1915, during the action at Givenchy, when he directed the fire of his Battery from a ruined house with great skill whilst exposed to very heavy rifle fire.

The reports furnished by Major Newcome during the engagement were of the greatest value.

Major Andrew Hamilton Gault, Princess Patricia's Canadian Light Infantry. For conspicuous gallantry at St. Eloi on 27th February 1915, in reconnitring quite close to the enemy's position and obtaining information of great valve for our attack which was carried out next day.

On the 28th February Major Gault assisted in the rescue of the wounded under most difficult circumstances while exposed to heavy fire.

Major Baptist Barton Crozier, 56th Battery, Royal Field Artillery.

Rendered valuable service in observing our artillery fire during the actions of 10th and 11th March 1915, at Givenchy, whilst exposed to the enemy's heavy rifle fire and our own shrapnel. Has been conspicuous for gallantry and coolness under fire throughout the campaign.

Major William Henry Denne, 2nd Battalion, The Bedfordshire Regiment.

For conspicuous gallantry at Neuve Chapelle on 12th March 1915, when he led a party of 20 men in a counter-attack under the most severe fire. All the 20 men were shot down, and he himself was seriously wounded.

Captain Wilfred Edward Nicol, 1st Battalion, Grenadier Guards.

For gallantry and ability at Neuve Chapelle from 10th to 14th March 1915, when he was largely instrumental in the capture of the great number of prisoners by reason of his able handling of the hand grenade company.

Captain (temporary) William Arthur Cecil Saunders-Knox-Gore, 1st Battalion, The King's Royal Rifle Corps.

For gallantry and conspicuous ability throughout the campaign. On the 27th February 1915, he photographed the enemy's position at Givenchy and made an important reconnaissance—the enemy's snipers being only 150 yards distant.

Captain Dick Macdonald Porteous, 1st Battalion, Princess Louise's (Argyll and Sutherland Highlanders).

For conspicuous gallantry on many occasions throughout the campaign.

His very great during and total disregard of danger on reconnaissance duty, especially at St. Eloi on 19th February 1915, were most noticeable.

Lieutenant Gerald Arthur Cammell, 44th Battery, Royal Field Artillery.

For conspicuous gallantry at Neuve Chapelle on 10th March 1915. When employed as observing Officer he saw that the 2nd line of the 1st Battalion, 39th Garhwal Rifles, had lost their British Officers and at once proceeded to lead the men. He went forward in the attack with 4 men under very heavy fire, but was wounded after going 20 yards—as were 3 of his 4 men.

Lieutenant (temporary) James Robertson Campbell Greenlees, M.B., 22nd Field Ambulance, Royal Army Medical Corps.

For his great gallantry and devotion to duty at Neuve Chapelle from 10th to 14th March 1915, in attending on the wounded under very heavy fire.

Lieutenant Greenlees has been twice previously brought to notice for similar acts of gallantry.

His Majesty the KING has been graciously pleased to confer the Military Cross on the undermentioned Officers in recognition of their gallantry and devotion to duty whilst serving with the Expeditionary Force :---

Lieutenant T. H. Beves, 2nd Battalion, The Border Regiment.

For conspicuous gallantry and exceptionally good work performed at Neuve Chapelle on 11th March 1915.

He led his men with great ability in the attack and was twice wounded.

Lieutenant W. G. Colquhoun, Princess Patricia's Canadian Light Infantry.

For conspicuous gallantry and resource on numerous occasions, especially at St. Eloi on 26th January 1915, when he rescued, with the assistance of one man, a mortally wounded officer after three others had failed in the attempt, being under very heavy close-range fire the whole time.

Again, on 27th February 1915, at St. Eloi, this officer rendered valuable assistance on reconnaissance duty under very difficult and dangerous circumstances. Lieutenant N. W. Curran, 5th (Princess Charlotte of Wales's) Dragoon Guards.

For gallantry and ability on the night of 25th-26th February 1915, when he carried out an excellent reconnaissance of the enemy's position, and also undertook a difficult task of ascertaining what sapping operations the Germans were carrying out, with complete success.

Lieutenant Curran encountered much difficulty in this duty from barbed wire fences, and was fired from point-blank range.

Lieutenant G. D. G. Elton, 2nd Battalion Princess Victoria's (Royal Irish Fusiliers).

For conspicuous gallantry at St. Eloi from 14th to 16th March 1915, when he obtained valuable and very essential information relative to the enemy's position on four occasions, whilst exposed to heavy close-range rifle fire.

Second Lieutenant A. H. Hales, 1st Battalion, The Duke of Edinburgh's (Wiltshire Regiment).

For conspicuous gallantry at Spanbroek Molen on 12th March 1915, in leading the attack after being twice wounded, and subsequently for placing other wounded men under cover.

Lieutenant R. C. Hargreaves, 4th Battalion, The Rifle Brigade (The Prince Consort's Own).

For conspicuous gallantry at St. Eloi on 15th March 1915, when he captured two of the enemy's barricades.

Has been noted for his enterprise in bombing the Germans saps and trenches, performing this dangerous work on several occasions when quite alone.

Second Lieutenant E. G. W. W. Harrison, 7th Mountain Battery, Royal Garrison Artillery.

For gallantry and initiative at Givenchy, on 10th March 1915, when he rushed up his gun under heavy shell fire and close-range rifle fire, and destroyed a hostile machine-gun.

Second Lieutenant W. S. Morrison, Royal Field Artillery (Special Reserve).

For conspicuous gallantry at Neuve Chapelle, from 10th to 14th March 1915, when he accompanied the Infantry in the attack, and kept up communication with his Battery, although his wires were often cut.

He was wounded and knocked down twice by shells bursting near him, but continued performing his duties.

Lieutenant T. M. Papineau, Princess Patricia's Canadian Light Infantry.

For conspicuous gallantry at St. Eloi, on 28th February 1915, when in charge of bomb throwers during our attack on the enemy's trenches.

He shot two of the enemy himself, and then ran along the German sap, throwing bombs therein.

Lieutenant J. G. Priestly, M.B., Royal Army Medical Corps.

For gallantry and devotion to duty at Neuve Chapelle, on 13th March 1915, when he continued attending on the wounded with great gallantry, although himself badly wounded.

Second Lieutenant R. H. Slater, 1st Battalion, The King's Royal Rifle Corps.

For conspicuous gallantry at Givenchy, on 10th March 1915, when he brought away the guns safely from near the enemy's wire entanglements after five of his men had been shot. He went out a second time under fire to bring in a gun which had been left in the open.

Subadar Parbat Chand, 59th Scinde Rifles (Frontier Force).

For conspicuous gallantry and exceptionally good service at Neuve Chapelle, on 12th March 1915, when he commanded his Corps for five hours with marked ability after the European Officers had fallen.

Subsequently this Officer took command of the Machine Gun Section after the British Officer had been killed.

The President of the French Republic has conferred, with the approval of His Majesty the King, the decoration of "Croix de Chevalier" of the Legion of Honour on the undermentioned Officers, in recognition of their distinguished service in the campaign :---

Major C. H. Foulkes, D.S.O., Royal Engineers.

Captain P. A. Clive, Reserve of Officers, 2nd Battalion, Grenadier Guards.

His Majesty the KING EMPEROR has been graciously pleased to approve of the following rewards to Officers, Non-commissioned Officers, and Men of the Indian Army for gallantry and devotion to duty whilst serving with the Indian Army Corps, British Expeditionary Force :---

WAR OFFICE, April 19, 1915.

His Majesty the KING has been graciously pleased to approve of the grant of the Victoria Cross to the undermentioned Officer, Non-commissioned Officer, and Men for their conspicuous acts of bravery and devotion to duty whilst serving with the Expeditionary Force :--

No. 15518 Private Edward Barber, 1st Battalion, Grenadier Guards.

For most conspicuous bravery on 12th March 1915 at Neuve Chapelle. He ran speedily in front of the grenade company to which he belonged and threw bombs on the enemy with such effect that a very great number of them at once surrendered.

When the grenade party reached Private Barber they found him quite alone and unsupported with the enemy surrendering all about him.

No. 15624 Lance-Corporal Wilfred Dolby Fuller, 1st Battalion, Grenadier Guards.

For most conspicuous bravery at Neuve Chapelle on 12th March 1915. Seeing a party of the enemy endeavouring to escape along a communication trench, he ran towards them and killed the leading man with a bomb; the remainder (nearly 50) finding no means of evading his bombs, surrendered to him.

Lance-Corporal Fuller was quite alone at the time.

Lieutenant Cyril Gordon Martin, D.S.O., 56th Field Company, Royal Engineers.

For most conspicuous bravery at Spanbroek Molen, on 12th March 1915, when in command of a grenade-throwing party of six rank and file. Although wounded early in the action, he led his party into the enemy's trenches and held back their reinforcements for nearly $2\frac{1}{2}$ hours, until the evacuation of the captured trench was ordered.

No. 7504 Private Henry May, 1st Battalion, The Cameronians (Scottish Rifles).

For most conspicuous bravery near La Boutillerie, on 22nd October 1914, in voluntarily endeavouring to rescue, under very heavy fire, a wounded man, who was killed before he could save him, and subsequently, on the same day, in carrying a wounded Officer a distance of 300 yards into safety whilst exposed to very severe fire.

No. 7281 Private Ross Tollerton, 1st Battalion, The Queen's Own Cameron Highlanders.

For most conspicuous bravery and devotion to duty on the 14th September 1914 at the battle of the Aisne. He carried a wounded Officer under heavy fire as far as he was able into a place of greater safety; then, although himself wounded in the head and hand, he struggled back to the firing line, where he remained till his Battalion retired, when he returned to the wounded Officer and lay beside him for three days, until they were both rescued.

On the 1st October 1914, Hinge was engaged with another man, at the Borstal Institution, Feltham, in removing an obstruction which had occurred in a gas main, when an explosion occurred, hurling Hinge out of the door of the building where they were working. The other man was thrown against the opposite wall, and his escape jeopardised by the flaming gas between him and the door. Hinge pluckily went to his rescue, and succeeded in helping him out. He then, although badly burned and nearly collapsing, took steps to cut off the pressure of the gas, thereby preventing the possibility of further explosions, which might have caused very serious loss of life.

Also to David Humphrey under the following circumstances :---

On the 8th December 1914, a woman was standing on the platform of Murton Railway Station and fell on to the line in an epileptic fit about eighty yards in front of a train which was approaching at fifteen miles an hour. Humphrey, a porter, who was standing some fifteen yards away, ran up and jumped on the line. The train at this moment was only a little over twenty yards off, and he was unable to remove the woman; but he succeeded in holding her down between the rails until the train came to a standstill, after the engine and one waggon had passed above them. By this brave action he saved the woman's life at great risk to himself.

DOWNING STREET, April 15, 1915.

BY THE LIEUTENANT-GOVERNOR

A PROCLAMATION.

Isle of Man to Wit.

WHEREAS it is deemed advisable to make Orders for regulating the importation of animals into this Island.

Now I, the said Lieutenant-Governor, by and with the advice and consent of two members of the Council, and under and by virtue of the powers conferred upon me by the Cattle Diseases Prevention Acts, do hereby Order as follows :---

LANDING REGULATIONS.

1. No animal shall be landed in this Island unless accompanied by a Permit, issued from the Government Office, which Permit may contain such conditions as may at the time of issue be considered desirable. No animal other than a calf shall be landed in this Island except at the Port of Douglas. Calves may be landed either at Douglas or Ramsey.

2. Any person importing animals shall give at least twelve hours' notice, in writing or by telegram, to the Chief Constable, Douglas, Isle of Man, of his intention to land the animals, and of the name of the boat by which it is proposed to import them.

3. No animals shall be allowed to be landed unless accompanied by the certificate of a duly qualified Veterinary Surgeon, that such animals are free from disease at the time of shipment on an examination of such animals made within twenty-four hours prior to shipment. Such certificate shall be produced to an Officer of Police before the animals can be landed, and shall be delivered up to the Superintendent of the Government Lairs on the removal of the animals to the Lairs.

The official marking of animals by a Government Veterinary Inspector at a port of shipment will be accepted in lieu of a certificate.

Where animals are imported without a certificate, but are officially marked, they shall be inspected by an Officer of Police, who before permitting them to be landed shall satisfy himself that they are properly marked.

4.—(1) Each cargo of animals landed under this Order shall on landing be driven to the Government Liars, and the animals shall be there detained until their movement therefrom is permitted by a Government Veterinary Inspector, to be appointed by the Lieutenant-Governor, which permission shall not be granted unless and until the whole cargo has been examined by him, and certified by him to be free from disease.

(2) If two or more cargoes or parts of cargoes are permitted to be in the Government Lairs at the same time, they shall, for the purposes of this Order, be treated as one cargo.

(3) Every consignment of animals removed to the Government Lairs shall be accompanied by a statement showing the place or premises from which the animals were originally moved, and their place of destination within this Island.

5. Animals landed under this Order and removed into the Government Lairs shall, while detained in such Lairs, he supplied with a proper and sufficient supply of food and water by the owners or consignees thereof.

6. The Superintendent of the Government thereof.

Lairs shall have power to forbid persons entering the same without permission from himself.

7. The Superintendent of the Government Lairs shall keep in a book, to be provided for the purpose, a record of all animals moved into or out of the Lairs.

ANIMALS SUFFERING FROM TUBERCULOSIS.

8. Any animal removed to the Government Lairs which, on being examined by the Government Veterinary Inspector, is found to be showing symptoms of tuberculosis, shall at the option of the owner or consignee, either be at once removed from the Lairs to the nearest public abattoir and there slaughtered under inspection or sent back by such owner or consignee at his own expense to the port from which such animal was shipped.

IMPORTATION OF ANIMALS FROM ABROAD.

9. It shall not be lawful to land in this Island any animal brought from any country or place outside the United Kingdom of Great Britain and Ireland and the Channel Islands.

10. It shall not be lawful to land in this Island—

(a) The carcase of an animal which has died or been slaughtered on board a vessel while in a port in any country outside the United Kingdom of Great Britain and Ireland and the Channel Islands, or during the passage from any such port to this Island or thereafter while in any port in this Island; or,

(b) the dung of any such animal; or

(c) any fittings, pens, hurdles, or utensils used for or about any such animal unless they have been scraped and then thoroughly washed or scrubbed or scoured with water, and subsequently disinfected, and unless the permission of the Chief Constable has been obtained.

11. The Principal Officer of Customs and Excise in this Island, or any Officer of Police, may seize and detain any carcase, dung, fittings, pens, hurdles, or utensils landed in contravention of this Order, and he shall forthwith report the facts to the Government Office with a view to the destruction or disposal of such carcase, dung, fittings, pens, hurdles, or utensils.

INTERPRETATION.

12. In this Order-

"Government Lairs" means such place or places as the Lieutenant-Governor may from time to time appoint for the detention of animals under this Order.

"Animals" for the purpose of this Order means bulls, cows, oxen, heifers, calves, sheep, lambs, goats, and swine.

"Disease" for the purpose of this Order means cattle plague (that is to say, rinderpest, or the disease commonly called cattle plague), Contagious Pleuro-pneumonia of cattle, Foot-and-Mouth Disease, Sheep-pox, Sheep Scab, Swine Fever (that is to say, the disease known as Typhoid Fever of Swine, Soldier, Purples, Red Disease, Hog Cholera, or Swine Plague), or Anthrax.

"Carcase" means the carcase of an animal, and part of a carcase, and the meat, flesh, bones, hide, skin, hoofs, horns, offal, or other part of an animal separately or otherwise, or any portion thereof.

REPEAL.

13. The Orders in Council of the 29th day of January 1907, the 16th day of April 1907, the 4th day of June 1907, the 4th day of January 1909, the 18th day of October 1910, the 1st day of July 1912, the 12th day of February 1913, the 20th day of July 1914, and the 6th day of August 1914, are hereby repealed.

COMMENCEMENT.

14. This Order shall come into operation on the 1st day of May 1915.

SHORT TITLE.

15. This Order may be cited as "The Animals (Importation) Order of 1915."

Trade Boards Act, 1909.

PROPOSAL TO FIX MINIMUM RATES FOR THE HOLLOW-WARE TRADE (GREAT BRITAIN).

Section 1. In accordance with Regulations made under Section 18 of the above Act, by the Board of Trade, and dated 27th April 1910, the Trade Board established under the above Act and the Trade Boards Provisional Orders Confirmation Act, 1913, for the Hollow-ware Trade as defined by the Regulations made by the Board of Trade and dated 6th July 1914, hereby give notice that they propose to fix the following minimum or lowest time-rate of wages, clear of all deductions, for FEMALE WORKERS, that is to say :-

(a) FOR FEMALE LEARNERS.—The minimum or lowest time-rates of wages for Female Learners shall be as follows :-

When employed under 15 years of age, 6s. 0d. per week ; when employed at 15 and under 16 years of age, 7s. 6d. per week; when employed at 16 and under 17 years of age, 9s. per week; when employed at 17 and under 18 years of age, 11s. 0d. per week.

Provided that a female worker entering the trade over the age of 16 may serve a period of one year as Learner at the following minimum rates, that is to say :-

First six months, 8s. per week; second six months, 9s. per week.

Thereafter the minimum rate shall be that applicable to the worker's age.

(b) FOR FEMALE WORKERS OTHER THAN LEARNERS.—The minimum or lowest time-rate of wages for Female Workers other than Learners shall be :--

13s. 6d. per week.

For the purpose of this section the term Learner shall mean a person who is employed under conditions which, in the circumstances of the case, afford a reasonable prospect of advancement to the minimum rate for Workers other than Learners.

subject to a proportionate deduction or increase according as the number of hours spent by the worker in the factory or workshop in any week is less or more than 54.

Section 3. The above rates shall apply to all female workers employed in those branches of the Hollow-ware trade which are engaged in the making of Hollow-ware from sheet iron or sheet steel including the process of galvanising, tinning, enamelling, painting, japanning, lacquering, and varnishing.

Section 4. The above minimum rates are without prejudice to workers who are earning higher rates of wages.

PROPOSAL TO FIX MINIMUM RATES FOR THE TIN BOX AND CANISTER TRADE (GREAT BRITAIN).

Section 1.-In accordance with Regulations made under Section 18 of the above Act by the Board of Trade and dated 27th April 1910, the Trade Board established under the above Act and the Trade Boards Provisional Orders Confirmation Act, 1913, for the Tin Box and Canister Trade in Great Britain, as defined in the Regulations made by the Board of Trade and dated 12th June 1914, hereby give notice, as required by Section 4 (2) of the above Act, that they propose to fix the following minimum or lowest time-rates of wages, clear of all deductions,* for FEMALE WORKERS, that is to say :-

When employed under 15 years of age, 63. per week; when employed at 15 and under 16 years of age, 8s. per week; when employed at 16 and under 17 years of age, 10s. per week; when employed at 17 and under 18 years of age, 12s. per week; when employed at 18 years of age and upwards, 14s. 1d. per week.

Subject to the following conditions :---

(a) That notwithstanding the above rates no workers under 18 years of age shall be employed on power presses which, on account of their size, heaviness, or upon other grounds, are unsuitable for the employment of such persons, unless paid a minimum rate of 14s. 1d. per week.

- (b) That as regards a worker employed under 18 years of age it shall be a condition of employment that she is employed during the whole or a substantial part of her time in learning any branch or process of the trade by an employer who provides her with reasonable facilities for such learning.
- (c) That female workers of 18 years of age and over who have been employed in the trade for an aggregate period of less than 12 months, and who cannot suitably be employed on piece-work, shall, until the expiry of such 12 months' period of employment, be paid at a rate of not less than 12s. per week.

Section 2.—The above rates are weekly rates based on a week of 52 hours, but they shall be subject to a proportionate deduction or increase according as the number of hours actually spent by the worker in the factory or workshop in any week is less or more than 52.

Section 3. The above rates shall, subject to the provisions of the Trade Boards Act, apply to all female workers employed in the trade for which the Trade Board is established, namely, the making of boxes and canisters from tinplate, excluding the sealing of filled boxes and canisters with solder, and excluding the following branches of work, namely, the lining of packing cases with tinplate, the making of trunks, uniform cases, suit and dress cases, bonnet and helmet boxes, cash and deed boxes, despatch boxes, letter boxes, kegs and drums, and any other branch of work which does not form part of the tin box and canister trade. Provided that notwithstanding anything contained in this section the above minimum rates shall not apply to Clerks, Saleswomen, Travellers, or to any other workers whose work stands in a relationship to the trade similar to that of the foregoing excluded classes.

Section 4. The above minimum rates are without prejudice to workers earning higher rates of wages.
