The KING's Most Excellent Majesty in Council.

**W**HEREAS by Section 5, Sub-section 2, of the Merchant Shipping (Mercantile Marine Fund) Act, 1898, it is enacted that the Scale and Rules set out in the Second Schedule to that Act shall have effect for the purpose of the levying of Light Dues in pursuance of that Act, but His Majesty may, by Order in Council, alter, either generally or with respect to particular classes of cases, the Scale or Rules and the exemptions therefrom:

And whereas by Order in Council dated the 10th day of August 1903, His Majesty was pleased to alter the said Scale as from the first day of April 1903, by reducing each of the Dues authorised to be levied by  $12\frac{1}{2}$  per centum of the amounts specified by the said Scale:

And whereas by Order in Council dated the 1st day of December 1906, His late Majesty was pleased further to alter the said Scale as from the 1st day of April 1907, by reducing each of the Dues authorised to be levied by the said Scale for a period of three years from the last mentioned date by  $7\frac{1}{2}$  per centum beyond the reduction of  $12\frac{1}{2}$  per centum provided for by the said Order in Council of the 10th day of August 1903:

And whereas by Order in Council dated the 21st day of December 1908, His late Majesty was pleased to alter the Scale of Rules set out in the said Second Schedule to the said Act in manner following, that is to say:—

"1. Each of the Dues authorised to be levied by the said Scale shall, for a period of three years from the date of coming into operation of this Order, be subject to a reduction of  $17\frac{1}{2}$  per centum beyond the reduction of  $12\frac{1}{2}$  per centum provided for by the said Order in Council of the 10th day of August 1903, and the said Dues as so reduced by the said Order in Council of the 10th day of August 1903, and by this Order, shall be levied and the said Rules construed accordingly.

"2. This Order in Council shall come into operation as and from the 1st day of April 1909, and as and from the coming into operation of this Order the recited Order in Council dated the 1st day of December 1906, shall be repealed."

And whereas by Order in Council, dated the 14th day of May 1912, His Majesty was pleased to direct that the provisions of the Order in Council, dated the 21st day of December 1908, should be continued for a period of three years from the 1st day of April 1912:

And whereas it has been made to appear to His Majesty that the provisions of the said Order in Council dated the 21st day of December 1908 should be continued for a further period of one year from the 1st day of April 1915:

Now, therefore, His Majesty, in exercise of the powers so vested in Him by the above-recited provisions, and by and with the advice of His Privy Council, doth by this Order in Council order, and it is hereby ordered, that the Dues authorised to be levied by the said Scale in the said Order in Council dated the 21st day of December 1908, mentioned, shall, subject to the reductions

therein mentioned, be levied for a further period of one year from the date of coming into operation of this Order, and the said rules construed accordingly.

This Order in Council shall come into operation as from the 1st day of April 1915.

#### DEFENCE OF THE REALM REGULATIONS.

Order of the Secretary of State with regard to Persons proceeding to or from Ports in the Orkney Islands.

Whereas the Admiralty are of opinion that in view of the public safety and the defence of the realm it is desirable to impose restrictions on persons proceeding to or from ports in the Orkney Islands.

Now, therefore, I, the Right Honourable Sir John Allsebrook Simon, K.C.V.O., one of His

Majesty's Principal Secretaries of State, in virtue of the powers conferred on me by the Defence of the Realm (Consolidation) Regulations, 1914, as amended by the Order in Council dated the 13th day of April 1915, do hereby make the following Order:—

(1) No person shall embark as a passenger on any ship proceeding to or from any port in the Orkney Islands without the permission of the competent naval authority at the port of embarkation, nor shall any passenger land at any port in the Orkney Islands without the permission of the competent naval authority at that port. Provided that the grant of any such permission by a competent naval authority shall not exempt an alien from any of the requirements of the Aliens Restriction (Consolidation) Order, 1914, or of the Aliens Restriction (Amendment) Order, 1915, with regard to the obtaining of permission to land or embark at any port in the United Kingdom or otherwise.

(2) This Order shall come into force on the first day of June 1915.

#### NATIONAL INSURANCE ACT, 1911 to 1915. UNEMPLOYMENT INSURANCE.

The Unemployment Insurance (Refunds to Employers) Regulations, 1915.

The Board of Trade, in exercise of their powers under Section 91 of the National Insurance Act, 1911, and in exercise of their powers under Section 5 of the National Insurance (Part II. Amendment) Act, 1914, and all other powers in

this behalf, hereby make the following Regulations:—

#### *Short title and commencement.*

1. These Regulations may be cited as the Unemployment Insurance (Refunds to Employers) Regulations, 1915, and shall come into force on the date thereof.

#### *Interpretation.*

2. In these Regulations, the expression "the Act" means the National Insurance Act, 1911, and the expression "the amending Act" means the National Insurance (Part II. Amendment) Act, 1914.

The expression "application" means an application for a refund in accordance with Section 94 of the Act, as amended by Section 5 of the Amending Act.

#### *Manner in which applications must be made.*

3. (1) Every application shall be in the form set out in the First Schedule hereto, or such other form as the Board may direct, accompanied by Schedules (in duplicate), setting out in respect of each workman included in the application.

(a) The particulars mentioned in Part I. of the Second Schedule hereto, and also

(b) (as regards each workman included in the application, in respect of whom no refund would have been payable otherwise than by virtue of the last subsection of Section 5 of the Amending Act), the particulars mentioned in Part II. of the Second Schedule hereto, or so many of them as are applicable.

(2) The application shall be lodged at a Local Office of the Unemployment Fund, or posted to the "Assistant Secretary, Board of Trade, Labour Exchanges and Unemployment Insurance Department, Queen Anne's Chambers, Westminster, London, S.W.," within two months after the termination of the insurance year to which it relates.

#### *Proportionate reduction in refund in certain cases.*

4. The proportionate reduction in the refund to the employer, referred to in the last subsection of Section 5 of the Amending Act, shall be at the rate of fourpence for every five contributions or part of five contributions by which the number of contributions paid by the employer (otherwise than by virtue of the said subsection of Section 5) falls below forty-five.

#### *Employer to furnish information and allow access to records.*

5. (1) An employer who has made an application shall furnish to the Board such other information as the Board may require for enabling them to check the particulars given in the application, or for the purpose of verifying the actual number of contributions paid in respect of any workman, or workmen, included in the application.

(2) An employer, so far as may be necessary for these purposes, shall allow an officer of the Board, duly authorised on their behalf, to inspect any material books of account, vouchers, or other documents.

## ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 31ST MAY 1915.)

### DUMBARTONSHIRE (CONTROL OF DOGS) ORDER OF 1915.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1914, the Dogs Act, 1906, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

#### *Power to make Regulations.*

1.—(1) The Local Authority of any District specified in the schedule to this Order may, in accordance with the provisions of this Order, make Regulations, with a view to the prevention of worrying of cattle (including sheep), for requiring that dogs or any class of dogs shall, during all or any of the hours between sunset and sunrise, be kept by the owners thereof under control in manner prescribed by the Regulations.

(2) The Regulations may apply to the whole or any part of the District, and may exempt any class of dogs either generally or under prescribed conditions.

#### *Confirmation of Regulations.*

2.—(1) Regulations made under this Order shall not take effect unless and until they have

been submitted to and confirmed by the Board of Agriculture and Fisheries.

(2) Unless the Board otherwise direct, the following provisions shall apply:—

(i.) Notice of intention to apply for confirmation of any Regulations shall be given in one or more of the local newspapers circulating within the District in two successive issues two weeks at least before the making of the application.

(ii.) For two weeks at least before an application, a copy of the Regulations proposed to be confirmed shall be kept at the Office of the Local Authority of the District, and be open during office hours thereof to the inspection of ratepayers of the District without fee or reward.

(iii.) The Clerk of the Local Authority shall on the application of any such ratepayer furnish him with a copy of the proposed Regulations on payment of sixpence.

(3) A copy of any Regulations made by a Local Authority under this Order, signed and certified by the Clerk of that Local Authority to be a true copy and to have been duly confirmed, shall be evidence, until the contrary is proved, in all legal proceedings, of the due making, confirmation, and existence of the Regulations, without further or other proof.

#### *Seizure of Dogs where Regulations are Contravened.*

3. Any dog in respect of which an offence is being committed against a Regulation made under this Order may be seized and treated as a stray dog under the powers conferred by section three of the Dogs Act, 1906.

#### *Extension of Definition in Diseases of Animals Act, 1894.*

4. Dogs shall be animals for the purposes of the following sections of the Diseases of Animals Act, 1894 (namely):—

Section forty-three (*Police*):

Section forty-four (*General administrative provisions*);

and also for the purposes of all other sections of the said Act containing provisions relative to or consequent on the provisions of those sections and this Order, including such sections as relate to offences and legal proceedings.

#### *Local Authority to enforce Order.*

5. The provisions of this Order shall be executed and enforced by the Local Authority.

#### *Short Title.*

6. This Order may be cited as the DUMBARTONSHIRE (CONTROL OF DOGS) ORDER OF 1915.

## AMERICAN GOOSEBERRY MILDEW (INFECTED AREAS) ORDER OF 1915.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Destructive Insects and Pests Acts, 1877 and 1907, do order, and it is hereby ordered, as follows:—

*Application of Order.*

1. The provisions of this Order, which refer to an Infected Area shall apply to any area which is declared by Order of the Board to be infected with "disease" as defined by this Order, and to be an Infected Area for the purposes of this Order.

*Notification of Disease.*

2. The occupier of any premises in an Infected Area on which disease exists or appears to exist shall forthwith notify the fact by post or otherwise to the Board, or to the person authorised by the Board to receive such reports. Where this Article applies Article 3 (*Notification of Disease*) of the American Gooseberry Mildew Order of 1911 shall not apply.

*Destruction of Diseased Fruit.*

3. The occupier of any premises in an Infected Area shall forthwith destroy on the premises by fire or other suitable method all diseased fruit of the gooseberry bushes on the premises.

*Removal of Visible Traces of Disease.*

4. All visible traces of disease on any part of a gooseberry bush within an Infected Area shall in each year be cut off and forthwith destroyed by fire by the occupier of the premises on which the bush is growing on or before the thirtieth day of September.

*Removal of Bushes.*

5. (1) No gooseberry bush or part of a gooseberry bush (other than fruit which is free from

disease) shall be moved or permitted by the owner thereof to be moved out of an Infected Area except under the authority, and in accordance with the conditions (if any), of a licence granted by an Inspector of the Board.

(2) Where any bush has been removed in contravention of this Article an Inspector of the Board may, by notice served by post or otherwise on the person in whose possession or under whose charge the bush is, require the movement forthwith of the bush back to the premises from which it was lifted or taken for the purpose of the movement out of the Infected Area, or its destruction forthwith by fire if the owner so prefer.

*Partial Exemption from General Order.*

6. No part of an Infected Area shall be declared to be "infected premises" under the American Gooseberry Mildew Order of 1911, and any premises included in an Infected Area shall cease to be "infected premises."

*Definitions.*

7. In this Order—

"The Board" means the Board of Agriculture and Fisheries.

"Disease" means the disease affecting gooseberry bushes known as *Sphaerotheca mors-uvæ* or American Gooseberry Mildew, and "diseased" means affected with disease.

"Bush" includes a part of a bush.

*Offences.*

8. Every person shall be liable on conviction to a penalty not exceeding ten pounds, who—

(1) fails to give notification of disease as required by Article 2; or

(2) fails to destroy any diseased fruit as required by Article 3; or

(3) fails to cut off and destroy all traces of disease as required by Article 4; or

(4) moves or permits to be moved any bush in contravention of Article 5, or fails to comply with any notice served under that Article.

*Short Title.*

9. This Order may be cited as the AMERICAN GOOSEBERRY MILDEW (INFECTED AREAS) ORDER OF 1915.
