By the Lords of His Majesty's Most Honourable Privy Council.

**W**HEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section one of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by a Proclamation, dated the 3rd day of February 1915, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section one of the Exportation of Arms Act, 1900, and Section one of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain Warlike Stores was prohibited:

And whereas by subsequent Orders of Council, the said Proclamation was amended and added to in certain particulars:

And whereas there was this day read at the

Board a recommendation from the Board of Trade to the following effect:—

That the Proclamation, dated the 3rd day of February 1915, as amended and added to by subsequent Orders of Council, should be further amended by making the following amendments in and additions to the same:—

1. That the following articles should be added to the list of goods the exportation of which is prohibited to all destinations:—

Capsicum and oleo-resin of capsicum.  
Chemicals, drugs, &c., viz.:—  
Caffeine and its salts.  
Paraldehyde.  
Theobromine-Sodium Salicylate.

2. That the following articles should be added to the list of goods the exportation of which is prohibited to all destinations abroad other than British Possessions and Protectorates:—

Bone ash.  
Guanos.  
Phosphates of metals, manufactured.  
Phosphate rock, viz.:—  
Apatites.  
Phosphates of lime and alumina.

Phosphides.  
Phosphoric acids and oxides.  
Steel containing tungsten or molybdenum or both, and any tools or other articles made from such steel.

3. That the heading "Rubber (including raw, waste, and reclaimed rubber solutions containing rubber, jellies containing rubber, or

any other preparations containing rubber) and goods made wholly of rubber; including tyres for motor vehicles and for cycles, together with articles or materials especially adapted for use in the manufacture or repair of tyres" in the list of goods the exportation of which is prohibited to all destinations abroad other than British Possessions and Protectorates should be deemed to include balata and gutta-percha and the following varieties of rubber, viz.:—"Borneo, Guayule, Jelutong, Palembang, Pontianac, and all other substances containing caoutchouc"; and that the words "goods made wholly or partly of rubber" should be substituted for the words "goods made wholly of rubber" in the aforesaid heading.

4. That the heading "rosin" in the list of goods the exportation of which is prohibited to all foreign ports in Europe and on the Mediterranean and Black Seas, other than those of France, Russia (except Baltic ports), Belgium, Spain and Portugal, should be deleted.

5. That the exportation of the following goods should be prohibited to all foreign ports in Europe and on the Mediterranean and Black Seas, other than those of France, Russia (except Baltic ports), Spain and Portugal:—

Cotton yarn and thread.

Gums, resins, balsams, and resinous substances of all kinds, except such as contain caoutchouc (the export of substances containing caoutchouc being prohibited to all destinations abroad other than British Possessions and Protectorates).

Hair, animal, of all kinds; and tops, noils and yarns of animal hair.

6. That the exportation of the following goods should be prohibited to ports in Denmark, the Netherlands, Norway, and Sweden:—

Terneplates.

7. That the exportation of "tin-plates, including tin boxes and tin canisters for food packing" which is prohibited to ports in Denmark, the Netherlands, and Sweden, should be prohibited also to ports in Norway.

Now, therefore, their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, the Director of the War Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

#### WAR OFFICE, June 23, 1915.

His Majesty the KING has been graciously pleased to approve of the grant of the Victoria Cross to the undermentioned Officers, Non-commissioned Officers and Men for most conspicuous bravery and devotion to duty:—

Lieutenant-Colonel Charles Hotham Montagu Doughty-Wylie, C.B., C.M.G., Headquarters Staff, Mediterranean Expeditionary Force.

Captain Garth Neville Walford, Brigade Major, Royal Artillery, Mediterranean Expeditionary Force.

On 26th April 1915, subsequent to a landing having been effected on the beach at a point on the Gallipoli Peninsula, during which both Brigadier-General and Brigade Major had been killed, Lieutenant-Colonel Doughty-Wylie and Captain Walford organized and led an attack through and on both sides of the village of Sedd-el-Bahr on the Old Castle at the top of the hill inland. The enemy's position was very strongly held and entrenched, and defended with concealed machine-guns and pom-poms.

It was mainly due to the initiative, skill and great gallantry of these two Officers that the attack was a complete success.

Both were killed in the moment of victory.

Captain Francis Alexander Caron Scrimger, Canadian Army Medical Service, Medical Officer, 14th Battalion, Royal Montreal Regiment.

On the afternoon of 25th April 1915, in the neighbourhood of Ypres, when in charge of an advanced dressing station in some farm buildings, which were being heavily shelled by the enemy, he directed under heavy fire the removal of the wounded, and he himself carried a severely wounded Officer out of a stable in search of a place of greater safety. When he was unable alone to carry this Officer further, he remained with him under fire till help could be obtained.

During the very heavy fighting between 22nd and 25th April, Captain Scrimger dis-

played continuously day and night the greatest devotion to his duty among the wounded at the front.

Lieutenant George Rowland Patrick Roupell, 1st Battalion, The East Surrey Regiment.

For most conspicuous gallantry and devotion to duty on April 20th, 1915, when he was commanding a company of his battalion in a front trench on "Hill 60," which was subjected to a most severe bombardment throughout the day. Though wounded in several places, he remained at his post and led his company in repelling a strong German assault. During a lull in the bombardment he had his wounds hurriedly dressed, and then insisted in returning to his trench, which was again being subjected to severe bombardment. Towards evening, his company being dangerously weakened, he went back to his battalion headquarters, represented the situation to his Commanding Officer, and brought up reinforcements, passing backwards and forwards over ground swept by heavy fire. With these reinforcements he held his position throughout the night, and until his battalion was relieved next morning.

This young Officer was one of the few survivors of his company, and showed a magnificent example of courage, devotion and tenacity, which undoubtedly inspired his men to hold out till the end.

No. 1539 Colour-Serjeant Frederick William Hall, 8th Canadian Battalion.

On 24th April 1915, in the neighbourhood of Ypres, when a wounded man who was lying some 15 yards from the trench called for help, Company Serjeant-Major Hall endeavoured to reach him in the face of a very heavy enfilade fire which was being poured in by the enemy. The first attempt failed, and a Non-commissioned Officer and private soldier who were attempting to give assistance were both wounded. Company Serjeant-Major Hall then made a second most gallant attempt, and was in the act of lifting up the wounded man to bring him in when he fell mortally wounded in the head.

No. 9539 Lance-Serjeant Douglas Walter Belcher, 1-5th (City of London) Battalion, The London Regiment (London Rifle Brigade).

On the early morning of 13th May 1915, when in charge of a portion of an advanced breastwork south of the Wieltje-St. Julien Road during a very fierce and continuous bombardment by the enemy, which frequently blew in the breastwork, Lance-Serjeant Belcher with a mere handful of men elected to remain and endeavour to hold his position after the troops near him had been withdrawn. By his skill and great gallantry he maintained his position during the day, opening rapid fire on the enemy, who were only 150 to 200 yards distant, whenever he saw them collecting for an attack. There is little doubt that the bold front shown by Lance-Serjeant Belcher prevented the enemy breaking through on the Wieltje Road, and averted an attack on the flank of one of our Divisions.

No. 24066 Lance-Corporal Frederick Fisher, 13th Canadian Battalion.

On 23rd April 1915, in the neighbourhood of St. Julien, he went forward with the machine gun, of which he was in charge, under heavy fire, and most gallantly assisted in covering the retreat of a battery, losing four men of his gun team.

Later, after obtaining four more men, he went forward again to the firing line and was himself killed while bringing his machine gun into action under very heavy fire, in order to cover the advance of supports.

No. 2052 Private William Mariner, 2nd Battalion, The King's Royal Rifle Corps.

During a violent thunderstorm on the night of 22nd May 1915, he left his trench near Cambrin, and crept out through the German wire entanglements till he reached the emplacement of a German machine gun which had been damaging our parapets and hindering our working parties.

After climbing on the top of the German parapet he threw a bomb in under the roof of the gun emplacement and heard some groaning and the enemy running away. After about a quarter of an hour he heard some of them coming back again, and climbed up on the other side of the emplacement and threw another bomb among them left-handed. He then lay still while the Germans opened a heavy fire on the wire entanglement behind him, and it was only after about an hour that he was able to crawl back to his own trench.

Before starting out he had requested a serjeant to open fire on the enemy's trenches as soon as he had thrown his bombs. Rifleman Mariner was out alone for one and a half hours carrying out this gallant work.

#### ITALIAN PRIZE COURT.

FOREIGN OFFICE, June 21, 1915.

His Majesty's Secretary of State for Foreign Affairs learns from His Majesty's Ambassador at Rome that an Italian Prize Court has been established at Rome with authority also as regards the Italian Colonies.

It is stated that parties interested in cases which may come before the Italian Prize Court are at liberty to present written memorials direct to the President of the Court, and that Representatives of Foreign Powers accredited to the Italian Government may address such observations to the Government Commissioner as they think advisable in the interests of their respective nationals.

The KING has been graciously pleased to give orders for the award of the Distinguished Service Cross to Flight Lieutenant John Philip Wilson, R.N., and Flight Sub-Lieutenant John Stanley Mills, R.N., for their services on the 7th June 1915, when, after a long flight in the darkness over hostile territory, they threw bombs on the Zeppelin shed at St. Evere, near Brussels, and destroyed a Zeppelin which was inside. The two Officers were exposed to heavy fire from anti-aircraft guns during the attack.

SLAUGHTER OF ANIMALS (SCOTLAND)  
ORDER OF 1915.

The Board of Agriculture for Scotland, by virtue and in exercise of the powers vested in them under the Slaughter of Animals Act, 1914, and for the purpose of maintaining a sufficient breeding stock, do hereby order as follows :—

*Restriction of Slaughter of Animals In-calf  
or In-pig.*

1. No animal which is visibly or obviously in-calf or in-pig shall be slaughtered, or sold or exposed for sale to be slaughtered.

*Restriction of Slaughter of Calves.*

2. No calf under the age of twelve weeks shall be slaughtered, or sold or exposed for sale to be slaughtered; (but this restriction shall not apply to a male calf of any of the following dairy breeds, that is to say, Channel Islands, Ayrshire, and Kerry breeds).

*Exceptions from Restrictions.*

3. The restrictions of slaughter imposed by this Order shall not apply to—

- (a) slaughter of any animal under the powers conferred by the Diseases of Animals Acts, 1894 to 1914, or any Order made thereunder; or
- (b) slaughter of any animal rendered desirable by illness or accidental injury; or
- (c) slaughter of any animal authorised by a licence granted by the Board of Agriculture for Scotland or an officer of that Board, on cause shown.

*Application of Order.*

4. This Order applies to Scotland.

*Duration of Operation of Order.*

5. This Order shall come into operation on the twenty-fifth day of June nineteen hundred and fifteen, and cease to operate after the thirty-first day of August following, except in relation to proceedings for any offence committed on or before such last-mentioned date.

*Short Title.*

6. This Order may be cited as the Slaughter of Animals (Scotland) Order of 1915.
