**W**HEREAS the Lords of the Committee of the Privy Council on Education in Scotland, by virtue and in pursuance of the powers in them vested under Section 14 of the Education (Scotland) Act, 1908, and of every other power enabling them in that behalf, have made a Scheme amending the Superannuation Scheme for Teachers in Scotland, approved by His Majesty in Council on the 14th day of May 1912, as amended by a Scheme approved by His Majesty in Council on the 12th day of August 1913:

And whereas the provisions of the said Act have been complied with, and the said amending Scheme has been laid before both Houses of Parliament in accordance with the directions contained in the said Act:

And whereas neither House of Parliament has presented an Address praying His Majesty to withhold His consent from the said amending Scheme or any part thereof:—

Now, **THEREFORE**, His Majesty, having taken the said amending Scheme (a copy whereof is hereunto annexed) into consideration, is pleased, by and with the advice of His Privy Council, to approve the same, and to order, as it is hereby ordered, that the said amending Scheme do take effect as from the 1st day of April 1912.

EDUCATION (SCOTLAND) ACT, 1908,  
SECTION 14.

AMENDMENT OF THE SUPERANNUATION SCHEME FOR TEACHERS.

Whereas Section 14 (6) of the Education (Scotland) Act, 1908, provides that upon the Superannuation Scheme for Teachers taking effect "the Elementary School Teachers (Superannuation) Act, 1898, shall cease to apply to Scotland subject to such adjustment of existing interests as may with the consent of the Treasury be prescribed."

And whereas Section 4 of the Elementary School Teachers (Superannuation) Act, 1912, provides that that Act shall be construed as one with the principal Act, and the Scotch Education Department deem it expedient to make certain amendments upon the Superannuation Scheme for Teachers with a view to saving the interests of any teachers who may be affected by the operation of the Act of 1912.

And whereas at the same time other amendments appear to be desirable in order to remove doubt as to certain articles of the Superannuation Scheme.

Now therefore the Scotch Education Department do amend the said Superannuation Scheme as follows:—

Articles 13, 14 and 17 shall be read as if they were and, except where otherwise provided, as if they had been from the date of commencement in the following words, viz.:—
