**SALMON FISHERIES (SCOTLAND) ACTS,
1828 to 1868.**

**THE DISTRICT OF THE RIVER FORTH
(ANNUAL CLOSE TIME) ORDER, 1915.**

IN pursuance of the powers vested in me, and upon application by Petition from the District Fishery Board of the River Forth, in terms of Section 9 of the Salmon Fisheries (Scotland) Act, 1868, I, the Right Honourable Thomas M'Kinnon Wood, His Majesty's Secretary for Scotland, do hereby make the following Order:—

1. The Annual Close Time for the District of the River Forth shall commence on the 27th day of August, and terminate on the 10th day of February, both days inclusive.
2. It shall be lawful to fish for and take salmon with the rod and line in the District of the River Forth from the first day of February to the 31st day of October, both days inclusive.
3. This Order shall take effect forthwith, and may be cited as the District of the River Forth (Annual Close Time) Order, 1915.
4. The Order of the Secretary for Scotland, dated the 22nd day of December 1900, applicable to the said District, is hereby revoked.

WHEREAS by an Order in Council, dated the twenty-eighth day of November nineteen hundred and fourteen, His Majesty was pleased to make Regulations (called the Defence of the Realm (Consolidation) Regulations, 1914) under the Defence of the Realm Consolidation Act, 1914, for securing the public safety and the defence of the Realm :

And whereas the said Act has been amended by the Defence of the Realm (Amendment) Act, 1915, the Defence of the Realm (Amendment) No. 2 Act, 1915, and the Munitions of War Act, 1915 :

And whereas the said Regulations have been amended by Orders in Council, dated the twenty-third day of March, the thirteenth day of April, the twenty-ninth day of April, the second day of June, the tenth day of June, the sixth day of July, and the twenty-eighth day of July, nineteen hundred and fifteen :

And whereas it is expedient further to amend the said Regulations in manner hereinafter appearing :

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following amendments be made in the said Regulations :—

1. After Regulation 6A the following Regulation shall be inserted :—

6B. The Secretary of State may grant licences for the establishment of new or the alteration of existing factories and magazines for gun-powder and other explosives intended for war purposes notwithstanding that the assent of the local authority to the grant of any such licence has not been obtained in accordance with the requirements of the Explosives Act, 1875, and any licence so granted shall, during the continuance of the present war,

have the like effect as if such assent had been obtained in manner provided by that Act.

2. At the end of Regulation 14 the following paragraph shall be inserted :—

If any person remains in or enters any area in contravention of an order under this Regulation he may be removed therefrom by the direction of the competent naval or military authority.

3. After Regulation 30 the following Regulation shall be inserted :—

30A. No person shall, without a permit issued under the authority of the Admiralty or Army Council or the Minister of Munitions, either on his own behalf or on behalf of any other person—

(a) buy, sell, or deal in ; or

(b) offer or invite an offer or propose to buy, sell, or deal in ; or

(c) enter into negotiations for the sale or purchase of or other dealing in—

any war material to which this Regulation may for the time being be applied by order of the Admiralty or Army Council or the Minister of Munitions, whether or not the sale, purchase, or dealing is, or is to be, effected in the United Kingdom.

If any person acts in contravention of the foregoing provision, or aids or abets any other person, whether or not such other person is in the United Kingdom, in doing anything which if done in the United Kingdom would be a contravention of the foregoing provision, or fails to comply with any condition subject to which a permit under this Regulation has been granted, such person shall be guilty of an offence against these Regulations, and if such person is a company, every director and officer of the company shall also be guilty of an offence against these Regulations unless he proves that the contravention took place without his knowledge or consent :

Provided that nothing in this Regulation shall affect any transaction authorised by a permit of the competent naval or military authority under Regulation 30.
