By the Lords of His Majesty's Most Honourable Privy Council.

**W**HEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas by a Proclamation, dated the 28th day of July 1915, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited :

And whereas by subsequent Orders of Council the said Proclamation was amended and added to in certain particulars :

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect :—

That the Proclamation, dated the 28th day of July 1915, as amended and added to by subsequent Orders of Council, should be further amended by making the following amendments in and additions to the same :—

(1) That the exportation of the following goods should be prohibited to all destinations :

Cinchona bark, quinine and its salts ;

Metal cylinders such as are used for containing compressed oxygen or hydrogen.

(2) That the exportation of "Aluminium, manufactures of aluminium, and alloys of aluminium," which is already prohibited to all destinations abroad other than British Possessions and Protectorates, should be prohibited to all destinations.

(3) That the heading "Oil, blast furnace (except creosote and creosote oil)," in the list of goods the exportation of which is prohibited to all destinations abroad other than British Possessions and Protectorates should be deleted, and there be inserted in the list of goods the exportation of which is prohibited to all foreign countries in Europe and on the Mediterranean and Black Seas, other than France, Russia (except through Baltic ports), Italy, Spain and Portugal, the heading "Creosote and creosote oils (including blast furnace oil) except wood tar oil (the exportation of which is already prohibited to all destinations abroad other than British Possessions and Protectorates)."

(4) That the heading "Woollen and worsted cloth suitable for uniform clothing, not including women's dress stuffs or cloth with pattern," in the list of goods the exportation of which is prohibited to all destinations abroad other than British Possessions and Protectorates should be deleted, and there be inserted in the list of goods the exportation of which is prohibited to all foreign countries in Europe and on the Mediterranean and Black Seas, other than France, Russia (except through Baltic ports), Italy, Spain and Portugal, the heading "Cloth of all kinds manufactured of wool or hair (except khaki woollen cloth, the exportation of which is already prohibited to all destinations)."

(5) That the heading "Herrings, cured or salted, in barrels or cases, including dry salted herrings and herrings in brine," in the list of goods the exportation of which is prohibited to all foreign countries in Europe and on the Mediterranean and Black Seas, other than France, Russia (except through Baltic ports), Italy, Spain and Portugal, should be deleted, and there be substituted therefor the heading "Fish of all kinds, whether cured, salted or fresh."

(6) That the exportation of the following goods should be prohibited to all foreign countries in Europe and on the Mediterranean and Black Seas, other than France, Russia (except through Baltic ports), Italy, Spain and Portugal :—

Arrowroot.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, the Director of the War Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

Vessels entering or leaving the Clyde must pass between two Trawlers situated as under-mentioned, which mark the gateway in the obstruction that now exists between Cloch point and Dunoon.

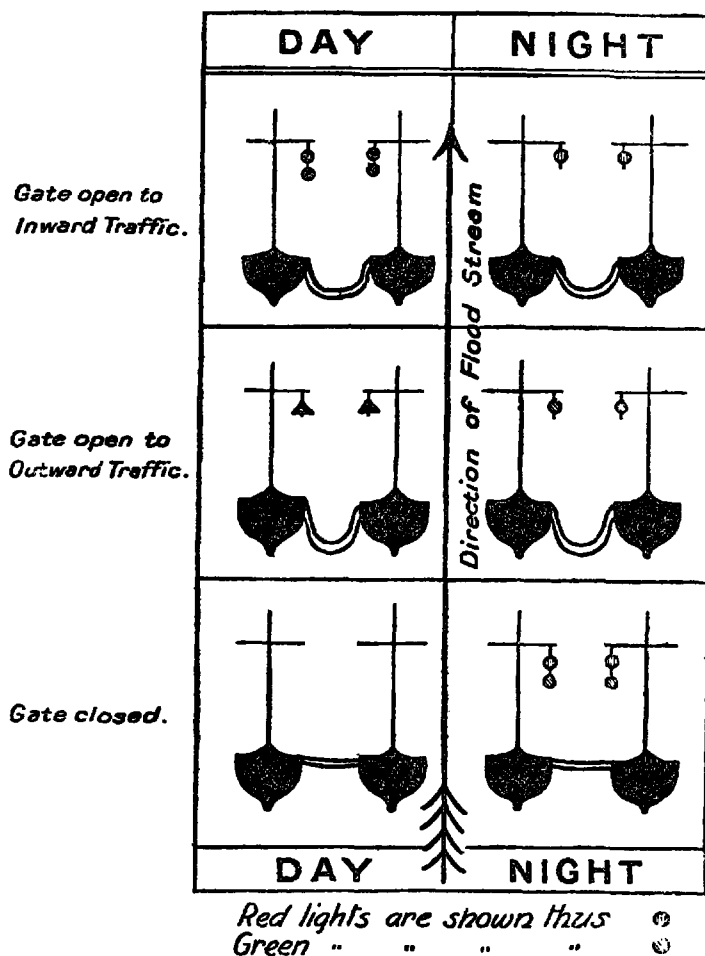

### Signals displayed by Gate-Ships



The above-mentioned gate Trawlers will display signals, as shown on the accompanying diagram, to indicate whether the gate is open to inward or outward bound traffic or whether the gate is closed.

A Trawler with hull painted black is moored a short distance to the northward of the gate Trawlers, and on the western side of the passage.

No vessels are to approach to within a distance of half a mile of the gateway until the special signals are hoisted indicating that the passage is open for them; neither are inward-bound vessels to approach within this distance when the signals are displayed for outward-bound vessels, and vice versa.

Speed must not exceed 10 knots, and vessels

## ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 1ST NOVEMBER 1915.)

### BANFFSHIRE (CONTROL OF DOGS) ORDER OF 1915.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1914, the Dogs Act, 1906, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

#### *Power to make Regulations.*

1.—(1) The Local Authority of the District specified in the Schedule to this Order may, in accordance with the provisions of this Order, make Regulations, with a view to the prevention of worrying of cattle (including sheep), for requiring that dogs or any class of dogs shall, during all or any of the hours between sunset and sunrise, be kept by the owners thereof under control in manner prescribed by the Regulations.

(2) The Regulations may apply to the whole or any part of the District, and may exempt any class of dogs either generally or under prescribed conditions.

#### *Confirmation of Regulations.*

2.—(1) Regulations made under this Order shall not take effect unless and until they have been submitted to and confirmed by the Board of Agriculture and Fisheries.

(2) Unless the Board otherwise direct, the following provisions shall apply—

(i) Notice of intention to apply for confirmation of any Regulations shall be given in one or more of the local newspapers circulating within the District in two successive issues two weeks at least before the making of the application.

(ii) For two weeks at least before an application, a copy of the Regulations proposed to be confirmed shall be kept at the office of the Local Authority of the District, and be open during office hours thereat to the

inspection of ratepayers of the District without fee or reward.

(iii) The Clerk of the Local Authority shall, on the application of any such ratepayer furnish him with a copy of the proposed Regulations on payment of sixpence.

(3) A copy of any Regulations made by the Local Authority under this Order, signed and certified by the Clerk of the Local Authority to be a true copy and to have been duly confirmed, shall be evidence, until the contrary is proved, in all legal proceedings, of the due making, confirmation, and existence of the Regulations without further or other proof.

#### *Seizure of Dogs where Regulations are Contravened.*

3. Any dog in respect of which an offence is being committed against a Regulation made under this Order may be seized and treated as a stray dog under the powers conferred by section three of the Dogs Act, 1906.

#### *Extension of Definition in Diseases of Animals Act, 1894.*

4. Dogs shall be animals for the purposes of the following sections of the Diseases of Animals Act, 1894 (namely):—

Section forty-three (*Police*);

Section forty-four (*General administrative provisions*);

and also for the purposes of all other sections of the said Act containing provisions relative to or consequent on the provisions of those sections and this Order, including such sections as relate to offences and legal proceedings.

#### *Local Authority to enforce Order.*

5. The provisions of this Order shall be executed and enforced by the Local Authority.

#### *Short Title.*

6. This Order may be cited as the BANFFSHIRE (CONTROL OF DOGS) ORDER OF 1915.

ORDER OF THE DEPARTMENT OF AGRICULTURE  
AND TECHNICAL INSTRUCTION FOR IRELAND.

(DATED 29TH OCTOBER 1915.)

HAY AND STRAW (MOVEMENT FROM  
GREAT BRITAIN TO IRELAND)  
ORDER OF 1915.

The Department of Agriculture and Technical Instruction for Ireland, by virtue and in exercise of the powers vested in them under the Agriculture and Technical Instruction (Ireland) Act, 1899, the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

*Prohibition of Landing of Hay or Straw.*

1. Unless and until the Department otherwise order, the landing in Ireland of hay or straw brought from a port or place in Great Britain, is, except as hereinafter expressly provided for, hereby prohibited.

*Exceptions.*

2. This Order shall not apply to—

(a) hay or straw which at the time of importation is being used for packing merchandise;

(b) manufactured straw not intended for use as fodder or litter for animals;

(c) hay or straw certified by a competent military authority to be required and exclusively used for military purposes; or

(d) hay or straw grown in Scotland and imported direct from a port in Scotland and in respect of which a declaration to that effect, made by the importer or the consignor, is produced to an officer of Customs at the port of landing in Ireland.

*Offences.*

3. (1) If any hay or straw shall be landed in contravention of this Order, the owner thereof, and the owner and the lessee and the occupier of the place of landing, and the person causing, directing, or permitting the landing, and the owner and the charterer and the master of the vessel from which the same is landed, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Diseases of Animals Acts, 1894.

*Interpretation.*

4. In this Order

“The Department” means the Department of Agriculture and Technical Instruction for Ireland.

The expression “animals” means horses, asses and mules, cattle, sheep, goats, and all other ruminating animals, and swine.

*Commencement.*

5. This Order shall come into operation on the 1st day of November, nineteen hundred and fifteen.

*Short Title.*

6. This Order may be cited as the HAY AND STRAW (MOVEMENT FROM GREAT BRITAIN TO IRELAND) ORDER OF 1915.
