On the night of 13th-14th November Flight Commander Smyth-Pigott volunteered to attack the railway bridge at Kuleli Burgas. He was able to locate the bridge by the moonlight shining on the river, and descended to within 300 feet of it before releasing his bombs. He was heavily fired on from several places, and, in spite of trouble with his engine, which commenced before he reached the bridge, he returned safely to his base after a night flight which had lasted over four hours.

DEFENCE OF THE REALM (LIQUOR CONTROL).

ORDER (AMENDMENT) OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) FOR THE LONDON

We, the Central Control Board (Liquor Traffic), in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm, hereby make the following Order:

- 1. This Order shall apply to the London Area as defined in Article 1 of the Order of the Central Control Board (Liquor Traffic) made on the 18th day of November 1915, and hereinafter referred to as the Principal Order.
- 2. After paragraph (a) of Article 6 of the Principal Order the following paragraph shall be inserted.
 - (a2) The consumption of intoxicating liquor at a meal by any person in any licensed premises or club at any time within half an hour after the conclusion of the afternoon and evening hours during which the sale or supply of intoxicating liquor is permitted by this Order; provided that the liquor was sold or supplied and served during such hours at the same time as the meal and for consumption at the meal.
- 3. The operation of the provisions of paragraph (e) of Article 4 of the Principal Order shall be suspended and the said provisions shall come into force on the 1st day of January 1916, instead of on the 29th day of November 1915, and notwithstanding the provisions of paragraph 1 (a) of Article 8 of the Principal Order it shall be lawful until the 1st day of January 1916, to dispatch intoxicating liquor from licensed premises before the same is paid for: provided always that no person shall by himself or any servant or agent deliver any intoxicating liquor unless it is paid for before or at the time of delivery.
- 4. This order shall come into force on the 29th day of November 1915.

TRADE BOARDS ACTS, 1909.

MINIMUM RATES FOR FEMALE WORKERS IN THE TIN BOX AND CANISTER TRADE (GREAT

Operative from 29th November 1915.*

Section I.—In accordance with Regulations Board of Trade, and dated 27th April 1910, the Trade Board established under the above Act and the Trade Boards Provisional Orders Confirmation Act, 1913, for the Tin Box and Canister Trade in Great Britain as defined in the Regulations made by the Board of Trade and dated 12th June 1914, hereby give notice, as required by Section 4 (3) of the above Act, that they have fixed the following minimum or lowest time-rates of wages' clear of all deductions, t for FEMALE WORKERS, that is to say :-

When employed under 15 years 6s. 0d. per week. of age When employed at 15 and 8s. 0d. under 16 years of age When employed at 16 and under 17 years of age ... 10s. **0**d. When employed at 17 and under 18 years of age ... When employed at 18 years ... 12s. 0d. of age and upwards ... 14s. 1d.

Subject to the following conditions:—

- (a) That notwithstanding the above rates workers under 18 years of age shall be paid at a minimum rate 14s. 1d. per week if employed on power presses which, on account of their size or heaviness, or the risk of personal injury involved or upon other grounds, are unsuitable for the
- * The Minimum Rates fixed to come into force on 29th November 1915, have at first a limited operation as follows:-
 - (a) Employers must pay wages at not less than the minimum rate unless there is a written agreement under which the worker agrees to accept less. If there is no such written agreement the employer would not be liable to a fine for payment of wages at less than the minimum rate but wages at the minimum rate could be recovered from the employer as a debt by the worker, or (in cases where a worker has lodged a formal complaint with the Trade Board) by the Trade Board acting on behalf of the worker.
 - (b) Any employer may give notice to the Trade Board that he is willing to be bound by the rate fixed, and must give such notice before he can receive a contract from a Government Department or Local Authority involving work to which the minimum rates are applicable. In such cases, agreements to accept less than the minimum rates would not be valid and the employer would be liable to a fine if he paid wages at less than the minimum rate.

The limited operation period continues until the Board of Trade make an Order making the minimum rates obligatory. Such Order can be made on the expiration of six months from the date on which the rate came into force.

- (b) That as regards workers under 18 years of age the above minimum rates are payable subject to the provision that the worker during the whole or a substantial part of her time is learning any branch or process of the trade under conditions which afford her a reasonable prospect of advancement to the minimum rate of 14s. 1d. per week. Otherwise the minimum rate payable shall be 14s. 1d. per week irrespective of age.
- (c) That female workers of 18 years of age and over who have been employed in the trade for an aggregate period of less than 12 months, and who cannot suitably be employed on piece-work shall, until the expiry of such 12 months' period of employment, be paid at a minimum rate of not less than 12s. per week.

Section II.—The above rates are weekly rates based on a week of 52 hours, but they shall be subject to a proportionate deduction or increase according as the number of hours actually spent by the worker in the factory or workshop under contract of employment in any week is less or more than 52.

Section III.—The above rates shall, subject to the provisions of the Trade Board Act, apply to all female workers occupied during the whole or any part of their time in the trade for which the Trade Board is established, namely: the making of boxes and canisters from timplate, excluding the sealing of filled boxes and canisters with solder, and excluding the following branches | of work, namely: the lining of packing cases with tinplate, the making of trunks, uniform cases, suit and dress cases, bonnet and helmet boxes, cash and deed boxes, despatch boxes, letter boxes, kegs and drums, and any other branch of work which does not form part of the into force on 29th November 1915 have at first tin box and canister trade. Provided that not a limited operation as follows:withstanding anything contained in this section the above minimum rates shall not apply to persons occupied merely as Clerks, Saleswomen, Travellers, Cleaners of Premises, or to any other workers whose work stands in a relationship to the trade similar to that of the foregoing excluded

Section IV.—The above minimum rates are without prejudice to workers earning higher rates of wages.

Operative from 29th November 1915.*

Section 1.—In accordance with Regulations made under Section 18 of the above Act by the

Board of Trade and dated 27th April 1910, the Trade Board established under the above Act and the Trade Boards Provisional Orders Confirmation Act, 1913, for the Tin Box and Canister Trade in Great Britain as defined in the Regulations made by the Board of Trade and dated 12th June 1914, hereby give notice, as required by Section 4 (3) of the above Act, that they have fixed the following minimum or lowest time-rates of wages, clear of all deductions,† for MALE WORKERS, that is to say :-

(a) That as regards workers employed under 21 years of age the above minimum rates are payable subject to the provision that the worker during the whole or a substantial part of his time is learning any branch or process of the trade under conditions which afford him a reasonable prospect of advancement to the minimum rate of 26s. per week. Otherwise the minimum rate payable shall be 26s. per week irrespective of age.

- (a) Employers must pay wages at not less than the minimum rate unless there is a written agreement under which the worker agrees to accept less. If there is no such written agreement the employer would not be liable to a fine for payment of wages at less than the minimum rate, but wages at the minimum rate could be recovered from the employer as a debt by the worker, or (in cases where the worker has lodged a formal complaint with the Trade Board) by the Trade Board acting on behalf of the worker.
- (b) Any employer may give notice to the Trade Board that he is willing to be bound by the rate fixed, and must give such Notice before he can receive a contract from a Government Department or Local Authority involving work to which the minimum rates are applicable. In such cases, agreements to accept less than the minimum rates would not be valid, and the employer would be liable to a fine if he paid wages at less than the minimum rate.

(b) That male workers of 21 years of age and upwards who have been employed in the trade for an aggregate period of less than 12 months, and who cannot suitably be employed on piece-work shall, until the expiry of such 12 months' period of employment, be paid at a minimum rate of not less than 22s. 6d. per week.

Section 2.—The above rates are weekly rates based on a week of 52 hours, but they shall be subject to a proportionate deduction or increase according as the number of hours actually spent by the worker in the factory or workshop under contract of employment in any week is less or more than 52.

Section 3.—The above rates shall, subject to the provisions of the Trade Boards Act, apply to all male workers occupied during the whole or any part of their time in the trade for which the Trade Board is established, namely: the making of boxes and canisters from tinplate, excluding the sealing of filled boxes and canisters with solder, and excluding the following branches of work, namely: the lining of packing cases with tinplate, the making of trunks, uniform cases, suit and dress cases, bonnet and helmet boxes, cash and deed boxes, despatch boxes, letter boxes, kegs and drums, and any other branch of work which does not form part of the tin box and canister trade. Provided that notwithstanding anything contained in this section, the above minimum rates shall not apply to persons occupied as Clerks, Salesmen, Travellers, Carpenters, Vanmen, Watchmen, Outside Mes-sengers, Cleaners of Premises, Timekeepers, or to any other workers whose work stands in a relationship to the trade similar to that of the foregoing excluded classes.

Section 4.—The above minimum rates are without prejudice to workers earning higher rates of wages.
