PROCEEDINGS BEFORE BRITISH PRIZE COURTS OVERSEA.

The KING has been graciously pleased to approve of the grant of the Victoria Cross to Lieutenant-Commander Edgar Christopher Cookson, D.S.O., R.N., in recognition of the following act of most conspicuous gallantry during the advance on Kut-el-Amara:—

On the 28th September 1915, the river gunboat "Comet" had been ordered with other gunboats to examine and, if possible, destroy an obstruction placed across the river by the Turks. When the gunboats were approaching the obstruction a very heavy rifle and machine gun fire was opened on them from both banks. An attempt to sink the centre dhow of the obstruction by gunfire having failed, Lieutenant-Commander Cookson ordered the "Comet" to be placed alongside, and himself jumped on to the dhow with an axe and tried to cut the wire hawsers connecting it with the two other craft forming the obstruction. He was immediately shot in several places and died within a very few minutes.

The KING has been graciously pleased to give orders for the award of the Distingiushed Service Cross to the undermentioned Officers in recognition of their services during the advance on Kut-el-Amara on the 27th and 28th September 1915:—

Flight-Lieutenant Vivian Gaskall Blackburn, R.N.

Flight-Lieutenant Blackburn did excellent air reconnaissance work, and came under heavy fire on the afternoon of the 28th September whilst carrying despatches between the General Officer Commanding and the "Comet."

Surgeon Dermot Loughlin, M.B., R.N.

Surgeon Loughlin attended the wounded on board the "Comet" under a heavy fire at close quarters on the night of the 28th September.

Engineer Thomas Kerr. R.I.M,

Engineer Kerr not only kept the Lascar engine-room complement of the "Comet" in excellent order during action, but assisted in carrying down the wounded under fire.

Sub-Lieutenant Lionel Charles Paul Tudway, R.N.

Sub-Lieutenant Tudway was in command of the armed launch "Sumana," and showed remarkable ability and coolness in manœuvring his vessel under heavy fire on the night of the 28th September, and on several other occasions under fire.

BRITISH NATIONALITY AND STATUS OF ALIENS (INDIA).

REGULATIONS.

In the exercise of the powers conferred on me by the British Nationality and Status of Aliens Act, 1914 (hereinafter referred to as "the Act"), I, the Right Honourable Austen Chamberlain, one of His Majesty's Principal lations :-

FORM OF CERTIFICATE OF NATURALISATION IN BRITISH INDIA.

1. A certificate of naturalisation granted in British India shall, save as otherwise hereinafter prescribed, be in one of the following forms :-

(A) Where the names of children are not included.

REGISTRATION OF CERTIFICATES OF NATURAL-ISATION AND OATHS OF ALLEGIANCE.

8. Every certificate of naturalisation granted in British India under the Act, and every oath of allegiance relating to any such certificate, shall be registered both in London at the Home Office and in British India at such place as the Governor-General of India in Council may direct.

REGISTRATION OF DECLARATIONS.

9. Every declaration of alienage and declaration of retention or resumption of British nationality made in British India shall be registered both in London at the Home Office and in British India at such place as the Governor-General of India in Council may direct.

OATH OF ALLEGIANCE.

10.—(1) The following persons may administer the oath of allegiance:—

In British India-

Any officer not below the rank of a District Magistrate or a magistrate of the first class.

In England or Ireland—

Any justice of the peace or any commissioner authorised to administer oaths in the Supreme Court.

In Scotland-

Any sheriff, sheriff-substitute, or justice of the peace.

In a British Possession (other than British India)—

Any judge of any court of civil or criminal jurisdiction, any justice of the peace, or any officer for the time being authorised by law, in the place in which deponent is, to administer an oath for any judicial or other legal purpose.

In any British Protectorate or British protected state—

Any officer for the time being authorised by law in that territory to administer an oath for any judicial or other legal purpose.

Elsewhere-

Any officer in the diplomatic or consular service of His Majesty.

- (2) The oath of allegiance shall be subscribed as well as taken, and the form in which the oath of allegiance is subscribed and attested shall be as follows:—
- I, A.B., swear by Almighty God that I will be faithful and bear true allegiance to His Majesty, King George the Fifth, His Heirs and Successors, according to law.

- (3) The oath of allegiance sworn, subscribed and attested as herein directed shall in every case be endorsed on the certificate of naturalisation to which it relates.
- (4) The oath of allegiance may be proved in any legal proceedings by the production of the original certificate or any copy thereof certified to be a true copy by the Secretary to the Government of India or by any person authorised by the Governor-General of India in Council in that behalf.

TIME WITHIN WHICH OATH OF ALLEGIANCE TO BE TAKEN.

11. The oath of allegiance shall be taken within one calendar month after the date of the certificate of naturalisation to which it relates, or, in any case where the Governor-General of India in Council grants an extension of time, within such extended time as the Governor-General of India in Council may direct, and if the oath is not so taken the certificate shall be void.

Persons before whom Declarations may be Made.

12. The persons before whom declarations of alienage and declarations of resumption or retention of British nationality may be made, shall be the same as the persons by whom the oath of allegiance may be administered.

FEES.

13. The following fees may be taken and shall be applied in the manner hereinafter shown:—
