**DEFENCE OF THE REALM (CONSOLIDATION) REGULATIONS, 1914-16.**

**ORDER AMENDING THE ORDER OF 31ST MARCH 1916.**

**PROHIBITION OF THE LIFTING OF HAY AND STRAW IN GREAT BRITAIN.**

1. Whereas, by Order of 31st March 1916, the Army Council, in pursuance of the powers conferred on them by the Defence of the Realm (Consolidation) Regulations, 1914-16, took possession of all hay or oat or wheat straw (threshed or unthreshed) then standing on a farm or other premises in bulk in Great Britain, and directed that as from the date of such Order the same should be held at the disposal of the duly authorised officers of the War Department, and provisions were made by the said Order as to applications for purchase or removal of such hay or oat or wheat straw.

And whereas it is desired to amend the said Order of 31st March 1916, by substituting for the provisions contained in the said Order, as to applications for purchase or removal the provisions hereinafter contained and otherwise as hereinafter appears.

Now therefore, in pursuance of the powers conferred upon them by the Defence of the Realm (Consolidation) Regulations, 1914-16, the Army Council hereby give notice that as

from the date of this Order the said Order of 31st March 1916 shall be amended as follows, viz. :—The portion of the said Order relating to applications for purchase or removal, that is to say, the whole of the said Order after the words “duly authorised officers of the War Department,” is hereby revoked, with the exception of the list of addresses of officers, and in lieu of the portion revoked the following provisions shall have effect :—

2. Applications (applying to hay or wheat or oat straw of the 1915 or earlier crops) for the sale or purchase or removal for the needs of private consumers will as a rule only be entertained for such amounts as appear to the person to whom the application is made from a declaration to be furnished by the applicant to be necessary either for consumption by the stock in the applicant's possession or control or to be equal to the average quantity dealt in, sold, or consumed by the applicant during the twelve calendar months preceding the date of this Order, and if it appears from the declaration accompanying an application to purchase that the applicant has not purchased or removed or applied for the purchase or removal of hay or straw from any other source covering the same service.

3. Applications to enable hay or wheat or oat straw to be sold to private consumers or dealers will only be granted in respect of qualities and quantities of hay or straw which, after inspection by an officer of the Forage Department or authorised Member of a County or Central Committee, or in Scotland of the Forage

Reference Committee, are found not to be required for Army use.

4. Farmers and stock breeders are authorised to use the normal quantity of hay or oat or wheat straw in their possession for consumption by stock in their possession or control.

5. Applications for sale under this Order must be made in writing to the District Purchasing Officer of the District or County in which the hay or straw affected is standing.

6. Applications for purchase for local consumption by the applicant's own stock or stock in his possession or control will be made to the District Purchasing Officer of the District or County in which the forage stands. Applications to purchase for the purpose of re-sale or applications to purchase direct from the producer by railway companies, mine owners, corporations, companies or other bodies, will be made in England and Wales to the Administrative Member, Forage Committee, 64 Whitehall Court, London, S.W., and in Scotland to the Area Administrative Officer, 7 West George Street, Glasgow.

7. All applications must be in writing and must contain a declaration either that the forage required is necessary for consumption by stock in the applicant's possession or control or is equal to the quantity dealt in, sold or consumed by the applicant during the twelve calendar months preceding the date of this Order; it must appear from the declaration that the applicant has not purchased or removed or applied for the purchase or removal of hay or straw from any other source covering the same service.

All licences or authorities issued under the Order will be issued subject to the restrictions and conditions contained in such licences or authorities, and any departure from these conditions or other acts in contravention of the provisions of this Order will be an offence under the Defence of the Realm Regulations and render the offender liable to the penalties attaching thereto.

DEFENCE OF THE REALM (CONSOLIDATION) REGULATIONS, 1914-16.

PROHIBITION OF THE LIFTING OF HAY AND OAT STRAW IN SCOTLAND.

1. In pursuance of the powers conferred on them by the Defence of the Realm (Consolidation) Regulations, 1914-16, the Army Council hereby give notice that all hay or oat straw of the 1916 crop in Scotland, now standing in bulk or as and when harvested is taken possession of by the Army Council, and shall from the date of this Order, or as and when harvested, be held at the disposal of the duly authorised officers of the War Department.

This Order is without prejudice to the Order of the Army Council of 31st March 1916, relating to the prohibition of the lifting of hay and straw in Great Britain, which still remains in force as regards Great Britain in respect of all hay or oat or wheat straw other than the 1916 crop, as amended by the subsequent Order of even date with this Order.

2. Applications (applying to hay or oat straw of the 1916 crop) for the sale or purchase or removal for the needs of private consumers will as a rule only be entertained for such amounts as appear to the person to whom the application is made from a declaration to be furnished by the applicant to be necessary either for consumption by the stock in the applicant's possession or control or to be equal to the average quantity dealt in, sold or consumed by the applicant during the twelve calendar months preceding the date of this Order, and if it appears from the declaration accompanying an application to purchase that the applicant has not purchased or removed or applied for the purchase or removal of hay or straw from any other source covering the same service.

3. Applications to enable hay or oat straw to be sold to private consumers or dealers will only be granted in respect of qualities and quantities of hay or straw which after inspection by an officer of the Forage Department or authorised Member of the Forage Reference Committee are found not to be required for Army use.

4. Farmers and stock breeders are authorised to use the normal quantity of hay or oat straw in their possession for consumption by stock in their possession or control.

## AUTHORISATION.

I, Andrew Bonar Law, His Majesty's Principal Secretary of State for the Colonies, hereby authorise the person for the time being holding the appointment of Staff Paymaster, New Zealand Expeditionary Force, and any person or persons authorised by him to perform on my behalf in

accordance with the conditions laid down in the Regimental Debts Act, 1893, 56 Victoria, Chapter 5, and any Regulations prescribed under the said Act, any of the following functions, namely:—

(1) To receive any surplus arising under the Regimental Debts Act, 1893, of any member of the New Zealand Expeditionary Force who may die subject to military law during the present war, and all arrears of pay, batta, grants and other allowances in the nature thereof standing to the credit of the deceased.

(2) To pay out of the money so received any debts payable out of the same in accordance with the provisions of the said Act and regulations, and any expenses or charges which under the said Act, or any regulations prescribed thereunder, may be chargeable against the same.

(3) To pay or apply the monies so received, or any residue thereof remaining after payment of debts, charges and expenses as aforesaid, to the representative of the deceased in the United Kingdom, or in the absence of any such representative to pay or apply the same to or for the benefit of such persons in the United Kingdom as appear to be beneficially entitled to the personal estate of the deceased or to or for the benefit of any such persons.

(4) To transmit any balance in his or their hands not disposed of as aforesaid to the Minister of Defence at Wellington, New Zealand, for distribution.

And I hereby authorise the Minister of Defence at Wellington, New Zealand, and all persons duly authorised by him to dispose of and distribute on my behalf any part of the estate coming to his or their hands as aforesaid in accordance with the conditions in the said Act and any regulations prescribed under the said Act.

And I declare that for the purposes of exercising the powers delegated to them all persons authorised to act on my behalf shall have and exercise all such further or incidental powers as are by the said Act or any regulations prescribed thereunder conferred or vested in the Secretary of State.

And I hereby further declare that all receipts of money or effects of any member of the New Zealand Expeditionary Force deceased during the present war, and all payments out of monies so received, and all distributions, disposals and applications of such monies and effects had or made before the date hereof by the said Staff Paymaster or by any person or persons acting under his authority in pursuance of the said Act, and of regulations prescribed thereunder, have been had and made under the authority of and with the sanction of the Secretary of State.

## TRADE BOARD'S ACT, 1909.

## TAILORING TRADE BOARD

(GREAT BRITAIN).

PROPOSAL TO VARY certain Minimum Rates of Wages for Female Workers in certain branches of the Tailoring Trade in Great Britain which are engaged in making garments to be worn by male persons.

In accordance with Regulations made under



Section 18 of the above Act by the Board of Trade, and dated the 27th of April 1910, the Trade Board established under the above Act for certain branches of the Tailoring Trade in Great Britain which are engaged in making garments to be worn by male persons, as defined in the Regulations made by the Board of Trade and dated the 10th January 1914,

Hereby give notice as required by Section 4 of the above Act that the Trade Board propose to

vary the Minimum Rates of Wages for female workers fixed by them on 19th August 1912, and 19th July 1915, and made obligatory under Orders of the Board of Trade dated the 20th February 1913, and the 20th January 1916, as follows, that is to say:—

I. (a) For female workers other than homeworkers, from 3½d. an hour to 4d. an hour.

(b) For female homeworkers, from 3½d. an hour to 4d. an hour.

On and after the 21st September 1916, no vessels other than those of British Nationality, or those of the Allied Nations, shall enter Granton Harbour, until further notice.

CAUTION.

This Admiralty Notice to Mariners is issued under the provisions of the Defence of the Realm (Consolidation) Regulations, 1914, and failure to comply strictly with the directions contained in it will constitute an offence against those Regulations.

Any person found guilty of such an offence is liable to severe penalties both of imprisonment and fine.

Any person aiding or abetting the commission of such an offence is himself guilty of an offence against the Regulations.

Attention is also drawn to the fact that any infringement of the directions contained in this Admiralty Notice to Mariners is liable to result in the detention of the ship or vessel.

The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of His Majesty's Treasury, viz. :—

**REGULATIONS** respecting Boy Clerks registered for Temporary Employment in Public Departments.

1. Two Registers of Boy Clerks for temporary employment in Public Departments will be kept by the Civil Service Commissioners.

2. These Registers will contain the names of boys who, being either natural-born or naturalised British subjects, are certified by the Civil Service Commissioners to be of good health and character, and duly qualified under the following Regulations (3 and 4). One Register will contain the names of boys for service in London, Edinburgh, and provincial towns of England, Scotland, and Wales. The other will contain the names of boys for service in Dublin and provincial towns in Ireland.

3. The limits of age are 15 to 16. If an examination begins in one of the first three months of any year, candidates must be of the prescribed age on the first of January in that year. If an examination begins in April or May of any year, candidates must be of the prescribed age on the first of April in that year. If an examination begins in June, July, or August of any year, candidates must be of the prescribed age on the first of June in that year. If an examination begins in one of the last four months of any year, candidates must be of the prescribed age on the first of September in that year.

4. The subjects for Examination are :—

1. Handwriting and Orthography.
2. Arithmetic (including Vulgar and Decimal Fractions).
3. English Composition.
4. Copying Manuscript.

*And any three of the following, except that not more than two languages may be taken :—*

5. Geography.
6. English History.
7. Latin.
8. French.
9. German.
10. Mathematics.
11. Elementary Science.

No Candidate will be regarded as qualified who fails to obtain such an aggregate number of marks as may indicate, in the judgment of the Civil Service Commissioners, a competent amount of general proficiency.

5. Open Competitive Examinations for the purpose of testing the qualifications of candidates in the above-mentioned subjects will be held by the Civil Service Commissioners from time to time as may be necessary, and a certain number, regulated by the probable demand from the Public Departments, of those who show sufficient proficiency will be placed upon the Registers kept by the Commissioners, and will be available for employment as their services are required. The competitions for the Irish service will, as a rule, be held at the same time as the competitions for service in Great Britain, and the list of successful candidates for Ireland will be separate from that of the success-

ful candidates for service in Great Britain. Candidates can enter for both competitions, when they are held simultaneously, paying only one fee. If successful in both they will be entered on the Register for Great Britain only, or on that for Ireland only, or on both Registers according to their choice.

6. The fee payable for attending an examination will be 5s.

7. Boy Clerks placed on these Registers will be summoned for employment in any of the Public Departments as they are wanted. When not wanted, they will have no claim to employment. Refusing to serve when called upon, except for reasons satisfactory to the Civil Service Commissioners, they will be removed from the Registers. The order in which they may be employed, the Departments to which they may be assigned, and their retention generally on the Registers, will be determined by the Civil Service Commissioners; but they will be subject to the orders of the Departments in which they are serving during the time of their actual employment, and will be liable to dismissal from them by the authorities thereof, without notice, for inefficiency or misconduct.

Boy Clerks resigning, or procuring their own discharges from Departments, except for sufficient reasons proved to the satisfaction of the Civil Service Commissioners, will be removed from the Registers.

Their assignment for service will, as a general rule, be according to their order of merit in the examination; but exceptions to this general rule may be made when the engagement offered is very short, or for other sufficient reasons.

8. Boy Clerks will usually be engaged and paid by the week of 39 hours, viz., 7 hours a day on Mondays, Tuesdays, Wednesdays, Thursdays, and Fridays, and 4 hours on Saturdays; and they will be paid 15s. per week during the first year of their service. After a year of approved service, an increase of pay to 16s. a week may be allowed.

In any case of absence without pay a Boy Clerk's increment shall be postponed one day for every day of such absence—absence without pay equally with the interval between two successive engagements not being reckoned as service for any purpose contemplated by the Regulations.

Boy Clerks may also be engaged and paid by the hour at the rate of 4½d. per hour during their first year of service; and at the rate of 5d. per hour thereafter. Any who may be engaged by the week, and who may be required to attend for more than 7½ hours on Monday, Tuesday, Wednesday, Thursday, or Friday, or more than 4½ hours on Saturday, will be paid at the hourly rate for the overtime attendance in excess of the normal attendance for such day. But in no case must overtime attendance exceed 6 hours in any one week. They may also be paid by the piece at such rates as may be fixed by the Civil Service Commissioners, with the approval of the Lords Commissioners of the Treasury.

9. No service in the capacity of Boy Clerk will confer any claim to superannuation or compensation allowance; and Boy Clerks will not be retained, as such, after they shall have reached the age of 18; subject to the following provisos :—(1) Boy Clerks who have had no opportunity of entering a Competition for Assistant Clerkships after reaching the age of 17½ may be retained until the next Competition takes place, and, pro-

vided they enter the Competition, until the announcement of the result, and for not more than one month afterwards. (2) Boy Clerks who reach the age of 18 after entering a Competition for Assistant Clerkships may be retained until the announcement of the result, and for not more than one month afterwards. (3) A Boy Clerk who has been declared successful in a Competition for Assistant Clerkships may be retained as a Boy Clerk until he is assigned to a vacant post as Assistant Clerk, unless he be rejected by the Civil Service Commissioners as not duly qualified in respect of age, health, or character for the permanent situation.

10. If a public holiday, on which the office is closed, fall within the period of a Boy Clerk's engagement, he may be paid in respect of it as for a working day. Boy Clerks may, with the consent of the Department in which they are serving, or if not at the time serving, with the consent of the Civil Service Commissioners, be allowed holidays, with full pay in the proportion of 12 days a year. No Boy Clerk shall be allowed to take more than 12 days' leave under these conditions, between the 1st day of January and the 31st day of December.

Holiday pay can only be allowed for holidays actually taken, not for days on which the Boy Clerk is drawing pay in respect of employment in any capacity in the Public Service.

11. Boy Clerks who may fall ill while serving in any Department, and whose illness may be attested by medical certificate to the satisfaction of the authorities of such Department, may be allowed sick-leave at the full rate of pay for the official day, provided that no Boy Clerk shall be paid for sick-leave for more than 36 days within any one year, exclusive of public holidays.

12. Except in conformity with Regulations 10, 11, 14, and 15, Boy Clerks will only receive pay for the hours, or parts of hours, during which they actually attend.

13. Persons who have entered upon or completed a course of education or training for the occupation of teacher, on account of which grants are payable from the Exchequer, are not eligible for employment as Boy Clerks until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

14. If any case of infectious disease should occur in the house where a Boy Clerk is living, he must immediately report the fact to the Officer under whom he is employed, and must, if required, at once discontinue his attendance. In cases of such enforced absence from his employment, it is in the discretion of the Head of the Department in which he has been serving to allow the Boy Clerk full pay at the usual rate for the period for which it is medically certified that his attendance at the office would be likely to be dangerous to his colleagues.

15. In any year in which the Open Competition for situations as Assistant Clerk (Abstractor Class) in the Civil Service, for situations as Officer of Customs and Excise, for situations as Established Clerk to Surveyors of Taxes, or for Clerkships of the Second Division, is held, a Boy Clerk who obtains from the Head of the Depart-

ment in which he is serving leave of absence to attend such Examination, may also, at the discretion of the Head of the Department, be allowed pay, at the usual rate, for the days during which he is attending the Examination.

16. Service Marks for each full period of three calendar months of actual approved service in the capacity of Boy Clerk, subject to a maximum of eight such periods, will be allowed to Candidates attending Examinations for the situations of—

Clerk in the Second Division of the Civil Service,

Officer of Customs and Excise,

who are serving or have served as Boy Clerks, provided they shall have rendered not less than six months' approved service in that capacity; but the number of marks to be allowed for each period may be different at successive Examinations.

17. In the promotions of permanent Civil Servants [Assistant Clerks (Abstractor Class) and others] under clause 45 of the Order in Council of 10th January 1910, not less than one year's and not more than two years' approved service as Boy Clerk may be allowed to reckon towards the six years' established service required by the said clause.
