PRESENT:

The KING's Most Excellent Majesty in Council.

WHEREAS by an Order in Council, dated the twenty-eighth day of November ninteeen hundred and fourteen, His Majesty was pleased to make regulations (called the "Defence of the Realm (Consolidation) Regulations, 1914"), under the Defence of the Realm Consolidation Act, 1914, for securing the public safety and the defence of the realm:

And whereas the said Act has been amended by the Defence of the Realm (Amendment) Act, 1915, the Defence of the Realm (Amendment) (No. 2) Act, 1915, and the Munitions of War Act, 1915:

And whereas the said regulations have been amended by various subsequent Orders in Council

And whereas it is expedient further to amend the said regulations in manner hereinafter appearing:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following amendments be made in the said regulations:—

- 1. In Regulation 9E, after the words, "the Army Council may" there shall be inserted the words "by order."
- 2. After Regulation 9r the following regulation shall be inserted:—

- 96.—(1) Where the Board of Trade are of opinion that, for securing the public safety and the defence of the realm, it is expedient that this regulation should be applied to any coal mines, the Board may by order apply this regulation, subject to any exceptions for which provision may be made in the order, either generally to all coal mines or to coal mines in any special area or in any special coalfields or to any special coal mines.
- (2) Any coal mines to which this regulation is so applied shall, by virtue of the order, pass into the possession of the Board of Trade as from the date of the order, or from any later date mentioned in the order; and the owner, agent, and manager of every such mine, and every officer thereof, and where the owner of the mine is a company every director of the company, shall comply with the directions of the Board of Trade as to the management and user of the mine, and if he fails to do so he shall be guilty of a summary offence against these regulations.
- (3) It is hereby declared that the possession by the Board of Trade under this regulation of any coal mine shall not affect any liability of the actual owner, agent, or manager of the mine under the Coal Mines Act, 1911, or any Act amending the same.
- (4) Any order of the Board of Trade under this regulation may be revoked or varied as occasion requires.
- 3. In Regulation 39A, for the opening words down to and including the words "requisitioned

by the Army Council" the following words shall be substituted:—

"If a person lawfully engaged to serve on board any ship or vessel belonging to or chartered, hired, or requisitioned by the Admiralty or Army Council."

At the end of the same regulation the following words shall be inserted:—

"and for the purposes of this regulation a copy of any entry made in an official log book in manner provided by the Merchant Shipping Act, 1894, shall, if it purports to be signed and certified as a true copy or extract by the officer in whose custody the original log book is entrusted, be admissible in evidence."

'The KING's Most Excellent Majesty in Council.

HEREAS there was this day read at the Boarda Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 21st day of November 1916, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas by Order in Council, bearing date the 6th February 1892, it is provided that payment of 6d. a day may be made to a Royal Marine employed on printing duties at each of the Royal Marine Divisions, and the Depôt:

"And whereas we are of opinion that the quantity of Printing now requiring to be done warrants the employment of two men at each Division, at a higher rate of pay than that now allowed:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the employment at each of the Royal Marine Divisions, and at the Depôt, of one Royal Marine as Printer, and one as Assistant Printer, with pay at Regimental rates, together with an allowance of £16 and £12 per annum respectively, as is now paid to men acting as Printer and Assistant Printer in Your Majesty's Navy, with effect as from the 21st September 1916.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

The KING was pleased, on Saturday, the 25th instant, at Buckingham Palace, to present to Lieutenant Henry Joseph Higgs, Royal Engineers, the Albert Medal of the First Class, which had been conferred upon him by His Majesty for gallantry in saving life, as detailed below:—

At Newark, on the 17th February last, whilst instruction in the use of bombs was being given to a class of non-commissioned officers and men who were standing round, two members of the class, after lighting the fuzes, dropped their bombs, through nervousness. Lieutenant Higgs picked up the bombs, the fuzes being more than half burned at the time, and threw them over the parapet. The bombs exploded when just clear of the parapet.

On the 11th April last, an officers' class was being practised in the throwing of live grenades from behind a breast work. One officer, when throwing a grenade, struck his arm against another officer, who was standing too close to him, so that the grenade was jerked out of his hand and fell between the class (numbering 30 officers) and the breastwork. Lieutenant Higgs dashed forward, seized the bomb, and threw it over the breastwork; it exploded in the air in front of the breastwork.

In addition, on several other occasions, ten or twelve in all, men when being practised in throwing the live grenades have dropped them, through nervousness, and Lieutenant Higgs has picked them up and thrown them over the parapet, thus avoiding serious accidents.

THE MOTOR CARS REGULATION (CITY OF DUNDER) (REVOCATION) ORDER, 1915, dated November 14, 1916.

In pursuance of the powers vested in me in that behalf, I, the Right Honourable Harold John Tennant, His Majesty's Secretary for Scotland, on the application of the Town Council of the City of Dundee, do hereby revoke the Motor Cars Regulation (Burgh of Broughty Ferry) Order, 1908.

This Order may be cited as the Motor Cars Regulation (City of Dundee) (Revocation) Order, 1916.

DEFENCE OF THE REALM (LIQUOR CONTROL).

ORDER OF THE CENTRAL CONTROL BOARD LIQUOR TRAFFIC) FOR THE ORKNEY AND SHETLAND AREA.

Any person contravening the provisions of this Order or of the Liquor Control Regulations is

liable to imprisonment for six months with hard labour and a fine of £100.

We, the Central Control Board (Liquor Traffic) in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm, hereby make the following Order:—

Limits of Area.

1. The area to which this Order applies is the Orkney and Shetland Area, being the area comprising the Counties of Orkney and Zetland (including all Burghs within the geographical limits thereof) and all arms of the sea and waters between the said Counties, and between the Islands forming part of the said Counties, and between the said Counties and the Mainland.

Hours during which Exciseable Liquor (other than Spirits) may be sold.

2. The days and hours on and during which exciseable liquor (other than spirits) may be sold or supplied in any licensed premises or club for consumption on or off the premises shall be restricted and be as follows:—

On Week days :-

The hours between 12 noon and 2.30 p.m. and between 6 p.m. and 8 p.m.

Except on the days and between the hours

aforesaid no person shall-

(a) Either by himself or by any servant or agent sell or supply to any person in any licensed premises or club or (except as hereinafter expressly provided) dispatch therefrom any such exciseable liquor to be consumed either on or off the premises; or

(b) Consume in or take from any such premises or club any such exciseable liquor; or

(c) Permit any person to consume in or take from any such premises or club any such exciseable liquor.

Sale of Spirits prohibited.

3. No person shall either by himself or by any servant or agent sell or supply to any person in any licensed premises or club or dispatch therefrom any spirits to be consumed either on or off the premises, or purchase or consume in or take from any such premises or club or permit any person to consume in or take from any such premises or club any spirts.

Hours of Opening for the Supply of Food and Non-exciseable Liquor.

- 4. (a) Notwithstanding any provisions of this Order or of the law relating to licensing or the sale of exciseable liquors, licensed premises may be kept open for the supply of commodities other than exciseable liquor at any time during which they may be kept open for that purpose under the Licensing (Scotland) Acts, 1903 to 1913; and
- (b) Licensed premises may be opened for that purpose at the hour of 5.30 in the morning.

Saving Provisions.

5. (a) The sale or supply of exciseable liquor (including spirits) on an order stating why such liquor is required and signed by an officer of police, procurator-fiscal, or medical official, or, in cases where spirits are immediately required.

for medicinal purposes, by any duly qualified medical practitioner, police constable, magistrate or minister of religion, shall not be deemed to be in contravention of the foregoing provisions, provided that such order be transmitted to the procurator-fiscal in the manner, with the note and within the time required by Section 55 of the Licensing (Scotland) Act, 1903, and the provisions of the said section shall apply to any such order.

(b) Nothing in the foregoing provisions of this Order shall be deemed to prohibit where

the same is otherwise lawful-

(i) The consumption of exciseable liquor (other than spirits) by any person in any licensed premises or club where

he is residing; or

(ii) The consumption of exciseable liquor (other than spirits) at a meal by any person in any licensed premises or club at any time within half an hour after the conclusion of the afternoon and evening hours during which the sale or supply of such exciseable liquor is permitted by this Order: Provided that the liquor was sold or supplied and served during such hours and at the same time as the meal and for consumption at the meal; or

(iii) The dispatch from licensed premises for delivery at a place more than five miles distant of exciseable liquor (other than spirits) in the forenoon of any day on which the sale of the same is permitted by Article 2 of this Order.

Treating Prohibited.

6. No person shall either by himself or by any servant or agent sell or supply any exciseable liquor to any person in any licensed premises or in any club for consumption on the premises unless the same is ordered and paid for by the person so supplied; nor shall any person order or pay for or lend or advance money to pay for any exciseable liquor wherewith any other person has been or is to be supplied for consumption on the premises; nor shall any person consume in any licensed premises or club any exciseable liquor which any other person has ordered or paid for or agreed to pay for or lent or advanced money to pay for.

Provided always that if such exciseable liquor is supplied or served for consumption at a meal supplied at the same time and is consumed at such meal the provisions of this article shall not be deemed to be contravened if the person who pays for such meal also pays for such

exciseable liquor.

For the purposes of this Article consumption on the premises includes consumption of exciseable liquor in or on any highway, open ground or railway station adjoining or near to the licensed premises or club in which the liquor was sold or supplied; and any person consuming exciseable liquor in or on any such highway, open ground or railway station shall be deemed to consume the liquor in such licensed premises or club as the case may be.

Credit Prohibited.

- 7. No person shall-
 - (1) (a) Either by himself or by any servant

or agent sell or supply in any licensed premises or club or dispatch therefrom any exciseable liquor to be consumed either on or off the premises; or

(b) Consume any exciseable liquor in or take it from such premises or club; unless it is paid for before or at the time when it is supplied or dispatched or taken away.

Provided always that if the liquor is sold or supplied for consumption at a meal supplied at the same time and is consumed at such meal this article shall not be deemed to be contravened if the price of the liquor is paid together with the price of such meal and before the person partaking thereof quits the premises:

(2) Introduce or cause to be introduced into the area any exciseable liquor unless it is paid for

before it is so introduced.

Long Pull Prohibited.

8. No person shall either by himself or by any servant or agent sell or supply to any person in any licensed premises or club as the measure of exciseable liquor for which he asks an amount exceeding that measure.

Provisions as to Passenger Steamers.

9. The foregoing provisions of this Order relating to the sale or supply of exciseable liquor (including the prohibition of the sale or supply of spirits) in licensed premises shall apply to all passenger steamers in which exciscable liquor is sold or supplied while actually within the area.

Canvassing Prohibited.

10. No person shall either by himself or by any servant or agent—

(a) Solicit or canvass for orders for or collect or receive payment for, exciseable liquor except at the licensed premises, or send, cause to be sent or leave or cause to be left to or at any premises, or to or with any person any order form for exciseable liquor:

(b) Cause or permit any payment for exciseable liquor to be made on his behalf by any person in the service or employment of the vendor of the liquor, or, being a person in such service or employment, make any such payment as the agent or on behalf of the

purchaser of the liquor.

Explanatory Provisions.

11. (a) Nothing in this Order authorises any licensed premises to be kept open for the sale of exciseable liquor except during the hours permitted under the general provisions of the

Licensing Acts.

(b) The prohibition under this Order of the sale and consumption of exciseable liquor except on and during certain days and hours and otherwise is not subject to the exceptions provided for in the Licensing Acts with respect to travellers and the supply of exciseable liquor at railway stations or to any other provisions in those Acts enabling exciseable liquor to be supplied during closing hours in special cases.

(c) The expression "licensed premises" includes any premises or place where the sale of exciseable liquor is carried on under a

licence.

(d) This Order does not affect the sale or and Men.

dispatch of exciseable liquor to a trader for the purposes of his trade or to a registered club for the purposes of the club.

(e) This Order does not affect the sale or supply of exciseable liquor to or in any canteen where the sale of exciseable liquor is carried on under the authority of a Secretary of State or of the Anmiralty.

Exhibition of Order.

12. The secretary of every club to which this Order applies and every holder of a licence for the sale of exciseable liquor shall keep permanently affixed in some conspicuous place in the club or in such public room in the licensed premises a copy of this Order and any notice required by the Board to be affixed.

Commencement of Order.

13. This Order shall come into force on the eleventh day of December 1916.

His Majesty the King has been graciously pleased to confer the Victoria Cross on the undermentioned Officers, Non-commissioned Officers, and Men.

Lieutenant (temporary Lieutenant-Colonel) Roland Boys Bradford, M.C., Durham Light

For most conspicuous bravery and good leadership in attack, whereby he saved the situation on the right flank of his Brigade and of the Division.

Lieutenant - Colonel Bradford's Battalion was in support. A leading Battalion having suffered very severe casualties, and the Commander wounded, its flank became dangerously exposed at close quarters to the enemy. Raked by machine-gun fire, the situation of the Battalion was critical. At the request of the wounded Commander, Lieutenant-Colonel Bradford asked permission to command the exposed Battalion in addition to his

Permission granted, he at once proce ded to the foremost lines.

By his fearless energy under fire of all description, and his skilful leadership of the two Battalions, regardless of all danger, he succeeded in rallying the attack, captured and defended the objective, and so secured the flank.

Temporary Second Lieutenant Tom Edwin Adlam, Bedfordshire Regiment.

For most conspicuous bravery during operations.

A portion of a village which had defied capture on the previous day had to be captured at all costs to permit subsequent operations to develop.

This minor operation came under very

heavy machine gun and rifle fire.

Second Lieutenant Adlam realising that time was all important, rushed from shell hole to shell hole under heavy fire collecting men for a sudden rush, and for this purpose also collected many enemy grenades. At this stage he was wounded in the leg, but nevertheless he was able to outthrow the enemy, and then seizing his opportunity, and in spite of his wound, he led a rush, captured the position and killed the occupants. Throughout the day he continued to lead his men in bombing attacks.

On the following day he again displayed courage of the highest order, and though again wounded and unable to throw bombs, he continued to lead his men.

His magnificent example and valour, coupled with the skilful handling of the situation, produced far-reaching results.

Temporary Second Lieutenant Henry Kelly, West Riding Regiment.

For most conspicuous bravery in attack.

He twice rallied his Company under the heaviest fire, and finally led the only three available men into the enemy trench, and there remained bombing until two of them had become casualties and enemy reinforcements had arrived.

He then carried his Company Serjeant-Major, who had been wounded, back to our trenches, a distance of 70 yards, and subsequently three other soldiers.

He set a fine example of gallantry and endurance.

No. 11213 Serjeant Robert Downie, Royal Dublin Fusiliers.

For most conspicuous bravery and devotion to duty in attack.

When most of the officers had become casualties, this Non-Commissioned Officer, utterly regardless of personal danger, moved about under heavy fire and reorganised the attack, which had been temporarily checked. At the critical moment he rushed forward alone, shouting, "Come on the Dubs."

This stirring appeal met with immediate response, and the line rushed forward at his

call.

Serjeant Downie accounted for several of the enemy, and in addition captured a machine gun, killing the team. Though wounded early in the fight, he remained with his company, and gave valuable assistance whilst the position was being consolidated.

It was owing to Serjeant Downie's courage and initiative that this important position, which had resisted four or five previous attacks, was won.

No. 15888 Serjeant James Young Turnbull, late Highland Light Infantry.

For most conspicuous bravery and devotion to duty, when, having with his party captured a post apparently of great importance to the enemy, he was subjected to severe counterattacks, which were continuous throughout the whole day. Although his party was wiped out and replaced several times during the day, Serjeant Turnbull never wavered in his determination to hold the post, the loss of which would have been very serious. single-handed, he maintained his position, and displayed the highest degree of valour and skill in the performance of his duties.

Later in the day this very gallant soldier was killed whilst bombing a counter-attack from the parados of our trench.

No. 2442 Private Frederick Jeremiah Edwards, Middlesex Regiment.

For most conspicuous bravery and resource. His part of the line was held up by machinegun fire, and all officers had become casualties. There was confusion and indication of retirement.

Private Edwards, grasping the situation, on his own initiative dashed out alone towards the gun, which he knocked out with bombs.

This very gallant act, coupled with great presence of mind and a total disregard of personal danger, made further advance possible and cleared up a dangerous situation.

No. 3281 Private Robert Ryder, Middlesex Regiment.

For most conspicuous bravery and initiation during an attack.

His company was held up by heavy rifle fire, and all his officers had become casualties. For want of leadership the attack was flagging.

Private Ryder, realising the situation, without a moment's thought for his own safety dashed absolutely alone at the enemy trench, and, by skilful manipulation of his Lewis gun, succeeded in clearing the trench. This very gallant act not only made possible, but also greatly inspired the subsequent advance of his comrades, and turned possible failure into success.

His Majesty the KING has been graciously pleased to confer the undermentioned awards for gallantry and distinguished service in the Field:—

Distinguished Service Order.

Capt. (temp. Maj.) George Lewis Baxter, Cam'n Highrs.

For gallantry and ability when in command of part of the force which was attacked by far superior numbers. Major Baxter showed great ability in the handling of his force, and repulsed the enemy with considerable losses. He showed great coolness, and rendered valuable assistance in bringing in a wounded officer under heavy rifle and machine-gun fire.

Military Cross.

Temp. 2nd Lt. Edward Kerr Borthwick, King's African Rifles.

For gallantry and determination when in command of a machine-gun engaged in thick bush fighting.

An enemy gun was brought 25 yards in rear of him, but he switched on his gun, killing four of the team and capturing the gun.

He later gave excellent supporting fire to our advance.

Royal Red Cross, 2nd Class.

Miss Margery Gertrude Burn, Nursing Staff, Universities' Mission.

Distinguished Conduct Medal.

No. 18 Rfn. H. Cairnduff, S. African Rif.

For gallantry in action. When his troop was ordered to retire from a position enfiladed by machine-gun fire, he returned and brought in two wounded men.

No. 3081 Cpl. M. C. Henry, S. African Mtd. Rif.

For gallantry and devotion to duty. Although severely wounded he helped a comrade away under heavy shell fire which had hit all his detachment.

No. 105 Rfn. J. E. Thomas, South African Rif. ,

For gallantry in bringing the Medical Officer to the firing line under heavy fire at close range, and under similar conditions assisting to bring in a wounded comrade.

No. 108 Rfn. A. A. Vial, S. African Rif.

For gallantry and devotion to duty in assisting Major Baxter to bring in a wounded officer under heavy rifle and machine-gun fire.
