# PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 14th day of December 1916, in the words following, viz. :--

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be

paid in such manner, and subject to such restrictions, conditions, and provisions; as are from time to time directed by Order in Council:

"And whereas we consider that certain changes should be made in the Regulations governing the conditions of service of Officers of Your Majesty's Fleet employed on Transport Duties :

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the establishment of a Royal Naval Transport Service, under the Regulations set forth in the annexed Schedule, with effect as from the 1st December 1916.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.

(c) The bonus of 25 per cent. to Emergency Officers, which is to be assessed on the same basis, but payment is to be in accordance with the special rules for Emergency Officers.

3. The consolidated rates to be subject to the usual deduction for commuted retired pay and for gratuity on discharge from Active List.

4. The above rates of pay not to apply to Engineer Officers, Accountant Officers, Chief

#### I. MARKS.

1. The marks shall be expressed by percentages.

2. The sequence of the parts of the Examination shall be (1) Written and (2) Oral and Practical.

3. The available marks in each part of the Examination shall be 100. Thus :---

To pass the Examination, Candidates must obtain not less than 50 per cent. in the Oral and Practical, and an average of not less than 50 per cent. in the conjoined Written and Oral parts.

4. Any mark below 50 in any department of the Examination must represent the concurrent judgment of two Examiners.

5. Candidates who are unsuccessful, can in no case be re-examined before the next Examination period.

# II. WRITTEN EXAMINATIONS.

1. The questions for the Written Examinations shall be prepared about one month previous to each Examination period in such manner as the Board may from time to time determine.

2. The paper shall consist of Six Questions. The time to be allowed therefor shall be three hours.

3. One Examiner shall be summoned to superintend. The Candidates shall be arranged

at the tables in alphabetical or other definite order. The Examiner shall occupy himself in observing the conduct of the Candidates until the time for which he has been summoned has fully expired.

4. At the scrutiny the written papers shall be read and signed by one Examiner, who shall indicate in figures thereon the value he attaches to the paper, but in the case of papers awarded less than 50 per cent., these will fall to be read also by a co-Examiner. The marks awarded must, in the latter case, represent the concurrent judgment of the two Examiners as indicated by their signatures.

*Note.*—It is desirable that not more than twenty-five papers shall be read by each Examiner during a two hours' sitting.

III. ORAL AND PRACTICAL EXAMINATION.

1. At the Oral and Practical Examination twenty minutes shall be allowed for the examination and adjudication of each Candidate.

2. At the Oral and Practical Examination two Examiners shall sit at each table, and each shall act alternately as Examiner and as Assessor. The Assessor shall note upon the space allotted to the Oral part on the Candidate's Written Book, the various subjects on which the Candidate is being examined; and the two Examiners shall together determine the numerical value of the Examination.

Note.—The Examiner who scutinises the written paper shall so far as possible in each case act as Assessor in the Oral Examination of that Candidate.

#### IV. EXAMINERS.

1. An Examiner summoned to superintend a Written Examination shall remain for the full period for which he was summoned; and if summoned for scrutiny or Oral, he is under obligation to remain, if required, until the adjudication on that part.

2. An Examiner unable to attend any part of an Examination for which he has been summoned shall provide another Examiner of the Board to fill his place, and in the event of failure on the part of an Examiner to observe this rule, such Examiner shall forfeit his right to be summoned at his next turn.

3. In case of the absence of an Examiner, the fee shall be paid to the Examiner who acts for him.

4. The fees payable to Examiners shall be at the rate of  $\pounds 1$ , 1s. per hour, with a minimum payment of  $\pounds 2$ , 2s., payable only at the completion of the Examination when the results have been recorded and reported to the Secretary at the Office of the Board.

In the case of Examiners summoned to examine at a different centre, there shall be payable, in addition, first-class travelling expenses and subsistence allowance at the rate of £1 a night (to cover 24 hours' absence), and 6s. 8d. for absences during the day exceeding 10 hours, or such other scale of expenses as may be approved from time to time by the Privy Council.

  - 3 p.m.-5 p.m.-SCRUTINY OF PAPERS. Not more than 25 papers shall be read by each Examiner at a sitting of two hours.
- Second Day.—10 a.m.—1 p.m.—ORAL AND PRACTICAL. Twenty minutes shall be allowed for the Examination of each Candidate. Nine Candidates shall be allocated to each table for every three hours.
  - Two Examiners shall sit at each table. The Examiner who has read the Candidate's paper shall so far as possible act as Assessor in each case.
  - E.g., if Examiner A has scrutinised papers of Candidates Nos. 1 to 25 and B has scrutinised 26 to 50—A will act as Assessor (with B as Examiner) when examining Candidates 1 to 25 and B will act as Assessor (with A as Examiner) when examining Candidates 26 to 50.

Any other method, provided it carries out the same principle, may be adopted.

# EDINBURGH AND DISTRICT WATER ORDER, 1914.

WHEREAS by the Special Acts (Extension of Time Act, 1915, it is provided, *inter alia*, that where the time within which a power may be exercised under any Special Act is limited, an application may be made by the person by whom such power may be exercised to the appropriate Government Department for an Order extending that time, and that the Department, if satisfied that the time should be extended, may make an Order accordingly: And whereas under Part II. of the Edinburgh

And whereas under Part II. of the Edinburgh and District Water Order, 1914, the Edinburgh and District Water Trustees (hereinafter called "the Trustees") were empowered compulsorily to acquire certain lands, for the purposes therein mentioned, and by Section 13 of that Order the time within which the said power of compulsory acquisition may be exercised is limited to a period which will expire on the 10th day of August 1917:

And whereas the Trustees have in terms of the Special Acts (Extension of Time) Act, 1915, applied to the Secretary for Scotland for an Order extending the said time as hereinafter prescribed:

And whereas I am satisfied that the time in respect of which the application is made should be extended as hereinafter prescribed.

Now therefore, in pursuance of the powers vested in me by the last-mentioned Act, I, the Right Honourable Robert Munro, His Majesty's Secretary for Scotland, hereby order as follows :---

1. The time within which the powers of the Trustees for the compulsory purchase of lands under the provisions of Part II. of the Edinburgh and District Water Order, 1914, in so far as that power extends to lands required for Works Nos. 6, 7, 8, 13, 14, 15 and 16 described in Section 8 of that Order, may be exercised is hereby extended for a period of one year, that is to say, until the 10th day of August 1918.

2. This Order may be cited as the Edinburgh and District Water Order, 1914 (Extension of Time) Order, 1916.

# ARMY COUNCIL ORDER.

#### COLONIAL WOOL.

In pursuance of the powers conferred upon them by Defence of the Realm (Consolidation) Regulations, 1914, the Army Council do hereby order that all persons engaged in the purchase or sale of Colonial Wool shall comply with the following Regulations, that is to say :---

1. No wool of the 1916-17 clip consigned to the United Kingdom from Australia or New Zealand on growers' account shall be sold or offered for sale otherwise than to the Director of Army Contracts or to persons authorised in his behalf.

2. All persons who have or may have in their custody or control any stocks of wool of the description aforesaid are hereby required to forward to the Director of Army Contracts, Raw Material Section, Imperial House, Tothill. Street, Westminster, S.W., particulars of all such consignments immediately upon their arrival in the United Kingdom, and all such further particulars as may be required on his behalf, and to sell such wool as may be required by or on behalf of the Director of Army Contracts, on the terms and subject to the conditions on and subject to which the sale thereof is authorised by this Order.

\* Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

(3) The landing of any animals under this Order must be authorised by the Superintendent or person in charge of the landing place.

(4) Animals so landed shall be subject to the provisions of the Animals (Landing from Ireland) Consolidation and Amendment Order of 1914, except that the animals shall not be moved from the landing place, and shall be slaughtered therein within ninety-six hours after their landing.

#### Special Provision as to Animals Destined for Manchester Irish Animals' Landing Place.

2. Animals, if intended to be landed at the anchester Irish Animals' Landing Place Manchester under this Order, shall not be carried through the Eastham lock until they have been examined by a Veterinary Inspector of the Board, and unless and until the Inspector certifies that his examination and information do not show that there is, or during the voyage has been, an animal on board affected with Foot-and-Mouth Disease.

#### Local Authority to Enforce Order.

3. The provisions of this Order shall be executed and enforced by the Local Authority.

#### Offences.

4. If any animal shall be landed or moved in contravention of this Order, or is not slaughtered as hereby required, the owner thereof and the owner and the lessee and the occupier of the place of landing, and the person causing, directing, or permitting the landing or movement, and the owner and person in charge of the animal which is not so slaughtered, and the owner and the charterer, and the master of the vessel from which the same is landed, as the case may be, shall, each according to and in respect of his own acts or defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.


