By the Lords of His Majesty's Most Honourable Privy Council.

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State, such List as so varied or added to being in the last mentioned Proclamation referred to as the "Statutory List":

And whereas the List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of

State for Foreign Affairs to the following effect:—

That the "Statutory List" of persons and bodies of persons, incorporated or unincorporated, with whom trading is prohibited, should be further varied in respect of the name set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

ISSUE OF TREASURY BILLS.

UNDER THE TREASURY BILLS ACT, 1877, THE NATIONAL DEBT ACT, 1889, AND THE WAR LOAN ACTS, 1914 TO 1916.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that, from time to time until further notice, Tenders will be received at the Chief Cashier's Office, Bank of England, for Treasury Bills to be issued under the above-mentioned Acts.

2. The Bills will be in amounts of £1000, £5000, or £10,000, and will be drawn for three, six, or twelve months from the date on which the relative payment is due.

3. The Bills will be issued and paid at the Bank of England.

4. In any week in which Bills are to be offered for Tender the amount of Bills to be so offered will be announced in the London Gazette on Monday in such week, and Tenders for the Bills must be lodged before one o'clock on the succeeding Friday.

5. The Tenders must specify the currency of the Bills required and the net amount per cent. which will be given for the amounts applied for. *The Tenders of private individuals must be made through a London Banker.*

6. The persons whose Tenders are accepted will be informed of the same forthwith, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England, *by means of cash or Banker's Draft on the Bank of England*, not later than two o'clock on the Tuesday next succeeding the date of tender.

7. In virtue of the provisions of section 26 of the Finance Act, 1915, Members of the House of Commons are not precluded from tendering for these Bills.

8. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

ORDER.

The Minister of Munitions, in exercise of the powers conferred upon him by the Defence of the Realm (Consolidation) Act, 1914, the Defence of the Realm (Amendment) No. 2 Act, 1915, the Defence of the Realm Regulations, the Munitions of War Acts, 1915 and 1916, and all other powers thereunto enabling him, hereby orders that all persons shall comply with the following Regulations:—

Manufacture.

(1) No person shall manufacture any electric lamp glass unless the purpose for which such glass is required has been approved. Such

approval must be evidenced by one or other of the following, which must be quoted by the ordering firm to the manufacturer, together with the purpose for which the glass is required:—

- (a) Reference to and number of an Admiralty, War Office or Ministry of Munitions contract for which the glass is necessary; or
- (b) A certificate authorising the supply issued on behalf of the Minister of Munitions by the Director of Optical Munitions and Glassware Supply.

(2) Manufacturers of Electric Lamp Glass are required to render to the Director of Optical Munitions and Glassware Supply at regular intervals full and accurate returns of their manufacture and output of electric lamp glass in accordance with the directions from time to time given by the said Director.

Purchase and Sale Outside the United Kingdom.

(3) No person shall buy, sell or deal in any electric lamp glass situated or to be manufactured outside the United Kingdom unless a certificate authorising such purchase, sale or dealing has been issued on behalf of the Minister of Munitions by the Director of Optical Munitions and Glassware Supply.

Definition Clause.

(4) For the purpose of this Order Electric Lamp Glass shall include all glass intended for use in the manufacture of electric lamps except glass used or intended for use in lamp caps for insulating purposes, but shall not include glass shades and similar accessories.

(5) All applications in reference to the above Order should be made to the Director of Optical Munitions and Glassware Supply, Ministry of Munitions of War, 117 Piccadilly, W. 1.

ORDER.

SPELTER.

The Minister of Munitions, in exercise of the powers conferred upon him by the Defence of the Realm (Consolidation) Act, 1914, the Defence of the Realm (Amendment) No. 2 Act, 1915, the Defence of the Realm Regulations, the Munitions of War Acts, 1915 and 1916, and all other powers thereunto enabling him, hereby orders as follows:—

1. No person shall, as from the date hereof until further notice, purchase, sell, or, except for the purpose of carrying out a contract in writing existing prior to such date for the sale or purchase of spelter, enter into any transaction or negotiation in relation to the sale or purchase of spelter situated outside the United Kingdom except under and in accordance with the terms of a license issued under the authority of the Minister of Munitions.

2. No person shall, as from the date hereof until further notice, purchase or take delivery of any spelter situated in the United Kingdom except under and in accordance with the terms of a licence issued under the authority of the

Minister of Munitions, or sell, supply or deliver any such spelter to any person other than the holder of such a licence and in accordance with the terms thereof; provided that no such licence shall be required in the case of any sale, purchase or delivery of such spelter for the purpose of necessary repairs or renewals involving the use of not exceeding 1 cwt. of such spelter.

3. No person shall, as from the date hereof until further notice, except under and in accordance with the terms of a licence issued under the authority of the Minister of Munitions, use any spelter for the purpose of any manufacture or work except:—

(a) For the purpose of a contract or order for the time being in existence certified to be within Class "A" in the order of the Minister of Munitions as to priority dated the 8th March 1917, and made in substitution for Circular L. 33.

(b) For the purpose of necessary repairs or renewals involving the use of not exceeding 1 cwt. of spelter.

4. All persons shall, in the first seven days of each month, commencing with the month of April 1917, send in to the Director of Materials (A.M.2.C.), Ministry of Munitions, Hotel Victoria, London, W.C. 2, monthly returns of:—

(a) All spelter held by them, in stock or otherwise under their control, on the last day of the preceding month, specifying the quality thereof.

(b) All spelter purchased or sold by them for future delivery and not yet delivered on such last day, specifying the names of the sellers to or purchasers from them, and the quantity and quality, and time and place of delivery in each case, and the position of the spelter at the date of the return.

(c) All spelter delivered to them during the preceding month, and from whom purchased.

(d) All contracts or orders existing on the last day of or entered into during the preceding month requiring for their execution the use of spelter, specifying the purposes thereof and the quality of the spelter to be used.

(e) Such other particulars as to spelter as may be required by the Director of Materials.

Notwithstanding the above, no return is required from any person whose total stock of spelter in hand and on order for future delivery to him has not at any time during the preceding month exceeded one ton.

5. For the purpose of this order the expression spelter shall mean spelter of all qualities, and shall include sheet and rolled zinc, scrap zinc, hard spelter, dross, zinc ashes, flux skimmings and zinc dust.

6. All applications for licences should be made to the Director of Materials (A.M.2.C.), Ministry of Munitions, Hotel Victoria, London, W.C. 2, and marked "Spelter Licence."

NOTE.—Every applicant for a licence must state the amount and quality of metal required by him per month, and the use to which it will be put.

Any person acting in contravention of or failing to comply with the above order, or making a false return, will be guilty of an offence under the Defence of the Realm Regulations, and be liable to penalties of fine and imprisonment.

DEFENCE OF THE REALM (LIQUOR CONTROL).

ORDER (FURTHER AMENDMENT) OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) FOR THE SCOTLAND, NORTHERN, AREA.

We, the Central Control Board (Liquor Traffic), in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm, hereby make the following Order:—

1. In the Burghs of Invergordon and Cromarty, and the Parishes of Kiltearn, AIness, Rosskeen, Kilmuir Easter, Cromarty and Resolis in the County of Ross and Cromarty the hours of 6.30 p.m. and 8.30 p.m. shall be substituted for the hours of 5 p.m. and 7 p.m. in paragraph (e) of Article 2 (1) of the Board's Order for the Scotland, Northern Area made on the seventeenth day of September 1915, and the said paragraph shall in so far as it affects the said Burghs and Parishes be read as amended as aforesaid.

2. The secretary of every club to which this Order applies and every holder of a licence for the sale of excisable liquor in the above mentioned Burghs and Parishes shall keep permanently affixed in the club or in each public room in the licensed premises a copy of this Order.

3. This Order shall come into force on the second day of April 1917.

NAVAL PRIZE BOUNTY MONEY.

*Department of the

Notice is hereby given to all persons interested therein, that preparations are now being made for the intended distribution of the Prize Bounty awarded for the destruction of the German mine-layer "Konigin Luise" on 5th August 1914, the following ships being entitled to share in the Award:— H.M. ships "Amphion," "Lance," "Landrail," "Lark," "Linnet," "Laforey," "Lawford," "Laurel," "Lysander," "Liberty," "Louis," "Lydiard," and "Laertes."

Agents or other persons having any just and legal demand, unliquidated, against the Award are required to transmit the particulars of any such demand to the Registrar of the Admiralty Division of H.M. High Court of Justice, in order that the same may be examined, taxed, and allowed by that Officer, and paid under the sanction of the Judge of the said Court.

Due notice will be given, by future advertisement in the London Gazette, of the date proposed for the commencement of distribution, and at the same time, the amount of an individual's share in the respective classes will be announced.

DEFENCE OF THE REALM REGULATIONS.

In pursuance of the powers conferred upon the Admiralty by Regulation 35A of the Defence of the Realm Regulations, the Lords Commissioners of the Admiralty hereby make the following rules:—

1. *Application.*

These Rules shall apply to every person who is employed or who is in or in the vicinity of any store, wharf, vessel, vehicle, receptacle or other premises or place in or upon which any ammunition or explosive substance or any highly inflammable substance required for the production thereof is handled, carried, stored, or deposited in the course of or for the purpose of transit under Admiralty direction.

The posting of these Rules conspicuously in or upon any such premises or place as aforesaid shall be deemed to be notice of their contents to all persons employed or being therein or in the vicinity thereof.

2. *Smoking, Tobacco, Matches, Lights, &c.*

No person while he is employed or is in or in the vicinity of any such store, wharf, vessel, vehicle, receptacle, premises or place, as aforesaid, shall either smoke or have in his possession any match or apparatus of any kind for producing a light or any tobacco, cigar, cigarette, pipe or contrivance for smoking, except as may be expressly sanctioned by an officer in the employ of the Admiralty or by some person authorised by him.

3. *Searching.*

Any Police Constable or anyone authorised by an Officer as aforesaid may search at any time any person entering or being in any such store, wharf, vessel, vehicle, receptacle, premises or place as aforesaid, and may examine any such person's clothing and any bag, basket, parcel or other article he may be carrying; and any such person shall if so required by any Police Constable or by anyone authorised as aforesaid, submit to be searched, and shall comply with any reasonable directions or regulations given or made with the object of enabling the search to be carried out. Provided that in no case shall any female person be searched by or in the presence of anyone but a female person.

4. *Intoxication.*

No person in a state of intoxication shall enter or remain in or in the vicinity of any such store, wharf, vessel, vehicle, receptacle, premises or place as aforesaid.

Any person failing to comply with the above Rules will be guilty of an offence against the Defence of the Realm (Consolidation) Regulations and liable on summary conviction to imprisonment with or without hard labour for a period not exceeding six months or to a fine not exceeding £100 or both.
