THE KING has been pleased, by Warrant under His Majesty's Royal Sign Manual, bearing date the 5th instant, to direct Letters Patent to be passed under the Seal appointed by the Treaty of Union to be kept and made use of in place of the Great Seal of Scotland, appointing His Grace The Duke of Montrose, K.T., to be His Majesty's High Commissioner to the General Assembly of the Church of Scotland, which is to meet on the 22nd instant.

HEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 24th day of April 1917, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted inter alia, that all pay pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer,

Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas we have had under consideration the Regulations governing the entry and payment of Engine Room Artificers in Your Majesty's Naval Reserve:

"And whereas we consider it to be desirable that an opportunity for advancement to the Rating of Chief Engine Room Artificer should be granted to Men entered as Engine Room Artificers in the Royal Naval Reserve:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the establishment, as from the 30th June 1915, of the Rating of Chief Engine Room Artificer, Royal Naval Reserve, ranking with, but after, the Rating of Chief Engine Room Artificer, 2nd Class, Royal Navy, with pay at the rate of 6s. 4d. per diem.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 27th day of April 1917, in the words following, viz. :-

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, wages, pensions, bounty money, grants, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being, or having been, an Officer, Seaman, or Marine, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas we consider that it would be to the benefit of Your Majesty's Naval Service that Mercantile Ratings belonging to Your Majesty's Ships in commission should be subject within certain limits to forfeiture of pay for misconduct:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to direct that in the event of any Mercantile Rating belonging to any of Your Majesty's Ships in commission misconducting himself, whether such ship is the property of Your Majesty or not, the pay which he shall receive may be reduced to the following extent and no further, namely, not more than 30 days' pay in respect of any one or more offences punished at any one time, the word 'pay' for this purpose being understood to include full pay and full pay allowances whether already accrued or not: Provided that mulcts of pay not authorised for Naval Ratings shall not be imposed in the case of Mercantile Ratings unless it is impracticable to inflict the appropriate naval penalty.'

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.
