#### PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 30th day of June 1917, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being, or having been, an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

by Order in Council:

"And whereas under existing Regulations the pensions payable to Warrant Officers, Class 2, and Non-commissioned Officers of the Royal Marines are restricted by maximum rates fixed with reference to the normal period of service of 21 years."

"And whereas in the present emergency a large number of such Warrant Officers and Non-commissioned Officers are being retained for further service beyond the completion of the term of 21 years under the provisions of the Royal Marine Acts of 1914 and 1916, Cap. 16, 5 George V., and Cap. 23, 6 and 7 George V.:

"And whereas the existence of the maximum rates will, in many cases, preclude such Warrant Officers and Non-commissioned Officers from

obtaining any increase of pension in respect of such additional service:

"And whereas we consider it desirable that the maximum rates should be increased to enable additional time served in consequence of the present War, amounting to at least one year, to carry with it the benefit of increase of pension:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the following increases in the existing maxima as shown in Article 1198 of the King's Regulations and Admiralty Instructions, such increases to be applicable to all cases in which the period of 21 years' service has been completed since the 4th August 1914, and in which the total service is at least 22 years:—

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect:—

That the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

Note (1). - All persons or firms resident, carrying on business, or being in the United Kingdom are prohibited from having with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3, any dealings other than such as are expressly authorised by Paragraph 5 of the Proclamation. A List consolidating all previous Lists was published on the 22nd June 1917 (The Consolidating List No. 29a), which together with the List herewith annexed contains all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

Note (2).—Where a person or firm mentioned in the List has more than one address

Schacht & Wyneken), Calle Blanco 947, Val- in the country or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specifically mentioned.

> Note (3).—Trading is prohibited under the Trading with the Enemy Proclamations of 25 June and 10 November 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

> Note (4).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required.

> Note (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The Lists for all countries in Central or South America are also telegraphed to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

> § Note (6).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name, followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.), as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under Berg and Komeet respectively, and not under "Handel" or "Naamlooze."

HEREAS by virtue and in exercise of the powers conferred on Him by Section one of the Exportation of Arms Act, 1900, as extended by Section one of the Customs (Exportation Restriction) Act, 1914, and Section one of the Customs (Exportation Restriction) Act, 1915, His Majesty was pleased to issue a Proclamation, dated the 25th day of June 1915, declaring that the exportation of the articles mentioned in the second column of the Schedule to that Proclamation is prohibited to the country named in the first column of the said Schedule unless those articles are consigned to the persons referred to in the third column of the said Schedule:

And whereas by Section two of the Customs (Exportation Restriction) Act, 1914, any Proclamation made under Section one of the Exportation of Arms Act, 1900, may be varied or added to whilst a state of war exists by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by an Order of Council dated the 7th day of October 1915, the said Proclamation of the 25th day of June 1915 was amended by the substitution of a new Schedule for the Schedule to that Proclamation:

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect:-

That the Proclamation dated the 25th day of June 1915, as amended, should be further amended by the substitution for the Schedule to that Proclamation, as amended, of the following Schedule :-

THE COAL TRANSPORT ORDER, 1917.

Order of the Board of Trade, dated the 4th July 1917, and made under Regulations 2F to 2JJ and 9G of the Defence of the Realm Regulations.

In pursuance of the powers conferred on them by Regulations 2F to 2JJ and 9G of the Defence of the Realm Regulations and all other powers enabling them in that behalf, the Board of Trade hereby order as follows:—

1. With a view to effecting economies in transport and of facilitating the supply of coal such restrictions may be placed on the transport of coal from particular areas or particular collieries in the United Kingdom to particular areas or particular destinations as the Board of Trade may from time to time consider necessary, and when such restrictions are so placed it shall be the duty of every person affected thereby to comply with the requirements of the Board of Trade for the purposes of giving effect thereto.

2. Contracts for the sale of coal shall be abrogated to such extent and as from such dates as may be deemed by the Board of Trade to be necessary in order to secure compliance with their

requirements under this Order.

- 3. The requirements of the Board of Trade under this Order shall be notified in the form of directions issued from time to time by the Controller of Coal Mines. Such directions may relate to any or all of the following matters:—
- (a) The restriction or discontinuance of the transport of coal from particular areas or particular collieries to particular areas or particular destinations, either absolutely or by any specified method of transport or otherwise than by such method of transport as may be specified.

(b) The contracts which are to be regarded as abrogated with a view to facilitating compliance

with such directions.

- (c) Furnishing information by and to such parties and in such forms as may be specified in the directions.
- (d) Any other matters for which provision may be necessary for the purpose of this Order.
- 4. Infringements of this Order are summary offences, subject to penalties under the Defence of the Realm Regulations.
- 5. This Order may be cited as the Coal Transport Order, 1917-

## STATUTORY RULES AND ORDERS. 1917, No. 700.

### DEFENCE OF THE REALM. MINISTRY OF FOOD.

The Intoxicating Liquor (Output and Delivery) Order No. 2, 1917, dated 7th July 1917, made by the Food Controller under Regulations 2F and 2J of the Defence of the Realm Regulations.

In exercise of the powers conferred upon him by Regulations 2F and 2J of the Defence of the Realm Regulations, and of all other powers enabling him in that behalf, the Food Controller hereby orders as follows:—

INCREASE OF MAXIMUM BARRELAGE.

- 1. During the quarter commencing on the 1st July 1917 (hereinafter referred to as the current quarter) the maximum barrelage which a brewer for sale is authorised to brew under the Intoxicating Liquor (Output and Delivery) Order, 1917 (hereinafter referred to as the principal order), shall be increased:—
  - (a) By twenty per cent. if he gives such notice and complies with such conditions as are hereinafter mentioned and such increase is, in this order, referred to as the twenty per cent. increase: and
  - (b) By such further amount if any as in his case may be authorised by licence of the Food Controller if he complies with the conditions subject to which such a licence is granted, and the increase authorised by such licence is hereinafter called the licenced increase:

Provided that the aggregate amount of the licenced increases shall not exceed such an amount as with the aggregate amount of the twenty per cent. increases will increase the aggregate barrelage to be brewed by all brewers for sale in the current quarter by more than thirty-three and one-third per cent.

#### ACCEPTING BREWERS.

2. A brewer for sale shall be authorised to brew in the current quarter the twenty per cent. increase if he gives notice to the Commissioners of Customs and Excise (hereinafter referred to as the Commissioners) on or before the 21st July 1917, and that he accepts and will comply with the conditions subject to which the twenty per cent. increase is authorised by this Order, and such brewer is hereinafter referred to as an accepting brewer.

#### CONDITIONS.

- The conditions subject to which the twenty per cent. increase is authorised are the following:—
  - (a) One-half of the total amount of beer brewed by the accepting brewer in the current quarter (exclusive of the licenced increase) shall be brewed and delivered out of his brewery at a gravity not exceeding an original gravity of 1036°:
  - (b) The remaining half of the beer brewed (exclusive of the licenced increase) shall be brewed at an average original gravity not exceeding the average original gravity of the total beer brewed at his brewery during the quarter commencing on the 1st July 1916:
  - (c) In the month of July not more than onethird and in the months of July and August not more than two-thirds of the total amount of beer which the brewer is entitled to brew during the current quarter (exclusive of the licenced increase) shall be delivered out of his brewery:

And it shall be the duty of every accepting brewer to comply with such conditions.

### Computation under Clause 2 (1) of the Principal Order.

4. The additional barrelage authorised to be brewed by this order and by licences under this order shall not be taken into account in reckoning the ten million barrels referred to in subsection (2) of clause one of the principal order.

#### CONTRACTS.

5. The same provision shall be applicable in relation to the effect of this Order on contracts as is applicable in relation to the effect of the Out of Beer (Restriction) Act 1916 on contracts under Section 4 of that Act.

SUPPLY OF BEER TO FREE LICENCED HOUSES.

- 6. The following provisions shall apply with respect to certificates available for the current quarter granted or to be granted to a licence holder.
  - (a) Except under the authority of the Food Controller a certificate granted by an accepting brewer shall not during the current quarter be used to transfer barrelage to a person who is not an accepting brewer.

(b) The number of standard barrels which a licence holder is entitled to obtain from an accepting brewer under a certificate shall be increased by 20 per cent.

- (c) An accepting brewer who has undertaken to supply the licence holder with beer under a certificate shall not supply more than one half of such beer at a gravity exceeding an original gravity of 1036 degrees.
- (d) This clause shall apply to persons having the same rights as licence holders in the same way as it applies to licence holders.

#### GRAVITY OF BEER.

7. If any question shall arise under this Order as to the average original gravity of beer, such question shall be determined by the Commissioners.

#### RECORDS.

8. Every accepting brewer shall keep such records as to gravity and amount of beer brewed and delivered and other matters as are requisite to determine whether or not the provisions of this Order are being complied with, and all such records and documents connected therewith shall at all times be open to the inspection of the Food Controller and of the Commissioners.

#### SURPLUS BARRELAGE.

9. No account shall be taken of any surplus barrelage accrued during the quarter commencing the 1st April 1917 for the purpose of computing the increase permitted by clause 1 of this Order or for the purpose of clause 3 of this Order.

#### Infringements.

10. Infringements of this Order are summary offences against the Defence of the Realm Regulations.

#### TITLE AND CONSTRUCTION.

11. This Order may be cited as the Intoxicating Liquor (Output and Delivery) Order No. 2 1917, and shall be read as one with the Principal Order.

· SHEEP AND LAMB SKINS.

In pursuance of the powers conferred upon them by the Defence of the Realm Regulations, the Army Council do hereby order that all persons engaged in the purchase, sale or manufacture of Slieep and Lamb Skins, taken from Sheep or Lambs killed in Great Britain, including Slink Lambs and Morts, or any article wholly or partly manufactured therefrom, shall comply with the following regulations:

(1) Save as hereinafter specifically excepted, no fellmonger shall without a permit issued by or on behalf of the Director of Army Contracts hold any Skins of the descriptions aforesaid (other than those from Slink Lambs) for a period exceeding three weeks after the receipt by him of the Woolled Skins, but all fellmongers shall deliver such skins as aforesaid duly fellmongered to a Tanner or Dresser within the said period.

Provided that no person shall without a permit issued by or on behalf of the Director of Army Contracts, fellmonger, sell or deliver any Shearling Skins of the descriptions aforesaid which would when fellmongered produce an Extra Pelt, but shall salt them immediately on receipt thereof, and keep them for inspection by a person authorised by the Director of Army Contracts. Such skins shall be re-salted within 7 days of the receipt thereof, and if they have not been inspected within 14 days of such receipt, application shall be made to the Director of Army Contracts for permission to fellmonger them.

(2) All Fellmongers and/or Tanners shall grade all Pelts of the descriptions aforesaid on the same principles and accordingly to the same standards of assortment as those generally prevailing in the

trade prior to April 9th, 1917.

The Classification shall be as follows:-

(a) Sheep Pelts.

- 1. English, Extras, Firsts, Seconds, Thirds.
- 2. Scotch, Primes, Light Primes, Seconds.
- (b) Lamb Pelts.
  - 1. English, Supers, Firsts, Seconds.
  - 2. Scotch, Primes, Seconds.

In the event of any dispute as to the classification, the determination of the Director of Army Contracts shall be final.

(3) Any person having in his possession any Skins, Pelts or Basils of the description aforesaid which he cannot put into work for manufacture into Basils or Finished Leather within 30 days of the date hereof, or of the receipt by him of the Woolled Skins, which ever period shall be the longer, shall forthwith notify the Director of Army Contracts.

(4) No Tanner or Dresser of Sheep Skins of the description aforesaid shall without a permit issued by or on behalf of the Director of Army Contracts, tan or dress any such Skins, Pelts or Basils otherwise than for the production of leather for the purposes of a Government Contract or Order, or for such other purpose as may be approved by or on behalf of the Director of Army Contracts.

2nd Lieutenant (acting Captain) Arthur Henderson, M.C., late Argyll and Sutherland Highlanders.

For most conspicuous bravery.

During an attack on the enemy trenches this officer, although almost immediately wounded in the left arm, led his Company through the front enemy line until he gained his final objective.

He then proceeded to consolidate his position, which, owing to heavy gun and machine gun fire and bombing attacks, was in danger of being isolated.

By his cheerful courage and coolness he was enabled to maintain the spirit of his men under most trying conditions.

Captain Henderson was killed after he had. successfully accomplished his task.

No. 18233 Pte. John Readitt, South Lancashire Regiment.

For most conspicuous bravery and devotion to duty when working down a broad, deep water-course.

Five times he went forward in the face of very heavy machine-gun fire at very closerange, being the sole survivor on each occasion. These advances drove back the enemy machine guns, and about 300 yards of water-course was made good in an hour.

After his officer had been killed Private Readitt, on his own initiative, organised and made several more advances.

On reaching the enemy barricade, he was forced by a counter-attack to retire, giving ground slowly and continuing to throw bombs. On supports reaching him, he held a forward bend by bombing until the position was consolidated.

The action of this gallant soldier saved the left flank and enabled his Battalion to maintain its position.
