### SPECIAL ACTS (EXTENSION OF TIME) ACT, 1915.

#### EDINBURGH CORPORATION ACT, 1913.

WHEREAS by the Special Acts (Extension of Time) Act, 1915, it is provided *inter* alia that where the time within which a power may be exercised under any Special Act is limited, an application may be made by the person by whom such power may be exercised to the appropriate Government Department for an Order extending that time, and that the Department, if satisfied that the time should be extended, may make an Order accordingly, and it is further provided that no time shall be extended under any such order for more than a year, without prejudice, however, to the making of any further order :

AND WHEREAS on the 3rd day of August 1916, upon the application of the Corporation of the City of Edinburgh (hereinafter called "the Corporation"), the Secretary for Scotland made an

Order (hereinafter called "the Order of 1916") under the said Special Acts (Extension of Time) Act, 1915, extending for one year, that is to say, until the 15th day of August 1917, the time within which the Corporation may exercise the powers for the compulsory purchase of lands conferred upon them by the provisions of Part II. of the Edinburgh Corporation Act, 1913:

AND WHEREAS the Corporation have applied to the Secretary for Scotland for an Order further extending the said time:

AND WHEREAS I am satisfied that the said time should be so extended :

Now THEREFORE in pursuance of the powers vested in me by the said special Acts (Extension of Time) Act, 1915, I, the Right Honourable Robert Munro, His Majesty's Secretary for Scotland, hereby order as follows:—

1. The time within which the powers of the Corporation for the compulsory purchase of lands under the provisions of Part II. of the Edinburgh Corporation Act, 1913, may be exercised as extended by the Order of 1916, is hereby extended for a further period of one year, that is to say, until the 15th day of August 1918.

2. This Order may be cited as the Edinburgh Corporation Act, 1913 (Extension of Time), Order, 1917.

#### ERICHT WATER AND ELECTRIC POWER (EXTENSION OF TIME) ORDER, 1917.

THEREAS it is provided by Section 19 of the Ericht Water and Electric Power Act, 1912 (hereinafter referred to as "the Act of 1912 ") as follows :--

"The powers of the Company for the compulsory purchase of lands for the purposes of this Act shall cease after the expiration of three years from the commencement of this Act."

AND WHEREAS by the Ericht Water and Electric Power (Extension of Time) Order, 1916, made by the Secretary for Scotland in terms of the Special Acts (Extension of Time) Act, 1915, the powers of the Company under the said section were extended for the period of one year from the 7th day of August 1915.

AND WHEREAS the Ericht Water and Electric Power Company (hereinafter called "the Company") have applied to the Secretary for Scotland for an Order in terms of the last-mentioned Act, further extending the time limited by the said Section.

AND WHEREAS I am satisfied that the time in respect of which the application is made should be extended.

Now THEREFORE I, the Right Honourable Robert Munro, His Majesty's Secretary for Scotland, in pursuance of the powers vested in me by the last-mentioned Act, hereby order as follows :-

1. This Order may be cited as the Ericht Water and Electric Power (Extension of Time) Order, 1917.

And whereas the Statutory List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect :-

That the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

NOTE (1). — All persons or firms resident, carrying on business, or being in the United Kingdom are prohibited from having with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3, any dealings other than such as are expressly authorised by Paragraph 5 of the Proclamation. A List, consolidating all previous Lists, was published on the 22nd June 1917 (The Consolidating List No. 29A), which, together with Lists No. 30 and 31 of the 6th and 20th July 1917, respectively, and the List herewith annexed contains all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

† Note (2).-Where a person or firm men-

tioned in the List has more than one address in the country or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specifically mentioned.

Note (3).—Trading is prohibited under the Trading with the Enemy Proclamation of 25th June and 10th November 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

NOTE (4).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable sub-When the applicant wishes this done stitutes. by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required.

NOTE (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as The Lists for all countries in they appear. Central or South America are also telegraphed to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

\* Note (6).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.), as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

#### CARGOES EX ENEMY VESSELS IN PORTUGUESE HARBOURS.

# Foreign Office,

July 31, 1917.

With reference to the notifications which were published in the London Gazette of May 30, 1916, and July 24, 1917, respecting the release of allied and neutral merchandise found on enemy vessels in Portuguese harbours, a translation is now appended of a Decree which has been issued by the Portuguese Government on the subject :---

Decree (No. 3246), July 13, 1917.

#### [TRANSLATION.]

Taking into consideration the representations made to me by the Ministers of all the Departments, with the view of simplifying in certain cases the procedure for the delivery of goods found on board requisitioned vessels; availing myself of the authorisation granted by the Laws No. 373 of September 2, 1915, and No. 491 of March 12, 1916: I hereby, on the advice of the Council of Ministers, decree as follows:—

#### ARTICLE I.

The production of a guarantee is dispensed with in the case of the delivery of the goods referred to in Article 32 of the Decree of the 20th of April 1916\*, whenever in regard thereto claimants produce *delivery orders* issued by the owners of the vessels.

#### ARTICLE II.

The goods referred to in the above mentioned Article 32 of the Decree of April 20, 1916which may have already been claimed, and respecting which a certificate, from the Legation of the Allied or Neutral country to which the claimant belongs, has been presented by the 31st of August 1917, declaring that the Government concerned will, up to the expiration of the period of one year counting from the date of the signature of the treaty of peace, indemnify the Portuguese Government against all claims by the shipowners, captains or third parties up to the amount of one and one-third times the value of the said goods-may be handed over on an order from the Minister of Finance provided the parties interested pay the expenses of unloading, storage and conservation of the goods, as well as the Customs clearance charges on re-exportation, at the time the clearance is effected.

#### ARTICLE III.

An extension is hereby granted to the 31st of August 1917, of the period for the presentation of all claims or documents relative to goods of the same origin.

§1. At the termination of this extended period no claim or document will be admitted, and all proceedings pending will follow their legal course.

#### ARTICLE IV.

The decisions referred to in Articles 34 and 35 and their sub-Articles of the Decree of the 20th of April 1916, shall appertain to the Tribunal of Commerce at Mormuagão as regards the questions still pending in connection with the cargoes of the ships "Pangim," "Damao" and "India," requisitioned at that port.

#### ARTICLE V.

Legislation to the contrary is hereby revoked.

The Ministers of all the Departments shall accordingly carry this Decree into effect. Seat of the Government of the Republic, July 13th, 1917.

#### POLICE, FACTORIES, &c. (MIS-CELLANEOUS PROVISIONS) ACT, 1916.

The Secretary of State for the Home Department hereby gives notice that, in pursuance of the powers conferred on him by the Police, Factories, &c. (Miscellaneous Provisions) Act, 1916, of making Orders for securing the welfare of the workers employed in factories or workshops, he proposes to make an Order, to take effect from the 1st October next, and to apply to all factories or parts of factories in which bichromate of potassium or sodium is used in dyeing or tanning.

Copies of the Draft Order may be obtained on application to the Home Office, Whitehall, London, S.W. 1.

Any objection to the proposed Order must be sent to the Secretary of State at the Home Office, Whitehall, London, S.W. 1, within 21 days after the date of this notice. The objection must be in writing and must state—

- (a) the requirements in the draft Order objected to;
- (b) the specific grounds of objection; and
- (c) the modifications asked for.

Where an objection is made jointly on behalf of a number of occupiers, the names of the occupiers and their addresses must be stated, or, if the objection is made by an association of occupiers on behalf of its members, the number of the members affected by the Order.

War Office, 2nd August 1917. His Majesty the KING has been graciously pleased to approve of the award of the Victoria Cross to the undermentioned Officers, Noncommissioned Officer, and Men :-

Capt. Robert Cuthbert Grieve, Aus. Inf.

For most conspicuous bravery.

During an attack on the enemy's position, in the face of heavy artillery and machine gun fire, and after all his officers had been wounded and his company had suffered very heavy casualties, Capt. Grieve located two hostile machine guns which were holding up his advance. He then, single-handed, under continuous fire from these two machine guns, succeeded in bombing and killing the two crews, reorganised the remnants of his company and gained his original objective.

Capt. Grieve, by his utter disregard of danger, and his coolness in mastering a very difficult position, set a splendid example, and when he finally fell wounded, the position had been secured and the few remaining enemy were in full flight.

2nd Lt. John Manson Craig, R. Sc. Fus.

For most conspicuous bravery on the occasion of an advanced post being rushed by a large party of the enemy. This officer immediately organised a rescue party, and the enemy was tracked over broken country back to his trenches. 2nd Lt. Craig then set his party to work removing the dead and wounded.

During the course of this operation his men came under heavy rifle and machine gun fire. An N.C.O. was wounded, and the Medical Officer who went out to his aid was also severely wounded. 2nd Lt. Craig at once went to their assistance and succeeded in taking the N.C.O. under cover. He then returned for the Medical Officer, and whilst taking him to shelter was himself wounded.

Nevertheless, by great perseverance, he succeeded in rescuing him also.

As the enemy continued a heavy fire and in addition turned on sharpnel and high explosives, 2nd Lt. Craig scooped cover for the wounded and thus was the means of saving their lives.

These latter acts of bravery occurred in broad daylight, under full observation of the enemy and within close range.

On three previous occasions this officer has behaved in a conspicuously brave manner, and has shown an exceptional example of courage and resource.

2nd Lt. John Spencer Dunville, late Dragoons. For most conspicuous bravery.

When in charge of a party consisting of scouts and Royal Engineers engaged in the demolition of the enemy's wire, this officer displayed great gallantry and disregard of all personal danger.

In order to ensure the absolute success of the work entrusted to him, 2nd Lt. Dunville placed himself between an N.C.O. of the Royal Engineers and the enemy's fire, and, thus protected, this N.C.O. was enabled to complete a work of great importance.

2nd Lt. Dunville, although severely wounded, continued to direct his men in the wire-cutting and general operations until the raid was successfully completed, thereby setting a magnificent example of courage, determination and devotion to duty, to all ranks under his command.

This gallant officer has since succumbed to his wounds.

2nd Lt. Thomas Harold Broadbent Maufe, R.G.A.

For most conspicuous bravery and initiative.

Under intense artillery fire this officer on his own initiative repaired, unaided, the telephone line between the forward and rear positions, thereby enabling his battery to immediately open fire on the enemy.

2nd Lt. Maufe further saved what might have proved a most disastrous occurrence by extinguishing a fire in an advanced ammunition dump, caused by a heavy explosion, regardless of the risk he ran from the effects of gas shells which he knew were in the dump.

By his great promptitude, resource and entire disregard of his own personal safety, he set an exceptionally fine example to all ranks.

#### 2nd Lt. Frank Bernard Wearne, Essex R.

For most conspicuous bravery when in command of a small party on the left of a raid on the enemy's trenches.

He gained his objective in the face of much opposition and by his magnificent example and daring was able to maintain this position for a considerable time, according to instructions.

During this period 2nd Lt. Wearne and his small party were repeatedly counter attacked. Grasping the fact that if the left flank was lost his men would have to give way, 2nd Lt. Wearne, at a moment when the enemy's attack was being heavily pressed and when matters were most critical, leapt on the parapet and, followed by his left section, ran along the top of the trench, firing and throwing bombs. This unexpected and daring manœuvre threw the enemy off his guard and back in disorder. Whilst on the top of the trench 2nd Lt. Wearne was severely wounded, but refused to leave his men. Afterwards he remained in the trench directing operations, consolidating his position and encouraging all ranks. Just before the order to withdraw was given, this gallant officer was again severely hit for the second time, and while being carried away was mortally wounded.

By his tenacity in remaining at his post, though severely wounded, and his magnificent fighting spirit, he was enabled to hold on to the flank.

T/2nd Lt. Frederick Youens, late Durh. L.I.

For most conspicuous bravery and devotion to duty.

While out on patrol this officer was wounded and had to return to his trenches to have his wounds dressed. Shortly afterwards a report came in that the enemy were preparing to raid our trenches. 2nd Lt. Youens, regardless of his wound, immediately set out to rally the team of a Lewis Gun, which had become disorganised owing to heavy shell fire. During this process an enemy's bomb fell on the Lewis Gun position without exploding. 2nd Lt. Youens immediately picked it up and hurled it over the parapet. Shortly afterwards another bomb fell near the same place; again 2nd Lt. Youens picked it up with the intention of throwing it away, when it exploded in his hand, severely wounding him and also some of his men.

There is little doubt that the prompt and gallant action of 2nd Lt. Youens saved several of his men's lives and that by his energy and resource the enemy's raid was completely repulsed.

This gallant officer has since succumbed to his wounds.

No. 6/2133 L/Cpl. Samuel Frickleton, N.Z. Infy.

For most conspicuous bravery and determination when with attacking troops, which came under heavy fire and were checked.

Although slightly wounded Cpl. Frickleton dashed forward at the head of his section, pushed into our barrage and personally destroyed with bombs an enemy machine gun and crew which was causing heavy casualties. He then attacked a second gun, killing the whole of the crew of twelve.

By the destruction of these two guns, he undoubtedly saved his own and other units from very severe casualties, and his magnificent courage and gallantry ensured the capture of the objective.

During the consolidation of the position he received a second severe wound.

He set, throughout, a great example of heroism.

#### No. 1804 Pte. John Carroll, Aus. Infy.

For most conspicuous bravery.

During an attack, immediately the barrage lifted, Pte. John Carroll rushed the enemy's trench and bayoneted four of the enemy.

He then noticed a comrade in difficulties, and at once proceeded to his comrade's assistance and killed one of the enemy. He continued working ahead with great determination until he came across a machine gun and team of four men in a shell-hole.

Single-handed he attacked the entire team, killing three of the men and capturing the gun.

Later on two of his comrades were buried by a shell, and, in spite of very heavy shelling and machine gun fire, he managed to extricate them.

During the 96 hours the battalion was in the line Pte. Carroll displayed most wonderful courage and fearlessness.

His magnificent example of gallantry and devotion to duty inspired all ranks in his battalion.

No. 808887 Pte. John George Pattison, Can. Infy.

For most conspicuous bravery in attack.

When the advance of our troops was held up by an enemy machine gun, which was inflicting severe casualties, Pte. Pattison, with utter disregard of his own safety, sprang forward and, jumping from shell-hole to shellhole, reached cover within 30 yards of the enemy gun.

From this point, in face of heavy fire, he hurled bombs, killing and wounding some of the crew, then rushed forward, overcoming and bayoneting the surviving five gunners.

His valour and initiative undoubtedly saved the situation and made possible the further advance to the objective.

No. 2251 Pte. William Ratcliffe, S. Lanc. R.

For most conspicuous bravery.

After an enemy's trench had been captured, Pte. Ratcliffe located an enemy machine gun which was firing on his comrades from the rear, whereupon, single-handed and on his own initiative, he immediately rushed the machine gun position and bayoneted the crew. He then brought the gun back into action in the front line.

This very gallant soldier has displayed great resource on previous occasions, and has set an exceptionally fine example of devotion to duty.



SCOTLAND NORTH-EAST COAST, ORKNEY AND SHETLAND ISLES.

Notice is hereby given that, under the Defence of the Realm (Consolidation) Regulations, 1914, the following Regulations have been made by the Lords Commissioners of the Admiralty, and are now in force :---

(1) PENTLAND AND MORAY FIRTHS-RESTRICTION OF TRAFFIC; PILOTAGE REGULATIONS.

The following regulations have been made with a view to safeguarding the interests of shipping in the Pentland and Moray Firths :---

I.--RESTRICTION OF TRAFFIC.

- (a) Anywhere along the coast between Tarbet ness and North Sutor, except within one mile radius of Balintore;
- (b) Anywhere off the south shore of the Moray Firth between the meridians of Port Gordon and Burghead, except within three-quarters of a mile of the low-water mark;
- (c) Outside a distance of one mile of the coast in any other portion of the area indicated in *red*.
- 2. Vessels proceeding to ports in the Moray Firth should therefore endeavour to enter the firth in time to reach their destinations not later than half an hour after sunset. Should they not reach their destinations by that time they are to anchor, weather permitting, subject to the restrictions given in clause 1.
- 3. Any vessel contravening the foregoing regulations will run the gravest risk of being sunk.

*Caution.*—Neutral or Allied vessels are particularly warned that the passage through the Pentland Firth presents very grave risks to a Westbound vessel, and are strongly advised not to take it.

#### II.—PILOTAGE REGULATIONS.

1. Pilotage is compulsory at the ports of Cromarty and Inverness for all vessels (including fishing vessels) which have a draught of over eight feet, and it is highly dangerous for any vessel to enter or leave without a pilot. Fishing and other small vessels having a draught of over eight feet are to assemble at the Pilotage stations, and will be conducted into and out of port in groups.

Vessels bound for Cromarty and Inverness will be led through the defences from a position off Tarbet ness by a pilot boat. They should follow directly astern of her.

Local arrangements for leading vessels through the defences will be made for vessels leaving Cromarty or Inverness.

2. It is dangerous for any vessel to be under way to the south-westward of a line joining Tarbet ness and Findhorn without a pilot.

3. No vessels of any description other than H.M. Ships and Auxiliaries are to be under way between sunset and sunrise in the waters contained between a line drawn from Tarbet ness to Findhorn, and a line drawn from Fort George to Chanonry point.

#### (2) ORKNEY ISLES-TRAFFIC REGULATIONS.

I.-SCAPA FLOW AND APPROACHES.

1. All entrances are dangerous, and entry is absolutely prohibited by any of them except as provided in succeeding paragraphs.

2. Examination services have been established in the entrances to Hoxa and Hoy sounds; vessels directed to enter must communicate with the Examination vessel and follow the instructions received from her very carefully.

3. No vessel is permitted to approach the entrance to Hoxa sound within a radius of 5 miles under any circumstances whatever, except when actually ordered to Scapa Flow.

4. The only vessels permitted to enter Hoy sound from the westward are those ordered to Stromness.

5. Vessels are not permitted to enter Hoxa or Hoy sounds by night or in thick weather. prohibited.

II.-PORT OF KIRKWALL AND APPROACHES.

1. The Port of Kirkwall shall comprise all enclosed waters of the Wide Firth and Kirkwall bay to westward of Thieves holm.

2. Merchant vessels shall obey all orders given them by the Admiralty Port Officer as regards anchoring or shifting position.

3. No vessel other than H.M. Ships shall enter or leave the Port of Kirkwall during hours of darkness, i.e. between half an hour after sunset and half an hour before sunrise, except in special circumstances with special permission from the Admiralty Port Officer.

4. During foggy and thick weather, traffic in and out of the port is stopped, and no vessel shall approach the boom from either direction.

5. No vessel (other than H.M. Ships) or boat shall move in the harbour during hours of darkness as aforesaid. And no boat (other than those belonging to H.M. Ships) shall approach the shore or go alongside any pier in the Port of Kirkwall.

6. All vessels (other than H.M. Ships) entering or leaving the Port of Kirkwall shall be piloted in and out by a Pilot drifter, and are prohibited from entering or leaving harbour unless so piloted, save and except only (1) in the case of such British vessels as have a written exemption therefrom, issued by the Admiralty Port Officer; (2) when a liner is entering the harbour, the Pilot may at his discretion, when circumstances of tide and sea render it advisable, direct such liner to enter the harbour without being piloted, provided always that the gate is open for incoming traffic.

7. Vessels, when cleared, shall wait for the Pilot vessel to conduct them out of port, or proceed as directed by the Naval Authorities.

8. Drifters engaged on pilot duty will fly the pilot flag (white and red, horizontal).

9. Incoming and outgoing traffic will be regulated by signals hoisted at the yardarm of the Boom trawler, and repeated at Hellier holm lighthouse.

10. Traffic signals are to be strictly obeyed, and no vessel shall approach the entrance against the signal.

11. The following Traffic signals will be displayed at the Boom and at Hellier holm :---

Gate "Open for Incoming Traffic":

By day-two balls, vertical.

By night-a red light.

Gate "Open for Outgoing Traffic": By day—a cone, point upwards.

By night—a green light.

Gate Closed: By day - Three balls at Hellier holm.

By night-Three red lights at Hellier holm.

12. Vessels entering will, as a rule, be given priority over those leaving.

13. All outgoing vessels shall pass round the Turning buoy (red and white striped, spherical) moored approximately 285° (N. 56° W. Mag.), one mile from the entrance.

14. Incoming vessels will not pass round the Turning buoy, but will shape course as requisite for the anchorage on entering.

15. No outgoing vessel shall pass the Turning buoy, unless the signal for outgoing traffic is up. If the signal is against it, such vessel shall stop

6. Passage through Cantick sound is entirely | and wait in the neighbourhood of the Turning buov

16. No incoming vessel shall pass Hellier holm, unless the signal for incoming traffic is up at Hellier holm. If the signal is against it, such vessel shall wait in Shapinshay sound.

17. Incoming and outgoing vessels shall not pass through the gate simultaneously. If, through any misunderstanding, an outgoing and an incoming ship are approaching the gate simultaneously, then the outgoing ship shall give way, and shall turn round, and return to the Turning buoy, and there wait till such time as the entrance is clear.

18. As a rule only one ship will be conducted out at a time, but under exceptional circumstances, in the event of two ships being conducted out, then the Pilot will give instructions as to which ship is to go first, and the rear ship shall then keep a full half mile directly astern, and is on no account to close or overhaul or attempt to pass the ship ahead.

19. Caution.-Caution is necessary when approaching the boom, as the tidal stream does not set fairly through the opening and attains considerable velocity especially on the ebb or westgoing stream, which sets in a north-westerly direction.

#### (3) SHETLAND ISLES-TRAFFIC OF NEUTRAL VESSELS PROHIBITED.

No vessels other than those of British Nationality or those of the Allied Nations, except vessels calling for the purpose of Examination, shall enter any ports or harbours in, or anchor off any part of, the coasts of the Shetland Isles until further notice.

#### Note.

This Notice is a revision of the former Notices quoted above.

#### CAUTION.

This Admiralty Notice to Mariners is issued under the provisions of the Defence of the Realm Regulations, and failure to comply strictly with the directions contained in it will constitute an offence against those Regulations.

Any person found guilty of such an offence is liable to severe penalties both of imprisonment and fine.

Any person aiding or abetting the commission of such an offence is himself guilty of an offence against the Regulations.
