## BY THE KING.

A PROCLAMATION UNDER THE MUNITIONS OF WAR ACTS, 9 1915 AND 1916.

## GEORGE R.I.

WHEREAS by section three of the Munitions of War Act, 1915, as amended by the Munitions of War (Amendment) Act, 1916, it is provided that the differences to which Part I. of the first-mentioned Act applies are differences as to rates of wages, hours of work, or otherwise as to terms or conditions of or affecting munitions work, and also any differences as to rates of wages, hours of work, or otherwise as to terms or conditions of or affecting employment on any other work of any description, if that Part of that Act is applied to such a difference by His Majesty by Proclamation, on the ground that in the opinion of His Majesty the existence or continuance of the difference is directly or indirectly prejudicial to the manufacture, transport, or supply of Munitions of War; and it is also provided that the said Part of the said Act may be so applied to such a difference at any time, whether a lock-out or strike is in existence in connection with the difference to which it is applied or not : Provided that if in the case of any industry the Minister of Munitions is satisfied that effective means exist to secure the settlement without stoppage of any difference arising on work other than on munitions work, no Proclamation shall be made under the said section with respect to any such difference :

And whereas a difference within the meaning of the said section exists between employers and certain locomotive drivers, firemen and cleaners employed on the Railways in the United Kingdom, as to rates of wages, hours of work, and otherwise as to terms and conditions of or affecting employment on the work carried on by such persons:

And whereas the President of the Board of Trade has investigated the matter and the Minister of Munitions, having considered the results of the investigation made by the President of the Board of Trade and his representations to the Minister of Munitions, is not satisfied that effective means exist to secure the settlement of the said difference without stoppage, being a difference arising on work other than munitions work :

And whereas in Our opinion the existence or continuance of the said difference is directly or indirectly prejudicial to the manufacture, transport, or supply of Munitions of War:

Now, THEREFORE, We, by and with the advice of Our Privy Council, are pleased to proclaim, direct and ordain, that Part I. of the Munitions of War Act, 1915, shall apply to the said difference.

Given at Our Court at Windsor Castle, this Eighteenth day of August, in the year of our Lord One thousand nine hundred and seventeen, and in the Eighth year of Our Reign.

## By the Lords of His Majesty's Most Honourable Privy Council.

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May 1916, entitled "The Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the following effect :-

That the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

Note (1). - All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, 1916, No. 3, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (the Consolidating List No. 33A) consolidating all previous Lists revised to date and including the amendments in the Schedule registered under names commencing with descrip-

annexed hereto is issued concurrently with this Order. This Consolidating List contains all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

† Note (2).-Where a person or firm mentioned in the List has more than one address in the country, or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specifically mentioned.

NOTE (3).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

NOTE (4).-In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required.

NOTE (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The Lists for all countries in Central or South America are also telegraphed to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

\* NOTE (6).-It is not unusual for firms in Holland and the Netherland East Indies to be

## Whitehall, August 17, 1917.

The KING has been pleased to award the Albert Medal of the First Class to Lieutenant Douglas Wood, Lancashire Fusiliers, in recognition of his gallantry in saving life when instructing a class in bomb throwing in France.

At Warloy, on the 17th April 1916, while a

bomb throwing, one of the men threw a live bomb, which failed to clear the bank behind which the throwers were sheltering, and started to roll down the bank towards the class. Lieutenant Wood sprang forward and tried to seize the bomb while it was falling. He failed to do so, but picked it up from the bottom of the trench, and was in the act of throwing it away when it exploded, blowing off his right hand, and severely injuring his back.

But for the officer's prompt and gallant conduct, there is no doubt that several lives would have been lost.

THE TOBACCO RESTRICTION ORDER (No. 3), 1917, DATED 13TH DAY OF AUGUST 1917, MADE BY THE BOARD OF TRADE UNDER REGULA-TIONS 2F, 2G, AND 2JJ OF THE DEFENCE OF THE REALM REGULATIONS.

Whereas it appears expedient to the Board of Trade to make further exercise of the powers vested in them by Regulations 2F, 2G, and 2JJ of the Defence of the Realm Regulations as respects Tobacco :

Now, therefore, the Board of Trade in exercise of their said powers and of all other powers them enabling hereby order as follows :-

(1) The Tobacco Control Board on behalf of the Board of Trade may fix the maximum price at which Tobacco may be sold by Manufacturers, Wholesale Dealers and Retailers, and may alter such price from time to time as occasion may require. The maximum price may be fixed by reference to the price ruling on 1st May 1917, or in such other way as the Tobacco Control Board may deem expedient and different prices may be fixed for different qualities and quantities of tobacco. Notice of the maximum price or prices so fixed shall be given in such form and in such manner as the Tobacco Control Board may direct.

(2) No person shall sell or offer for sale any Tobacco at a price exceeding the maximum price fixed in accordance with the last paragraph.

(3) Every person who sells Tobacco by retail shall exhibit and keep exhibited in a conspicuous position in the shop, bar, store or place where he sells Tobacco a copy of the Schedule or list issued by the Board of Trade, or by the Tobacco Control Board on their behalf, and in force for the time being whereby the maximum price at which Tobacco may be sold by retail is fixed. An Innkeeper shall in addition exhibit such Schedule or list in the entrance hall of his Inn.

(4) All Importers, Manufacturers and Dealers in Tobacco shall comply with any general or special direction which may be given by the Board of Trade or by any person or body of persons deputed by them for that purpose as to the manner or quantities in which Tobacco may be disposed or sold by them to their customers.

(5) Every manufacturer of Tobacco shall if required by the Tobacco Control Board manufacture the same brands and qualities of Tobacco in similar quantities as were manufactured by him during the year 1916.

(6) Every Manufacturer or Wholesale Dealer in Tobacco shall supply to his customers, if class of thirty men was under instruction in required by them, the same brands and quality of Tobacco in similar quantities as were supplied by him to them during the year 1916 : provided that if in the opinion of the Board of Trade the fulfilment of any such order is impossible or unreasonable on account of any restrictions in force at the time or for other sufficient reason, they may in writing excuse the fulfilment of any such order or any part thereof. (7) No person shall in connection with any

(7) No person shall in connection with any sale or proposed sale of tobacco impose or attempt to impose any condition relating to the purchase of any other tobacco or articles whatsoever.

(8) Every person owning or having the power to sell any Tobacco shall, when required, make a true return to the Board of Trade or to the Tobacco Control Board, in such form as may be prescribed in the Notice calling for any such return of all stocks of Tobacco held by them or which they have power to sell, giving such particulars as may be required by such form.

(11) Infringements of this Order are summary offences under the Defence of the Realm Regulations.

(12) This Order may be cited as the Tobacco Restriction Order (No. 3), 1917.

## Imported Cigars.

No increase in the price of imported cigars beyond that charged on 1st May will be allowed before 31st August 1917.
