THIS day George Henry Roberts, Esquire, was, by His Majesty's command, sworn of His Majesty's Most Honourable Privy Council, and took his place at the Board accordingly.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS it is enacted by the Suspensory Act, 1914, that notwithstanding anything in the Government of Ireland Act, 1914, no steps shall be taken to put that Act into operation until the expiration of twelve months from the date of the passing of that Act, or, if at the expiration of those twelve months the present War has not ended, until such later date (not being later than the end of the present War) as may be fixed by His Majesty by Order in Council; and that the provisions of that Act shall have effect accordingly:

And whereas by Order in Council dated the 14th day of September 1915 His Majesty was pleased to order that no steps shall be taken to

put the Government of Ireland Act, 1914, into operation until the expiration of eighteen months from the date of the passing of that Act, unless the present War has previously ended, nor, if at the expiration of those eighteen months the present War has not ended, until such later date, not being later than the end of the present War, as may hereafter be fixed by Order in Council:

And whereas His Majesty was pleased, by Order in Council dated the 29th day of February 1916, to extend by six months the time mentioned in the said Order of the 14th day of September 1915, and by Order in Council dated the 7th day of September 1916 to extend that time by a further period of six months, and by Order in Council dated the 13th day of March 1917 to extend that time by a further period of six months:

And whereas it is expedient to extend further the time mentioned in the said Orders:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that:—

No steps shall be taken to put the Government of Ireland Act, 1914, into operation until the expiration of a period of six months after the termination of the eighteen months and three periods of six months mentioned in the recited Orders, unless the present War has previously ended, nor, if at the expiration of that period the present War has not ended, until such later date, not being later than the end of the present War, as may hereafter be fixed by Order in Council.

And whereas the provisions of Section 1 of the Rules Publication Act, 1893, have been complied with :

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to revoke the said Order of the 11th June 1910, and the same is hereby revoked.

WHEREAS by the Merchant Shipping Act, 1894, it is enacted as follows :—

“Where the Legislature of any British Possession provides for the survey of, and grant of Certificates for, Passenger Steamers, and the Board of Trade report to Her Majesty the Queen that they are satisfied that the Certificates are to the like effect, and are granted after a like survey, and in such manner as to be equally efficient with the Certificates granted for the same purpose in the United Kingdom under this Act, Her Majesty in Council may :—

(1) Declare that the Certificates granted in the said British Possession shall be of the same force as if granted under this Act ; and

(2) declare that all or any of the provisions of this Part of this Act which relate to Passenger Steamers' Certificates shall, either without modification or with such modifications as to Her Majesty may seem necessary, apply to the Certificates granted in the said British Possession ; and

(3) impose such conditions and make such regulations with respect to the Certificates, and to the use, delivery, and cancellation thereof, as to Her Majesty may seem fit, and impose fines not exceeding £50 for the breach of those conditions and regulations :

And whereas by Orders in Council dated respectively the 26th day of June 1884 and the 17th day of October 1884, Her late Majesty was pleased to direct that, subject to the modifications contained in such Orders, Certificates granted by the Governments of Bombay and

Bengal respectively should be of the same force as if they had been granted for the same purpose in the United Kingdom under the Acts relating to Merchant Shipping :

And whereas it is made to appear expedient to His Majesty that during the present War the modifications contained in the above-recited Orders in Council, dated respectively the 26th day of June 1884 and the 17th day of October 1884, should be suspended :

And whereas on account of urgency this Order in Council should come into immediate operation :

Now, therefore, His Majesty, in virtue of the powers vested in Him by the above-recited provision, and by and with the advice of His Privy Council, is pleased to direct that during the continuance of the present War :—

1. The Certificates granted by the Governments of Bombay and Bengal respectively for Passenger Steamers shall be of the same force as if they had been granted for the same purpose in the United Kingdom under the provisions of the Acts relating to Merchant Shipping.

2. That all the provisions of the said Acts which relate to Certificates granted for Passenger Steamers under those Acts shall apply to the Certificates referred to in this Order without modification, and that during the continuance of the present War the modifications in the above-recited Orders in Council dated the 26th day of June 1884 and 17th day of October 1884 be, and the same are hereby, suspended.

And His Majesty is further pleased, by and with the advice aforesaid, to direct that this Order do come into operation *provisionally*, in accordance with the provisions of Section 2 of the Rules Publication Act, 1893, from the date hereof.

ORDER OF THE MINISTER OF MUNITIONS APPLYING REGULATION 30A TO TINPLATES AND TERNEPLATES.

In pursuance of the powers conferred upon him by Regulation 30A of the Defence of the Realm Regulations, the Minister of Munitions hereby orders that as from the 19th day of July 1917 the war material to which that regulation applies shall include war material of the following classes, that is to say :—

- Tinplates.
- Terneplates.

NOTICE OF ADDITION TO GENERAL PERMIT AS REGARDS DEALINGS IN TINPLATES AND TERNEPLATES.

With reference to the above Order, applying Regulation 30A of the Defence of the Realm Regulations to Tinplates and Terneplates, the

Minister of Munitions hereby gives notice that the General Permit of the 1st November 1916, under the Orders of the 7th July and 31st October 1916, shall as from the 19th day of July 1917, take effect as if the war material referred to in the above Order were included in the Order of the 31st October 1916, and the following materials and prices were specified in the schedule to the said General Permit: Provided that Condition 2 of the said General Permit shall not apply to any sale or purchase of the war material referred to in the above Order of this date, under a contract in writing entered into prior to the 19th day of July 1917; and that the proviso contained in the said Condition, that such Condition shall not apply to any sale by a Manufacturer, of finished steel rolled from steel purchased by him or to a sale or purchase of material, the export of which has been duly sanctioned, shall not apply to any sale or purchase of the war Material referred to in the above Order of this date: Provided also that nothing herein contained shall affect or prejudice the provisions of the Order of the Minister of Munitions as to control of Steel supplies dated the 20th November 1916.

WASTE, WASTE TINPLATES, AND WASTE, WASTE TERNEPLATES.

At not less than 2s. basis below the prices for *Waster* Tinplates and Terneplates respectively.

To the maximum prices and extras for Tinplates and Terneplates, a sum not exceeding 2 per cent. on such prices may be added in the case of sales made by persons other than the makers or their agents, plus the actual cost of delivery from works to destination.

In the case of dealings between merchant firms it is not permissible for each of them to add such 2 per cent., as in no case must the cost to the ultimate consumer be beyond 2 per cent. over the said maximum prices, plus carriage charges.

Merchant Stock Holders delivering from their own warehouses (not public warehouses) are permitted to sell from their stock at the maximum prices, plus the maximum addition of $7\frac{1}{2}$ per cent. on such prices, exclusive of inwards and outwards carriage. This $7\frac{1}{2}$ per cent. will include the merchants' commission of 2 per cent., and is not in addition thereto.

And whereas the Local Government Board for Scotland have approved a scheme for the gratuitous treatment of persons suffering from venereal disease within the area of the City and Royal Burgh of Aberdeen, which scheme came into operation on the fourteenth day of February nineteen hundred and seventeen ;

Now, therefore, We, the Local Government Board for Scotland, by this Our Order declare that Section One of the Venereal Disease Act, 1917, shall operate from and after the first day of November nineteen hundred and seventeen, within the area of the City and Royal Burgh of Aberdeen.
