A PROCLAMATION

RELATING TO THE IMPORTATION OF CERTAIN ARTICLES INTO THE UNITED KINGDOM.

GEORGE R.I.

**W**HEREAS by Section forty-three of the Customs Consolidation Act, 1876, it is provided that the importation of arms, ammunition, gunpowder, or any other goods may be prohibited by Proclamation:

And whereas by certain Proclamations entitled Prohibition of Import Proclamations the importation of certain goods has been prohibited accordingly:

And whereas it is expedient that the importation into the United Kingdom of certain other goods should be prohibited:

Now, therefore, We, by and with the advice of Our Privy Council, in pursuance of the said Act and of all other powers enabling Us in that behalf, do hereby proclaim, direct and ordain as follows:—

As from and after the date hereof, subject as hereinafter provided, the importation into the United Kingdom of the following goods is hereby prohibited, viz.:—

- Abrasive wheels.
- Binder or reaper twine.
- Brass rod and brass wire.
- Cycles, other than motor cycles.
- Electric meters.
- Electrical motors over one-half horse-power.
- Electric hand lamps and torches.
- Magnetos.
- Measuring tapes and rules of all descriptions, including verniers.
- Micrometers.
- Pens, penholders, pencils and all other stationery of which the importation is not already prohibited.
- Vegetables in brine.

Provided always, and it is hereby declared, that this prohibition shall not apply to any such goods which are imported under licence given by or on behalf of the Board of Trade, and subject to the provisions and conditions of such licence.

This Proclamation may be cited as the Prohibition of Import (No. 20) Proclamation, 1917.

The KING's Most Excellent Majesty in Council.

WHEREAS by an Order in Council, dated the twenty-eighth day of November nineteen hundred and fourteen, His Majesty was pleased to make regulations (called the "Defence of the Realm Regulations") under the Defence of the Realm Consolidation Act, 1914, for securing the public safety and the defence of the realm:

And whereas the said Act has been amended by the Defence of the Realm (Amendment) Act, 1915, the Defence of the Realm (Amendment) (No. 2) Act, 1915, and the Munitions of War Act, 1915, and other enactments:

And whereas the said regulations have been amended by various subsequent Orders in Council:

And whereas it is expedient further to amend the said regulations in manner hereinafter appearing:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following amendments be made in the said regulations:—

1. Regulation 2JJ shall be amended as follows:—

(1) By the insertion in subsection (1) thereof after the words, "any section of the public," of the words, "or which is otherwise required for the public safety or defence of the Realm."

(2) By the insertion at the end thereof of the following new paragraph:—

"(5) Without prejudice to the powers of the Army Council the Board of Trade may exercise as respects horses (including mules) and horse-drawn vehicles all the powers that they may exercise under this regulation with respect to an article of commerce not being an article of food, and orders under this subsection may provide for the giving of instructions in relation to horses and horse-drawn vehicles in such manner and by such persons as the Board of Trade may direct, and for enabling the Board to take possession of any horse or horse-drawn vehicle either absolutely or by way of hire.

Such compensation shall be paid for any horse or horse-drawn vehicle so taken possession of as shall in default of agreement be determined by the arbitration of a single arbitrator appointed in manner provided by an order of the Board of Trade, but in determining the amount of the compensation the arbitrator shall have regard to the age and condition of the horse or vehicle, to the allowance of a reasonable profit on the price, if any, paid by the person from whom the same is taken, and to any other circumstance without necessarily taking into consideration the market price at the time.

Nothing in this subsection shall apply to horses or horse-drawn vehicles used wholly or mainly in agriculture or to vehicles licensed to ply for hire."

2. Regulation 2M shall be amended as follows:—

(1) By the substitution of the following paragraph for paragraph (z) of subsection (1) thereof—

"(z) by notice served on the occupier or person in control of any dam, mill, lock, sluice, weir, or other structure affecting the flow of water in any river or stream, require such occupier or person to keep open or closed any mechanical appliance by which the inflow or outflow of water is capable of being regulated during such times and in such manner as the Board, having regard to the use by such occupier or person of the structure and of the water thereby impounded, consider to be necessary or desirable for the prevention of floods or for the draining of land adjoining or near the river or stream; and"

(2) By the insertion after paragraph (j) of subsection (1) thereof of the following new paragraphs:—

"(k) enter on or take possession of any dam, mill, lock, sluice, weir, or other structure affecting the flow of water in any river or stream and remove or repair or alter or maintain and use the same where such action is in the opinion of the Board necessary or desirable for the prevention of floods or for the drainage of agricultural land; and

(l) for the purpose of removing any obstruction to or otherwise improving the flow of water in any river or stream, or maintaining or improving the banks of any river or stream or any sea defence or drainage outfall, enter on the river or stream or any land adjoining or near the river stream, defence, or outfall; and

(m) where any expenses are incurred by the Board in the exercise of any of their powers under paragraphs (k) or (l) of this regulation, recover those expenses, so far as they are directly attributable to the default of any person in carrying out his obligations under statute or otherwise, from that person."

(3) By the substitution in subsection (4) thereof for the words, "the person then entitled to resume occupation of the land," of the words, "any person then interested in the land as owner or tenant or otherwise."

(4) By the substitution in paragraph (9) thereof for the words, "paragraphs (h) (z) and (j)," wherever those words occur, of the words, "paragraphs (h) to (m) (both inclusive)."

3. The following shall be substituted for Regulation 2NN:—

"2NN.—(1) Subject to the provisions of this regulation, the acreage planted with hops on any holding in England or Wales shall, before the first day of April, nineteen hundred and eighteen, be reduced to one half of the acreage on the holding which is proved by the occupier of the holding to have been planted with hops in the month of June, nineteen hundred and fourteen (excluding from such last mentioned acreage land which was planted with hops after the first day of October, nineteen hundred and thirteen), and thereafter, so long as this regulation remains in force, the acreage on the holding so planted shall not exceed that proportion.

(2) This regulation shall have effect notwithstanding any covenant, agreement, condition, or provision as to the user of a holding, whether contained in any lease or other instrument affecting the holding or in any verbal contract of tenancy or implied by law, and no such covenant, agreement, condition, or provision shall operate so as to penalise, impede, or interfere with compliance with any obligation imposed by this regulation.

(3) The Board of Agriculture and Fisheries may by licence exempt any occupier wholly or partly or for a specified period from any obligation imposed by this regulation in any case where it appears to the Board that by reason of exceptional circumstances the issue of such a licence is advisable.

(4) If the occupier of any holding fails to comply with the provisions of this regulation, or with any condition subject to which a licence under this regulation has been granted, he shall be guilty of a summary offence against these regulations.

(5) Any person authorised by the Board in that behalf, may, for the purposes of this regulation, and upon production if so required of his authority, enter on and inspect any land.

(6) The Board may, with respect to land in any district, authorise any person or any body constituted by the Board for the purpose to exercise on behalf of the Board any of the powers of the Board under this regulation, and prescribe the procedure of any such body, and the authentication of any notice or other instrument issued by any body or person so authorised.

(7) Any authority given by the Board under any of the provisions of the regulation for which this regulation is substituted shall, unless and until revoked by the Board, be deemed to have been given under and for the purposes of the corresponding provision of this regulation."

4. In the third paragraph of Regulation 14B the word "modify" shall be substituted for the word "relax," and after the words "such restrictions" there shall be inserted the following words, "and if any person so interned escapes or attempts to escape from the place of internment or commits any breach of the rules in force therein he shall be guilty of an offence against these regulations."

5. After Regulation 27B the following regulation shall be inserted:—

"27c. It shall not be lawful for any person to print, publish, or distribute, any leaflet relating to the present war or to the making of peace unless—

"(a) There is printed on every copy of the leaflet the true name and address of the author and of the printer thereof; and

"(b) The contents thereof have previously been submitted to and passed by the Directors of the Official Press Bureau or some other person authorised in that behalf by the Secretary of State;

and if any person contravenes the foregoing provisions he shall be guilty of a summary offence against these regulations, and if any person without lawful authority or excuse has in his possession or on premises in his occupation or under his control any leaflet the publication of which would be a contravention of the foregoing provisions he shall be guilty of a summary offence against these regulations, unless he proves that he did not know and had

no reason to suspect that the leaflet related to such matters as aforesaid or that he had no intention of transmitting or circulating the leaflet or distributing copies thereof to or amongst other persons:

"Provided that a person shall not be deemed to have contravened this regulation by reason only that proofs of a leaflet have been printed for submission to the Directors of the Official Press Bureau or other person authorised as aforesaid.

"For the purposes of this regulation the expression 'leaflet' includes a pamphlet or circular, but does not include any newspaper or other periodical which was in existence on the sixteenth day of November nineteen hundred and seventeen, or any leaflet issued by or under the authority of His Majesty's Government."

6. Regulation 39BBB shall be amended as follows:—

(1) In subsection (1) after the word "regulating" there shall be inserted the word "restricting."

(2) In subsection (1) after the words "passenger tickets," there shall be inserted the words "the building, repairing, equipping, refitting, converting or altering of any ship or vessel, the user of and the work to be done in or with any dock, shipyard, dry dock, or other accommodation adapted or capable of being adapted for building, repairing, equipping, or refitting ships or vessels (in this regulation included in the term 'shipyard'), and any plant in or about the same, the priority and manner in which and the places at which orders or contracts for building, repairing, equipping, refitting, converting or altering ships or vessels are to be executed or any such work is to be done, and the payments to be made in respect thereof."

(3) In subsection (1) after the words "circumstances of the time" there shall be inserted the words "or for providing and maintaining an efficient supply of shipping."

(4) In subsection (5) after the word "ship" there shall be inserted the words "or shipyard," and after the word "ships" wherever it occurs there shall be inserted the words "or shipyards."

(5) In subsection (6) after the words "in charge of a ship" there shall be inserted the words "or the occupier of a shipyard."

(6) In subsection (7) after the words "powers of His Majesty" there shall be inserted the words "and the Shipping Controller may make arrangements with any other Government department for the exercise by that department on behalf of the Shipping Controller of any of the powers of the Shipping Controller under this regulation."

7. In Regulation 51 after the words "printed publication" there shall be inserted the words "or where a leaflet has been printed in contravention of Regulation 27c," and after the words "other publication" there shall be inserted the words "or of the leaflet."

8. In Regulation 60 the words "any of His Majesty's forces or" shall be omitted, and after the words "military matters" there shall be inserted the words "or any matters connected with any financial or other measures taken or any financial or other arrangements made by or on behalf of His Majesty's Government with a view

to the prosecution of the war or otherwise connected with the public safety or the defence of the Realm."

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 25th day of October 1917, in the words following, viz:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

"And whereas we consider that the emoluments of Quartermaster Sergeant Instructors in the Royal Marines are inadequate.

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to approve of the following allowances being granted to these Warrant Officers, with effect as from the 10th October 1917.

"Quartermaster Sergeant Instructors of Gunnery to receive, in addition to their pay, Gunnery Instructional Allowance of 6d. a day, and such gunlayer pay as they are qualified for.

"Quartermaster Sergeant Instructors of Musketry and Infantry to receive Instructional Allowance of 6d. a day.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 28th day of October 1917, in the words following, viz:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allow-

ances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

"And whereas Your Majesty was graciously pleased, by Your Order in Council bearing date the 28th day of June, 1917, to institute the Commissioned Warrant Rank of Commissioned Master at Arms, and to provide that one Officer of this rank should be borne pending the operation of the rule under which deserving Warrant Officers belonging to Classes in which Commissioned Warrant Rank is attainable are promoted to Commissioned Warrant Rank after 15 years' service as Warrant Officer:

"And whereas we consider that, pending the operation of this rule, the number of Commissioned Masters at Arms allowed should be increased to three:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to approve of such increase in the number of Commissioned Masters at Arms; the Officers of this rank to be included in the established number of Chief Masters at Arms.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

#### DEFENCE OF THE REALM REGULATIONS.

#### TREASURY (SECURITIES) ORDER, 1917 (No. 5).

Whereas the Treasury have power under Regulations 7c, 7d, and 7e of the Defence of the Realm Regulations (inserted in those regulations by an Order in Council dated the twenty-fourth day of January nineteen hundred and seventeen) to apply Regulation 7c to certain securities and to take possession or require delivery of the securities to which the regulation is for the time being applicable subject to and in accordance with the provisions of the regulation:—

And whereas the Treasury are of opinion that for the purpose of strengthening the financial position of the country it is expedient that Regulation 7c should be applied to ordinary shares (including sub-shares and provisional certificates) of the Royal Dutch Company for the Working of Petroleum Wells in Netherlands India, which securities are in this Order referred to as "the Royal Dutch securities."

Now, therefore, in pursuance of their powers under the said regulations, and of all other powers

enabling them in that behalf, the Treasury hereby order as follows:—

1. Regulation 7c is hereby applied to the Royal Dutch securities.

2.—(1) Any such securities shall be transferred to the Treasury on or before the seventeenth day of December 1917, and for that purpose any person who is the owner of any such securities shall, on or before that date, deliver the securities to the American Dollar Securities Committee at the National Debt Office, 19 Old Jewry, London E.C. 2.

Any such person (in this Order referred to as the transferor) shall also deliver to the Treasury any documents of title relating to the securities which may be in his possession or at his disposal.

(2) Any owner of any of the Royal Dutch securities and any person who has power to dispose of or sell any of the Royal Dutch securities, or has the custody of any of the Royal Dutch securities, or receives on his own behalf or on behalf of any other person the dividends or income of any of the Royal Dutch securities or has any interest in any of the Royal Dutch securities shall (if he is not the transferor) on or before the seventeenth day of December 1917, give to the American Dollar Securities Committee full particulars of the securities and of his position in relation thereto, delivering at the same time to the Committee any documents of title relating to the securities which may be in his possession or at his disposal and comply with any directions given to him by the Committee for completing the delivery of those securities.

(3) The American Dollar Securities Committee may, if they think fit, on the application of the owner of any Royal Dutch securities which are not for the time being in the United Kingdom arrange for the transfer of the securities to Messrs. Hope & Co. at their Amsterdam Office, and the transfer in accordance with this Order of the securities to Messrs. Hope & Co. at their Amsterdam Office will in such a case for the purposes of this Order be treated by the Treasury as the transfer of the securities to the Treasury.

3.—(1) Subject to the provisions of this Order the Treasury will, within seven days after any securities are transferred under this Order, pay compensation through the American Dollar Securities Committee for the securities at the rate of £51 (fifty-one pounds sterling) per each 100 florins.

(2) The compensation money shall be paid to the transferor of the securities (whose receipt shall be a sufficient discharge) and the compensation money shall be subject to the same trusts, charges, liens, rights and equities (if any) as the securities in respect of which it is paid.

(3) The transfer of securities under this Order to the Treasury includes the transfer of the right to receive all dividends or interest payable or paid on or after the seventeenth day of November 1917; and all coupons representing such interest or dividends shall be surrendered on the transfer of the securities; and if any coupons are not so surrendered the Treasury will deduct from the compensation money such sum as they consider just in the circumstances of each particular case.

(4) Where securities transferred under this Order are held either on loan or contango, and the loan or contango is carried over under the scheme for providing Government assistance in dealing with account to account loans on the

Stock Exchange, special arrangements will be made by the Treasury for postponing the payment of compensation until the securities cease to be subject to the scheme, and for the determination of the compensation as at the time when it becomes payable, and for payment to be made in the meantime in respect of the income of the securities.

(5) Where securities are not transferred to the Treasury within the required time, the Treasury will not be bound to give the compensation for which provision is made under this Order, but may give such compensation as they think just in the circumstances; Provided that any reduction of the compensation under this provision shall not prejudice the recovery of any penalty which may have been incurred.

4.—(1) Securities are excepted from the operation of this Order if it is proved to the satisfaction of the Treasury—

- (a) that the securities come within the proviso to subsection (1) of Regulation 7c, as set out in Part I. of the Schedule to this Order; or
- (b) that the securities have, with the permission in writing of the American Dollar Securities Committee given at the time of purchase, been purchased since the twenty-fourth day of January, nineteen hundred and seventeen, by or on behalf of a person not ordinarily resident in the United Kingdom and that they remain in the beneficial ownership of such person; or
- (c) that the securities are securities within the scope of paragraph (a), (b) or (c) of Part II. of the Schedule to this Order.

(2) Where the transferor of any securities claims that the securities are, by virtue of this provision, excepted from the operation of this Order, he shall, on or before the eighth day of December 1917, give notice to the American Dollar Securities Committee, stating particulars of the grounds on which his claim is based; and if on adjudication his claim is not sustained, this Order shall take effect as respects those securities as if the seventh day after the date of adjudication (if that day is later than the seventeenth day of December 1917) were substituted for the seventeenth day of December 1917.

Provided that no notice shall be necessary under this subsection in respect of any securities where notice has been given to the Custodian as to those securities under section three of the Trading with the Enemy Act, 1914, as amended by any other Act, and no penalty shall be incurred for not giving any such notice.

5. The owner of any securities to which Regulation 7c of the Defence of the Realm Regulations is for the time being applicable (including any person who has power to dispose of or sell the securities, or has the custody of, or receives on his own behalf or on behalf of any other person, the dividends or income from the securities) and any person who has any interest in any such securities or is the registrar of any such securities, is under that regulation bound to take all steps and do anything which is necessary or is directed by the Treasury for the purpose of or in connection with the delivery or transfer of those securities to the Treasury; and if he acts in contravention of, or fails to comply with, that provision, he is guilty of a summary offence against those regulations.

6. The Treasury reserve to themselves the right to decline the transfer of any securities of which they have power to take possession in pursuance of this Order, and in that case no person shall be subject to a penalty for not complying with the provisions of this Order as to the transfer of the securities.

7. This Order shall, in its application to securities which come into ownership or cease to be exempted or excepted after the date of this Order and to persons owning any such securities, be modified as follows:—

- (a) In subsections (1) and (2) of Article 2 one month after the substituted date as herein-after defined shall be inserted in lieu of the dates specified in those subsections;
- (b) In subsection (3) of Article 3 the substituted date shall be inserted in lieu of the date specified in that subsection.
- (c) In subsection (2) of Article 4 twenty-one days after the substituted date shall be inserted in lieu of the dates first specified in that subsection, and the dates specified in the latter part of that Article shall be altered accordingly; and
- (d) The rate of compensation to be paid for any such securities shall be varied from the rate specified in Article 3 so as to allow for variations in (a) the market value as shown by the quotations on the Amsterdam Stock Exchange, and (b) the rate of exchange between the day immediately preceding the date of the Order and the day immediately preceding the substituted date.

The expression "substituted date" means, as respects any such securities, the date on which the securities come into ownership, or cease to be exempted or excepted, as the case may be.

8. This Order may be cited as the Treasury (Securities) Order, 1917 (No. 5), and the Treasury (Securities) Order, 1917 (No. 1), the Treasury (Securities) Order, 1917 (No. 2), the Treasury (Securities) Order, 1917 (No. 3), the Treasury (Securities) Order, 1917 (No. 4), the Treasury (Securities) Amendment Order, 1917, and this Order, may be cited together as the Treasury (Securities) Orders, 1917.

#### SCHEDULE.

##### PART I.

*Proviso to subsection (1) of Regulation 7c.*

Provided that no such Order shall apply to any securities as to which the Treasury are satisfied that on the twenty-fourth day of January nineteen hundred and seventeen they were beneficially owned by a person not ordinarily resident in the United Kingdom and that they remain so owned.

##### PART II.

- (a) Securities which are held, in any country outside the United Kingdom, by persons who are not domiciled in the United Kingdom, or by trustees who are prevented

by the laws of such other country or by the terms of their trust from placing the securities at the disposal of the Treasury, and are not entitled to the benefit of any indemnity conferred by Act of Parliament in respect of the contravention of those terms, if the securities were so held before the twenty-ninth day of May, nineteen hundred and sixteen, or where such securities are under the jurisdiction of a court in such other country, and it would be contrary to the laws of such other country to place such securities at the disposal of the Treasury;

- (b) Securities which are deposited with persons outside the United Kingdom as a security for a loan from persons outside the United Kingdom, if they were so deposited or made security before the twenty-ninth day of May, nineteen hundred and sixteen, or after that date with the approval of the Treasury, and if the Treasury are satisfied that the securities cannot be released without impairing the security for the loan;
- (c) Securities which are proved to the Special Commissioners of Income Tax to be held by any company or persons concerned in the trade or business in any country outside the United Kingdom as a condition (imposed in that country) of carrying on that trade or business.

#### DEFENCE OF THE REALM.

THE LIGHTS (SCOTLAND) (AMENDMENT) ORDER OF THE 16TH NOVEMBER 1917, MADE BY THE SECRETARY FOR SCOTLAND UNDER REGULATION 11 OF THE DEFENCE OF THE REALM REGULATIONS.

In pursuance of the power conferred on me by Regulation 11 of the Defence of the Realm Regulations, I hereby order that the Lights (Scotland) Order of the 25th August 1916 (hereinafter referred to as the Principal Order), as amended by my Order dated 29th March 1917, No.  $\frac{293}{S.43}$ , shall be amended as follows:—

(1) Paragraph (9) of the Principal Order is hereby revoked, without prejudice however to any proceedings in respect of contraventions of the said Order, and the following paragraph is substituted:—

"Except as otherwise provided in paragraph (1) this Order shall apply as follows:—(1) in the Counties of Berwick, Fife, Haddington and Roxburgh from half an hour after sunset till half an hour before sunrise; (2) in the Counties of Ayr, Dumbarton, Dumfries, Kirkeudbright, Lanark (including the County of the City of Glasgow), Renfrew and Wigtown from two hours after sunset till two hours before sunrise; (3) in the rest of Scotland, from one hour after sunset till one hour before sunrise."

(2) The Principal Order may be printed with the amendments effected by this Order and by the Order of the 29th March 1917, and cited as the Lights (Scotland) Order.

#### DEFENCE OF THE REALM REGULATIONS.

In exercise of the powers conferred on them by the Defence of the Realm Regulations and all other powers thereunto enabling them the Lords Commissioners of the Admiralty hereby make the following Regulations—

All British Merchant Vessels of 2500 gross tonnage and upwards shall include in their crew (4) men specially engaged who will when required act as Look-outs at the Masthead or elsewhere,

but the total number of the crew should not be increased for this purpose.

When in areas in which submarines may be encountered, these Look-outs are to be employed solely on their special duty keeping watch in four watches, each watch to be of not more than two hours' duration. When off watch in these areas they are not to be employed upon any of the ordinary work of the ship.

Before men are signed on for this duty they must agree to undertake this special work whilst in the areas mentioned.

These men must obtain the special Board of Trade Certificate as to eyesight and men are not to be signed on for this particular service unless they are in possession of this Certificate.

Any members of the ship's crew may be selected, provided it is clearly understood that none of the ship's Officers, Petty Officers, or any of the Guns' Crew are to be considered as borne for this special duty.

These special Look-outs, provided their duties are carried out to the satisfaction of the Master, who will be required to give a written certificate that this is the case, should be given extra pay at the rate of 15s. per month whilst the ship is in areas in which submarines may be met.

A proper Crow's Nest is to be provided for Look-out purposes as high as possible in every ship which has a mast suitable in character and position for the purpose.

From daybreak till dark the Look-out is to be stationed in the Crow's Nest when fitted. In other cases the Look-out is to be stationed as high aloft as possible.

From dark to daybreak the Look-out will be stationed in the position the Master considers the most suitable.

For conspicuous gallantry and devotion to duty in air fights and bombing raids. Since the award of a bar to the Distinguished Service Cross, Act. Flt. Cdr. Graham has carried out five night bombing raids, and attacked and brought down three enemy seaplanes. On one occasion he ascended at night for the purpose of attacking hostile machines, notwithstanding the fact that he had only returned a few hours previously from a successful action with hostile aircraft in superior numbers. He has always displayed remarkable skill and courage.

Act. Flt. Cdr. Philip Sidney Fisher, D.S.C., R.N.A.S.

For conspicuous gallantry and devotion to duty in air fights and bombing raids. On one occasion, when very heavy fighting took place between eight machines of his squadron and about twenty Albatross scouts, he fought at least six combats single-handed, shooting down one of his opponents out of control. On another occasion, when he was acting as leader of a flight of five machines detailed for an offensive patrol, a general action took place with a number of Albatross scouts, in the course of which Act. Flt. Cdr. Fisher was wounded whilst fighting with great gallantry.

He has shown himself to be a most efficient and plucky flight leader, and has also taken part in numerous night bombing raids in addition to his day fighting.

*To receive the Distinguished Service Cross.*

Flt. Cdr. Gerald Essex Hervey, R.N.A.S.

For conspicuous gallantry and devotion to duty in air fights and bombing raids. On the 22nd August 1917 he attacked a formation of ten hostile aircraft engaged in a raid on England and brought one of them down into the sea.

He has taken part in numerous night bombing raids, and on one occasion he ascended at night for the purpose of attacking hostile machines, notwithstanding the fact that he had only returned a few hours previously from a successful action with hostile aircraft in superior numbers.

On the 4th September 1917 he attacked an enemy Torpedo Boat Destroyer with machine-gun fire.

For conspicuous gallantry and devotion to duty. He has destroyed several hostile machines, and has also attacked and scattered parties of enemy infantry from low altitudes, on one occasion from a height of only 100 feet.

#### GLASGOW CORPORATION.

(Powers to the Corporation of the City of Glasgow with respect to Farmed-out Houses, definition, registration and inspection thereof; Increased borrowing powers for Slaughterhouses and Markets; Increase of and new and additional Rates Tolls and Rents for Slaughterhouses and Markets; Triperies; Byelaws and Penalties; Amendment and Repeal of Acts; and other purposes.)

NOTICE is hereby given that application is intended to be made to the Secretary for Scotland on or before the 17th day of December next by the Corporation of the City of Glasgow (in this Notice called "the Corporation" and "the City" respectively) for a Provisional Order (in this Notice called "the Order"), to be confirmed by Parliament pursuant to the Private Legislation Procedure (Scotland) Act 1899, for all or some of the following purposes (that is to say) :—

#### FARMED-OUT HOUSES.

1. To provide that the Corporation may by resolution declare certain buildings or houses, or parts thereof, in the City to be farmed-out houses, as defined in the Order, or prescribed by Parliament.

2. To provide for an appeal against such resolution and for the revocation thereof.

3. To authorise the Corporation and their Officers to enter upon any building or house which may be liable to be declared a farmed-out house.

4. To make provisions for the registration of farmed-out houses and of the owners, factors tenants and keepers thereof and for the better regulation and control of such houses and to amend the provisions of the Public Health (Scotland) Act 1897, and any other Acts in relation thereto.

5. To confer power of entry into farmed-out houses and powers of inspection of such houses on constables and on the Medical Officer of Health the Sanitary Inspector and other Officers of the Corporation.

6. To make provisions for the renewal of the registration of farmed-out houses the refusal to renew registration of such houses or the keepers thereof and the removal of such houses and the keepers thereof from the register of farmed-out houses; to require certificates of character from keepers of farmed-out houses; to provide that buildings or houses shall not be used as farmed-out houses unless registered, and to provide for the removal of persons from farmed-out houses in certain events.

#### SLAUGHTERHOUSES AND MARKETS.

7. To authorise the Corporation to borrow further money for the purposes of the Glasgow Markets Acts 1865 to 1914 (hereinafter referred to as "the Markets Acts") and the Order, and the Glasgow Corporation Acts 1855 to 1917, on such security and on such terms and conditions as

the Order may prescribe, or as Parliament may sanction.

8. To alter vary and increase all or some of the rates tolls rents and charges the Corporation are authorised by the Markets Acts to levy and recover in respect of their Slaughterhouses and Markets.

9. To authorise the Corporation to levy and recover new and additional rates tolls rents and charges in respect of such Slaughterhouses and Markets and to make such provisions with respect to the levying and recovery thereof as the Order may prescribe or as Parliament may sanction.

10. To authorise the Corporation to provide and maintain Triperies and other conveniences in connection with the Slaughterhouses and to make and recover charges in connection with said Triperies.

#### MISCELLANEOUS.

11. To authorise the Corporation to make and enforce byelaws rules and regulations for all or any of the purposes of the Order, and to provide for the imposition and recovery of penalties and fines in connection therewith.

12. To provide that offences against any of the provisions of the Order or any of the byelaws, rules, or regulations made thereunder may be Police offences under the Glasgow Police Acts 1866 to 1915, that penalties and fines in respect of such offences may be recoverable, and applied under those Acts, and that persons guilty of any such offences may be liable to imprisonment with or without the option of a fine.

13. The Order will vary or extinguish all rights and privileges inconsistent with or which would or might in any way interfere with the objects or purposes of the Order, and will confer other rights and privileges and will incorporate with itself the necessary provisions of the Markets and Fairs Clauses Acts 1847 and any Acts amending the same and apply the same or some parts or portions thereof with or without modification amendment alteration or addition to and for the purposes of the Order.

14. To vary, amend, alter, or repeal the Acts and Orders following and any other Acts and Orders, or some or one of them, or some parts or portions thereof, in so far as they relate or may by virtue of the Order relate to the City or the Corporation, viz. :—the Glasgow Corporation Acts 1875 to 1917; the Glasgow Police Acts 1866 to 1915; the Glasgow Markets Acts 1865 to 1914; the Burgh Police (Scotland) Acts 1892 to 1911; the Criminal Law Amendment Acts 1885 to 1912; the Public Health (Scotland) Act 1897; and the Prevention of Crimes Act 1871, and any Acts amending the same or relating to the Corporation or the City.

The subsequent procedure on the application for the Order will be by way of Provisional Order, unless it is otherwise decided in terms of the Private Legislation Procedure (Scotland) Act 1899, in which case the procedure may be by way of Private Bill, and this notice and the deposits with reference to the said application will, subject to the Standing Orders of Parliament, apply to such Bill.

To authorise the Company at any time to discharge water from any of the works or lands into any available stream or watercourse or into any stream or watercourse with which any of the intended works may communicate or into any stream or watercourse crossed by any aqueduct tunnel or conduit or line of pipes and to make provisions for compensating all persons for any damage which may be caused by the exercise of such power.

10. 20. To incorporate with the Order with or without alteration or modification the Lands Clauses Acts the Waterworks Clauses Acts 1847 and 1863 the Gasworks Clauses Acts 1847 and 1871 the Railways Clauses Consolidation (Scotland) Act 1845 and all other Acts amending those Acts respectively and to extend and apply to the proposed works and to the Company with or without exception or variation all or such of the provisions of the Electric Lighting Acts 1882 to 1909 and the Acts incorporated therewith and of the Electric Lighting (Clauses) Act 1899 as may be thought expedient or applicable and to exempt the Company from or apply to the Company in a modified form all or any of the provisions of those Acts.
