The KING has been pleased to grant unrestricted permission to Miss Lina Mary Potter, Licentiate in Medicine and Surgery of the Society of Apothecaries, London, to wear the Insignia of the Fifth Class of the Order of St. Sava, conferred upon her by His Majesty the King of Serbia in recognition of her services to the Serbian sick and wounded, under the auspices of the Scottish Women's Hospitals for Foreign Service.

#### Whitehall, 11th December 1917.

The KING has been pleased by Letters Patent under the Great Seal of the United Kingdom of Great Britain and Ireland, bearing date the 30th ultimo, to define the styles and titles to be borne henceforth by members of the Royal Family. It is declared by the Letters Patent that the children of any Sovereign of the United Kingdom and the children of the sons of any such Sovereign and the eldest living son of the eldest son of the Prince of Wales shall have and at all times hold and enjoy the style, title or attribute of Royal Highness with their titular dignity of Prince or Princess prefixed to their respective Christian names or with their other titles of honour; that save as aforesaid the titles of Royal Highness, Highness or Serene Highness, and the titular dignity of Prince and Princess shall cease except those titles already granted and remaining unrevoked; and that the grandchildren of the sons of any such Sovereign in the direct male line (save only the eldest living son of the eldest son of the Prince of Wales) shall have the style and title enjoyed by the children of Dukes.

#### Whitehall. December 12, 1917.

The KING has been pleased to award the Albert Medal in Gold to Nicholas Rath, Seaman, R.N.R., and the Albert Medal to Richard Knoulton, Ordinary Seaman, R.N., and George Faucett Pitts Abbott, Deckhand, R.N.R. (Trawler Section), in recognition of their gallantry in saving life in the following circumstances :--

On the 14th September 1917 a seaplane collided with a Poulsen mast and remained wedged in it, the pilot (Acting Flight Commander E. A. de Ville) being rendered unconscious and thrown out of his seat on to one of the wings.

The three men above mentioned at once climbed up the mast for 100 feet, when Rath, making use of the boatswain's chair, which moves on the inside of the mast, was hoisted up by men at the foot of the mast to the place, over 300 feet from the ground, where the seaplane was fixed. He then climbed out on the plane, and held the pilot until the arrival of Knoulton and Abbott, who passed the mast head gantline out to him.

Having secured the pilot with the gantline,

Rath, with the assistance of Knoulton and Abbott, lifted him from the plane to the inside of the mast and lowered him to the ground.

The three men were very well aware of the damaged and insecure condition of the mast, which was bent to an angle where the seaplane had become wedged. One of the three supports of the mast was fractured, and, so far as the men knew, the mast or seaplane might at any time have collapsed.

#### ORDER.

CONTROL OF FLAX SEED FOR SOWING IN OR IN COURSE OF TRANSIT TO IRELAND.

The Minister of Munitions, in exercise of the powers conferred upon him by the Defence of the Realm Regulations, and all other powers thereunto enabling him, hereby orders as follows :-

1. No sale of Flax Seed for sowing shall without a permit, issued by or on behalf of the Depart-ment of Agriculture and Technical Instruction for Ireland, be made by a wholesale dealer to a wholesale dealer, by a retail dealer to a retail dealer, or by a farmer to a retail or wholesale dealer.

2. No person shall, without a permit issued by or on behalf of the Department of Agriculture and Technical Instruction for Ireland, make or take delivery of any Flax Seed for sowing for shipment from Ireland.

3. No wholesale dealer shall sell or deliver any Flax Seed for sowing to a retail dealer at a price exceeding the actual cost price of such seed to the said wholesale dealer by more than 7s. 6d. per bag of 182 lbs., together with the actual cost of transport and an allowance in respect of such actual and necessary charges as may be ap-proved by or on behalf of the Department of Agriculture and Technical Instruction for Ireland, provided that no allowance shall be made in respect of commission paid or payable to agents in Ireland.

4. No retail dealer shall sell or deliver any Flax Seed for sowing to a farmer at a price exceeding the actual cost price of such seed to the said retail dealer by more than 10s. per bag of 182 lbs.

5. Every retail dealer shall so long as he shall have any Flax Seed for sowing on sale display prominently at the shop or other place of sale a statement or statements showing the prices at which he is selling such Flax Seed at such shop or place, and when he is selling different lots of Flax Seed for sowing at different prices the statement or statements shall be in such form or shall be so displayed as to show clearly which are the prices for each lot.

6. All persons engaged in any of the trans-actions herein referred to shall furnish such particulars as to his business as may be required by or on behalf of the Department of Agriculture and Technical Instruction for Ireland, verified as may be directed by the said Department.

7. In this Order the expression "Flax Seed for sowing " shall mean such Flax Seed now or hereafter situated in or in course of transit to Ireland, and shall include all such seed capable of being sown for fibre, and the expressions

"wholesale dealer," "retail dealer," and "farmer" shall mean any person carrying on business in Ireland as a wholesale dealer, retail dealer, or farmer, as the case may be.

8. This Order may be cited as the Sale of Flax Seed (Ireland) Order, 1917.

ORDER AMENDING THE ORDER OF THE MINISTER OF MUNITIONS OF THE 20TH NOVEMBER 1916, AS TO CONTROL OF STEEL SUPPLIES.

Now, the Minister of Munitions, in exercise of the powers conferred upon him by the De-fence of the Realm Regulations and all other powers thereunto enabling him, hereby orders as follows :-

1. As from the date hereof the said Order of the 20th November 1916 shall operate and take effect as if the following were omitted therefrom, namely :-

(a) The words " (other than Shell Discard Quality)" in clause 1.

(b) The words "other than Shell Discard quality," in clause 7. (c) The words "except those in Shell

Discard quality which may be rolled for all classes " in clause 9.

(d) Clauses 11 and 12, and
(e) The words "except in Shell Discard quality" in clause 15---

and as if the following were inserted therein, namely :-

(a) The words "or Electrical" immediately after the word "Bessemer" in clause 1, and

(b) The words "and Steel made by Electrical Process," immediately after the words Bessemer Steel " in clause 18.

2. This Order may be cited as the Control of Steel Supplies (Amendment) Order, 1917.
