A PROCLAMATION

UNDER THE MUNITIONS OF WAR ACT,
1915 TO 1917.

GEORGE R.I.

WHEREAS by section three of the Munitions of War Act, 1915, as amended by the Munitions of War (Amendment) Act, 1916, it is provided that the differences to which Part I. of the first-mentioned Act applies are differences as to rates of wages, hours of work, or otherwise as to terms or conditions of or affecting munitions work, and also any differences as to rates of wages, hours of work, or otherwise as to terms or conditions of or affecting employment on any other work of any description, if that Part of that Act is applied to such a difference by His Majesty by Proclama-

tion, on the ground that in the opinion of His Majesty the existence or continuance of the difference is directly or indirectly prejudicial to the manufacture, transport, or supply of Munitions of War; and it is also provided that the said Part of the said Act may be so applied to such a difference at any time, whether a lock-out or strike is in existence in connection with the difference to which it is applied or not; Provided that if in the case of any industry the Minister of Munitions is satisfied that effective means exist to secure the settlement without stoppage of any difference arising on work other than on munition work, no Proclamation shall be made under the said section with respect to any such difference:

And whereas a difference within the meaning of the said section exists between employers and persons employed as General Cargo Workers and Dock Labourers, in the Port of London, as to rates of wages, hours of work, or otherwise as to terms and conditions of or affecting employment of workers loading, discharging, and handling cargoes at quays and wharves overside and in warehouses at docks or wharves, including all men engaged on dock labour embraced in existing local agreements:

And whereas the Minister of Labour has investigated the matter and the Minister of Munitions, having considered the results of the investigation made by the Minister of Labour and his representations to the Minister of Munitions, is not satisfied that effective means exist to secure the settlement of the said difference without stoppage, being a difference arising on work other than munitions work:

And whereas in Our opinion the existence or continuance of the said difference is directly and indirectly prejudicial to the manufacture, transport, or supply of Munitions of War:

Now, therefore, We, by and with the advice of Our Privy Council, are pleased to proclaim, direct, and ordain, that Part I. of the Munitions of War Act, 1915, shall apply to the said difference.

Given at Our Court at Buckingham Palace, this Twentieth day of April in the year of our Lord One thousand nine hundred and eighteen, and in the Eighth year of Our Reign.

By the Lords of His Majesty's Most Honourable Privy Council.

Whereas it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by a Proclamation, dated the 10th day of May 1917, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited:

And whereas by subsequent Orders of Council the said Proclamation was amended and added to in certain particulars:

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect:—

That the goods mentioned in the Schedule to the Proclamation of the 10th day of May 1917, as amended and added to by subsequent Orders of Council, and marked "(C)" which are at present prohibited to be exported to all destinations in foreign countries in Europe and on the Mediterranean and Black Seas, other than France and French possessions, Russia, Italy and Italian Possessions, Spain and Portugal, and to all ports in any such foreign countries, and to all Russian Baltic ports, should be prohibited to be exported to all destinations in European and Asiatic Russia and in other foreign countries in Europe and on the Mediterranean, except France and French Possessions, Italy and Italian Possessions, Spain

and Portugal, and to all ports in any such foreign countries.

Now, therefore, their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, the Director of the War Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

THE RAW COTTON (FOURTH CENSUS) ORDER,
1918.

Dated 19th day of April 1908, made by the Board of Trade under Regulations 2 G and 2 JJ of the Defence of the Realm Regulations.

The Board of Trade, deeming it desirable to make further exercise of their powers under Regulations 2 G and 2 JJ of the Defence of the Realm Regulations, hereby order as follows:—

1. Every person who spins and every person who spins and manufactures raw cotton shall, on or before the 27th day of April 1918, make a return to the Cotton Control Board in the form contained in the first schedule to this Order, giving such particulars of his business as are required by such form.

2. Every person who deals in raw cotton other than a member of the Liverpool or Manchester Cotton Associations shall, on or before the 27th day of April 1918, make a return to the Cotton Control Board in the form contained in the second schedule to this Order, giving such particulars of his business as are required by such form.

3. Every person who deals in cotton who is a member of the Liverpool or Manchester Cotton Association shall, if and when required by the Cotton Control Board, make a return to them, giving such particulars of his business in such form as the Cotton Control Board may direct.

4. This Order may be cited as the Raw Cotton (Fourth Census) Order, 1918.

Admiralty, 23rd April 1918.

The KING has been graciously pleased to approve of the posthumous award of the Albert Medal in Gold for gallantry in saving life at sea to Commander Francis Herbert Heaveningham Goodheart, D.S.O., R.N.

The account of the services, in respect of which the medal has been conferred, is as follows:—

Owing to an accident, one of H.M. submarines sank and became fast on the bottom in 38 feet of water, parts of the vessel becoming flooded. After several hours the only prospect of saving those remaining on board appeared to be for some one to escape from the submarine in order to concert measures with the rescuers, who were by this time present on the surface. Commander Goodhart, after consultation with the Commanding Officer, volunteered to make the attempt. Accordingly, after placing in his belt a small tin cylinder with instructions for the rescuers, Commander Goodhart went into the conning tower with the Commanding Officer. The conning tower was flooded up to their waists, and the high-pressure air was turned on; the clips of the conning tower were knocked off and the conning tower lid was soon wide open. Commander Goodhart then

stood up in the dome, took a deep breath, and made his escape, but, unfortunately, was blown by the pressure of air against part of the superstructure, and was killed by the force of the blow.

The Commanding Officer, whose intention it had been to return inside the submarine after Commander Goodhart's escape, was involuntarily forced to the surface by the air pressure, and it was thus rendered possible for the plans for rescuing those still inside the submarine to be carried out.

Commander Goodhart displayed extreme and heroic daring in attempting to escape from the submarine in order to save the lives of those remaining on board, and thoroughly realised the forlorn nature of his act. His last remark to the Commanding Officer was: "If I don't get up, the tin cylinder will."

DEFENCE OF THE REALM
REGULATIONS.

ORDER MADE BY THE ADMIRALTY UNDER
REGULATION 45F.

In pursuance of the powers conferred upon them by Regulation 45F of the Defence of the Realm Regulations and of every other power enabling them in that behalf, the Admiralty hereby order as follows:

1. Any members of a naval force of an Ally may if authorised by the proper naval authority of that Ally arrest and hand over to that authority any other member of the naval or military force of such Ally whom he finds committing or has reason to suspect of having committed an offence for which he is amenable to the naval or military courts of the Ally.

2. Any police constable and any officer or petty officer of His Majesty's Naval Forces may arrest any member of a naval or military force of an Ally whom he finds committing or has reason to suspect of having committed a civil offence, if the offence is such that if such man had been a member of His Majesty's Naval forces he could have arrested him.

3. Any police constable and any officer or petty officer of His Majesty's Naval forces may on the request of the proper naval or military authority of an Ally or any person authorised by him arrest any person whom he has reason to believe to be a member of a naval or military force of that Ally and who is alleged by such authority to be guilty of an offence for which he is amenable to the naval or military courts of that Ally.

4. Subject to any general or special agreement any member of a naval or military force of an Ally arrested under this order by a police constable, or by any officer or petty officer of His Majesty's Naval forces for any offence for which he is amenable to the naval or military courts of that Ally shall as soon as practicable be handed over to the proper naval or military authority of that Ally whether within or without the United Kingdom, to be dealt with according to the law of that Ally applicable to the case, and in the meantime may be kept in civil or naval custody.

His Majesty the KING has been graciously pleased to approve of the award of the Victoria Cross to the undermentioned Officers:—

Capt. (A./Lt.-Col.) John Stanhope Collings-Wells, D.S.O., late Bedf. R.

For most conspicuous bravery, skilful leading and handling of his battalion in very critical situations during a withdrawal.

When the rearguard was almost surrounded and in great danger of being captured, Lieutenant-Colonel Collings-Wells, realising the situation, called for volunteers to remain behind and hold up the enemy whilst the remainder of the rear-guard withdrew, and with his small body of volunteers held them up for one and a-half hours until they had expended every round of ammunition. During this time he moved freely amongst his men guiding and encouraging them, and by his great courage undoubtedly saved the situation.

On a subsequent occasion, when his battalion was ordered to carry out a counter-attack, he showed the greatest bravery. Knowing that his men were extremely tired after six days' fighting, he placed himself in front and led the attack, and even when twice wounded refused to leave them but continued to lead and encourage his men until he was killed at the moment of gaining their objective. The successful results of the operation were, without doubt, due to the undaunted courage exhibited by this officer.

Lt. (A./Capt.) Reginald Frederick Johnson Hayward, M.C., Wilts. R.

For most conspicuous bravery in action. This officer, while in command of a company, displayed almost superhuman powers of endurance and consistent courage of the rarest nature. In spite of the fact that he was buried, wounded in the head, and rendered deaf on the first day of operations, and had his arm shattered two days later, he refused to leave his men (even though he received a third serious injury to his head), until he collapsed from sheer physical exhaustion.

Throughout the whole of this period the enemy were attacking his company front without cessation, but Captain Hayward continued to move across the open from one trench to another with absolute disregard of his own personal safety, concentrating entirely on re-organising his defences and encouraging his men.

It was almost entirely due to the magnificent example of ceaseless energy of this officer that many most determined attacks upon his portion of the trench system failed entirely.

Lt. Gordon Muriel Flowerdew, late Can. Cav.

For most conspicuous bravery and dash when in command of a squadron detailed for special service of a very important nature. On reaching the first objective, Lieutenant Flowerdew saw two lines of the enemy, each about sixty strong, with machine guns in the centre and flanks, one line being about two hundred yards behind the other. Realising

the critical nature of the operation and how much depended upon it, Lieutenant Flowerdew ordered a troop under Lieutenant Harvey, V.C., to dismount and carry out a special movement while he led the remaining three troops to the charge. The squadron (less one troop) passed over both lines, killing many of the enemy with the sword; and wheeling about galloped at them again. Although the squadron had then lost about 70 per cent. of its numbers, killed and wounded, from rifle and machine-gun fire directed on it from the front and both flanks, the enemy broke and retired. The survivors of the squadron then established themselves in a position where they were joined, after much hand-to-hand fighting, by Lieutenant Harvey's party. Lieutenant Flowerdew was dangerously wounded through both thighs during the operation, but continued to cheer on his men. There can be no doubt that this officer's great valour was the prime factor in the capture of the position.

(1) In clause 1 the words "gathered wool or" shall be omitted.

(2) In clause 5 the words "excepting gathered wool" shall be omitted.

(3) This Order may be cited as the Sale of Wool (United Kingdom) Amendment Order, 1918.

ARMY COUNCIL ORDER.

WOOL (COLONIAL FELLMONGERS) ORDER, 1918.

(1) Possession is taken of all wool pulled or to be pulled from the skins of sheep or lambs in Great Britain, provided that nothing herein contained shall be deemed to refer to any wool referred to in the Sale of Wool (United Kingdom) Order, 1918.

(2) All persons having in their custody or control any stocks of wool of the description aforesaid are hereby required to furnish such particulars thereof as may be required by or on behalf of the Director of Raw Materials.

(3) This Order may be cited as the Wool (Colonial Fellmongers) Order, 1918.
