The Timber Control Order, 1918, dated 16th July 1918, made by the Board of Trade pursuant to Regulations 2E, 2F, 2G, and 2J of the Defence of the Realm Regulations.

The Board of Trade, deeming it expedient to make further exercise of the powers conferred upon them by the Defence of the Realm Regulations as respects Timber, hereby order as follows :—

#### PART I. TIMBER GROWN OUTSIDE THE UNITED KINGDOM.

1. No person in the United Kingdom shall buy, sell, receive, take or make delivery of, or enter into any transaction or negotiation in relation to the sale, purchase, or transport, of any timber outside the United Kingdom except under and in accordance with the terms of a permit granted by or on behalf of the Controller.

2. Except as provided in paragraph 15 hereof no person shall—

(a) Buy or enter into any contract for the purchase of any timber imported into the United Kingdom except under and in accordance with the terms and conditions of a permit granted by or on behalf of the Controller.

(b) Sell or enter into any contract for the sale of any such timber except to the holder of a permit granted by or on behalf of the Controller, and then only in accordance with the terms and conditions specified in such permit.

3. The Controller may by notice under his hand fix the maximum prices at which any

imported timber may be sold, and may by a like notice vary such prices from time to time.

4. No person shall buy or sell imported timber at a price exceeding the maximum fixed in accordance with the terms of this Order; provided that stocks of imported softwood timber in the United Kingdom at the date of this Order may, save as hereinafter mentioned, be sold in accordance with the orders regulating the price of imported timber in force immediately before the date of this Order, but only to holders of a permit granted by or on behalf of the Controller. Holders of stocks imported from Norway, Sweden, or Russia before the 15th May 1917, and from Canada or the United States before 19th July 1917, shall make a return of such stocks to the Controller, who may authorise such stocks to be sold to holders of a permit at prices to be fixed by the Controller.

Sales by a merchant to a merchant without a permit are prohibited.

5. In this part of this Order the expression "timber" includes plywood, boxboards, and dressed timber, but does not include standing timber.

#### PART II. HOME-GROWN TIMBER.

6. No person shall—

(a) Buy or enter into any contract for the purchase of any standing or felled timber of the descriptions mentioned in Schedule A. of the Home-Grown Timber Prices Order, 1918, except under and in accordance with the terms and conditions of a permit granted by or on behalf of the Controller.

(b) Sell or enter into any contract for the sale of any such timber as aforesaid except to the holder of a permit granted by or on behalf of the Controller, and then only in accordance with the terms and conditions specified in such permit.

7. No person shall by tender offer any home-grown timber, whether standing or felled, for sale, except under and in accordance with the terms of a permit granted by or on behalf of the Controller.

8. No person shall by auction sell or offer for sale any home-grown timber whether standing or felled except under and in accordance with the terms of a permit granted by or on behalf of the Controller, provided that if a permit has been granted to the auctioneer it shall not be necessary for the principal to obtain a permit in respect of the same timber. A permit to sell under this paragraph may provide that the sale shall be conditional on a permit being granted by or on behalf of the Controller to the person who is declared to be the purchaser, and in that case the sale shall not be completed unless and until a permit has been granted to the purchaser, and the conditions of sale shall provide accordingly. Where the Controller refuses in his discretion to grant a permit to such person he may grant a permit to any other person who bid at the auction and who is willing to pay a price equal to the highest price bid.

9. Paragraphs 6, 7, and 8 do not apply to timber included in the sale of the land on which it is growing.

10. Where an estate or land with the timber

growing thereon is sold by private contract, whether in separate lots or as a whole, the vendor shall, if the contents of such timber (excluding hedgerow trees) exceed ten thousand cubic feet, before completion submit to the controller full particulars concerning the timber thereon at the date of the contract, together with the name and address of the purchaser, and unless a permit is thereupon granted by or on behalf of the Controller, the sale so far as it relates to the timber thereon shall be void.

11. Where an estate or land with the timber growing thereon is offered for sale by auction, whether in separate lots or as a whole, the auctioneer or the vendor shall, if the contents of such timber (excluding hedgerow trees) exceed ten thousand cubic feet, before the same is offered at auction submit full particulars of the timber thereon to the Controller together with a valuation thereof on the basis of Schedule A. of the Home-Grown Timber Prices Order, 1918, and unless a permit is granted either to the auctioneer or to the vendor, such timber shall be excluded from the sale of the land. A permit granted under this paragraph may provide that the sale shall not be completed as regards the timber unless and until a permit has been granted by or on behalf of the Controller to the person who is declared to be the purchaser, and the conditions of sale shall provide accordingly. The valuation of the timber shall in all cases be announced at the time of sale.

12. The expression "timber" in paragraphs 10 and 11 includes all trees of pitprop size and over, other than orchard trees.

13. Where a permit is granted for the purchase or sale of standing or felled timber such permit may specify the use for which such timber may be put or the district in which it may be used or resold after severance or removal as the case may be, and any other conditions which the Controller may see fit to impose, and no person shall in respect of such timber act in any manner contrary to the terms and conditions of such permit.

14. Subject to the provisions of paragraph 15 hereof, and except as in this paragraph provided, no person shall—

(a) Buy or enter into any contract for the purchase of (1) any timber in the log of the descriptions mentioned in Schedule B. of the Home-Grown Timber Prices Order, 1918, or (2) any converted timber of the descriptions mentioned in Schedules C. or D. of the said Order, or sawn to any other sizes, except under and in accordance with the terms of a permit granted by or on behalf of the Controller.

(b) Sell or enter into any contract for the sale of any timber in the log or converted timber of the descriptions aforesaid except to the holder of such a permit.

Provided that a permit shall not be required for the purchase by the occupier of a sawmill of timber in the log for the purpose of conversion for sale, or for resale in the log, or by a merchant or retailer of timber in the log or converted timber for the purpose of resale, provided that a certificate is given by the purchaser at the time of sale that the timber is required only

for the purpose of conversion for sale or for resale as the case may be, and such certificate shall be a sufficient authority to the seller to supply such timber to the person from whom he receives such certificate. "Conversion" means the sawing of timber to any of the specifications mentioned in Schedules C. and D. of the Home-Grown Timber Prices Order, 1918, or to any other specifications, and "Converted Timber" means timber sawn to any specifications.

#### PART III. GENERAL.

15. (a) Notwithstanding anything hereinbefore contained a permit shall not be required for the purchase of home-grown or imported timber not exceeding a total value of £5 in any one week, provided that at the time of purchase the purchaser signs a declaration in the form marked A. in the Schedule to this Order, and the signing of such declaration shall be a sufficient authority to supply such timber in accordance therewith.

All persons supplying timber in accordance with this paragraph shall forward to the Controller a statement showing the total value of Home-Grown and Imported timber so supplied not later than seven days after the last day of the calendar month within which such timber was sold.

(b) Where the Admiralty or Ministry of Shipping grant a Certificate in the form marked B. in the Schedule that home-grown or imported timber is urgently required for the repair of one of His Majesty's ships or of any ship which is for the time being under the control or direction of the Shipping Controller, such certificate shall be a sufficient authority to any person named therein to purchase such timber to the amount (not exceeding 5 standards of 165 cubic feet) and of the quality or description named therein. The purchaser shall deliver such certificate to the seller, and any person to whom such certificate is delivered at the time may supply such timber accordingly.

All persons supplying timber in accordance with this paragraph shall forward the certificates to the Controller together with a statement in the form marked C. in the Schedule not later than 7 days after the last day of the calendar month within which such timber was supplied.

(c) No permit shall be required by a colliery or other mine owner to purchase manufactured pitwood (including sawn props, pillar wood, crowns and pit sleepers) or pitprops, but permits will be required in accordance with this Order to purchase standing or converted timber other than the above.

(d) No permit or certificate shall be required for use for estate purposes of timber grown by the owner.

16. Applications for permits shall be made as follows:—

(a) For permits relating to timber situated outside the United Kingdom to the Controller.

(b) For permits relating to imported and home-grown timber in Great Britain (except standing or felled timber in Scotland) to the Controller.

(c) For permits relating to standing or felled timber in Scotland to the Board of Trade (Timber Supplies Department), 1 Queen Street, Edinburgh.

(d) For permits relating to imported and home-grown timber in Ireland, to the Board of Trade (Timber Supplies Department), 6 Hume Street, Dublin.

17. All persons engaged in the purchase, sale, transport, conversion or manufacture of timber of any description shall furnish such particulars as to their business or transactions as may be required from time to time by or on behalf of the Controller.

18. In this Order "the Controller" means the Controller of Timber Supplies.

"Standing or felled timber" includes all trees standing or lying, of pitprop size or over.

19. The following Orders are hereby revoked without prejudice to any act or matter done or suffered or to any proceeding or prosecution instituted thereunder :—

**TRADING WITH THE ENEMY.**

**FEEES AND AGENTS' CHARGES IN RESPECT OF PATENTS, DESIGNS AND TRADE MARKS.**

Whereas by a Licence dated 7th day of December 1915, the Board of Trade, in pursuance of the powers conferred upon them by certain Royal Proclamations relating to Trading with the Enemy, authorised all persons in the United Kingdom or in any part of His Majesty's Dominions to pay any fees necessary for obtaining the grant, registration or renewal of Patents, Designs or Trade

Marks in an enemy country, and to pay to enemy agents their charges and expenses in relation to such matters, and also to pay on behalf of an enemy fees payable in the United Kingdom or in His Majesty's Dominions on applications for the grant, registration or renewal of Patents, Designs or Trade Marks, and to pay the charges and expenses of agents in relation thereto;

And whereas the said Licence was amended by a further Licence of the Board of Trade dated 5th September 1917;

And whereas it appears to the Board of Trade that such payments as aforesaid should no longer be authorised;

Now, therefore, the Board of Trade hereby revoke the said Licences and give notice that all

such payments as aforesaid are from the date hereof prohibited under the Proclamations relating to Trading with the Enemy.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the consent of the Lords Commissioners of His Majesty's Treasury, viz.:—

REGULATIONS RESPECTING OPEN COMPETITIVE EXAMINATIONS FOR THE SITUATION OF FEMALE WRITING ASSISTANT IN THE GENERAL POST OFFICE, IN LONDON, IN THE OFFICE OF THE PUBLIC TRUSTEE, AND IN THE NATIONAL HEALTH INSURANCE COMMISSIONS FOR ENGLAND AND SCOTLAND.

*These Regulations are liable to alteration from time to time.*

1. The limits of age for these situations are 16 and 18. If an examination begins in one of the first 6 months of any year, Candidates must be of the prescribed age on the 1st day of February in that year. If an Examination begins in one of the last 6 months of any year, Candidates must be of the prescribed age on the 1st day of August in that year.

2. Candidates will be required to satisfy the Civil Service Commissioners—

(a) That they are duly qualified in respect of health and character.

(b) That they are natural-born or naturalised British subjects.

A Candidate who was not born or whose father was not born within the British Dominions, or whose mother was at any time before marriage of enemy nationality, will not be eligible for admission to examination for appointment to the Post Office unless she has obtained the special permission of the Civil Service Commissioners to compete.

3. At each Examination the number of Candidates to be selected will be such as may from time to time be fixed.

4. The Examination will be in the following subjects, viz.:—

1. English Composition.
2. Handwriting.
3. Spelling.
4. Arithmetic.
5. Geography.
6. Reading Manuscript.

5. No Candidate will be admitted to Examination who does not, at such time as may be fixed by the Civil Service Commissioners, produce an undertaking, signed by her Parent or Guardian, that she will, if successful, reside either with her parents or guardians, or with relations or friends approved by such parents or guardians.

*Candidates who fail to obtain such an aggregate number of marks as may indicate in the judgment of the Civil Service Commissioners a competent amount of general proficiency will not be regarded as qualified.*

6. Candidates for the Post Office Service must be at least five feet in height.

7. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to attend the examination, dated before the commencement of the competition.

8. Persons who have entered upon or completed a course of education or training for the occupation of teacher, on account of which grants are payable from the Exchequer, will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

9. Application for permission to attend an Examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.

10. A fee of 7s. 6d. will be required from every Candidate attending an Examination.

The Civil Service Commissioners further give notice that an Open Competitive Examination for situations as Female Writing Assistant in certain Public Departments will be held, under the foregoing Regulations, in London, Bristol, Leeds, Edinburgh, Aberdeen, Glasgow, Dublin, Belfast, Cork and Londonderry, commencing on the 19th September 1918.

Appointments will eventually be offered to not fewer than 57 of the Candidates highest on the list, provided they obtain the necessary aggregate of marks and are duly qualified in other respects.

No person will be admitted to Examination from whom the Secretary of the Civil Service Commission has not received, on or before the 15th August, an application, in the Candidate's own handwriting, on a prescribed form, which may be obtained from the Secretary at once.

ORDER OF THE BOARD OF  
AGRICULTURE AND FISHERIES.

(DATED 15TH JULY 1918.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894

to 1914, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

*Application of Sheep (Double Dipping) Order of 1914.*

1.—(1.) The provisions of the Sheep (Double Dipping) Order of 1914 (hereinafter referred to as "the principal Order") are hereby applied to the Area described in the Schedule hereto, subject to the modifications contained in this Order.

(2.) While this Order remains in operation, sheep in the Area described in the Schedule hereto shall be exempt from the provisions of Article 3 of the Sheep Dipping (Scotland and North of England) Order of 1915 so far as they relate to dipping within the first prescribed dipping period.

*Modification of Part I of the Principal Order.*

2. Part I of the Principal Order shall, in its application to the Area described in the Schedule hereto, be read and have effect as if paragraph (3) of Article 2 of that Order were omitted.

*Provision for Movement through Area by Road.*

3. For the purposes of the Principal Order and this Order, sheep shall not be deemed to be moved out of the Area described in the Schedule hereto, where they are moved through the Area without unnecessary delay from a place outside the Area to another place outside the Area by the main road from Forres to Grantown-on-Spey.

*Period Prescribed as Double Dipping Period.*

4. The dates between which all sheep in the Area described in the Schedule hereto are to be dipped within the Area by the owner or person in charge of the sheep under and in accordance with Part II of the Principal Order, are hereby fixed to be the nineteenth day of July and the first day of September in each year.

*Commencement.*

5. This Order shall come into operation on the twentieth day of July, nineteen hundred and eighteen.

THE FORMALDEHYDE (DEALINGS) ORDER, 1918.

In pursuance of the powers conferred upon them by the Defence of the Realm Regulations, the Army Council hereby order as follows:—

1. No person shall purchase, sell or make, or take delivery of or payment for any Formaldehyde (40 per cent. solution) at any price other than £150 per ton delivered free on rail; provided that upon any sale of any quantity exceeding ten gallons and not exceeding one barrel an addition of 7d. per lb. may be made; and provided that upon any sale of any quantity exceeding five gallons and not exceeding ten gallons an addition of 7½d. per lb. may be made; and provided that upon any sale of any quantity not exceeding five gallons an addition of 8d. per lb. may be made; and provided further that upon any sale of any quantity less than one barrel additional charges may be added to the sale price in respect of carriage and containers, such charges to be limited to any expenses actually incurred by the vendor, subject to an addition of 1d. per container in the case of containers holding less than one-half gallon.

2. This Order may be cited as the Formaldehyde (Dealings) Order, 1918.
