# PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Order in Council, dated the twenty-eighth day of November nineteen hundred and fourteen, His Majesty was pleased to make regulations (called the "Defence of the Realm Regulations") under the Defence of the Realm Consolidation Act, 1914, for securing the public safety and the defence of the realm:

And whereas the said Act has been amended by the Defence of the Realm (Amendment) Act, 1915, the Defence of the Realm (Amendment) (No. 2) Act, 1915, and the Munitions of War Act, 1915, and other enactments:

And whereas the said regulations have been amended by various subsequent Orders in Council:

And whereas it is expedient further to amend the said regulations in manner hereinafter appearing:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following amendments be made in the said regulations :--

1. In subsection (1) of Regulation 2J the words "on behalf of the Food Controller" shall be omitted.

2. For removing doubts it is hereby declared that the powers conferred on the Board of Trade by Regulation 2JJ shall include and shall be deemed always to have included power of making

arrangements with the Food Controller, as well as with any other Government Department, for the exercise of the powers of the Board under Regulations 2B, 2F, 2G, 2H and 7, as applied by the said Regulation 2JJ.

3. After Regulation 34A the following regulation shall be inserted :----

"34B.—(1) Where a difference has been referred under subsection (2) of Section one of the Munitions of War Act, 1915, for settlement in accordance with the provisions of the First Schedule to that Act, and it appears to the Minister of Labour that an award cannot be obtained, and that in consequence thereof the production of any article essential to the successful prosecution of the war is hampered, the Minister may annul the reference and substitute therefor a reference to a single arbitrator appointed by himself.

(2) An award given by any such arbitrator shall be binding both on employers and employed and may be made retrospective.

(3) If any employer or person employed thereafter acts in contravention of or fails to comply with the award, or if an employer declares, causes, or takes part in a lock-out within the meaning of the said Act, or a person employed takes part in a strike within the meaning of the said Act, in connection with the difference so referred to a single arbitrator, he shall be guilty of a summary offence against these regulations, but a person guilty of any such offence shall not be sentenced to imprisonment."

# SCHEDULE.

The Military Service Act, 1916, (Session 2), (6 & 7 Geo. 5. c. 15) section twelve.

References to "The Army Council," "The Reserve," "The Regular Forces," "Military necessity," and "Military Discipline" shall respectively be construed as including references to the Air Council, the Air Force Reserve, the Regular Air Force, necessity of the Air Force service, and air force discipline, and the references to the temporary demobilisation of any member of the territorial force shall not apply.

His Majesty the KING has been graciously pleased to approve of the award of the Victoria Cross to the undermentioned Non-commissioned

Officers and Man :-

No. 1327 Corporal Philip Davey, M.M., A.I.F.

For most conspicuous bravery and initiative in attack. In a daylight operation against the enemy position, his platoon advanced 200 yards, capturing part of the enemy line, and whilst the platoon was consolidating, the enemy pushed a machine gun forward under cover of a hedge and opened fire from close range, inflicting heavy casualties and hampering work.

Alone Corporal Davey moved forward in the face of a fierce point-blank fire, and attacked the gun with hand grenades, putting half the crew out of action. Having used all available grenades he returned to the original jumpingoff trench, secured a further supply, and again attacked the gun, the crew of which had in the meantime been reinforced. He killed the crew, eight in all, and captured the gun.

This very gallant N.C.O. then mounted the gun in the new post, and used it in repelling a determined counter-attack, during which he was severely wounded.

By his determination Corporal Davey saved the platoon from annihilation, and made it possible to consolidate and hold a position of vital importance to the success of the whole operation.

No. 1689A Corporal Walter Ernest Brown, D.C.M., A.I.F.

For most conspicuous bravery and determination when with an advanced party from his battalion which was going into the line in relief.

The company to which he was attached carried out during the night a minor: operation resulting in the capture of a small system of enemy trench. Early on the following morning an enemy strong post about 70 yards distant caused the occupants of the newly captured trench great inconvenience by persistent sniping.

Hearing that it had been decided to rush this post, Corporal Brown, on his own initiative, crept out along the shallow trench and made a dash towards the post. An enemy machine gun opened fire from another trench and forced him to take cover. Later he again dashed forward and reached his objective. With a Mills grenade in his hand he stood at the door of a dug-out and called on the occupants to surrender. One of the enemy rushed out, a scuffle ensued, and Corporal Brown knocked him down with his fist. Loud cries of "Kamerad" were then heard, and from the dug-out an officer and eleven other ranks appeared. This party Corporal Brown brought back as prisoners to our line, the enemy mean· machine-gun fire to bear on the party.

St. James's Palace, S. W., 16th August 1918.

No. 3399 L./Cpl. Thomas Leslie Axford, M.M., A.I.F.

For most conspicuous bravery and initiative during operations.

When the barrage lifted and the Infantry advance commenced, his platoon was able to reach the first enemy defences through gaps which had been cut in the wire. The adjoining platoon being delayed in uncut wire, enemy machine guns got into action, and inflicted many casualties, including the Company Commander. Lance-Corporal Axford, with great initiative and magnificent courage, at once dashed to the flank, threw his bombs amongst the machine-gun crews, jumped into the trench, and charged with his bayonet. Unaided he killed ten of the enemy and took six prisoners: he threw the machine guns over the parapet, and called out to the delayed platoon to come on. He then rejoined his own platoon, and fought with it during the remainder of the operations.

Prior to the incidents above mentioned he had assisted in the laying out of the tapes for the jumping off position, which was within 100 yards of the enemy. When the tapes were laid he remained out as a special patrol to ensure that the enemy did not discover any unusual movement on our side. His initiative and gallantry undoubtedly saved many casualties, and most materially assisted towards the complete success of his company in the task assigned to it.

# No. 1936 Driver Henry Dalziel, A.I.F.

For most conspicuous bravery and devotion to duty when in action with a Lewis gun section.

His company met with determined resistance from a strong point which was strongly garrisoned, manned by numerous machine guns, and undamaged by our artillery fire, was also protected by strong wire entanglements. heavy concentration of machine-gun fire caused many casualties, and held up our advance.

His Lewis gun having come into action and silenced enemy guns in one direction, an enemy gun opened fire from another direction. Private Dalziel dashed at it, and with his revolver killed or captured the entire crew and gun, and allowed our advance to continue. He was severely wounded in the hand, but carried on and took part in the capture of the final objective.

He twice went over open ground under heavy enemy artillery and machine-gun fire to secure ammunition, and though suffering from considerable loss of blood, he filled magazines and served his gun until severely wounded through the head.

His magnificent bravery and devotion to duty was an inspiring example to all his comrades, and his dash and unselfish courage at a most critical time undoubtedly saved many lives and turned what would have been a severe check into a splendid success.

The KING has been graciously pleased to give orders for the following appointment to the Most Honourable Order of the Bath in recognition of distinguished services rendered during the War :-

DEFENCE OF THE REALM REGULATIONS.

PROHIBITION OF THE LIFTING OF RYE GRASS AND SEED MIXTURE HAY IN IRELAND.

1. In pursuance of the powers conferred on them by the Defence of the Realm Regulations the Army Council do hereby give notice that all first and second year rye grass and seed mixtures (except as hereinafter mentioned) now standing in bulk in Ireland or as and when harvested is taken possession of absolutely by the Army Council, and shall from the date of this Order or as and when harvested be held at the disposal of the duly authorised Officers of the War:Department.

2. The sale of hay and straw in Ireland other than such first and second year rye grass and seed mixtures as mentioned in paragraph 1 hereof will be unrestricted and uncontrolled subject only to such maximum prices as may from time to time be in force by any Order of the Army Council. No restriction is placed on the use for stock-feeding purposes of first and second year rye grass and seed mixtures by any Producer who has not grown in the aggregate more than two acres during the year 1918, or for such stockfeeding purposes by any person who at the date of this Order does not hold more than 4 tons of such first and second year rye grass and seed mixtures.

3. All Producers who have grown during the year 1918 in the aggregate more than two statute acres of first and second year rye grass and seed mixtures, and all persons who may, at the date of this Order, be in possession of 4 tons or more of first and second year rye grass and seed mixtures, must within fourteen days of this Order render a return to the Administrative Area Officer, Royal Hospital, Dublin, showing the following particulars:— (a) The estimated quantity of first and second year rye grass and seed mixtures produced by them or in their possession.

(b) The estimated quantity of hay (other than first and second year rye grass and seed mixtures) and oat straw produced by them or in their possession.

(c) The number of animals and their classification for which forage is required.

(d) The estimated quantity of forage other than first and second year rye grass and seed mixtures required for feeding of stock actually in their possession for the period ending 30th September 1919.

(e) The place at which such hay and straw is situate.

4. As soon as possible after the return mentioned in paragraph 3 has been received by the Administrative Area Officer the Forage will be inspected and a Producer Consumer's Licence issued for such quantity as it may be determined is required by the Producer or Holder for the feeding of Stock in his possession. The balance of the first and second year rye grass and seed mixtures as is found suitable will be taken for War Department requirements. Pending such inspection, Producers or Holders are authorised to use a reasonable amount of first and second year rye grass and seed mixtures for stock in their possession, provided that they have not other suitable forage for feeding purposes.

5. Producer Consumer's Licences issued under paragraph 4 will be liable to revision on or after the 1st March 1919, and if on any such revision it is determined that any first and second year rye grass and seed mixtures suitable for Army purposes in respect of which a Licence has been issued is in excess of the Holder's proper requirements, such excess must be taken over by the War Department and such Licence may be cancelled in respect thereof.

6. Should a Producer or Holder consider that the quantity licensed for his own requirements is insufficient for his needs, or in the case of hay and straw taken for Army requirements, that the price is inadequate, provided that such price is less than the maximum allowed by any Order that may at the time of taking be in force, he shall have the right to appeal to the Chairman of the Irish Forage Advisory Committee, whose address is c/o the Department of Agriculture and Technical Instruction for Ireland, Dublin, whose decision or the decision of any person appointed to act by the chairman as his deputy shall be final.

7. All hay or straw taken for Army use will be the subject of a purchase note at the time of purchase; interest at certain rates as set out therein will be added to the price stated thereon.

Where a vendor refuses or neglects to sign a purchase note such interest will not be payable, excepting that, where a vendor has appealed to the chairman of the Irish Advisory Forage Committee, as laid down in paragraph 6 of this Order, and the chairman or his deputy has allowed the appeal, then he shall receive interest as aforesaid as if the appeal had not been made or the signature had not been withheld.

8. First and second year rye grass and seed mixtures shall not be sold, exchanged, dealt with or in any way disposed of except under licence issued by the D.P.O.S. of the District.

9. All licences issued under this Order will be

issued subject to the conditions and restrictions contained in such licences.

Any departure from these conditions or other act of contravention of the provisions of this Order will be an offence against the Defence of the Realm Regulations and render the offender liable to the penalties attaching thereto.

Detailed instructions regarding the necessary procedure to be adopted by all desiring to use or sell such first and second year rye grass and seed mixtures which are not suitable for War Department requirements can be obtained from the Area Administrative Officer, Royal Hospital, Dublin, or the D.P.O.S. of the District as set out hereunder.

10. To ensure the maintenance of the supply of milk, or to provide hay or straw for essential purposes in Ireland, the Area Administrative Officer on behalf of the Army Council, may, notwithstanding anything in this Order contained, (1) take possession of any hay (other than rye grass or seed mixtures) or straw on such terms as he may decide, for and on behalf of properly constituted committees; who shall be responsible for payment, for the distribution of any hay or straw acquired on their behalf, (2) may at any time require certified returns of sales or purchases of hay or straw made by any person or persons.

11. On and after 1st November 1918, forage used for the feeding of stock must contain at least 25 per cent. of oaten straw.

12. The Army Council Order dated 17th July 1917, prohibiting the lifting of hay and straw in Great Britain and Ireland and the Isle of Man, in so far as it relates to Ireland, is hereby cancelled.

D.P.O.S. No. 3 District, comprising Clare, Cork, Kerry, Kilkenny, Limerick, Tipperary, and Waterford, 6 Lapps Quay, Cork.

# Rules Publication Act, 1893.

In conformity with the provisions of the Statute 56 and 57 Victoria, cap. 66, notice is hereby given that the Secretary of State for India in Council proposes, with the advice and assistance of the Civil Service Commissioners, at the expiration of forty days from the date of this Gazette, to make the addition shown below in the Regulations for the admission of candidates to the Indian Civil Service, under Section 97 (2) of the Statutc 5 & 6 George V., cap. 61.

It is proposed to add the following proviso to Regulation 11; that is to say :-

"Provided that the Secretary of State for India in Council may exempt from the operation of Regulations 7 and 10 a selected Candidate who was successful at the open Competition held in August 1914, and who, after his nomination as a Selected Candidate, has continuously served and is still serving in His Majesty's Forces, and the Civil Service Commissioners, if satisfied as to the eligibility of the said candidate, exempted as aforesaid, in respect of health, character and conduct, may certify that he is entitled to be appointed to the Indian Civil Service, notwithstanding that he has not complied with the requirements of Regulations 7 and 10."

It is intended that the above proviso shall come into force as soon as made in order that certain selected candidates for the Indian Civil Service, who were successful at the open Competition of 1914, and .who are now serving in His Majesty's Forces, may be appointed to the Indian Civil Service, without further examination.
