### TO THEIR MOST EXCELLENT MAJESTIES KING GEORGE AND QUEEN MARY.

### May it please Your Majesties,-

WE, Ministers and Elders of the General Assembly of the Church of Scotland, now met in Commission, desire with humble respect and loyal devotion to tender the warm congratulations of the Church of Scotland on the twenty-fifth anniversary of your Majesties' wedding. With the whole Scottish people we give thanks to Almighty God for the manifold goodness He has vouchsafed to your Majesties throughout these years; and our earnest prayer is that the Divine blessing may continue to rest upon your Majesties through many years to come, gladdened by an unbroken family circle, and cheered by the loyal affection of all the peoples of the Empire.

### War Office, 16th September 1918.

His Majesty the KING has been graciously pleased to approve of the award of the Victoria Cross to the undermentioned Officer and Noncommissioned Officers :--

Lt. Albert Borella, M.M., A.I.F.

For most conspicuous bravery in attack.

Whilst leading his platoon with the first wave Lt. Borella marked an enemy machine gun firing through our barrage. He ran out ahead of his men into the barrage, shot two German machine-gunners with his revolver, and captured the gun.

He then led his party, now reduced to ten men and, two Lewis guns, against a very strongly held trench, using his revolver and later a rifle, with great effect, causing many enemy casualties. His leading and splendid example resulted in the garrison being quickly shot or captured. Two large dug-outs were also bombed and thirty prisoners taken.

Subsequently the enemy twice counterattacked in strong force, on the second occasion outnumbering Lt. Borella's platoon by ten to one, but his cool determination inspired his men to resist heroically, and the enemy were repulsed with very heavy loss.

No. 200854 Sjt. John Meikle, M.M., late Sea. Highrs. (Nitshill).

For most conspicuous bravery and initiative when his company, having been held up by machine-gun fire, he rushed single-handed a machine-gun nest. He emptied his revolver into the crews of the two guns and put the remainder out of action with a heavy stick. Then, standing up, he waved his comrades on.

Very shortly afterwards another hostile machine gun checked progress, and threatened also the success of the company on the right. Most of his platoon having become casualties, Sjt. Meikle seized the rifle and bayonet of a fallen comrade, and again rushed forward against the gun crew, but was killed almost on the gun position. His bravery allowed two other men who followed him to put this gun out of action. This gallant non-commissioned officer's valour, devotion to duty, and utter disregard for his personal safety was an inspiring example to all.

No. 889958 Cpl. Joseph Kaeble, M.M., late Quebec R.

For most conspicuous bravery and extraordinary devotion to duty when in charge of a Lewis gun section in the front line trenches, on which a strong enemy raid was attempted.

During an intense bombardment Cpl. Kaeble remained at the parapet with his Lewis gun shouldered ready for action, the field of fire being very short. As soon as the barrage lifted from the front line, about fifty of the enemy advanced towards his post. By this time the whole of his section except one-had become casualties. Cpl. Kaeble jumped over the parapet, and holding his Lewis gun at the hip, emptied one magazine after another into the advancing enemy, and, although wounded several times by fragments of shells and bombs, he continued to fire, and entirely blocked the enemy by his determined stand. Finally, firing all the time, he fell backwards into the trench, mortally wounded. While lying on his back in the trench he fired his last cartridges over the parapet at the retreating Germans, and before losing consciousness shouted to the wounded about him: "Keep it up, boys; do not let them get through ! We must stop them!" The complete repulse of the enemy attack at this point was due to the remarkable personal bravery and self-sacrifice of this gallant non-commissioned officer, who died of his wounds shortly afterwards.

Where laundry work is collected or delivered by a vehicle to which \* Regulation 2JJJ of the Defence of the Realm Regulations applies, such work must be collected and delivered on the same day, and no customer may be visited on more than one day per week without the leave of the Divisional Road Transport Officer. This instruction does not apply to laundry work for hospitals.

HONOURS FOR SERVICES IN ACTION WITH THE "Goeben" and "Breslau" in January 1918.

The KING has been graciously pleased to approve of the award of the following honours, decorations, and medals to the undermentioned Officers and Men in recognition of their services on the occasion of the sortie of the "Goeben" and "Breslau" from the Dardanelles on the 20th January 1918 :---

### To be Companions of the Distinguished Service Order.

Lieut-Cdr. Joseph Bernard Newill, R.N. (H.M.S. " Tigress ").

For the great skill and gallantry displayed by him in handling his ship in the presence of a greatly superior enemy force and under heavy fire. He performed most efficiently his main duty of shadowing the enemy and re-porting his movements. He proceeded into the minefield to engage a superior force of enemy destroyers and drove them back to their base. He again entered the minefield at great risk to his ship, and gallantly rescued 162 survivors of the "Breslau" whilst still being fired on from shore batteries.

Lieut. Norman Albert Gustave Ohlenschlager, R.N. (H.M.S. " Lizard ").

He showed great skill and gallantry in handling his ship in the presence of a greatly superior enemy force and under very heavy fire. He performed most efficiently his main duty of shadowing the enemy and reporting . his movements. He proceeded into the minefield to engage a superior force of enemy destroyers and drove them back to their base. He again entered the minefield at great risk to his ship, and gallantly rescued 162 sur-vivors of the "Breslau" whilst still being fired on from shore batteries.

To receive the Distinguished Service Cross.

Lieut. Frederick Faulkner, R.N. (H.M.S. " Lizard ").

He showed great coolness throughout the action. He got the armament into action against the "Breslau," and later against destroyers, ably and quickly and soon obtained a straddle. He personally took charge of firstaid party, reviving survivors, and made excellent arrangements for the custody of prisoners.

Lieut. Arthur Jelfs Cubison, R.N. (H.M.S. "Tigress").

He showed marked ability as gunnery officer of the ship; straddled quickly and hit an enemy destroyer.

Flt. Cdr. Ralph Squire Sorley, R.N.A.S. (now tempy. Capt. R.A.F.).

For the determined and successful bombing attacks on the "Breslau" and "Goeben" on the 20th January 1918, and subsequent days, both by day and by night.

Surg. James Maurice Harrison, R.N. (H.M. Monitor "M28").

A wounded man having fallen into the water, Surg. Harrison went in after him and kept him afloat until picked up. It was due to his untiring efforts that eight severely wounded cases arrived in good condition at the hospital ship twenty-two hours later.

Flt. Lieut. Harry Vernon Worrall, R.N.A.S. (now Hony. Capt., R.A.F.).

Made a successful attack on the "Goeben," obtaining a direct hit, although this was his first night flight.

Acting Lieut. David Blyth Dun, R.N.R. (H.M. Monitor "M28").

He was sent by his Captain in the whaler to rescue men in the water. After landing them, although "M28" was visibly on fire, he returned with a volunteer crew, and remained alongside until she blew up, sinking his boat.

Flt. Sub.-Lieut. Robert Withy Peel, R.N.A.S. (now Lieut., R.A.F.).

Carried out a determined and courageous bombing attack on the "Goeben" in the face of attacks from a vastly superior enemy air force.

Obs. Sub-Lieut. Frederick Charles Smith, R.N.A.S. (now Lieut., R.A.F.).

Acted as observer for Flt. Cdr. Sorley during a determined and successful bombing attack on the "Breslau" on the 20th January 1918, and also during subsequent day and night attacks on the "Goeben."

Skpr. Harry Oliver Hunn, R.N.R., " W.S.A., H.M. Drifter "Anchor of Hope II." 1145

Skpr. Benjamin George Reynolds, R.N.R., 2114 S.A., H.M. Drifter "Supernal."

Remained on patrol in their drifters during the action and made smoke screen in a gallant endeavour to screen H.M. Monitors "Raglan" and "M28," showing great presence of mindand initiative. Both vessels were invaluable in rescuing survivors.



# CORN PRODUCTION ACT, 1917.

THE DISTRICT AGRICULTURAL WAGES COMMITTEE FOR THE COUNTIES OF ABERDEEN, KINCARDINE AND BANFF.

NOTICE OF AN ORDER FIXING MINIMUM RATES OF WAGES FOR AGRICULTURAL WORKMEN IN THE AREA COMPRISING THE COUNTIES OF ABERDEEN, KINCARDINE AND BANFF.

The District Agricultural Wages Committee for these Counties, duly certified by the Board of Agriculture for Scotland under the Second Schedule to the Corn Production Act, 1917, hereby in terms of Section 5 (4) of said Act and relative Regulations by the Board of Agriculture for Scotland give notice to the persons affected that they have fixed a minimum wage of 33s. per week for all male workmen of 18 and upwards engaged in agriculture within the area. The said Minimum Rate is inclusive of all benefits or advantages which may be reckoned as payment of wages in lieu of payment in cash within the meaning of Section 12 (1) (b) of the Corn Production Act, 1917.

# THE WART DISEASE OF POTATOES (SCOTLAND) ORDER OF 1918.

### DATED 16TH SEPTEMBER 1918.

The Board of Agriculture for Scotland, by virtue and in exercise of the powers vested in them under the Destructive Insects and Pests Acts, 1877 and 1907, and of every other power enabling them in that behalf, do order, and it is hereby ordered, as follows :--

#### Commencement.

1. This Order shall come into operation on the first day of October, nineteen hundred and eighteen.

### Definition of Infected Area.

2.—(1) For the purposes of this Order the expression "Infected Area" means an area which is for the time being certified by the Board of Agriculture for Scotland (in this Order referred to as "the Board") to be an area infected with Wart Disease for the purposes of this Order.

(2) The areas described in the First Schedule to this Order shall, unless and until the Board otherwise certify, be Infected Areas for the purposes of this Order, but the provisions of this Order shall not apply to holdings exceeding half an acre in extent situated in an Infected Area, except such holdings or parts of them as have already been declared to be "infected premises" under the Wart Disease of Potatoes Order of 1912 or the Wart Disease of Potatoes (Scotland) Order of 1913, or which may, subsequent to the date of this Order, be found to be infected with Wart-Disease or to which, in the opinion of an Inspector, Wart Disease is likely to spread, and in respect of which a notice applying the provisions of this Order may be served by an Inspector.

### Restriction on planting Potatoes in an Infected Area.

3 - (1) Except under the authority of the Board no person shall plant, or cause or permit to be planted, in any land in his occupation or under his charge which is situated in an Infected Area, and to which the provisions of this Order apply, any potatoes which are not of an approved immune variety, and no person shall permit any potatoes to remain in such land in his occupation or under his charge if the potatoes have been planted in contravention of this Article, and the removal of the potatoes is required by notice served on him by an Inspector; Provided that a person shall not be liable to conviction for planting potatoes or causing or permitting potatoes to be planted in contravention of this Article if he proves to the satisfaction of the Court that the potatoes were sold to him as potatoes of an approved immune variety by a person authorised by the Board under this Order to sell for planting potatoes of an approved immune variety, and that he did not know that the potatoes were not of an approved immune variety.

3503

(2) The restrictions imposed by this Article shall not apply to any planting which is licensed by an Inspector of the Board for the purpose of enabling a first early variety of potatoes to be grown.

(3) An approved immune variety is a variety approved for the time being by the Board as being immune from Wart Disease.

### Restriction on Sale of Approved Immune Varieties.

4.—(1) (a) No person shall sell or offer for sale for planting any potatoes of an approved immune variety except under the authority of and subject to the conditions, if any, imposed by a licence granted by the Board: Provided that this restriction shall not apply to a sale of such potatoes to a dealer in seed potatoes buying for re-sale as seed.

(b) No person shall sell as potatoes of an approved immune variety potatoes that are not of an approved immune variety.

(2) Any person who sells or offers for sale for planting (otherwise than to a dealer in seed potatoes buying for re-sale as seed) potatoes of an approved immune variety shall, if so required by the person to whom the potatoes are sold or offered for sale, produce the authority of the Board or a copy thereof for his inspection and permit him to copy the authority or copy.

### Restriction on use of Potatoes grown in an Infected Area.

5. No person shall knowingly sell or purchase or use for planting in land which is not in an Infected Area any potatoes which have to his knowledge been grown in land in an Infected Area to which the provisions of this Order apply.

### Application of Provisions of Order to land not in an Infected Area.

6.—(1) An Inspector may by notice served on an occupier or other person in charge of any land, not in an Infected Area, on which the Inspector is satisfied that Wart Disease exists, or to which in his opinion the disease is likely to spread, apply the provisions of this Order to such land and such provisions shall, while such notice remains in force, apply to such land as if it were land in an Infected Area to which the provisions of this Order apply.

(2) The provisions of this Order shall, without service of notice under this Article, apply until they are withdrawn by an Inspector of the Board, to any lands which at the commencement of this Order are "infected premises" for the purposes of the Wart Disease of Potatoes (Scotland) Order of 1913.

### Notification of Disease.

7.—(1) The occupier or other person in charge of any land on which Wart Disease exists or appears to exist, and any person having in his possession or under his charge potatoes which are affected with Wart Disease, shall forthwith notify the fact by post or otherwise to the Board or to an Inspector.

(2) If Wart Disease is found to exist in any subsequent year on land to which the provisions of this Order apply or may have been applied, a further notification of disease shall forthwith be given to the Board or to an Inspector by the occupier or other person in charge of such land.

### Sale of Diseased Tubers prohibited.

S. Tubers visibly affected with Wart Disease shall not, except under licence granted by the Board or an Inspector, be sold or offered for sale for any purpose.

# Precautions to be adopted in case of an outbreak of Disease.

9.—(1) An Inspector may at any time and from time to time by notice served on an occupier or other person in charge of land to which the provisions of this Order apply require him to adopt such measures for the prevention of the spread of the disease as are authorised by this Article and specified in the notice.

(2) A notice under this Article may require the occupier or other person in charge of the land to adopt one or more of the following measures, that is to say :---

(a) to destroy or render innocuous any part of the crop, including all diseased tubers, by burning, boiling, or such other suitable method as may be specified in the notice;

(b) to take such other steps as the Inspector may consider necessary to prevent the spread of the disease.

(3) A notice under this Article may also require that no potatoes or potato shaws shall be removed or be permitted to be removed out of the area defined in the notice except with and subject to the conditions (if any) of a licence given by the Inspector.

(4) A notice under this Article may prescribe the time within which the adoption of any measure thereby prescribed shall be completed.

### Service of Notices, etc.

10.—(1) For the purpose of this Order a notice shall be deemed to be served on any person if it is delivered to him personally or left for him at his last known place of abode or business, or sent through the post in a letter addressed to him there; and a notice purporting to be signed by an Inspector shall be *prima facie* evidence that it was signed by him as an Inspector.

(2) A copy of every notice served under this Order shall be sent to the Board by the Inspector by whom the notice is signed.

(3) A notice served under this Order, which applies the provisions as to Infected Areas to premises which are not in an Infected Area, shall remain in force until its operation is determined in writing by an Inspector of the Board.

### Power to deal with Diseased Potatoes.

11. An Inspector may, by a notice served on any person having in his possession, or under his charge, tubers which are affected with Wart Disease, or which are in a pit, bag, or other receptacle with tubers so affected, or which the Inspector has reason to believe to have been in a pit, bag, or other receptacle with tubers so affected or otherwise exposed to infection with Wart Disease,

(a) prohibit the removal of the tubers from the premises on which they are when the notice is served, except under such conditions as the Inspector may consider necessary to prevent the spread of Wart Disease and prescribe by the notice,

(b) require the person having in his possession, or under his charge, any such tubers to destroy by burning or other effective method prescribed in the notice, all diseased tubers and the shaws (if any) belonging thereto, as well as all packing material and packages used for the storing or conveying of such potatoes.

#### Information to be given as to Diseased Potatoes.

12. Every person who has or has had in his possession or under his charge any tubers affected with Wart Disease, and every person who as auctioneer, salesman, or otherwise has sold or offered for sale any such tubers shall, if so required in writing by the Board or an Inspector, give the Board or the Inspector, as the case may be, all such information as he possesses as to the persons in whose possession or under whose charge they are or have been: Provided that any information given under this Article shall not be available as evidence against the person giving the same in any prosecution under this Order, except in respect of an alleged failure to comply with this Article.

### Powers of Entry.

13. An Inspector, upon production if so required of his appointment, may enter any premises and examine any potatoes thereon.

### Notification of Order.

14. This Order and any certificate issued by the Board thereunder shall be published by the Local Authority in accordance with any direction given by the Board.

### Offences.

15. Every person shall be liable on conviction to a penalty not exceeding ten pounds who---

(1) does any act in contravention of this Order ; or

(2) fails to do any act which, by this Order or any notice served on him under this Order, he is required to do; or

(3) wilfully obstructs or impedes any Inspector or other officer in the course of his duties under this Order.

### Definitions.

### 16. In this Order-

"Inspector" means, where the context permits, an Inspector of the Board or of the Local Authority.

"The Board" means the Board of Agriculture for Scotland.

'The Local Authority" means as regards any district the Local Authority for the District under the Diseases of Animals Act, 1894.

" Disease " means the disease affecting potatoes which is known as Synchitrium endobioticum, or Wart Disease of Potatoes, Black Scab, Cauliflower Disease, or Potato Canker; and "diseased" means affected with disease.

"Tubers" means tubers of the potato plant.
