By the Lords of His Majesty's Most Honourable Privy Council.

THEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May 1916, and amended on the 16th day of January 1918, entitled "The Trading with the Enemy (Statutory List) Proclamation, to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last-mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last-mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the effect that the

> Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered,

Note (1). - All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidated List, No. 61a) consolidating all previous Lists, up to and including that of the 9th August 1918, together with List 62 of 23rd August, and List 63 of 6th September, and the List herewith annexed, contain all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of

two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.
Note (2).—Where a person or firm men-

tioned in the List has more than one address in the country, or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specially mentioned.

Note (3).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned

by name in the Statutory List.

Note (4).—In order to minimise as far as possible any inconvenience which may be caused to the British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes for individual firms on the Lists, without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for

which substitutes are required. General inquiries for new connections abroad should be addressed to The Comptroller General, Department of Overseas Trade (Development and Intelligence), 73 Basinghall Street, London, E.C. 2.

Note (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The names on the Lists for all countries in Central or South America are also notified to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

Note (6).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms, such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name, followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

The following Addresses were presented to His Majesty upon the occasion of the celebration of the twenty-fifth anniversary of Their Majesties' Wedding Day:—

ADDRESS OF THE WOMEN WAR WORKERS.

(Presented at Buckingham Palace on 29th June.)

May it please Your Majesties our Sovereign King and Queen,

It is with feelings of profound loyalty and devotion that we avail ourselves of this opportunity of placing before Your Majesties a record of our respect and homage on this the occasion of Your Majesties' Silver Wedding.

For four anxious years it has been our dearest wish and earnest endeavour to devote ourselves mind and body to the service of our King, and to strive humbly, so far as in us lies, to assist our country and our allies in the conflict against our common foe. May we most humbly assure Your Majesties that our united efforts will in no whit be relaxed until once again the blessings of an honourable peace are spread throughout the land, and all our zeal and strength will be devoted to the attainment of that end.

It is our dearest hope that on the next anniversary of this day the dark cloud of war may be dispersed and we can earnestly pray that in the years succeeding we may share with Your Majesties the return of peaceful happiness and

prosperity to our beloved country. It is with the deepest sense of gratification that we are permitted to come here before Your Majesties to express our homage and loyalty.

We have the honour to submit ourselves Your

Majesties' most devoted subjects.

To which Address His Majesty was pleased to return the following gracious answer:—

The Queen and I heartily thank you for the Address to which We have listened with much interest and satisfaction. We are touched by the thought that the first expression of loyalty and devotion on the occasion of Our Silver Wedding should come from this representative Body of Women, who by their services have assisted the State in the full mobilisation of its Man Power.

In Our visits to various centres We have had opportunities of seeing and appreciating the great part which the women of Our land are taking in all branches of war service; and everywhere We have been filled with admiration of their achievements—an admiration which I believe to be shared by the whole Nation.

The Queen follows with deep interest every branch of women's work and has constantly at heart the welfare of women and children, She is proud to be associated with the workers in her position of Commandant-in-Chief of the Women's Army Auxiliary Corps, and it is a satisfaction to Us both that Our daughter is serving as a Commandant of a Voluntary Aid Detachment.

The range of war work undertaken by women is well exemplified in your imposing procession. I understand that every woman in your respective units is a whole-time worker, engaged either in some work of national importance under a State Department or in some service of public utility under local authorities.

When the history of our Country's share in the War is written, no chapter will be more remarkable than that relating to this range and extent of

women's participation.

This service has been rendered only at the cost of Women have much self-sacrifice and endurance. readily worked for long hours and under trying conditions in our factories and elsewhere to produce the supplies of munitions which were urgently needed at the front and to maintain the essential services of the Country. As nurses and V.A.D. workers they have laboured in hospital and dressing station for the care of the sick and wounded with even more than the accustomed devotion which has characterised our Red Cross service since the days of the Crimean War. They have often faced cheerfully and courageously great risks both at home and Overseas in carrying on their work, and the Women's Army has its own Roll of Honour of those who have lost their lives in the service of their country. Some even have fallen under the fire of the enemy. Of all these We think to-day with reverent pride.

We should commemorate, too, the many acts of courage and self-sacrifice performed by women workers in the attempt to save life, and in other ways which appear in the lists of those to whom has been awarded the Medal of the Order of the British Empire.

What has already been achieved must serve as a stimulus and a call to further effort.

As the struggle in which we are engaged becomes more intense the need of the assistance of all the women of the Country grows greater. In many branches of service-in Queen Mary's Army Auxiliary Corps and the Land Army, to mention only two-more women are wanted and will be wanted. I trust this Procession to-day will bring home to those who have not yet realised it, the Country's need of their help. I am confident that women and men alike are prepared to make every sacrifice to that end and that, with God's help, these sacrifices will not be made in vain.

In the sure hope that your labours may soon have their reward in that decisive victory and enduring peace towards which we with all our brave Allies are ever striving, I wish you Godspeed. In that happy day it will be your proud satisfaction to feel that you have nobly shared in ecuring these priceless results.

ADDRESS OF THE LORD MAYOR AND CORPORATION OF THE CITY OF LONDON.

(Presented at the Guildhall on the 6th July, after the Thanksgiving Service in St. Paul's Cathedral.)

To Their Most Excellent Majesties the King and Queen:

May it please Your Majesties,

We, Your Majesties' loyal and dutiful subjects, the Lord Mayor, Aldermen and Commons of the City of London in Common Council assembled, humbly approach Your Majesties with the liveliest sentiments of loyalty and devotion to present to Your Majesties our heartfelt congratulations on the celebration of Your Silver Wedding.

It was in 1786 that Your illustrious ancestors, King George III. and Queen Charlotte, observed a similar anniversary amid the rejoicings of Their loyal subjects. No such event has since occurred in the case of the reigning sovereign.

The Citizens of London have regarded with deep satisfaction and affectionate interest the domestic felicity which has been the outstanding feature of Your Majesties' wedded life, and has been at once an example and an inspiration to all Your Majesties' subjects throughout Your vast dominions.

The sorrows which have followed in the train of this terrible war are very great, but Your loyal subjects gratefully recognise, and have derived much comfort from, the all-absorbing interest which Your Majesties have taken in every phase of the world-wide tragedy.

By visits to Your soldiers at the Front, to the Grand Fleet, to the wounded sufferers in our hospitals, and to the noble army of men and women who have been working day and night to supply the necessities of our forces in the field, on the sea and in the air, You have shown Your solicitude and concern for their welfare, and from castle and cottage alike, prayers have ascended to Almighty God that success may attend our arms and blessings be showered upon Your Royal House.

So, too, the Citizens of London have seen with genuine pleasure and gratification the great anxiety which Your Majesties have always shown for the

social happiness and welfare of Your Peoplenotably in the housing of the working classes, in which King Edward took so paternal an interest, in questions connected with the well-being of the children of the people, and, indeed, in every scheme having for its object the amelioration of, the conditions of life of all classes of the community.

We know how deep the sympathy of Your Majesties has been with the sufferers in the many air raids which have been made upon the Metropolis of the Empire-attacks which have had no effect upon the military situation, but merely resulted in wicked and wanton destruction

of life and property.

If there have been moments of depression and discouragement in the course of this great war, this human weakness has soon given way to a courageous and uncomplaining spirit, but we have been sustained by the lofty example which Your Majesties-living in our midst and sharing in all the fluctuating incidents of these perilous timeshave ever set before us.

The active and heroic services of His Royal Highness the Prince of Wales at the Front since the commencement of the War, his gallant bearing and his chivalry have won for him the admiration of all ranks of the Army, the confidence of the Empire, and the affection of our Allies.

The Citizens of London highly appreciate the honour which Your Majesties have done them by Your presence to-day in our ancient Guildhall, accompanied as You are by Her Royal Highness the Princess Mary, whose coming of age this year, gives additional lustre to this interesting anniversary.

We would desire, in conclusion, most respectfully to renew the heartfelt assurance of our loyal and dutiful regard, and pray that Your Majesties, and your family, may long be spared to enjoy true happiness when the clouds which now darken the heavens have passed away and it has pleased God to restore to the world the blessings of a real and lasting peace.

To which Address His Majesty was pleased to return the following gracious answer:-

I thank you very heartily for your loyal address. It has given the Queen and Myself great pleasure to come again to the City of London, which has so many associations with My Family, and to receive your congratulations and good wishes on the twenty-fifth anniversary of Our wedding day. We are greatly touched by the kind references which you have made to the happiness of Our married life—a happiness which has been so much increased by the unfailing sympathy and affection of Our people. acknowledge with gratitude to Almighty God the many blessings bestowed upon Us during these years.

This anniversary falls at a time when the shadow of war lies heavily on our land, and the very existence of the Empire is assailed by an unscrupulous foe. In this time of trial it is Our earnest desire to share the sorrows of Our people, and so far as in Us lies, to alleviate their suffering. But while Our hearts are heavy at the thought of the bereavement and distress which have befallen the Nation, We have seen with joyful gratitude the whole-hearted response to the call of duty which has reverberated throughout the Empire.

And here in the presence of the distinguished répresentatives of the Dominions and Colonies and the Empire of India, I warmly acclaim the noble and self-sacrificing spirit in which our Brothers across the Seas have given their best in our united defence of liberty and right.

Through four long years of unceasing conflict the ancient qualities of the British race have shown themselves in innumerable heroic deeds and in a dogged endurance which have baffled

the purpose of the enemy.

From the visits which I have made to the sailors in our fleets and the soldiers in our armies I have brought back an ever-increasing admiration for the spirit which pervades all ranks, for their resolution and cheerfulness in all circumstances. What words can express the debt we owe to the Navy which, with unsleeping watchfulness and through every kind of difficulty and danger, has protected our shores and kept open for us and for our Allies the highways of the sea; to the splendid Army, the very flower of the Nation, which has stood and still stands as a wall between us and the fury of our enemies; and to our Air Force, distinguished by so many glorious achievements, and now the third arm of the Defences of the Empire, of which I am proud indeed to be the General-in-Chief. And when we think of the great fighting services, let us remember, too, the unflinching gallantry and determination of the men of the Merchant Service who have refused to be dismayed by a terrorism hitherto unknown in naval warfare; and the courage of the minesweepers, trawlers, and fleet auxiliaries, who have performed without ceasing their perilous tasks.

And a hearty tribute of praise is due to the services of My troops on those more distant fronts which I have been unable to visit in person. The men who are fighting in Italy by the side of our gallant Allies; the Army of Salonika which has so long helped to keep the enemy from the waters of the Eastern Mediterranean; the East African force which has performed feats of courage and endurance in difficult conditions of climate and locality; the armies of Mesopotamia and Palestine which have rescued once rich and famous territories from the tyranny which has devastated and depopulated them, and have restored already something of their ancient prosperity-all these have abundantly earned our gratitude and

admiration.

The conditions at home also give cause for pride and thankfulness. We have seen a ready acceptance by all classes, men and women alike, of the burdens which the War has brought, courage in times of crisis, calmness and selfpossession when by his air attacks the enemy sought to terrify the non-combatant population of this great City, and at all times an unfaltering determination to persevere to the end in the maintenance of our righteous cause. I would recall in particular the efforts so successfully made, in which the City of London has played such a great part, to uphold and enhance the financial credit of the Country and to raise the vast sums needed for the prosecution of the War.

Especially have I been struck on Our visits to the industrial districts of the Country by the evidence in so many quarters of a spirit of mutual concession animating both employers and workers in regard to matters affecting their individual interests, and a readiness to sink differences in

should be carried on. We may cherish, I believe, well-founded hopes that in the furnace of war new links of understanding and sympathy are: being forged between man and man, between class. and class; and that we are coming to recognise as never before that we are all members of one com-: munity and that the welfare of each is dependent upon and inseparable from the welfare of all.

We thank you for your kind references to the Prince of Wales, whose knowledge of our fellowcountrymen has been increased in the comradeship of war, and to Our dear daughter. It has been a source of gratification to the Queen and Myself that Our children have been able to bear some part in the great task to which the Country has been called.

We are deeply moved by the manifestations of goodwill which have been so abundantly displayed towards Us.

We rejoice to feel that We are united with the people of the whole Empire in their ideals and aspirations, in their joys and sorrows, determined to secure such a peace as will save the generations to come from the sufferings, horrors and desolationinflicted upon the world during the past four

When that Peace comes, may it dawn upon an Empire strengthened in character by the fiery trial through which it has passed, and knit together more closely by the memory of common efforts and common sacrifices.

Address of the London County Council.

(Presented at Buckingham Palace on the 8th July.)

To Their Most Excellent Majesties the King and Queen:

May it please Your Majesties—

We, the Chairman, Aldermen and Members of the Council of the Administrative County of London, humbly beg leave, as representing the people of the Capital of Your Majesty's Empire, to present to Your Majesties our heartfelt loyal congratulations upon the twenty-fifth anniversary of Your Majesties' wedding day.

Such an anniversary will be celebrated wherever the British flag flies; and, while in this time of stress and trial the measure of public rejoicing may well be restrained, we are grateful that we are allowed to express once again the devotion to Your Majesty's Throne and the love and duty to Your Majesties' persons which at all times animates the hearts of the inhabitants of London.

We look back over the period of Your Majesties' wedded life, and we draw therefrom an eminent example for all who seek in British home life the source of much that is best and noblest. desire to refer to the gratification with which London has noted that Your Majesty has made in the capital the principal residence of the Royal Family. Not only do we take pride that Your Majesty's home is in our midst, but we rejoice that Your Majesty has thereby been enabled to exercise most fully a truly Royal care for every. phase of the lives of our fellow citizens. This has been evinced in regard both to their material comfort and to their moral and spiritual welfare. Especially has Your Majesty's thoughtful interest order that the essential work of the Country been manifested in services for which we are

largely responsible. To extend facilities for locomotion; to secure London against the dangers of fire; to safeguard the health of the community, particularly in relation to infant life; to promote education; and to ameliorate housing conditions; all these have been among the objects in which we have long had the advantage of Your Majesty's gracious favour and encouragement. In these and many other spheres of municipal activity we feel that, when the conclusion of a just and lasting peace shall permit that activity to attain full scope, we may look to Your Majesty for renewed inspiration.

We pray that God may long preserve Your Majesty and Your Majesty's Gracious Consort in health and happiness.

To which Address His Majesty was pleased to return the following gracious answer:—

I thank you very sincerely for your loyal and dutiful Address and for your congratulations upon the twenty-fifth anniversary of Our wedding day.

It is a great support to Us in the midst of the trials and dangers of this world war to know that the sympathy and affection of the people of London are continually with Us. I trust that the ties between My House and them will be strengthened and drawn closer by our common service in the great cause to which London has given so many heroic sons.

But the absorbing interest of the war must not blind us to the work to be done at home. It is a debt which we owe to the men now under arms to look to the well-being of those whom they are risking their lives to defend, and to make provision for the day of their return.

The discharge of this debt in London imposes upon the Council services of paramount importance.

I heard with pleasure the mention of the efforts which you are making to improve the housing conditions of working men. I realise that in this matter London occupies an exceptional position. But I am confident that its County Council and the other local authorities concerned will recognise to the full their responsibilities in this important sphere of work. Their co-operation will secure the provision of sufficient comfortable and sanitary dwellings, and provide the necessary transport facilities to make these dwellings available for those they are intended to benefit. If these questions are adequately dealt with you will have taken a long step towards the improvement of insanitary areas which forms so essential a part of a complete programme of housing reform.

I inherited from My dear Father a profound interest in the splendid work of the London Hospitals and I rejoice that in spite of the adverse effect of the war upon their financial resources these National Institutions have been able to continue and even to extend their Missions of Charity.

I note with satisfaction that you are making provision for the welfare of infant life. The training of women for motherhood, the adequate supply of pure milk and proper food for mother and child, and all measures necessary to protect the newly born and ensure their growth into healthy men and women I regard as vital to the welfare of the Nation at all times, and especially at the present time. The increasing activity of local authorities, and of voluntary agencies acting in co-operation with them, in this great field of

health administration is to me a source of keen satisfaction.

I welcome also the special efforts that have recently been inaugurated and are being energetically prosecuted to combat and prevent those diseases which not only impair by their ravages the lives of the sufferers of to-day, but are fraught with injury to the health of future generations.

The Queen and I noted with much satisfaction, during Our recent visits to London Schools, the attention given by the Council to the physical as well as the intellectual development of their children by the encouragement of organised games and the instruction of classes in the open air. We are aware how much the teachers have at heart the interests of the children under their charge, and We were gratified to witness the happy relations existing between teachers and pupils.

We look forward with hopefulness to the results to be expected from the Educational Measures now under the consideration of Parliament. These days of severe trial, but also of great opportunity, present to us new tasks and problems. To grapple successfully with these we need a quickened sense of civic life and duty, and a thorough training both physical and moral of the rising generation.

I rejoice that in these and in many other spheres of local government your labours in the past have borne good fruit. We all look confidently for the advent of a just and enduring peace. When that happy time comes, and the men and the material resources now imperatively required for war are set free for the work of reconstruction and development at home, you will be able to carry on your beneficent activities in still wider measure and to still greater success.

### DEFENCE OF THE REALM.

The Local Authorities (Fuel and Lighting) (Scotland) Order, 1918, made by the Secretary for Scotland on the 18th September 1918 under Regulations 2 J and 2 JJ of the Defence of the Realm Regulations.

In pursuance of the powers conferred on me by Regulation 2 J as read with Regulation 2 JJ of the Defence of the Realm Regulations, and by arrangement with the Board of Trade, I hereby order as follows:—

- (1) In this Order the expression "Local Authority" shall mean the Council of a County or Burgh or any District Committee to which a County Council shall delegate its powers under the Household Fuel and Lighting (Scotland) Order, 1918.
- (2) I hereby confer and impose upon the Local Authority and upon such of their officers as they may designate or appoint for the purpose the powers and duties necessary to provide for the due discharge within their district, in conformity with the Defence of the Realm Regulations, of the functions assigned to Local Authorities by the Household Fuel and Lighting (Scotland) Order, 1918.
- (3) (a) Any expenses incurred by a Local Authority in the execution of this Order shall be defrayed out of the public health general assessment provided that such expenses shall not be reckoned in any calculation as to the statutory limit of that assessment.

(b) Where any Local Authorities have combined for any of the purposes of this Order, any expenses incurred by these Local Authorities under this Order shall be defrayed in such proportions as may be agreed upon or in default of agreement as may be determined upon by me.

(4) A District Committee, Parish Council, School Board or other local body may make available without charge or on such terms as may be agreed, to a Local Authority or to any Committee appointed by the Authority, any of their premises and the services of any of their officers for the purposes of the Household Fuel

and Lighting (Scotland) Order, 1918.

(5) The Local Authorities (Retail Coal Prices) (Scotland) Order, 1917, made by the Secretary for Scotland on the 11th September 1917, is

hereby revoked.

(6) This Order may be cited as the Local Authorities (Fuel and Lighting) (Scotland) Order, 1918.

THE SALE OF FLAX SEED (IRELAND) ORDER, 1918.

The Minister of Munitions, in exercise of the powers conferred upon him by the Defence of the Realm Regulations and all other powers thereunto enabling him, hereby orders as follows :--

. 1. No sale of Flax Seed for sowing shall, without a permit issued by or on behalf of the Department of Agriculture and Technical Instruction for Ireland, be made by a wholesale dealer to a wholesale dealer, by a retail dealer to a retail dealer, or by a farmer to a retail or wholesale dealer.

2. No wholesale dealer shall sell or deliver any Flax Seed for sowing to a retail dealer at a price exceeding the actual cost price of such seed to the said wholesale dealer by more than 7s. 6d. per bag of 189 lbs., together with the actual cost of transport and an allowance in respect of such actual and necessary charges as may be approved by or on behalf of the Department of Agriculture and Technical Instruction for Ireland, provided that no allowance shall be made in respect of commission paid or payable to agents in Ireland.

3. No retail dealer shall sell or deliver any Flax Seed for sowing to a farmer at a price exceeding the actual cost price of such seed to the said retail dealer by more than 10s. per bag of 189 lbs., together with the actual cost of transport, as may be approved by or on behalf of the Department of Agriculture and Technical

Instruction for Ireland.

4. Every retail dealer shall, so long as he shall have any Flax Seed for sowing on sale, display prominently at the shop or other place of sale a statement or statements showing the prices at which he is selling such Flax Seed at such shop or place, and when he is selling such Flax Seed at such shop or place, and when he is selling different lots of Flax Seed for sowing at different prices, the statement or statements shall be in such form or shall be so displayed as to show clearly which are the prices for each lot.

5. All persons engaged in any of the transactions herein referred to shall furnish such particulars as to his business as may be required by or on behalf of the Department of Agriculture and Technical Instruction for Ireland, verified as

may be directed by the said Department.

6. In this Order the expression "Flax Seed for sowing" shall mean such Flax Seed now or hereafter situated in or in course of transit to Ireland, and shall include all such Seed capable of being sown for fibre, and the expressions "wholesale dealer," "retail dealer," and "farmer" shall mean any person carrying on business in Ireland as a wholesale dealer, retail dealer, or farmer, as the case may be.

7. This Order may be cited as the Sale of Flax

Seed (Ireland) Order, 1918.

8. The Sale of Flax Seed (Ireland) Order, 1917, and the Flax Seed (Control) Notice, 1917, are hereby cancelled.

The KING has been graciously pleased to approve the award of the Albert Medal for gallantry in saving life at sea to

John Allan, Donkeyman, M.M.R., No. 942760.

The account of the services, in respect of which this medal has been conferred, is as follows:—

As the R.F.A. "Mixol" was dropping alongside to fuel one of H.M. Battle Cruisers on the 19th June 1918, an Able Seaman slipped and fell overboard between "Mixol" and the Cruiser; "Mixol" was only about ten feet clear of the Cruiser, and was closing at the time.

Donkeyman John Allan, who was standing on the fore well deck of "Mixol," saw the man fall and that he was struggling in the water. Although it was clear that the man in the water was in imminent danger of being crushed between the two ships, Allan at once jumped overboard in the clothes he was wearing to save him. He assisted the Able Seaman to keep afloat until a rope was thrown, which he gave to him, the Able Seaman being hauled on board before Allan took the rope himself.

The ship was in an open anchorage, and the temperature of the water was 50°.
