At the Council Chamber, Whitehall, the 18th day of October 1918.

By the Lords of His Majesty's Most Honourable Privy Council.—No. 66.

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May 1916, and amended on the 16th day of January 1918, entitled "The Trading with the Enemy (Statutory List) Proclamation," to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last-mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last-mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the effect that the

Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered,

That the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

Note (1).—All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidated List, No. 61a) consolidating all previous Lists, up to and including that of the 9th August 1918, together with List No. 62 of 23rd August, List No. 63 of 6th September, List No. 64 of 20th September, List No. 65 of 4th October, and the List herewith annexed, contain all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

Note (2).—Where a firm is mentioned in the List, every partner in the firm is also included in the List, and all dealings with any partner in the firm, as well as all dealings with the firm, are prohibited: and conversely, all dealings with a firm, any partner in which is mentioned in the List, are also prohibited.

Note (3).—Where a person or firm mentioned in the List has more than one address in the country, or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specially mentioned.

Note (4).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia, or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

Note (5).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory

List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes for individual firms on the Lists, without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required. General inquiries for new connections abroad should be addressed to The Comptroller-General, Department of Overseas Trade (Development and Intelligence), 73 Basinghall Street, London, E.C. 2.

Note (6).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's Representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The names on the Lists for all countries in Central or South America are also notified to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

Note (7).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms, such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name, followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

DEFENCE OF THE REALM.

INSTRUCTION ISSUED BY THE ROAD TRANSPORT BOARD PURSUANT TO PARAGRAPH 1 OF THE ROAD TRANSPORT (No. 2) ORDER, 1918.

LIMITATION OF ROAD TRANSPORT DELIVERY BY RETAILER TO CUSTOMER.

Where goods are delivered by a retailer to a customer by means of a vehicle to which *Regulation 2jjj of the Defence of the Realm Regulation applies, such delivery shall be limited to a place not exceeding 10 miles from the retailer's premises or place of business where the goods are loaded on to the vehicle; provided that any retailer whose premises or place of business are situated within the Metropolitan Police District or City Police District may deliver to the residence of any customer within either of these districts notwithstanding that such delivery may exceed 10 miles in distance from such premises or place of business.

The limits of distance prescribed by this instruction will not apply where means of transport by rail or common carrier do not exist.

This instruction shall take effect as from the 18th November 1918.

is reasonably estimated, having regard to their consumption in the past, to exceed 100 tons a year, shall not later than Wednesday, 30th October instant, make a Return addressed to the Controller of Coal Mines, Room 412, Holborn Viaduct Hotel, London, E.C. 1, in the form contained in the Schedule hereto;

PROVIDED that this Order shall not apply to-

- (a) fuel in respect of which weekly Returns are already made to the Controller of Coal Mines:
- (b) fuel supplied under the provisions of the Household Fuel and Lighting Order, 1918, and the Household Fuel and Lighting (Scotland) Order, 1918;

- (c) fuel used solely for agricultural purposes; (d) fuel used solely for steam lorries.
- 2. Similar Returns shall be made by all such consumers not later than each Wednesday subsequent to Wednesday, 30th October instant, and each such Return shall apply to the week ended on the Saturday immediately previous.
- 3. In this Order, the expression "fuel" means coal, coke, slack, breeze, and any solid fuel of which coal or coke is a constituent.
- 4. Failure to comply with the provisions of this Order is a Summary Offence against the Defence of the Realm Regulations.
- 5. This Order may be cited as the Fuel Consumers' (Returns) Order, 1918.

DEFENCE OF THE REALM REGULA-TIONS.

ADMIRALTY ORDER.

CAMERAS ON BOARD SHIP.

In exercise of the powers conferred upon them by Regulation 19 of the Defence of the Realm Regulations, the Lords Commissioners of the Admiralty hereby order as follows:—

1. No person shall use any camera on board any British vessel at any time or on board any foreign-owned vessel while the vessel is within the territorial waters of the United Kingdom unless expressly authorised to do so in writing 12-16 July 1916.

for official purposes by a Competent Naval or Military Authority.

- 2. Any person not being a person authorised as aforesaid who takes or is in possession of a camera on board any British vessel or on board any foreign-owned vessel within the territorial waters of the United Kingdom, shall forthwith deliver it into the custody of the Master of the vessel.
- 3. The Master shall take charge of all cameras on board his vessel as aforesaid and retain them in his custody in the case of a British vessel until the owner or person claiming possession of the camera quits the vessel, and in the case of a foreign-owned vessel so long as the vessel is within the territorial waters of the United Kingdom.
- 4. Cameras in the custody of the Master of a vessel may be placed under the Seal of H.M. Customs and Excise by an Officer of Customs, and such seal shall not be broken so long as the Master is required by paragraph 3 of this Order to retain them in his possession.
- 5. This Order shall not apply to cameras on board His Majesty's ships nor to a camera taken or sent on board any vessels as part of the cargo or in baggage which is not accessible during the voyage to the owner or person claiming possession thereof.
- 6. Any person acting in contravention of this Order will be liable to prosecution for an offence against the said Regulations.

ARMY COUNCIL ORDER.

REGULATION OF THE SALE AND USE OF Untereshed Oats in Great Britain.

In pursuance of the powers conferred on them by the Defence of the Realm Regulations and all other powers them enabling, the Army Council hereby order that :-

1. Producers having in their possession unthreshed oats grown by them may use a reasonable quantity as feed for their own stock.

2. Farmers desirous of purchasing unthreshed oats must make application to the D.P.O.S. of the county or district concerned for a licence to do so, stating the name and address of the producer from whom they desire to purchase the same and the quantity required. Such unthreshed oats must not be used for any purpose other than the consumption by stock in the purchaser's possession, and must not be re-sold.

3. The above are the only instances where the consumption of unthreshed oats is permissible outside possible Army requirements.

His Majesty The KING has been pleased to approve of the award of the Military Medal to the undermentioned Ladies for distinguished services in the Field as recorded:—

Doctor Phœbe Chapple, R.A.M.C., attd-Q.M.A.A.C.

For gallantry and devotion to duty during an enemy air raid. While the raid was in progress Doctor Chapple attended to the needs of the wounded regardless of her own safety.

Assistant Administrator Elizabeth Sophy Cross, Q.M.A.A.C.

For gallantry and devotion to duty during an enemy air raid. Whilst in charge of a camp a bomb fell, killing several women and wounding others. She was knocked down, but immediately got up, and, after obtaining assistance, worked with the doctor amongst the killed and wounded while the raid was still in progress.

18659 Forewoman Clerk Ethel Grace Cartledge, Q.M.A.A.C.

For gallantry and devotion to duty during an enemy air raid. She was of the greatest assistance in keeping the workers steady. Although both her shoes were blown off during the explosion, Forewoman Cartledge continued to carry out her duties after being wounded in the foot by some fallen wreckage.

Sister Jane Elizabeth Trotter, Q.A.I.M.N.S. (R.).

For gallantry and devotion to duty during an enemy air raid, which lasted from 11 p.m. till 3 a.m. Sister Trotter was in charge on night duty. During the raid she visited all the wards, reassuring the sick and wounded; her orderly being mortally wounded whilst standing by her in one of the wards. Her conduct during the whole of the raid was most praiseworthy.

Sister Ethel Frances Watkins, Q.A.I.M.N.S. (R.).

For gallantry and devotion to duty during an enemy air raid which lasted for four hours. Sister Watkins behaved with the utmost coolness. When wounded by a piece of shrapnel she made light of her injury and set a magnificent example to those who were with her.

Staff Nurse Agnes Jack Parker, T.F.N.S.

For gallantry and devotion to duty under trying conditions when heavily bombed by hostile aircraft at night. The ward in which Staff Nurse Parker was on duty was badly damaged early in the raid by a bomb falling close to it. By her exceptional coolness and complete disregard for her own safety, she set a splendid example to all, and gave great confidence and comfort to the patients.

Miss Mary Stubbs, F.A.N.Y.

For gallantry and devotion to duty during

an enemy air raid. Miss Stubbs was detailed to evacuate a hospital. While her car was waiting to be loaded a bomb dropped within 30 yards. The stretcher-bearers, who had been loading a car immediately in front, ran for protection to dug-outs, calling to Miss Stubbs to do the same. She, however, regardless of her own safety, stayed in the open with two wounded and helpless patients to help and reassure them. She finally got them unloaded and to a place of safety. During the unloading a second bomb fell on the hospital.

PLYMOUTH AND DEVONPORT (DOCKYARD PORTS)
ORDER IN COUNCIL.

At the Court at Buckingham Palace, the 4th day of September 1918.

PRESENT,

The KING's Most Excellent Majesty in Council.

Whereas by the Dockyard Ports Regulation Act, 1865, it is enacted that it shall be lawful for His Majesty in Council, from time to time, by Order in Council, to define the limits of a Dockyard Port for the purposes of that Act, and to make regulations in relation to any Dockyard Port for all or any of the purposes in the said Act particularly mentioned, and for such other purposes as from time to time seem necessary, with a view to the proper protection of His Majesty's vessels, dockyards, or property, or to the requirements of His Majesty's Naval Service:

And whereas by the same Act it is also enacted that in relation to any Dockyard Port, it shall be lawful for His Majesty in Council, from time to time, by Order in Council, on the joint recommendation of the Admiralty and the Board of Trade, to make rules concerning the Lights or Signals to be carried or used, and the steps for avoiding collision to be taken by His Majesty's vessels, and other vessels, navigating the waters of the Port and of the approaches thereto:

And whereas in pursuance of the said Act certain Regulations and Rules were made by Order in Council dated the 14th day of October 1915, with reference to the two Dockyard Ports of Plymouth and Devonport:

And whereas it appears expedient to amend and add to such Rules as hereinafter provided:

And whereas the provisions of Section 1 of the Rules Publication Act, 1893, have been complied with:

Now, therefore, His Majesty, by virtue of the powers in this behalf by the said Act or otherwise in Him vested, on the joint recommendation of the Admiralty and the Board of Trade, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows:—

1. This Order shall take effect from one calendar month from the date hereof.

2. Clause 9 of the Second Schedule to the said Order in Council dated the 14th day of October 1915, is hereby repealed.

3. The following Rule shall have effect in

relation to the two Dockyard Ports of Plymouth and Devonport, and shall be read and construed as though inserted in the Second Schedule of the said Order in Council of the 14th day of October 1915, in the position indicated by the number

prefixed thereto :-

"9. When one of His Majesty's vessels or other vessel in charge of His Majesty's Officers intends to pass between the Dockyard Port of Devonport and Plymouth Sound she shall hoist the Red Ensign over 'M' flag (International Code-Alphabetical) by day, or a red light by night at the foremast head, and all other of His Majesty's vessels present in the port shall hoist the Pilot Jack by day, or show position lights (two white lights vertical, 8 feet apart, hoisted at the peak, or, if no gaff, hoisted abreast the maintop in the middle line of the ship or on the Ensign Staff) by night, as a general warning. The Pilot Jack shall also be hoisted by day, or position lights by night, on the Flagstaff at Mount Wise for the same purpose, and all other vessels under way in the Dockyard Port of Devonport or in the narrow waters of Plymouth Sound shall keep out of the way of the said vessel flying the Red Ensign over 'M' flag, or showing a red light at the foremast head; provided always that the said vessel shall be navigated with due care and at a moderate speed."
