#### A PROCLAMATION

RELATING TO THE IMPORTATION OF CERTAIN ARTICLES INTO THE UNITED KINGDOM.

GEORGE, R.I.

WHEREAS by Section forty-three of the Customs Consolidation Act, 1876, it is provided that the importation of arms, ammunition, gunpowder, or any other goods may be prohibited by Proclamation:

And whereas by certain Proclamations entitled Probibition of Import Proclamations the importation of certain goods has been prohibited accordingly: And whereas it is expedient that the importation into the United Kingdom of certain other goods should be prohibited :

Now, therefore, We, by and with the advice of Our Privy Council, in pursuance of the said Act and of all other powers enabling Us in that behalf, do hereby proclaim, direct, and ordain as follows:—

As from and after the date hereof, subject as hereinafter provided, the importation into the United Kingdom of the following articles is hereby prohibited, viz. :---

Oleo stearine and tallow.

Olive oil.

Onions.

Provided always, and it is hereby declared, that this prohibition shall not apply to any such goods which are imported under licence given by or on behalf of the Board of Trade, and subject to the provisions and conditions of such licence.

This Proclamation may be cited as the Prohibition of Import (No. 28) Proclamation, 1918.

WHEREAS by an Order in Council, dated the twenty-eighth day of November nineteen hundred and fourteen, His Majesty was pleased to make regulations (called the "Defence of the Realm Regulations") under the Defence of the Realm Consolidation Act, 1914, for securing the public safety and the defence of the realm :

And whereas the said Act has been amended by the Defence of the Realm (Amendment) Act, 1915, the Defence of the Realm (Amendment) (No. 2) Act, 1915, and the Munitions of War Act, 1915, and other enactments:

And whereas the said regulations have been amended by various subsequent Orders in Council :

And whereas it is expedient further to amend the said regulations in manner hereinafter appearing:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following amendments be made in the said regulations :---

1. In Regulation 43B after the word "soldier" wherever that word occurs there shall be inserted the words "or airman."

2. The following Regulation shall be substituted for Regulation 46A :-

"46A. If any person-

٤.

- (a) assists any prisoner of war to escape or knowingly harbours or assists any prisoner of war who has escaped;
- (b) without lawful authority transmits, either by post or otherwise, or conveys to any prisoner of war any money or valuable security, or any article likely to facilitate the escape of any prisoner of war;
- (c) (i) without lawful authority transmits or conveys otherwise than by post to any prisoner of war any letter or written message, or written or printed matter;
  - (ii) without lawful authority transmits or conveys by post or otherwise on behalf of any prisoner of war any letter or written message, or written or printed matter;
- (d) without lawful authority conveys or sells any article of food to any prisoner of war who is in any place of detention for prisoners of war, or who is in receipt of Government rations;
- (e) without lawful authority conveys or sells any intoxicating liquor or tobacco to any prisoner of war;
- being a person by whom any prisoner of (f)war is employed fails to comply with any instructions issued to him by the proper authority as to the conditions of such employment;
- (g) does any act calculated or likely to prejudice the discipline of any prisoner of war or to interfere with the administration of any place of detention for prisoners of war or to interfere with the arrangements for the custody, management, employment, or proper conduct of any prisoner of war:

At the Court at Buckingham Palace, the Sth | he shall be guilty of an offence against these Regulations.

> " his regulation applies to interned persons, and to persons detained by order or under the directions of a Secretary of State while awaiting repatriation or deportation, as it applies to prisoners of war,"

> 3. In paragraph (b) of subsection (1) of Regulation 55B for the words "or any of them" there shall be substituted the words "and, if so required, in any adjoining area, or any of such brigades."

# THE REPRESENTATION OF THE PEOPLE (ADAPTATION OF ACTS, No. 2) (SCOT-LAND) ORDER, 1918.

#### Dated 6th November 1918.

Whereas by Section 42 of the Representation of the People Act, 1918 (hereinafter referred to as "the Act"), the provisions of the Sixth Schedule to the Act with respect to the adaptation of Acts have effect for the purpose of adapting the law to the provisions of the Act, and by paragraph 7 of the said Schedule it is provided that, as respects Scotland, the Secretary for Scotland may by Order make such further adaptations in the provisions of any Act as may seem to him necessary to make those provisions conform with the provisions of the Act, and that any Order so made shall operate as if enacted in the Act;

And whereas certain further adaptations in the provisions of the Parliamentary Elections and Corrupt Practices Act, 1880, appear to me, the undersigned, H.M.'s Secretary for Scotland, to be necessary to make those-provisions conform with the provisions of the Act:

Now Therefore, in pursuance of my powers in that behalf, I hereby Order as follows :---

ARTICLE I.—The following adaptations shall be made in the provisions of the Parliamentary Elections and Corrupt Practices Act, 1880, that is to say,—

The provisions contained in Section 3 shall have effect—

(a) So that the questions numbered 1 and 2 in the Section shall be as follows:—

1. Are you the same person whose name appears as A.B. on the register of electors now in force for the parliamentary county of (or for the division of the parliamentary county of ) or for the parliamentary borough of (or for the parliamentary borough of ) (as the case may be)?

2. Have you already voted, either here or elsewhere, at this election for the parliamentary county of (or for the division of the parliamentary county of ) or for the parliamentary borough of (or for the division of the parliamentary borough of ) (as the case may be)?

ARTICLE II.—This Order may be cited as "The Representation of the People (Adaptation of Acts, No. 2) (Scotland) Order, 1918."

REPRESENTATION OF THE PEOPLE ACT, 1918

#### Section 46 (3).

ORDER by the Secretary for Scotland, dated 6th November 1918, for the Removal of Difficulties in connection with the Holding of the First Elections after the Commencement of the Representation of the People Act, 1918.

Whereas by subsection (3) of Section 46, as read with subsection (1) (c) of Section 43 of the Representation of the People Act, 1918 (hereinafter referred to as "the Act") it is provided that if any difficulty arises in Scotland as to the holding of the first elections after the commencement of the Act (hereinafter referred to as "the first elections"), the Secretary for Scotland may by Order do any matter or thing which appears to him necessary for the proper holding of the elections:

And Whereas by an Order of the 10th September 1918, entitled the Representation of the People (Adaptation of Acts, No. 1) (Scotland) Order, 1918, made by the Secretary for Scotland in pursuance of his powers under Paragraph 7 of the Sixth Schedule to the Act, certain adaptations are made in the provisions of Section 2 and Rule 24 of the First Schedule of the Ballot Act, 1872:

And Whereas it appears to me, the undersigned, His Majesty's Secretary for Scotland, necessary, for the proper holding of the first elections in Scotland, to make the provisions hereinafter contained as to the construction of the said Order of the 10th September 1918.

Now Therefore, in pursuance of my powers in that behalf, I hereby order as follows :---

ARTICLE I.—Where the part or parts of a register applicable to a polling district bear a distinguishing sign other than a separate letter for such polling district, the expression "distinctive letter" wherever occurring in the Representation of the People (Adaptation of Acts, No. 1) (Scotland) Order, 1918, shall be construed as meaning such distinguishing sign, and shall have effect accordingly.

ARTICLE II.—This Order may be cited as the First Elections (Removal of Difficulties) (Scotland) Order, 1918.

The KING has been pleased by Letters Patent under the Great Seal bearing date the fifth day of November 1918, to grant to Paul Ogden Lawrence, Esq., K.C., the office of one of the Justices of His Majesty's High Court of Justice.

## Whitehall, 4th November 1918.

His Majesty The KING has been pleased to award the Edward Medal to John Garner under the following circumstances :—

On the 29th April 1918; one of a battery of seven boilers in the boiler-house of the factory of the British Thomson-Houston Co. Ltd., at Rugby, exploded. Garner, a stoker, at once . . entered the house, which was filled with steam and boiling water and in a serious condition, in the hope of rescuing any person who might be injured. Large masses of masonry were • threatening to fall, and either of the remaining two boilers under steam was likely to explode at any time. The only light available was a hand lamp carried by Garner. After searching some five minutes, Garner discovered an injured man lodged on a projecting beam; but was unable to reach him. He stood by him, however, until the beam canted, and the injured man fell to the ground without further hurt. No other persons were injured by the accident. Garner undoubtedly risked his life to save a fellow-workman. ÷ A second se

Also the Edward Medal in silver to James Simpson, a fireman at the Glencraig Colliery, Fife:—

On the 21st May 1918, a repairer, whilst engaged with two other workmen in carrying out repairs, was killed by a fall of roof. The two workmen were both caught and held by the fall. Simpson, who arrived half an hour later, found the men imprisoned, and realised that if he went for help they would be suffocated before it could arrive. He immediately set to work unaided and worked for three hours without relaxation, though exposed to danger from the falling roof. At last he succeeded in releasing one of the men. Simpson was then so exhausted that he could not release the second man; but he protected him with timber before going for help. Had it not been for Simpson's presence of mind and devotion the two men would have lost their lives.

Also the Edward Medal to Charles Sellars, Deputy, and Laurence Wiseman, a collier, employed at the Grimethorpe Colliery, Barnsley :--

On the 20th April 1918 a collier was buried by a fall of roof. Sellars was soon on the spot, and, after failing in an effort to get at the man by working under falling ground, he got on the top of the fall and worked along with Wiseman. After two hours and a half of persistent effort they succeeded in rescuing the workman. Both Sellars and Wiseman ran the risk of being injured by further falls.

Also the Edward Medal in silver to Frederick | Holdway, a Deputy, and the Edward Medal to George Henry Laver, Under Manager, and Thomas

Harper, Collier, all employed at the Ackton Hall Colliery, Featherstone :---

On the 6th May 1918 three miners were working at the face in the Ackton Hall Colliery when a heavy fall of roof occurred, imprisoning one of the men. Holdway, who was soon on the spot, immediately began the work of rescue, and, with six others, including Harper and Laver, succeeded, after working hard for nearly 24 hours, in rescuing the imprisoned workman. The rescue was carried out with exceptional skill and determination under very dangerous conditions. Holdway specially distinguished himself and showed a fine example of courage and coolness. Harper and Laver were also specially mentioned for their resource and presence of mind.

Also the Edward Medal to John Johnson, Deputy at the Newdigate Colliery, Bedworth, Nuneaton:---

On the 29th July 1915 a heavy fall of roof occurred at the Newdigate Colliery, by which a man named Pacey was buried. Johnson ran at once to the spot, where others were already at work, and, finding that the roof was still very uneasy, ordered props to be set. Leaving the men at work, he found his way to the other side of the fall, where the roof was also very uneasy. Estimating correctly, however, that it was from this side Pacey could most easily be reached, he decided to carry on the work, and himself started to set props. Almost immediately, however, a further heavy fall occurred, burying and severely injuring him. The roof then ceased to be uneasy, and Johnson and Pacey were rescued alive. Pacey unfortunately died in hospital. Johnson was in and out of hospital for nearly two years, and had to undergo many operations as a result of his injuries.

Also the Edward Medal to Edward Colwell and Frederick Lindley :---

On the 17th July 1918 three men were ascending a steel chimney 175 feet high at Vickers' River Don Works, Sheffield, for the purpose of fixing a scaffold in order to paint the exterior chimney. They ascended by means of iron rungs permanently bolted to the chimney, at distances of 12 inches throughout its height, by rivets bolted through the exterior casing of the chimney. The men were about 10 feet apart. When the topmost had reached a height of about 100 feet, one of the rungs supporting the second man broke away and he fell, in his fall breaking 10 other rungs beneath him and striking the third man, who, fortunately, managed to retain his hold and descend to the ground. The man who fell was killed instantaneously.

The topmost man was left on the upper part of the ladder, 100 feet from the ground, with a gap of 10 feet below him preventing his descent. Although it was likely that many of the rungs below him were defective, Colwell and Lindley at once volunteered to rescue him. They ascended the rungs bearing the weight of a long wooden ladder with lifting and lashing tackle. In the course of the ascent they discovered another defective rung, which they easily wrenched out and threw to the ground. They nevertheless proceeded and lashed the wooden ladder against the chimney and across the gap, thus enabling the man, who was cut off by the gap, to descend to the ground.

# Whitehall, 6th November 1918.

The KING has been pleased to award the Albert Medal to Lieutenant-Colonel (Temporary Brigadier-General) Alfred Burt, D.S.O., and Sergeant Victor Brooks, Canadian Cavalry Field Ambulance; and (*posthumous awards*) to Private Arthur Johnson and Driver Alfred Horn, late of the Army Service Corps, in recognition of their gallantry in saving or endeavouring to save life in France in June last. The circumstances are as follows:—

On the 30th June 1918 a Corporal of the Royal Air Force, who had been lowered by a rope into a crater caused by a bomb which had been dropped by a hostile aeroplane, was overcome by carbon monoxide gas, which had accumulated in large quantities in the crater. Endeavours were made to haul him out, but his head became caught, and Private Johnson volunteered to descend and re-adjust the rope, which he did successfully, and the Corporal was rescued, but Johnson was himself overcome. Driver Horn at once put on his respirator and lowered himself to the rescue, but was likewise overcome. Sergeant Brooks then volunteered to attempt to rescue both men, but was also overcome by the gas; fortunately he was hauled out.

At this stage Brigadier-General Burt refused to permit anyone else to descend, but did so himself, and succeeded in dragging one of the unconscious men some way towards the rope; he, however, became unconscious and had to be pulled out.

There can be no doubt that all knew the risk that they were running, and willingly incurred it in the hope of saving life.

# DEFENCE OF THE REALM.

#### RAILWAY WAGONS DISPOSAL (SCOTLAND).

ORDER DATED 9TH NOVEMBER 1918 MADE BY THE BOARD OF TRADE UNDER REGULATION 7B OF THE DEFENCE OF THE REALM REGULATIONS.

In the exercise of the powers conferred upon them by Regulation 7B of the Defence of the Realm Regulations, the Board of Trade hereby order as follows:—

1. The trader responsible for the loading or unloading of any merchandise, including coal, coke and patent fuel, conveyed or to be conveyed by railway, shall load or unload and tender to or place at the disposal of the railway company the wagon employed, together with the covering sheet or sheets, if any, within such time as is specified in the schedule hereto.

2. After the expiration of such time as is mentioned in the schedule hereto, a railway company may make charges for the detention of any wagon or sheet owned by them, or which

for the time being they are entitled to use, or for the use or occupation of any accommodation provided by them in connection with or arising out of such detention of any wagon or sheet.

3. No trader shall, without the written consent of the railway company, use for internal purposes any wagon or sheet belonging to a railway company, or any wagon or sheet of which the Board of Trade have taken possession under any Orders made in that behalf.

4. Nothing in this Order shall extend or apply to a wagon belonging to a private owner whilst the same is upon the private siding or premises of such owner, but save as aforesaid this Order applies to all railway wagons whether owned by a railway company or by a private owner. The expression "private owner" includes a person entitled to the use of a wagon under a hiring contract.

5. In this Order, the term "trader" includes any person sending or desiring to send or receiving merchandise by railway at whose disposal **a** wagon, whether empty or loaded, is placed.

6. The provisions of this Order are in addition to, and not in derogation of, any other provisions for enforcing the prompt loading and unloading of wagons.

7. The Detention of Wagons and Sheets (Scotland) Order, 1917, is hereby revoked without prejudice to any matter or thing done or suffered or penalty incurred or proceedings taken thereunder.

8. Infringements of this Order are summary offences against the Defence of the Realm Regulations.

9. This Order applies to Scotland only and may be cited as "The-Railway Wagons Disposal (Scotland) Order, 1918."

#### SCHEDULE.

NUMBER OF DAYS ALLOWED FOR LOADING OR UNLOADING MERCHANDISE.

(a) Wagons supplied empty for loading with Merchandise (other than Coal, Coke or Patent Fuel for shipment).

At Stations, Private Sidings, Docks, Wharves, &c. :--

Wagon to be loaded and tendered to railway company for conveyance within 1 day exclusive of the day on which the wagon is placed at the trader's disposal.

(b) Wagons supplied empty for loading with Coal, Coke or Patent Fuel for shipment.

At Private Sidings :--

Wagon to be loaded and tendered to railway company for conveyance within 2 days exclusive of the day on which the wagon is placed at the trader's disposal.

(c) Loaded Wagons after Conveyance.

At Stations :---

Traffic other than Coal, Coke or Patent Fuel:

Wagon to be unloaded and placed at railway company's disposal within 2 days exclusive of the day of receipt by the trader of notice of arrival.

Coal, Coke or Patent Fuel:

Wagon to be unloaded and placed at | railway company's disposal within 3 days exclusive of the day of receipt by the trader of notice of arrival.

At Ports (Shipment Traffic only):---

Wagon to be unloaded and placed at railway company's disposal within 4 days exclusive of the day of arrival.

At Private Sidings, Docks, Wharves, &c. :---Traffic other than Coal, Coke or Patent Fuel :

Wagon to be unloaded and placed at railway company's disposal, if empty, within 2 days, or, if reloaded, within 4 days, exclusive in either case of the day on which the wagon is placed at the trader's disposal.

Coal, Coke or Patent Fuel:

Wagon to be unloaded and placed at railway company's disposal, if empty, within 3 days, or, if reloaded, within 4 days, exclusive in either case of the day on which the wagon is placed at the trader's disposal.

The number of days allowed for the return of any covering sheet or sheets to be the same as for wagons.

The term "day" in this Schedule means the twenty-four hours beginning at 6 a.m., excluding the twenty-four hours beginning at 6 a.m. on Sundays, New Year's Day and the day following, and any day declared by or under any Statute or Regulation to be a public holiday in Scotland.

Notice of arrival may be given verbally or in writing, and may be sent by post, telegram or telephone.

THE ROAD TRANSPORT (No. 3) ORDER, 1918, DATED 7TH NOVEMBER 1918, MADE BY THE BOARD OF TRADE UNDER REGULATION 2JJJ OF THE DEFENCE OF THE REALM REGULATIONS.

In pursuance of the powers vested in them by Regulation 2JJJ of the Defence of the Realm Regulations, the Board of Trade hereby order as follows :-

1. Paragraphs 1, 2, and 3 of the Road Transport Order, 1918, may by notice be applied within any particular area specified in such notice to horse-drawn vehicles having a load capacity of less than 15 cwt. either as regards all such vehicles or as regards such vehicles used by any particular class of trader.

2. A notice under this Order shall be given by the Road Transport Board, and shall specify the date by which and the form in which and the person to whom returns relating to the vehicles to which such notice applies are to be made.

3. From and after such day as may be specified in such notice no person shall use any vehicle to which such notice applies for the transport of

Road Transport Board on behalf of the Board of Trade.

4. A notice under this Order shall be advertised in such manner as the Road Transport Board may determine, and by further notice given by the said Board may be cancelled or suspended in whole or in part.

5. This Order shall, so far as may be necessary, be read and construed together with the Road Transport Order, 1918.

6. The Order may be cited as the Road Transport (No. 3) Order, 1918.

## ORDER.

#### ELECTRICITY SUPPLY.

The Minister of Munitions in exercise of the powers conferred upon him by Regulation 11A of the Defence of the Realm Regulations and all other powers thereunto enabling him hereby orders as follows :-

1. No person shall on or after the date hereof except under and in accordance with the terms of a permit issued under the authority of the Minister of Munitions :---

(a) Connect or cause to be connected to any source or means of supply of electricity any place or any building, premises or plant or any part thereof not so connected at the date hereof, or

(b) Supply or cause to be supplied any electricity to any place or any building, premises or plant or any part thereof not supplied with electricity at the date hereof, or

(c) Use or cause to be used any electricity in or at any such place, building or premises or for the purpose of any such plant as hereinbefore mentioned.

Provided that in any case coming within the scope of the Household Fuel and Lighting Order, 1918, or the Household Fuel and Lighting (Scotland) Order, 1918, as defined by Clause 1 of these Orders respectively, where the previous assent of the Local Fuel Overseer is required and has been duly obtained to any fitting, equipment or supply under Clause 99 of the first mentioned Order or Clause 77 of the secondly mentioned Order, no permit hereunder shall be required for such fitting, equipment or supply or the use of such supply.

2. All applications with reference to this Order should be addressed to the Director of Electric Power Supply, Ministry of Munitions, 8 Northumberland Avenue, London, W.C. 2.

3. This Order may be cited as The Electricity (Restriction of New Supply) Order, 1918.

Note.-The permission required by the Order goods by road except under and in accordance is in addition to and not in lieu of the usual with the terms of a permit granted by the Priority Certificates and permit reference number.

### ORDER.

#### SULPHURIC ACID.

The Minister of Munitions, in exercise of the powers conferred upon him by the Defence of the Realm Regulations, and of all other powers enabling him, hereby orders as follows:—

1. As on and from the 1st November 1918, the maximum prices for Sulphuric Acid fixed by the Sulphuric Acid (Amendment of Prices) Order, 1918, shall cease to be operative, and such Order shall be deemed to be cancelled, but such cancellation shall not affect the operation of that Order up to the 31st October 1918, nor the liability to any penalty or punishment in respect of any contravention or failure to comply with the Sulphuric Acid Order, 1917, as amended by the Sulphuric Acid (Amendment of Prices) Order, 1918, occurring prior to the 1st November 1918, nor any proceeding or remedy in respect of such penalty or punishment. 2. As on and from the 1st November 1918, the maximum prices for Sulphuric Acid specified in the schedule to this Order shall be deemed substituted for those specified in the schedule to the Sulphuric Acid Order, 1917, and such last-mentioned Order shall accordingly operate and have effect as though the prices specified in the schedule hereto had originally been fixed by the said Order as the maximum prices to be charged or received in payment by manufacturers of Sulphuric Acid or agents of such manufacturers for Sulphuric Acid supplied by or through them on or after the 1st November 1918.

3. This Order may be cited as the Sulphuric Acid (Amendment of Prices) No. 2 Order, 1918, and as from the 1st November 1918, the Sulphuric Acid Order, 1917, and this Order may be cited together as the Sulphuric Acid Orders, 1917-18.

Over 96 per cent. in both classes, an addition of 1s. 2d. per ton for each complete one-tenth of 1 per cent. of additional mono-hydrate.

## PACKAGES.

All the above maximum prices are for acid delivered into tank wagon, tank cart or tank barge at maker's works.

When the acid maker supplies the railway tank wagons, he shall be entitled to make a further charge of not more than 5s. per ton for hire of such wagons, and also to charge demurrage on tank wagons detained at the purchaser's sidings for more than one clear day, exclusive of the days of arrival and despatch, at a rate not exceeding 6d. per ton capacity per day in respect of each clear day, after the first during which the same are so detained.

When the acid maker supplies the acid in his own drums he shall be entitled to make a further charge of not more than 10s. per ton for filling and hire of drums. When drums are supplied by the purchaser a charge of 2s. per ton may be made to cover the cost of filling.

When the acid is supplied in the acid maker's own carboys, he shall be entitled to make a further charge of  $\pounds 1$  per ton for filling and hire of carboys. When carboys are supplied by the purchaser, a charge of 5s. per ton may be made by the acid maker to cover the cost of filling.

#### EXTRA CARRIAGE.

In cases where a maker of sulphuric acid has, in order to supply his customers, to purchase supplies of acid from a third party, it will be permissible for him, in so far as this is a departure from his normal procedure, to charge to his customers any extra cost of carriage thereby incurred.

1. No person shall purchase or sell or make or take delivery of or payment for any Sulphate of Quinine at prices exceeding those indicated in the Schedule hereto annexed, or such other prices as in any particular case may be determined by or on behalf of the Director of Army Contracts.

2. No person shall, without a permit issued by or on behalf of the Director of Army Contracts, sell or purchase any Sulphate of Quinine in quantities exceeding 1000 oz.

3. All persons having in their possession, custody or control any stocks of Quinine or Quinine Salts exceeding 25 oz., shall furnish such particulars as may be required by or on behalf of the Director of Army Contracts.

4. This Order may be cited as the Quinine (Dealings) Order, 1918.

Lieut. (actg. Capt.) Ferdinand Maurice Felix West, M.C., Royal Air Force (formerly of the Special Reserve, Royal Munster Fusiliers), in recognition of his outstanding bravery in aerial combat.

Captain West, while engaging hostile troops at a low altitude far over the enemy lines, was attacked by seven aircraft. Early in the engagement one of his legs was partially severed by an explosive bullet, and fell powerless into the controls, rendering the machine for the time unmanageable. Lifting his disabled leg, he regained control of the machine, and, although wounded in the other leg, he, with surpassing bravery and devotion to duty, manceuvred his machine so skilfully that his observer was enabled to get several good bursts into the enemy machines, which drove them away. Captain West then, with rare courage and determination, desperately wounded as he was, brought his machine over our lines and landed safely. Exhausted by his exertions, he fainted, but on regaining consciousness insisted on writing his report.

2nd Lt. (Actg. Lt.) Frank Bacon Palmer, Royal Air Force.

On the night of 24th August 1918, this officer performed very gallant and meritorious service. In an attack on one of our aerodromes by hostile aircraft, a hangar full of machines was set on fire, illuminating the whole camp, making the aerodrome an easy mark for the raiders, who continued dropping bombs for fifteen minutes. Great confusion ensued, and twenty officers and men were wounded.

Lt. Palmer was blown over by the explosion of a bomb, and although badly shaken he exhibited coolness and courage of a high order, and by his promptitude succeeded in collecting the wounded, placing them in comparative safety, and also managed to remove the machines and transport from the burning hangars and shelters, notwithstanding the continual dropping of the enemy's bombs in the area.
