His Majesty the KING has been graciously pleased to approve of the award of the Victoria Cross to the undermentioned Officers, N.C.O.'s, and Men:—

T./Maj.(A./Lt.-Col.) Harry Greenwood, D.S.O., M.C., 9th Bn., K.O. Yorks. L.I.

For most conspicuous bravery, devotion to duty and fine leadership on the 23rd/24th

October 1918. When the advance of his battalion on the 23rd October was checked, and many casualties caused by an enemy machine-gun post, I.t.-Col. Greenwood single-handed rushed the post and killed the crew. At the entrance to the village of Ovillers, accompanied by two battalion runners, he again rushed a machine-gun post and killed the occupants.

On reaching the objective west of Duke's Wood his command was almost surrounded by hostile machine-gun posts, and the enemy at once attacked his isolated force. The attack was repulsed, and, led by Lt.-Col. Greenwood, his troops swept forward and captured the last objective, with 150 prisoners, eight machine guns, and one field gun. During the attack on the Green Line, south of Poix Du Nord, on 24th October, he again displayed the greatest gallantry in rushing a machinegun post, and he showed conspicuously good leadership in the handling of his command in the face of heavy fire. He inspired his men in the highest degree, with the result that the objective was captured, and, in spite of heavy casualties, the line was held.

During the further advance on Grand Gay Farm Road, on the afternoon of 24th October, the skilful and bold handling of his battalion was productive of most important results, not only in securing the flank of his brigade, but also in safeguarding the flank of the Division.

His valour and leading during two days of fighting were beyond all praise.

Maj. Blair Anderson Wark, D.S.O., 32nd Bn., A.I.F.

For most conspicuous bravery, initiative and control during the period 29th Sept. to 1st Oct. 1918, in the operations against the Hindenburg Line at Bellicourt and the advance through Nauroy, Etricourt, Magny La Fosse, and Joncourt.

On 29th Sept., after personal reconnaissance under heavy fire, he led his command forward at a critical period and restored the situation. Moving fearlessly at the head of, and at times far in advance of, his troops, he cheered his men on through Nauroy, thence towards Etricourt. Still leading his assaulting companies, he observed a battery of 77mm. guns firing on his rear companies and causing heavy casualties. Collecting a few of his men, he rushed the battery, capturing four guns and ten of the crew. Then moving rapidly forward with only two N.C.O.'s, he surprised and captured fifty Germans near Magny La

On 1st Oct. 1918 he again showed fearless -leading and gallantry in attack, and without hesitation and regardless of personal risk dashed forward and silenced machine guns which were causing heavy casualties.

Throughout he displayed the greatest courage, skilful leading and devotion to duty,

and his work was invaluable.

2nd Lt. James Johnson, 2nd Bn., North'd Fus., attd. 36th Bn.

For most conspicuous bravery and devotion to duty S.W. of Wez Macquart on the morning of 14th Oct. 1918, during operations

by strong patrols.

He repelled frequent counter-attacks and for six hours under heavy fire he held back the enemy. When at length he was ordered to retire he was the last to leave the advance position, carrying a wounded man. Three times subsequently this officer returned and brought in badly wounded men under intense enemy machine-gun fire. His valour, cheerfulness, and utter disregard of danger inspired

2nd Lt. James Palmer Huffam, 5th Bn., W. Rid. R. (T.F.), attd. 2nd Bn.

For most conspicuous bravery and devotion to duty on the 31st Aug. 1918. three men he rushed an enemy machine-gun post and put it out of action. His post was post and put it out of action. His post was then heavily attacked and he withdrew fighting, carrying back a wounded comrade. Again, on the night of 21st Aug. 1918, at St. Servin's Farm, accompanied by two men only, he rushed an enemy machine gun, cap-turing eight prisoners and enabling the advance to continue. Throughout the whole of the fighting from Aug. 29th to Sept. 1st 1918 he showed the utmost gallantry.

No. 4119 Sit. John O'Niell, M.M., 2nd Bn., Leins. R. (Glenboig).

For most conspicuous bravery and devotion to duty near Moorseele on 14th October 1918, when the advance of his company was checked by two machine guns and an enemy field battery firing over open sights. At the head of eleven men only he charged the battery, capturing four field guns, two machine

guns, and sixteen prisoners.

Again, on the morning of the 20th October 1918, Sit. O'Neill, with one man, rushed an enemy machine-gun position, routing about 100 enemy and causing many casualties, Throughout the operations he displayed the most remarkable courage and powers of leadership.

No. 271410 L./Cpl. (A./Cpl.) Roland Edward. Elcock, M.M., 11th Ba., R. Scots (Wolverhampton).

For most conspicuous bravery and initiative south-east of Capelle St. Catherine on the 15th October 1918, when in charge of a Lewis gun team. Entirely on his own initiative, Cpl. Elcock rushed his gun up to within ten yards of enemy guns, which were causing heavy casualties and holding up the advance. He put both guns out of action, captured five prisoners, and undoubtedly saved the whole attack from being held up. Later, near the River Lys, this non-commissioned officer again attacked an enemy machine gun and captured the crew. behaviour throughout the day was absolutely fearless.

No. 1153 L./Cpl. (T./Cpl.) Lawrence Carthage Weathers, 43rd Bn., A.I.F.

For most conspicuous bravery and devotion to duty on the 2nd September 1918, north of Peronne, when with an advanced

bombing party.

The attack having been held up by a strongly held enemy trench, Cpl. Weathers went forward alone under heavy fire and attacked the enemy with bombs. Then, returning to our lines for a further supply of bombs, he again went forward with three comrades, and attacked under very heavy fire. Regardless of personal danger, he mounted the enemy parapet and bombed the trench, and, with the support of his comrades, captured 180 prisoners and three machine guns.

His valour and determination resulted in the successful capture of the final objective, and saved the lives of many of his comrades.

No. 23 L./Cpl. Bernard Sidney Gordon, M.M., 41st Bn., A.I.F.

For most conspicuous bravery and devotion to duty on the 26th/27th August 1918,

east of Bray.

He led his section through heavy shell fire to the objective, which he consolidated. Single-handed he attacked an enemy machine gun which was enfilading the company on his right, killed the man on the gun, and captured the post, which contained one officer and ten men. He then cleared up a trench, capturing twenty-nine prisoners and two machine guns. In clearing up further trenches he captured twenty-two prisoners, including one officer, and three machine guns.

Practically unaided, he captured, in the course of these operations, two officers and sixty-one other ranks, together with six machine guns, and displayed throughout a wonderful example of fearless initiative.

No. 16796 Pte. William Edgar Holmes, late 2nd Br., G. Gds. (Didbrook, nr. Winchmere, Glos.).

For most conspicuous bravery and devotion to duty at Cattenières on the 9th October 1918.

Pte. Holmes carried in two men under the most intense fire, and, while he was attending to a third case, he was severely wounded. In spite of this, he continued to carry wounded, and was shortly afterwards again wounded, with fatal results. By his self-sacrifice and disregard of danger he was the means of saving the lives of several of his comrades.

No. 18321 Pte. Martin Moffat, 2nd Bn., Leins. R. (Sligo).

For most conspicuous bravery and devotion to duty on the 14th October 1918, near Ledeghem, when, advancing with five comrades across the open, the party suddenly came under heavy rifle fire at close range from a strongly held house.

Rushing towards the house through a hail of bullets, Pte. Moffat threw bombs, and then, working to the back of the house, rushed the door single-handed, killing two and capturing thirty of the enemy. He displayed the greatest valour and initiative throughout.

No. 1717 Pte. John Ryan, 55th Bn., A.I.F. For most conspicuous bravery and devotion to duty during an attack against the Hindenburg defences on 30th September 1918.

In the initial assault on the enemy's positions Pte. Ryan went forward with great dash and determination, and was one of the first to reach the enemy trench. His exceptional skill and daring inspired his comrades, and, despite heavy fire, the hostile garrison was soon overcome and the trench occupied. The enemy then counter-attacked, and succeeded in establishing a bombing party in the rear of the position.

Under fire from front and rear, the position was critical, and necessitated prompt action. Quickly appreciating the situation, he organised and led the men near him with bomb and bayonet against the enemy bombers, finally reaching the position with only three men. By skilful bayonet work, his small party succeeded in killing the first three Germans on the enemy's flank, then, moving along the embankment, Pte. Ryan alone rushed the remainder with bombs. He fell wounded after he had driven back the enemy, who sufferd heavily as they retired across "No Man's Land."

A particularly dangerous situation had been saved by this gallant soldier, whose example of determined bravery and initiative was an inspiration to all.

No. 3244A Pte. James Park Woods, 48th Bn., A.I.F.

For conspicuous bravery and devotion to duty near Le Verguier, north-west of St. Quentin, on the 18th September 1918, when, with a weak patrol, he attacked and captured a very formidable enemy post, and subsequently, with two comrades, held the same against heavy enemy counter-attacks.

Although exposed to heavy fire of all descriptions, he fearlessly jumped on the parapet and opened fire on the attacking enemy, inflicting severe casualties. He kept up his fire and held up the enemy until help arrived, and throughout the operations displayed a splendid example of valour, determination, and initiative.

CENTRAL CHANCERY OF THE ORDERS OF KNIGHTHOOD.

The KING has been graciously pleased to institute a Military Division of the Most Excellent Order of the British Empire to date from the creation of the Order, i.e., the 4th June

The following classes of persons will be eligible for appointment to the Military Division of the Order :-

All commissioned, warrant and subordinate Officers subject to the Naval Discipline Act or employed under the Order of the Admiralty, and all commissioned and warrant Officers recommended by any Commander-in-Chief in the field or elsewhere, or by the General Officer Commanding, Independent Force, Royal Air Force, or employed under the War Office or Air Ministry, or under the Administrative Headquarters of Dominions or Overseas Forces, or employed under the Ministry of Munitions or the Ministry of National Service on work which, but for the creation of those Departments, would have been performed by the War Office; and all members of the Naval, Army, Dominions, or Overseas Nursing Services, or officials of the Women's Royal Naval Service, Queen Mary's Army Auxiliary Corps, or the Women's Royal Air Force, and such commandants of the Women's Legion or similar organisations as are under contract with or employed by the Admiralty, War Office or Air Ministry.

Persons already appointed to the Order who are qualified for the Military Division will, on the recommendation of the First Lord of the Admiralty, the Secretary of State for War or the Secretary of State for the Royal Air Force, as the case may be, be transferred to the Military Division.

The insignia for both Military and Civil Divisions will be the same, but the ribbon of the Military Division will be distinguished by a vertical red stripe in the centre of the existing

ADMIRALTY NOTICE TO MARINERS. No. 1486 of the year 1918.

SCOTLAND, WEST COAST AND HEBRIDES.

Former Notice.-No. 954 of 1918; hereby cancelled.

Mariners are hereby warned that, under the Defence of the Realm (Consolidation) Regulations, 1914, the following Regulations have been made by the Lords Commissioners of the Admiralty, and are now in force :-

(1) Firth of Clyde—Prohibited Area; Traffic Regulations.

I. PROHIBITED AREA.

Position.—Denure harbour, lat. 55° 24½' N., long. 4° 45 1' W.

The undermentioned area off Denure harbour is prohibited to all traffic. The area is enclosed by lines joining the following positions:-

- (a) Lat. 55° 25′ 25″ N., long. 4° 48′ 10″ W.
- (b) Lat. 55° 24′ 45″ N., long. 4° 47′ 00″ W. (c) Lat. 55° 24′ 23″ N., long. 4° 48′ 45″ W.

II. TRAFFIC REGULATIONS.

Position.—Dunoon bank, lat. 55° 563′ N., long. 4° 541' W.

Vessels entering or leaving the Clyde must pass between two Trawlers, situated as undermentioned, which mark the gateway in the obstruction that now exists between Cloch point and Dunoon.

(a) Eastern Trawler:

Position .- On east side of Dunoon bank, at a distance of 8 cables and 66 yards, 281° (N. 61° W. Mag.), from Cloch lighthouse.

Description .- The hull of this vessel is painted red.

Fog-signal.-This vessel will sound on her steam whistle four blasts every two minutes, thus (), alternately with the fog-signal sounded by the western Trawler.

(b) Western Trawler:

Position.—On west side of Dunoon bank, at a distance of one cable, 272° (N. 70° W. Mag.), from the eastern Trawler.

Description.—The hull of this vessel is painted green.

Fog-signal.—The vessel will sound on her steam whistle three long blasts every two minutes, alternately with the fog-signal sounded by the eastern Trawler.

The above-mentioned gate Trawlers will display signals, as shown on the accompanying diagram, to indicate whether the gate is open to inward or outward bound traffic, or whether the gate is closed.

A Trawler with hull painted black is moored a short distance to the northward of the gate Trawlers, and on the western side of the passage.

No vessels are to approach to within a distance of half a mile of the gateway until the special signals are hoisted, indicating that the passage is open for them; neither are inward-bound vessels to approach within this distance when the signals are displayed for outward-bound vessels, and vice

Speed must not exceed 10 knots, and vessels are cautioned to keep a mid-channel course when passing through the gateway.

Outward-bound vessels are to approach the gateway on a 196° (S. 34° W. Mag.) course, leaving the black and white chequered lightbuoy with occulting green light, situated three-quarters of a mile, 27° (N. 45° E. Mag.), from the gateway, on their port hand.

Similarly, inward-bound vessels must steer to the eastward for the Examination anchorage and Kempock point, as soon as they have passed clear of the gateway.

Variation.-18° W.

- 1. Until further orders, no vessels other than H.M. ships, those in Government employ, or those granted special permits (vide pars. 2 and 3), will be permitted to navigate the Caledonian Canal;

(3) Caledonian Canal—Traffic Regulations.

and entrance thereto, either at Inverness or Corpach, is prohibited.

- 2. Owners of Merchant, Fishing, or other private vessels, who can show urgent and sufficient reason why their vessels should be allowed to pass through the Canal, may make application to the Divisional Naval Transport Officer at Inverness for a special permit to enable their vessels to do so. Such applications must contain full information as to the length and breadth of the vessel, registered number, destination, why she cannot proceed North-about, and proposed date of entering the Canal; but they will only be entertained in exceptional cases and with full regard to National interests.
- 3. When the requirements of the Naval Authorities allow of such special permits being issued, they will be granted subject to the following conditions:-
 - (a) That priority of passage through the Canal is reserved for Admiralty vessels.
 - (b) That no liability is accepted in respect of demurrage or detention on passage.
 - (c) That the passage is commenced when ordered by the Divisional Naval Transport Officer, Inverness, or his representative, and completed in accordance with issued by instructions these authorities.

- (d) That the regulations governing the navigation of the Canal are strictly complied with.
- (e) That the owner of a vessel permitted to navigate the Canal will be held responsible for any damage caused by the vessel, or by the master, skipper, or members of the crew of such vessels, to the Canal, the machinery or appliances connected therewith, or to other vessels. The value of any such damage to be assessed by representatives of the Admiralty and Canal Commissioners, whose certificate thereof will be final and binding and not subject to review.
- 4. Neutral vessels are also prohibited from entering the Port of Inverness, the seaward limit of which is defined by a line drawn from Fort George, in the County of Inverness, to Chanonry point, in the County of Ross and Cromarty.

Regulations for the Port of Inverness are given in Admiralty Notice to Mariners No. 925 of 1918.

Note.

This Notice to Mariners is a revision of the former Notice quoted above.

CAUTION.

This Admiralty Notice to Mariners is issued under the provisions of the Defence of the Realm (Consolidation) Regulations, 1914, and failure to comply strictly with the directions contained in it will constitute an offence against those Regula tions.
