At the Council Chamber, Whitehall, the 3rd day of January 1919.

By the Lords of His Majesty's Most Honourable Privy Council.

WHEREAS it is provided by Section 2 of the Customs (Exportation Prohibitions) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital. may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas by a Proclamation, dated the 10th day of May 1917, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited :

And whereas by subsequent Orders of Council, and by the Proclamation, dated the 18th day of December 1918, the said Proclamation was amended and added to in certain particulars:

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect :—

That the Proclamation, dated the 10th day of May 1917, as amended and added to by subsequent Orders of Council, and by the Proclamation, dated the 18th day of December 1918, should be further amended by making the following amendments in and additions to the Schedule to the same :---

(1) That the following headings should be deleted :—

Boots and shoes, materials and tools used in the manufacture of, the following :---

(A) Shoemakers' machines and their component parts, and sandpaper coils, sand cloth coils, emery paper coils and emery cloth coils used in connection therewith;

(A) Shoemakers' tools, hand and machine;

(A) Brushes, tooth ;

(A) Card clothing;

(1) Copper stamps for stamping woven piece goods;

(A) Coppers and their component parts;

(A) Cotton waste and articles containing cotton waste;

(A) Grates and registers for heating purposes and their component parts;

(A) Guanos;

( $\blacktriangle$ ) Horn, buttons and combs manufactured of;

(B) Maps and plans of any place within the territory of any belligerent, or within the area of military operations, on a scale of four miles to one inch, or on any larger scale, and reproductions on any scale by two, of the said Act, it is provided that any photography or otherwise of such maps or plans

(A) Matches;

over;

(A) Motor vehicles and motor cycles, component parts of and accessories to;

(A) Oilstones;

(B) Ramie stockings and ramie fabrics suitable for the manufacture of gas mantles;

(A) Ranges, cooking and their component parts

(B) Rubber gloves, surgical ;

(B) Rubber (raw, waste and reclaimed), solutions containing rubber, jellies containing rubber, and any other preparations containing rubber, and also balata, gutta-percha, and the following varieties of rubber, viz. :-Guayule, Jelutong, Palembang, Borneo, Pontianac, and all other substances containing caoutchouc ;

(B) Sparking plugs :

(A) Stoves, heating, capable of consuming coal, coke or other solid fuel, and their component parts;

(A) Tobacco, unmanufactured and manufactured, except cigars and snuffs ;

(B) Tyres for motor vehicles and for motor cycles (whether attached to a vehicle or cycle or not) together with articles and materials especially adapted for use in the manufacture or repair of tyres

(A) Vices.

(2) That the following heading should be added :-

(A) Guanos, except whale guano.

Now, therefore, their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, the Director of the War Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

WHEREAS His Majesty has been pleased, in exercise of the power in that behalf conferred on Him by Section one, sub-section one, of the Trading with the Enemy (Extension of Powers) Act, 1915, by divers Proclamations, and in particular by a Proclamation dated the 23rd day of May 1916, and amended on the 16th day of January 1918, entitled "The Trading with the Enemy (Statutory List) Proclamation, to prohibit all persons or bodies of persons, incorporated or unincorporated, resident, carrying on business, or being in the United Kingdom from trading with any of the persons or bodies of persons mentioned in the List contained in the last-mentioned Proclamation, such List being therein referred to as the Statutory List:

And whereas by Section one, sub-section Cavasos, Manuel, Sr., Nuevo Laredo.

List of persons and bodies of persons, incor-porated or unincorporated, with whom such trading is prohibited by a Proclamation under the (A) Motor cars of 30 horse power and said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State :

And whereas the Statutory List contained in the last-mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the effect that the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered,

That the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

Note (1). - All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidated List, No. 68A) consolidating all previous Lists, up to and including that of the 15th November 1918, together with List No. 69 of November 29th, List No. 70 of December 13th, List No. 71 of December 20th, and the List herewith annexed, contain all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

Note (2).—Where a firm is mentioned in the List, every partner in the firm is also included in the List, and all dealings with any partner in the firm, as well as all dealings with the firm, are prohibited: and conversely, all dealings with a firm, any partner in which is mentioned in the List, are also prohibited.

Note (3).—Where a person or firm mentioned in the List has more than one address in the country, or group of countries under which the nume of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specially mentioned.

Note (4).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia, or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

NOTE (5).-In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of in-formation is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes for individual firms on the Lists, without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required. General enquiries for new connections abroad should be addressed to The Comptroller-General, Department of Overseas Trade (Development and Intelligence), 73 Basinghall Street, London, E.C. 2.

Note (6).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The names on the Lists for all countries in Central or South America are also notified to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

NOTE (7).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name, followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

(1) Such permission shall apply only to securities which have not at the time of sale been included in any Order issued by the Treasury under the Regulations.

(2) The proceeds of any such sales shall be remitted to this country forthwith and retained here.

(3) The proceeds of drawn securities or maturing securities collected abroad shall be remitted to this country forthwith and retained here in the same manner as the proceeds of any sales of securities.

(4) All existing Regulations in regard to dealing with securities which have not been continuously in physical possession in the United Kingdom, or which have been in enemy ownership, or in which any enemy interest is concerned, will continue to apply in full force to all dealings under this permission.

(5) Before any securities are sent abroad for registration and return, a form of permit for the re-import of such securities under the terms of the Prohibition of Import (No. 21) Proclamation, 1917, must be obtained from the American Dollar Securities Committee, 19 Old Jewry, E.C.

The KING has been pleased to award the Albert Medal in recognition of the gallant action of Mr. Arthur Hamilton Ambury, late of New Plymouth, in endeavouring, at the cost of his own life, to save the life of another when mountaineering in New Zealand in June last.

On the 3rd June 1918, Mr. Ambury, with his wife and two friends, were climbing on Mount Egmont, Taranaki, New Zealand, and had reached an altitude of about 5,500 feet when a call for help was heard from above.

Two members of Mr. Ambury's party immediately commenced to climb to render assistance, and Mr. Ambury, after placing his wife in a Christoher and Nevis.

safe place, went up after them. At a height of about 7,300 teet they found two climbers, one of whom had been hurt. They took charge of the injured man, and his companion, who had an ice axe, proceeded higher up the mountain, to assist a third member of the party.

The injured man had been assisted down some 1,000 feet, and Mr. Ambury had nearly reached the party who were descending a steep ice slope in which they had to cut steps, when one of the two men in the rear slipped and slid down the slope at a terrific pace.

Mr. Ambury, who was about 60 feet lower down, braced himself and endeavoured to stop the falling man by seizing his alpenstock which was trailing behind him, but the alpenstock was jerked out of his hand and he was precip i ted down the slope of the mountain. He was an experienced mountaineer and must have realised how terrible a risk he was running in endeavouring to save the falling man.

# Whitehall, January 1, 1919.

The KING has been pleased to award the Albert Medal to Second Lieutenant Geoffrey Rackham, Royal Army Service Corps, M.T., attached 545th Siege Battery, Royal Garrison Artillery, in recognition of his gallantry in saving life in France in October last.

At Le Cateau on the 27th October 1918, a lorry (one of a convoy of seven) laden with shells and cartridges caught fire. Lieutenant Rackham, who was awakened by the fire alarm, hurried to the scene of the fire in his pyjamas to find that flames three to four feet high were issuing from the petrol tank. He put the cap on the petrol tank, jumped into the driver's seat, started up the blazing lorry and drove it, while cartridges were exploding, to a place of safety, afterwards helping to extinguish the flames. By his prompt and courageous conduct, serious damage, and in all probability loss of life, was averted; for the other loaded lorries were close by, and some 130 men of the battery were only thirty yards distant.

# TRADING WITH THE ENEMY.

Repair of Enemy Merchant Ships under the Control of the Allied Maritime Transport Council.

Whereas by Royal Proclamation relating to Trading with the Enemy, dated the 9th day of September 1914, it was, amongst other things, declared as follows :--

"The expression 'enemy country' in this Proclamation means the territories of the German Empire and of the Dual Monarchy of Austria-Hungary together with all the Colonies and Dependencies thereof."

And whereas it was also declared by the said Proclamation that from and after the date of the said Proclamation the persons therein referred to were prohibited from doing certain acts therein more specifically mentioned :

And whereas it was further declared by the said Proclamation as follows :---

# PART I.

# CLOSING OF PORTS.

#### Former Notice.—No. 814 of 1918; hereby cancelled.

(1) My Lords Commissioners of the Admiralty, having taken into consideration the fact that it may be necessary to forbid all entrance to certain ports of the Empire, this is to give Notice that on approaching the shores of the United Kingdom, or any of the ports or localities of the British Empire, referred to in Part III. of this Notice, a sharp look-out should be kept for the signals described in the following paragraph, and for the vessels mentioned in paragraph (5), Part II., of this Notice, and the distinguishing and other signals made by them. In the event of such signals being displayed, the port or locality should be approached with great caution, as it may be apprehended that obstructions may exist.

(2) If entrance to a port is prohibited, three red vertical lights by night, or three red vertical balls by day, will be exhibited in some conspicuous position, in or near to its approach, which signals will also be shown by the vessels indicated in paragraph (5), Part II., of this Notice.

If these signals are displayed, vessels must approach the port with the greatest caution and implicitly obey all orders or signals given them by the Examination vessel or signal station.

(3) At all the ports or localities at home or abroad referred to in Part III. of this Notice, search-lights are occasionally exhibited for exercise.

Instructions have been given to avoid directing moveable search-lights during practice on to vessels under way, but mariners are warned that great care should be taken to keep a sharp look-out for the signals indicated in paragraph (2) above, when search-lights are observed to be working.

# EXAMINATION SERVICE.

(4) In certain circumstances it is also necessary to take special measures to examine vessels desiring to enter the ports or localities at home or abroad, referred to in Part III. of this Notice.


(5) In such case, vessels carrying the distinguishing flags or lights mentioned in paragraph (7) will be charged with the duty of examining ships which desire to enter the ports and of allotting positions in which they shall anchor. If Government vessels, or vessels belonging to the local port authority, are found patrolling in the offing, merchant vessels are advised to communicate with such vessels with a view to obtaining information as to the course on which they should approach the Port. Such communication will not be necessary in cases where the pilot on board has already received this information from the local authorities.

(6) As the institution of the Examination Service at any port will never be publicly advertised, especial care should be taken in approaching the ports, by day or night, to keep a sharp look-out for any vessel carrying the flags or lights mentioned in paragraph (7), and to be ready to "bring to" at once when hailed by her or warned by the firing of a gun or sound rocket.

In entering by night any of the ports mentioned in Part III., serious delay and risk will be avoided if four efficient all round lamps, two red and two white, are kept available for use.

(7) By day the distinguishing flags of the Examination Steamer will be a special flag (white and red horizontal surrounded by a blue border) and a blue ensign.

Also, three red vertical balls if the port is closed.



By night the steamer will carry :---

(a) Three red vertical lights if the port is closed.

(b) Three white vertical lights if the port is open.

The above lights will be carried in addition to the ordinary navigation lights, and will show an unbroken light around the horizon.

(8) Masters are warned that, when approaching a British port where the Examination Service is in force, they must have the distinguishing signal of their vessel ready to hoist immediately the Examination Steamer makes the signal.

(9) Masters are warned that, before attempting to enter any of these ports when the Examination Service is in force, they must in their own interests strictly obey all instructions given to them by the Examination Steamer.

Whilst at anchor in the Examination Anchorage, Masters are warned that they must not lower any boats, communicate with the shore, work cables, move the ship, or allow anyone to leave the ship, without permission from the Examination Steamer (except to avoid accident).

(10) In case of fog, Masters are enjoined to use the utmost care, and the Port should be approached with caution.

(11) Merchant vessels when approaching ports are especially cautioned against making use of private signals of any description, either by day or night; the use of them will render a vessel liable to be fired on.

(12) The pilots attached to the ports will be acquainted with the regulations to be followed.

#### PART IV.

#### SWEEPING OPERATIONS.

Notice is hereby given that under the Defence of the Realm (Consolidation) Regulations, 1914, the following Regulations have been made by the Lords Commissioners of the Admiralty, and are now in force.

H.M. Vessels are constantly engaged, both singly and in pairs, in sweeping operations off the coasts of the United Kingdom, and whilst so engaged they are hampered to a very considerable extent in their manœuvring powers.

With a view to indicating the nature of the work on which they are engaged, these vessels will show the signals hereinafter mentioned, and for the public safety all other vessels, whether steamers or sailing craft, must keep out of the way of vessels flying these signals and not approach them inside the distances mentioned herein, specially remembering that it is dangerous to pass inside these distances or between the vessels of a pair, as the vessels may have mines trailing in their sweeps and also on account of the danger caused to traffic if mine-sweepers have to slip their sweeps to get out of the way of vessels.

1. SIGNALS THAT WILL BE SHOWN BY DAY.

- (a) By vessels working singly:
  - A black ball at the foremast head, and a similar ball at each yardarm or where they can best be seen.

Vessels showing this signal are not to be approached nearer than 300 yards.

(b) By vessels working in pairs:

- A black ball at the foremast head, and a similar ball at the yardarm or where it can best be seen, on that side on which it is dangerous to pass.
- Vessels are not to pass within a distance of 400 yards astern of a single pair of sweepers, or when more than one pair

are working in company within a distance of 400 yards astern of rear pair. They are on no account to attempt to pass between pairs working in company.

2. SIGNALS THAT WILL BE SHOWN BY NIGHT.

As for day, except that all round green lights will be used in place of the black balls.

#### CAUTION.

Part IV. of this Admiralty Notice to Mariners is issued under the provisions of the Defence of the Realm (Consolidation) Regulations, 1914, and failure to comply strictly with the directions contained in it will constitute an offence against those Regulations.

Any person found guilty of such an offence is liable to severe penalties both of imprisonment and fine.

Any person aiding or abetting the commission of such an offence is himself guilty of an offence against the Regulations.

Attention is also drawn to the fact that any infringement of the directions contained in Part IV. of this Admiralty Notice to Mariners is liable to result in the detention of the ship or vessel.

#### ENGLAND, SOUTH-EAST COAST.

DOVER CHANNEL-TRAFFIC REGULATIONS.

Former Notices.—Nos. 1037, 1131, 1289 and 1418 of 1918.

1. Two light-vessels and four light-buoys have been established to mark a gateway in the Dover channel off Folkestone, as shown on the charts.

2. Shipping is hereby warned that the only passage for traffic proceeding between the Downs and Dungeness is between the North-East and South-East gate light-buoys and then between North and South Folkestone gate light-vessels shown on the chart, and between North-West and South-West gate light-buoys and vice versa, and that Article 25 of the Collision Regulations must be complied with, that is to say, East-bound traffic must keep to the Southern side of the passage and West-bound traffic must keep to the Northern side. Ships disregarding this warning will do so at their own peril.

3. Caution.—Mariners are warned to exercise great caution when approaching the ships' passage between the Folkestone gate light-vessels, as the tidal streams may at times set obliquely across the

passage. Both light-vessels should be given as wide a berth as the width of the passage and compliance with Article 25 of the Collision Regulations permit.

4. The latest route information and route instructions are to be obtained from the examination vessels off Calais and Boulogne, or in the Downs or from Patrol vessels westward of Folkestone gate or in the vicinity of Cape Gris Nez. Any deviation from these instructions may entail the destruction of the vessel. No vessels are to pass through the area given in paragraph 5 of this Notice except by the authorised routes.

5. No vessel is to anchor or to fish in the following area:---

The area is bounded by lines joining the following points :---

(a) Admiralty pier lighthouse, Dover.

(b) Les Quenocs buoy No. 4.

(c) Cape Gris Nez lighthouse.

(d) The light-buoy at the north-east end of the Bassure de Baas in lat. 50°  $48\frac{1}{2}'$  N., long. 1° 33' E.

(e) The light-buoy at the south-west end of Le Colbart in lat. 50° 494' N., long. 1°  $15\frac{1}{2}$ ' E.

(f) Sandgate castle.

6. No Merchant vessel is to pass to the northeastward of an imaginary line drawn in a direction  $292^{\circ}$  (N.  $55^{\circ}$  W. Mag.) from the outer end of Gravelines pier as far as the South Sand Head of the Goodwin Sands, unless in receipt of special authority to do so from the Vice Admiral, Dover, or the Examination or Patrol vessels mentioned in paragraph 4.

7. British Merchant vessels approaching the Straits of Dover are to hoist their number in the International Code.

8. Caution.—Mariners are warned that lightbuoys which are not shown on the chart may be met with between the parallels of lat.  $51^{\circ}$  04' N. and 51° 20' N.

# ADMIRALTY NOTICE TO MARINERS. No. 7 of the year 1919.

SCOTLAND, NORTH-EAST COAST, WITH ORKNEY AND SHETLAND ISLES.

Former Notice.—No. 1505 of 1918.

Notice is hereby given that, under the Defence of the Realm (Consolidation) Regulations, 1914, the following Regulations have been made by the Lords Commissioners of the Admiralty, and are now in force :---

(1) SCOTLAND, NORTH-EAST COAST --- TRAFFIO REGULATIONS.

#### I. INVERNESS AND APPROACHES—PILOTAGE AND TRAFFIC REGULATIONS.

#### Port of Inverness and Approaches.

1. All Merchant Vessels, including Fishing craft, are to speak the Examination vessel off Cromarty, and are to obtain permission from her to proceed into the Port of Inverness, the selward entrances to which are dangerous.

2. Merchant vessels shall obey all orders given them by the Naval Port Authorities as regards anchoring or shifting berth.

3. Vessels proceeding in the same direction must not attempt to overtake and pass a vessel ahead in any of the channels in the Firth, or within the seaward entrances of the North and South channels.

This is not intended to apply to small fishing craft, and vessels of similar size, which must carefully observe the rule of the road whilst keeping out of the way of larger vessels.

4. No vessel (other than H.M. Ships and allied Men-of-War) or boat shall without special permission move in or approach the port during the hours of official night, and no boat (other than those belonging to H.M. Ships and allied Men-of-War) shall without special permission approach the shore or go alongside any pier or wharf in the Port of Inverness.

5. Pilotage is compulsory for all vessels of 8 feet draught and over (other than H.M. Ships and allied Men-of-War) entering or leaving the Port of Inverness, unless otherwise ordered by the Naval Authorities.

6. Vessels, when cleared, shall wait for the orders from Naval Authorities before leaving.

7. Drifters engaged on Inverness Pilotage duty will fly the Pilot flag, and will be stationed at the Examination anchorage off Cromarty, and all vessels arriving are to close the drifter flying this flag, after speaking the Examination vessel, and obey any orders they may receive.

and obey any orders they may receive. 8. Incoming and outgoing traffic will be regulated by signals hoisted at Fort George and on the Control vessel stationed seaward of the entrance to the port.

9. Traffic signals are to be strictly obeyed, and no vessel shall approach the entrances when the signals displayed are not in her favour, and no outgoing vessel is to approach Chanonry point within half a mile whilst the signals are against her.

10. Vessels proceeding with the tidal stream will, as a rule, be given priority over those proceeding against the tidal stream, but the signals are equally applicable to all vessels, entering or leaving the harbour, and they are only to use the channel between the light-buoys defining the ship passages.

11. Incoming and outgoing vessels shall not pass through the ship passages simultaneously. If through any misunderstanding an outgoing and an incoming ship are approaching the ship passages simultaneously, then the ship proceeding against the tidal stream shall give way and wait until the entrance is clear.

12. Vessels are to pass through the ship passages at a speed not exceeding 12 knots.

13. Inward-bound vessels, with special permission to be under way in Inverness firth and approaches during the hours of official night, when within 3 miles of the whistle-buoy off Cromarty and until they arrive at their anchorage within the Port of Inverness are to exhibit

navigation lights (with the exception of a stern light, which is not to be shown).

Outgoing vessels are to carry similar lights which are to be extinguished as soon as they are past Cromarty.

14. All vessels under way within the limits of the Port of Inverness are to exhibit navigation lights during the daylight hours, when owing to mist or other weather conditions the visibility is sufficiently low to render such a course desirable.

15. Vessels at anchor in the Port of Inverness and approaches are to obey all orders given them by the Naval Authorities as to the exhibition or obscuring of riding lights and darkening of ships.

#### (2) ORKNEY ISLES-TRAFFIC REGULATIONS.

# I. SCAPA FLOW AND APPROACHES.

1. All entrances are dangerous, and entry is absolutely prohibited by way of them except as provided in succeeding paragraphs.

2. Examination services have been established in the entrances to Hoxa and Hoy sounds; vessels directed to enter must communicate with the Examination vessel and follow the instructions received from her very carefully.

3. No vessel is permitted to approach the entrance to Hoxa sound within a radius of 5 miles under any circumstances whatever, except when actually ordered to Scapa Flow.

4. The only vessels permitted to enter Hoy sound from the westward are those ordered to Stromness.

5. Vessels are not permitted to enter Hoxa or Hoy sounds by night or in thick weather.

6. Passage through Cantick sound is entirely prohibited.

#### II. PORT OF KIRKWALL AND APPROACHES.

1. The Port of Kirkwall shall comprise all enclosed waters of the Wide Firth and Kirkwall bay to westward of Thieves holm.

2. Merchant vessels shall obey all orders given them by the Admiralty Port Officer as regards anchoring or shifting position.

3. No vessel other than H.M. Ships shall enter or leave the Port of Kirkwall during hours of darkness, *i.e.*, between half an hour after sunset and half an hour before sunrise, except in special circumstances with special permission from the Admiralty Port Officer.

4. During foggy and thick weather, traffic in and out of the port is stopped, and no vessel shall approach the Boom from either direction.

5. No vessel other than H.M. Ships or boat shall move in the harbour during hours of darkness as aforesaid. And no boat other than those belonging to H.M. Ships shall approach the shore or go alongside any pier in the Port of Kirkwall.

6. All vessels other than H.M. Ships entering or leaving the Port of Kirkwall shall be piloted in and out by a Pilot drifter, and are prohibited from entering or leaving harbour unless so piloted, save and except only, (1) in the case of such British vessels as have a written exemption therefrom, issued by the Admiralty Port Officer; (2) when a liner is entering the harbour, the Pilot may at his discretion, when circumstances of tide and sea render it advisable, direct such liner to enter the harbour without being piloted, provided always that the gate is open for incoming traffic. Pilot vessel to conduct them out of port, or until further notice. proceed as directed by the Naval Authorities.

8. Drifters engaged on pilot duty will fly the pilot flag (white and red, horizontal).

9. Incoming and outgoing traffic will be regulated by signals hoisted at the yardarm of the Boom trawler and repeated at the Helliar holm lighthouse.

10. Traffic signals are to be strictly obeyed, and no vessel shall approach the entrance against the signal.

11. The following Traffic signals will be displayed at the Boom and at Helliar holm :---

Gate "Open for Incoming Traffic":

By day—Two balls, vertical. By night—A red light.

Gate "Open for Outgoing Traffic":

By day-A cone, point upwards. By night—A green light.

Gate Closed: By day - Three balls at Helliar holm.

By night-Three red lights

at Helliar holm.

12. Vessels entering will, as a rule, be given priority over those leaving.

13. All outgoing vessels shall pass round the Turning buoy (red and white striped, spherical) moored approximately 285° (N. 56° W. Mag.), one mile from the entrance.

14. Incoming vessels will not pass round the Turning buoy, but will shape course as requisite for the anchorage on entering.

15. No outgoing vessel shall pass the Turning buoy, unless the signal for outgoing traffic is up. If the signal is against it, such vessel shall stop and wait in the neighbourhood of the Turning buoy.

16. No incoming vessel shall pass Helliar holm, unless the signal for incoming traffic is up at Helliar holm. If the signal is against it, such vessel shall wait in Shapinsay sound.

17. Incoming and outgoing vessels shall not pass through the gate simultaneously. If, through any misunderstanding, an outgoing and an incoming ship are approaching the gate simultaneously, then the outgoing ship shall give way and shall turn round, and return to the Turning buoy and there wait till such time as the entrance is clear.

18. As a rule only one ship will be conducted out at a time, but under exceptional circumstances, in the event of two ships being conducted out, then the pilot will give instructions as to which ship is to go first and the rear ship shall then keep a full half-mile directly astern, and is on no account to close or overhaul or attempt to pass the ship ahead.

19. Caution.-Caution is necessary when approaching the Boom, as the tidal stream does not set fairly through the opening and attains considerable velocity especially on the ebb or westgoing stream, which sets in a north-westerly direction.

Variation.-19° W.

#### (3) SHETLAND ISLES-TRAFFIC OF NEUTRAL VESSELS PROHIBITED.

No vessels other than those of British Nationality or those of the Allied Nations, except vessels calling for the purpose of Examination, shall enter any ports or harbours in, or anchor

SCOTLAND, WEST COAST-FIRTH OF CLYDE, ISLE OF ARRAN.

#### LAMLASH HARBOUR ENTRANCES-TRAFFIC REGULATIONS.

Former Notices.-Nos. 154, 320, 455, 554, 677, 797, 926, 1038, 1133, 1291 and 1422 of 1918.

A ship-passage, 500 feet in width, has been established at the entrance to North channel. This ship-passage is marked on its northern side by a light-buoy situated about 43 cables south-eastward from Hamilton rock as shown on chart.

A ship-passage, 500 feet in width, has also been established at the entrance to South channel. This ship passage is marked on its western side by a light-buoy situated about 63 cables south-eastward from Stone on Kingscross point as shown on chart.

All vessels bound for Lamlash must approach by the Northern channel, and maintain a course 244° (S. 82° W. Mag.) for a distance of a quarter of a mile on either side of the light-buoy, which should be left on the starboard hand at a distance not exceeding 75 yards.

Vessels must not attempt to enter by the Southern channel unless they have been definitely ordered by their route instructions or a Clyde Patrol vessel to do so, when they must maintain a course  $329^{\circ}$  (N. 13° W. Mag.) for a distance of a quarter of a mile on either side of the lightbuoy, which should be left on the port hand at a distance not exceeding 75 yards.

When using the Northern channel, inwardbound vessels will be given priority over those outward bound.

Vessels entering are not to approach the shippassage at a speed exceeding 10 knots.

Vessels entering are to close the drifter, which will be lying off the ship-passage, for instructions. Any instructions which may be given by Patrol vessels in the outer reaches of the Clyde must also be strictly observed.

The drifter regulates the traffic both inward and outward bound as follows :----

To indicate that the ship-passage is clear for inward-bound traffic, she will display at both yardarms:

By day—Two black balls hoisted vertically. By night—One red light.

To indicate that the ship-passage is clear for outward-bound traffic, she will display at both yard-arms:

By day—One black cone, point up.

By night-One green light.

During fog or thick weather, she will sound three long blasts on her steam whistle at intervals of five minutes to indicate that the ship-passage is clear for outward-bound traffic.

There will be no sound signal for inward-bound traffic.

No vessel, either inward or outward bound, is to approach within half a mile of the ship-passage unless the drifter is displaying the traffic signal in her favour.

In foggy or thick weather, vessels approaching are to sound the regulation fog-signals, and proceed with great caution.

All vessels entering Lamlash by night are to burn side-lights.

Vessels entering Lamlash by day are to anchor to the southward of a line joining the new Pier head and the north end of Holy island.

Vessels entering during the night may anchor to the northward of this line until the morning.

Before attempting to leave Lamlash, all vessels must obtain instructions as to the route to be followed.

Variation.—18° W.
