WHEREAS by Our Royal Proclamation of the twenty-fifth day of November one thousand nine hundred and eighteen, dissolving the late Parliament, We did require Writs to be issued by Our Chancellor of that part of Our United Kingdom called Great Britain, and Our Chancellor of Ireland respectively, for causing the Lords Spiritual and Temporal and Commons who are to serve in the new Parliament to be duly returned to, and give their attendance in, Our said Parliament on the twenty-first day of January instant, We, by and with the advice of Our Privy Council, hereby issue Our Royal Proclamation, and publish and declare that the said Parliament be prorogued from the said twenty-first day of January instant, to which it now stands summoned, to Tuesday the fourth day of February one thousand nine hundred and nineteen, and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and

the Commissioners for Shires and Burghs of the House of Commons are discharged from their meeting and attendance on the said twentyfirst day of January instant.

#### A PROCLAMATION

FOR PROHIBITING THE IMPORTATION INTO THE UNITED KINGDOM OF ALL FOREIGN COINS OTHER THAN GOLD AND SILVER COINS.

#### GEORGE R.I.

WHEREAS by Section two of the Customs Amendment Act, 1886, We are empowered from time to time to make, and when made to revoke, a Proclamation prohibiting the importation into Our United Kingdom of such coins coined in a foreign country as are in that behalf specified in such Proclamation :

And whereas by Our Proclamation, made the thirtieth day of March, one thousand nine hundred and seventeen, We did prohibit, subject as therein provided, the importation into Our United Kingdom of all coins coined in any foreign country other than gold or silver coins:

And whereas it is expedient that Our said Proclamation should be revoked, and that the importation into the United Kingdom of such coins coined in a foreign country as are hereinafter specified should be prohibited :

Now, therefore, We by and with the advice of Our Privy Council, in pursuance of the said Act and of all other powers enabling Us in that behalf, do hereby proclaim, direct, and ordain as follows:—

1. All coins coined in any foreign country other than gold or silver coins are prohibited to be imported into Our United Kingdom.

2. Our said Proclamation of the thirtieth day of March, one thousand nine hundred and seventeen, is hereby revoked.

3. This Proclamation shall not affect the provisions of the Prohibition of Import (Consolidation and Amendment) Proclamation, 1917.

4. This Proclamation may be cited as "The Foreign Coins (Importation Prohibition) Proclamation, 1919," and shall come into operation on the fourteenth day of January 1919.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 2nd day of January 1919, in the words following, viz. :--

"Whereas by Section 3 of the Naval and Marine Fay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being, or having been, an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are, from time to time, directed by Order in Council:

"And whereas the Regulations for the Government of Your Majesty's Fleet provide that an Officer, who receives a wound or injury which is not equivalent or nearly equivaleut to the loss of a limb or the use of a limb, may receive a gratuity of such sum as we may think fit, provided that it does not amount to one year's full pay of his rank:

"And whereas Army Officers who sustain wounds or injuries which are very severe, but not nearly equivalent to the loss of a limb, may receive, in addition to a gratuity, temporary pensions at half the rates of pension allowed for the loss of a limb, and we consider that provision for the payment of similar pensions should be made in the case of Naval Officers, whose wounds or injuries are of the same description :

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to approve of such cases being dealt with under the following Begulation :—

"Officers and Warrant Officers on the Permanent, Supplementary, or Temporary Lists of the Navy and Reserve, who have sustained in action injuries which are very severe, but which are not equivalent or nearly equivalent to the loss of a limb or the use of a limb, to be eligible to receive, at the discretion of the Admiralty, in addition to the authorised gratuity, temporary pensions at half the rates laid down for the loss of a limb, such pensions to commence after the expiration of the period for which a gratuity has been awarded, and to be renewable from year to year, provided the effects of the injury continue to be very severe and likely to be permanent.

If the temporary pension is renewed for 5 years, and the bodily disability continues, the pension may, at the discretion of the Admiralty, be converted into a permanent pension:

"The above Regulation to take effect as from the fourth day of August 1914:

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

THE DISTRICT AGRICULTURAL WAGES COMMITTEE FOR THE BORDER COUNTIES DISTRICT (being District No. 7).

NOTICE OF THE COMING INTO FORCE OF MINIMUM Rates of Wages for Agricultural Workmen in the Area comprising the Counties of Roxburgh, Berwick, and Selkirk.

The District Agricultural Wages Committee for the Border Counties District (being District No. 7) duly certified by the Board of Agriculture for Scotland under the Second Schedule of the Corn Production Act, 1917, hereby give notice that the following Minimum Rates of Wages for Workmen employed in Agriculture for time-work, which were fixed by them on the seventh day of October 1918, in terms of the Schedule hereto, not having been disallowed by the Central Agricultural Wages Committee for Scotland, have COME INTO FORCE under Clause 6 of the Second Schedule, with effect from the said seventh day of October 1918, and will remain in force until cancelled or varied, either wholly or in part, by the Committee.

#### SCHEDULE.

1. The wages payable in respect of a boy engaged in agricultural work shall be not less thon 10s. per week during the first year he is so employed; 16s. per week during the second year; 22s. per week during the third year; and 28s. per week during the fourth year and until he reaches the age of 18.

- 2. The wages payable in respect of a skilled female agricultural worker shall be not less than at the rate of 20s. per week.
- 3. For the purpose of the above minimum rate, a female agricultural worker shall be regarded as skilled only in the event of her having attained the age of 17 and having worked on a farm continuously (1) for one year before reaching the age of 17, or (2) for one year after having reached the age of 17.
- 4. The wages payable in respect of a girl engaged in agricultural work shall be not less than at the rate of 10s. per week during the first year she is so employed; 14s. per week during the second year; and 18s. per week during the third year and until she reaches the age of 17.
- 5. The wages payable in respect of female agricultural workers of 17 years of age and over, other than those special classes whose wages have already been fixed, shall be not less than at the rate of 18s. per week.
- 6. The above minimum rates shall apply to all workmen employed in agriculture within the meaning of Section 17 (1) (a) and (c) of the Corn Production Act, 1917, in the above-mentioned areas, except as after mentioned.
- 7. The hours of employment to which the above-mentioned rates of wages shall be held to apply are those customary in the district in which the workman is employed.
- 8. Perquisites, *i.e.* "benefits or advantages" in the sense of the Act, are to be reckoned as part payment of the said minimum wages in lieu of cash payment. These "benefits and advantages" will be defined and valued by a subsequent Order.
- 9. The above minimum rates shall not apply to Agricultural Students.
