HEREAS by an Order in Council, dated VV the twenty-eighth day of November nineteen hundred and fourteen, His Majesty was pleased to make regulations (called the "Defence of the Realm Regulations") under the Defence of the Realm Consolidation Act, 1914, for securing the public safety and the defence of the realm :

And whereas the said Act has been amended by the Defence of the Realm (Amendment) Act, 1915, the Defence of the Realm (Amendment) (No. 2) Act, 1915, and the Munitions of War Act, 1915, and other enactments :

And whereas the said regulations have been amended by various subsequent Orders in Council :

And whereas it is expedient further to amend the said regulations in manner hereinafter appearing :

And whereas owing to the suspension of hostilities it is expedient that several of the said regulations should be revoked :

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that the following amendments be made in the said regulations :

1. Regulation 55 shall be amended as follows :-

(1) After the first paragraph the following

either in civil custody or in military custody; and without prejudice to any other powers of detention any such person may, on the order of the competent naval or military authority, be detained in any of His Majesty's prisons as a person committed to prison on remand, or, in Scotland, for further examination, until it has been determined whether or not he is to be proceeded against for an offence under these regulations and, if the offence for which he is to be proceeded against is not a summary offence, until it has also been determined in what manner he is to be tried." (2) After the words "direction from the

competent naval or military authority' the following paragraph shall be inserted :-

"The power given by this regulation to an

officer of the police to discharge any person in custody shall in Ireland be exerciseable by a resident magistrate or in the police district of Dublin Metropolis by a divisional justice of that district."

2. For subsection (10) of Regulation 56 the following subsections shall be substituted :---

"(10) Any person who is in custody in respect of any offence under these regulations may be detained either in civil custody or in military custody and may at any time be transferred from civil custody to military custody or from military custody to civil custody; and without prejudice to any other powers of detention any such person as respects whom it has been determined that he is to be tried by court martial or by a civil court with a jury may, on an order made by the competent naval or military authority in the form set out in Part III. of the Schedule to these regulations be detained in any of His Majesty's prisons, as a person com-mitted for trial for felony, until thence delivered in due course of law, and in every case in which a person detained in pursuance of this provision is to be tried by a civil court with a jury such an order shall, if application is made for the purpose, be made by a competent naval or military authority :

"(IOA) Where any person as respects whom it has been determined as aforesaid is detained in pursuance of the provisions of the foregoing subsection either in prison or otherwise, he may apply to the competent naval or military authority, and if that authority signifies in writing that in his opinion the case is a proper one for bail the said person may apply to a justice of the peace for bail, and the justice may on that application admit him to bail in like manner in England and Ireland as if he had been committed by that justice for trail for a felony.

"Nothing in this regulation shall affect any power of the High Court or the High Court of Justiciary, or any power of any court of summary jurisdiction, to admit any person to bail. "The powers conferred by this subsection

"The powers conferred by this subsection on justices of the peace shall be exerciseable in Scotland only by a sheriff, and in Ireland only by a resident magistrate or in the police district of Dublin Metropolis by a divisional justice of that district."

3. In Regulation 57 after the words "as if he belonged to the unit in whose charge he may be," there shall be inserted the words "or if he is in civil custody as if he belonged to such unit as the competent naval or military authority may direct."

4. In Regulation 58A for the words "paragraphs (6) to (10)" there shall be substituted the words "paragraphs (6) to (9)."

5. The following shall be substituted for the form of order set out in Part III. of the Schedule to the Regulations :

"To the Governor of His Majesty's Prison at

Whereas A.B. is to be proceeded against for an offence under the Defence of the Realm Regulations :

Now I, the undersigned, being the competent naval (or military) authority within the meaning of the said regulations, do hereby request and require you to receive the said A.B. into His Majesty's Prison aforesaid, and therein to detain him as a prisoner committed to the said prison for trial for felony and to produce him, as and when required, for the purpose of his trial in pursuance of the said regulations and until he be delivered from your custody in due course of law.

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction payment of such an Allowance at the rate not exceeding those and under the conditions set forth in the following Schedule :

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.

" SCHEDULE.

" Parents' Allowance.

" To take effect from the 3rd day of October 1918 :

5s. a week to the Parent or Parents of each Seaman, Marine or Reservist, who is over the age of 21, provided that on the outbreak of the War, or his entry into His Majesty's Service, if later, he was under the age of 23.

"To take effect from the 7th day of November 1918:—

5s. a week to the Parent or Parents of each Seaman, Marine or Reservist, who is borne on the books of one of His Majesty's Ships and is over the age of 18, provided that on the outbreak of the War. or his entry into His Majesty's Service, if later, he was under the age of 26. "For the purpose of this Allowance 'Parent' may be taken to include the Grand-parent or other person who has been in the place of a Parent to a Seaman, Marine or Reservist, and has wholly or mainly supported him for not less than one year before his entry into His Majesty's Service."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

"And whereas we consider it desirable that additions should be made to the Rates of Allowance therein specified for children until they attain 14 years of age :

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction additional payments, not exceeding those set forth in the Schedule hereto.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.

"SCHEDULE.

"Additional Allowances payable for children under 14 years of age until they attain that age.

 $^{\prime\prime}$ To take effect from the 3rd day of October 1918 :

Where the number of children under 14 is 1, 2s. 6d. a week.

Where the number of children under 14 is 2 or more, 4s. 6d. a week.

Motherless children under 14, 3s. a week for the first child, 1s. a week each for the

second and subsequent Motherless Children. "Further additions to take effect from 7th day of November 1918.

Where the number of children under 14 is 1, 1s. a week.

Where the number of children under 14 is 2, 2s. a week.

Where the number of children under 14 is 3, 4s. a week.

Where the number of children under 14 is more than 3, 1s. a week more than the number of such children.

Motherless children under the age of 14, 15. a week for each child."

W HEREAS there was this day read at the Board a Memorial from the Right Honourable John Hodge, Minister of Pensions, of the 31st December 1918, in the words following, viz.: -

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, wages, pensions, bounty money, grants, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an officer, seaman, or marine, or to the widow or any relative of a deceased officer, seaman, or marine, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council :

"And whereas under Section 2, sub-section (I) of the Ministry of Pensions Act, 1916, it is enacted, *inter alia*, that there shall be transferred to the Ministry of Pensions the powers and duties of the Admiralty with respect to pensions and grants to persons who have served as officers or men, and to their widows, children, and other dependants, other than service pensions, as far as such pensions and grants are payable out of monies provided by Parliament and not provided exclusively for the purpose of Greenwich Hosp tal, and that Your Majesty may, by Your Order in Council, make such adaptations in the enactments relating to such powers and duties as aforesaid as may be necessary to make them exerciseable by the Minister of Pensions and his officers, and may fix the time or times as from which the several powers and duties are to be transferred to him : "And whereas provision was made in Your

"And whereas provision was made in Your Majesty's Order in Council of 30th March 1917, for pensions to certain seamen and marines disabled by service in consequence of the present war and to the widows, children, and dependants of such seamen and marines whose death was due to or occurred during service in the present

war: "And whereas I am of opinion that it is desirable to make further provision concerning the pensions of seamen and marines disabled, and of the families and dependants of seamen and marines deceased, whose claims arise in t respect of service during the present war:

I beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the grant of pensions to the aforesaid persons on the scales and subject to the conditions prescribed in the regulations annexed hereto, in substitution for those laid down in Your Order in Council of 30th March 1917, with effect from the 1st day of May 1918, without prejudice, however, to the validity of anything which may have been done by the Lords Commissioners of the Admiralty under Your Majesty's Order in Council of 12th August 1915, or by me under Your Order in Council of 30th March 1917, and, further, to empower me to make or revise grants under the said previous Orders in respect of any claims which may have arisen between the outbreak of the war and the aforesaid 1st day of May 1918. Provided always, that if more favourable to the scaman or marine, the pension, allowance, or grainity payable under existing Regulations shall is granted, and no grant to a seaman or marine, or to the family or dependants of a seaman o marine, shall be re-assessed to his or their disadvantage.

"The Lords Commissioners of Your Majesty's Treasury have signified Their concurrence in these proposals."

His Majesty having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Minister of Pensions for the time being is to give the necessary directions herein accordingly.

PENSIONS .REGULATIONS FOR OF BRITISH SEAMEN AND MARINES, THEIR WIDOWS, RELATIVES AND DEPENDANTS.

PART I.-SEAMEN AND MARINES.

1,-(1) A seaman or marine discharged as medically unfit for further service, or while suffering impairment, such unfitness or impairment being certified as either attributable to or aggravated by naval or military service during the present war and not being due to the serious negligence or misconduct of the discharged man, may, if he is disabled in any of the manners set forth in the Schedule to these Regulations, be granted a pension at the weekly rates therein shown as corresponding to the degree of his disablement. In the case of injuries not shown therein, and in the case of disease, the pension may be assessed at the degree in the Schedule which is held most closely to represent the disablement corresponding to the injury or disaese.

(2) Except in those cases where the disablement has reached its final condition a disablement pension shall be temporary, at the rate appropriate to the temporary disablement, and

the grant shall be reviewed from time to time until a permanent assessment can be made or the grant ceases. Where a temporary disablement pension, including renewals, does not run beyond one year a supplementary gratuity of £5 may be granted at the termination of such pension.

(3) In any case where the degree of disablement is assessed at less than 20 per cent., or where it is considered more in the interests of the seaman or marine, a gratuity or temporary allowance may be granted in place of any pension. The grant will be subject to such conditions as the Minister of Pensions may determine, and its amount will not exceed £200 and will depend on the extent of the disablement and on the other circumstances of the case.

(4) Men in possession of good conduct badges or medals, and men who have completed time for long-service pension with very good characters throughout their service, shall receive the same addition to their pension in respect thereof as under existing Regulations. Chief Petty Officers. Petty Officers and Leading Rates of the Royal Navy shall also receive the same additions in respect of petty time as under existing Regulations. Non-Commissioned Officers of the Royal Marines shall receive the additions laid down in the existing Regulations for long-service pensions in respect of service above the rank of private.

A further addition will be made to the pension in respect of service at the following rates :--

(5) The disablement pension granted to a seaman or marine who held paid acting rank at the time he was wounded, injured or removed from duty in consequence of disablement may be at the rate appropriate to that rank.

2.-(1) A disabled man pensioned under Article 1 of these Regulations may be granted during the continuance of the pension an allowance for each child under the age of 16 at such proportion of the following weekly rates as corresponds to the degree of disablement at which the man is assessed for pension :---

(2) The allowance may (subject to the continuance of the pension) be granted or continued beyond the age of 16 in the case of young persons receiving not more than nominal wages, or of children being educated at secondary schools. technical institutes or universities, and may be granted or continued between the ages of 16 and 21 in the case of a child incapable through mental or physical infirmity of earning a living, provided the infirmity existed before the child attained the age of 16.

(3) In any case in which, in the opinion of

the Minister of Pensions, it may become necessary to secure the proper care of a child on behalf of which an allowance is payable, the allowance instead of being paid to the parent may be administered under such conditions as the Minister of Pensions may determine.

(4) In the event of a parent being wholly or partially relieved of the charge of any child by its maintenance in the Army or Navy, or in any institution wholly or mainly supported from public funds, the allowance granted on account of that child may be reduced by the extent of that relief.

3. Any disabled man pensioned under Article 1 of these Regulations who makes application and shows that the disablement pension with children's allowances (if any) which he has been granted, together with the average earnings (if any) of which he remains capable, are less than his pre-war earnings, may be granted, temporarily or permanently, in lieu of the disablement pension and children's allowances, a pension which, together with the average earnings (if any) of which he is judged capable shall not exceed his pre-war earnings up to a maximum of 50s. a week. plus half of any prewar earnings between 50s. and 100s. a week.

Provided that in the case of a man who has lost both arms or both legs or the sight of both eyes, the average earnings (if any) of which he may be capable shall not be taken into account.

4. Half the pension and allowances (if any) awarded under the preceding Articles may be subject to the condition that the disabled man shall undergo medical treatment in an institution or otherwise, for any period during which it may be certified that such treatment is necessary in his interests.

5.—(1) When a permanent pension has been granted it shall not be altered on account of any change in the man's earning capacity, whether resulting from training or other cause ; neither shall it be subject to review except—

(a) When a man whose pension is assessed under Article I of these Regulations claims that there has been a substantial increase in the extent of the disablement due to the original cause.

(b) When a man whose pension is assessed under Article I of these Regulations shows that it would be more advantageous to him to be assessed under Article 3: provided that the cessation or reduction of any allowance under Article 2 of these Regulations shall not be a ground for review.

(c) Under the following sub-section.

(2) The Minister of Pensions may at any time order the review of any pension in any case where—

(a) A pension has, by error in interpretation or fact, been granted to a disabled man in excess of the amount appropriate to the degree of his disablement;

(b) The Minister of Pensions has reason to believe that a pension has been obtained by any improper means; or

(c) A pension has been granted by error.

5A. During the continuance of the present war a man who, being in receipt of any pension for disability, re-joins the Royal Navy or Marines, or enlists in the Army or joins the Royal Air Force, or is granted a commission, or is recalled to the Naval, Military, or Air Service, shall,

whilst he remains in the Naval, Military, or Air Service, be entitled—

(a) if in receipt of a permanent pension, whether disablement or alternative, to receive his appropriate disablement pension, but shall not be entitled to receive any children's allowances ; and

(b) if in receipt of a temporary pension, whether disablement or alternative, to receive his appropriate disablement pension, without allowances to children, for the period of the award, at the expiration of which the grant of pension will be reviewed.

6.—(I) In any case where it is certified that a disabled man to whom a pension has been awarded under the preceding Articles of these Regulations should, in consequence of his disablement, undergo any course of medical treatment in an institution or otherwise, or where it is decided that he should, in consequence of his disablement, receive training in a technical institution or otherwise, and he is deemed unable in consequence to provide for his own support and that of his family, there may be granted to or in respect of him, in lieu of any pension and children's allowances, for the purpose of undergoing treatment or training for such period and subject to such conditions as the Minister of Pensions may determine—

either (a) an allowance equal to his disablement pension for the highest degree of disablement, together with an allowance in respect of each child at the full rate as in Article 2 (I), and in the case of a man whose treatment or training necessitates the man living away from home, a further allowance which will secure to his wife an amount equivalent to the pension authorized for a widow under Article II of these Regulations, or to a dependant supported by him up to the time when his treatment or training commences, such amount not exceeding the amount of ascertained dependence up to Ios. a week, as may be determined by the Minister of Pensions;

or (b) an allowance equal to the maximum pension which would be payable to him under Article 3 of these Regulations if he were without earning capacity;

whichever is the greater: provided that any allowance under this sub-section to a lunatic seaman or marine may be reduced by the amount which may be granted to a dependant who is not a relative of such seaman or marine or by such less amount as the Minister of Pensions may determine.

(2) A deduction of such an amount and under such conditions as the Minister of Pensions may determine, may be made from any allowance granted under sub-section (I) of this Article, on account of the cost of the disabled man's maintenance in an institution.

(3) Any charges, fees or expenses in respect of the treatment or training of a disabled man that are not otherwise provided for may be paid under such conditions as the Minister of Pensions may determine.

(4) At the termination of any period of training as is provided for in this Article, there may be granted to the disabled man an amount equal to the sum of 5s. for each week of the period during which he has been undergoing training, and there may be a further grant not exceeding $\pounds 10$ for the purchase of tools if required to be provided by the man in the trade in which he has been trained.

(5) In any case where it is certified that a disabled man should, in consequence of his disablement, undergo medical treatment in circumstances which do not render him unable to provide for his own support and that of his family, but require him to absent himself from his work on one or more occasions in a week, there may be granted to him, in addition to any pension awarded to him under the preceding Articles of these Regulations, an allowance not exceeding 10s. a week for the time he is required so to absent himself, the allowance to be subject to such conditions as the Minister of Pensions may determine.

6A. In addition to any pension awarded under the following Articles there may be granted, under such conditions as the Minister of Pensions may determine, to or on behalf of a man disabled in the highest degree, an allowance not exceeding 20s. a week in any case where the constant attendance of a second person is necessary.

7.—(1) A seaman or marine discharged as medically unfit for further service, such unfitness being neither attributable to nor aggravated by naval or military service, and not being due to the serious negligence or misconduct of the discharged man, may be granted a gratuity or temporary allowance. The grant will be subject to such conditions as the Minister of Pensions may determine. In exceptional croumstances it may amount to a sum not exceeding £150, and generally it will depend on the extent to which a man is incapacitated, on the length and character of his service, and on the other circumstances of the case.

(2) Subject to such conditions as he may determine, the Minister of Pensions may pay any charges, fees, or expenses, not otherwise provided for, in respect of the treatment for the period of the war and 12 months afterwards of any disabled man who comes within the provisions of the preceding sub-section and who is certified to need medical treatment in an institution : provided that such treatment shall be limited to the disability for which the man was discharged.

During such treatment there may be granted to the wife and children of such disabled man, or to a dependant supported by him up to the time when his treatment commences, allowances in accordance with the provisions of Article 6 (1) (a) of these Regulations.

8.—(1) A seaman or marine discharged as medically unfit for further service, or while suffering impairment, may be granted a temporary allowance of 27s. 6d. a week for any period that may elapse between the date of his discharge and the announcement of a decision as to the award of pension or gratuity in his case, together with children's allowances at the full disablement rate from the date of cessation of separation allowance. Arrears of this allowance will not be granted for more than a fortnight before an intimation of the discharge is received by the Ministry or, if there has been no such intimation, before the date of any application that may be made to the Ministry for an allowance or for a pension.

(2) This temporary allowance will be deducted from any pension for the corresponding period in so far as the pension for that period may be sufficient to meet it, but no deduction on account of the temporary allowance exceeding the rate of pension will be made from any subsequent issues of pension and no deduction will be made from any gratuity. (3) Subject to such conditions as he may

(3) Subject to such conditions as he may determine, the Minister of Pensions may pay any charges, fees or expenses that are not otherwise provided for in respect of the treatment in an institution of any disabled man to whom a temporary allowance has been granted under sub-section (1) of this Article, and who is certified to need medical treatment in consequence of the disability for which he was discharged.

9. If a man after discharge from the Royal Navy or Marines suffers from a disablement which is certified as either attributable to or aggravated by naval or military service during the present war, such disablement not being due to the man's serious negligence or misconduct, he may be granted a disablement pension or a gratuity or temporary allowance under Article 1 of these Regulations as if he had been discharged as medically unfit for further service upon the date from which his claim is established.

PART II.-WIDOWS AND DEPENDANTS.

10.—(1) Pensions to the widows, children, and dependants of deceased seamen or marines, for which provision is made in the following Articles, shall not be claimed as a right, but shall be given as a reward of service, and no pension shall be granted or continued to a widow or dependant who, in the opinion of the Minister of Pensions, is unworthy of the public bounty, and it shall be in the power of the Minister of Pensions to terminate or suspend any pension that may have been granted to such persons or to provide for its administration under such conditions as he may determine, and his decision in any case shall be final.

(2) It shall be within the power of the Minister of Pensions to deduct from any sum paid by way of pension or allowance under this Part of these Regulations the cost of any benefit which it may hereafter be decided to substitute for part of the pension or allowance : provided that no deduction made under this sub-section shall be at a greater rate than one penny for each full half-crown of the pension or allowance

(3) Where a widow, or a dependant under Article 20 of these Regulations, is under treatment for physical or mental disability in a poor law or other institution at the cost, either wholly or in part, of the Poor Law Authorities any pension or allowance which may have been granted to her shall be administered on behalf of herself and her children under such conditions as the Minister of Pensions may determine.

11. The widow of a seaman or marine who (a) is killed while in the performance of naval or military duty during the present war, or (b) dies as a result of wounds or injuries received in the performance of such duty within seven years of receiving such wounds or injuries, or (c) dies of disease, certified as contracted or commencing while on active service during the present war, or as having been aggravated by such active service, within seven years of his removal from duty on account of such disease

may, provided the man's death has not been caused by his serious negligence or misconduct, be granted a widow's pension at the following rates :—

12. A widow pensioned under Article 11 of these Regulations may be granted an allowance at the following weekly rates for each child under the age of 16 maintained by her :—

The provisions for the grant or continuation of this allowance beyond the age of 16 for its administration to secure the proper maintenance of the child, and for its reduction to the extent to which the parent is relieved of the charge of the child shall be as set forth in sub-sections (2), (3), and (4) of Article 2 of these Regulations.

13. Any widow pensioned under the conditions set forth in Article II of these Regulations, who makes application and shows that she was married to the seaman or marine before the commencement of the war or before the date of his enlistment, whichever was the later, and that the widow's pension, with any chil-dren's allowances and pension, is less than twothirds of any alternative pension that might have been awarded to the deceased seaman or marine under Article 3 of these Regulations had he survived and been incapable of supplementing that pension by earnings, may be granted, in lieu of a widow's pension and any children's allowances and pension, an alternative pension which shall not exceed two-thirds of such deceased man's alternative pension : provided that the cessation or reduction of a child's allowance or pension shall not be a ground for making an application. Any pension awarded under Article 18 of these Regulations shall be deducted from the widow's alternative pension.

14. In addition to any pension and children's allowances awarded under the foregoing three Articles there may be granted, under such conditions as the Minister of Pensions may determine :—

(1) To any widow a gratuity not exceeding f_5 for herself and f_1 on account of each child for whom she may be receiving separation allowance to meet expenses consequent on or caused by the death of the seaman or marine.

(2) To any widow pensioned under Article II of these Regulations, an addition of IS 3d. a week to the pension granted under that Article when she reaches the age of 45.

(3) To any widow a allowance not exceeding 12s. 6d. per week for a period not ordinarily exceeding 13 weeks whilst she is undergoing any course of instruction which, in the opinion of the Minister of Pensions, will be advantageous to her. Where an allowance is granted under this sub-section any fees for training, for which provision is not otherwise made, may be paid, subject to such conditions as the Minister of Pensions may determine.

15. The widow of a seaman or marine who during the present war has died from wounds, injuries or disease, neither attributable to naval or military service nor certified as aggravated by such service, but not due to the serious negligence or misconduct of the deceased man, may be granted a temporary pension of 15s. a week for the period of the war and for 12 months afterwards.

If the seaman or marine died in the circumstances set forth above whilst in naval or military service, the widow may be granted in addition a gratuity not exceeding f_5 for herself and f_I on account of each child for whom she may be receiving separation allowance to meet expenses consequent on or caused by the man's death.

16. Any pension granted to the widow of a seaman or marine under Articles 11 or 13 of these Regulations shall cease on her remarriage, and she may then be given a gratuity equal to one year of her widow's pension under Artcle 11, subject to such conditions as to payment as the Minister of Pensions may determine. Allowances for children under Article 12 may be paid after re-marriage.

17. The widow of a man who was at the time of his death in receipt of a disablement or of an alternative pension of not less than 10s. a week, but whose death does not entitle her to a pension under Article 11 of these Regulations, may, provided she was living with the man at the time of his death, receive a pension of not more than one-half of the deceased man's pension, and in no case at a higher rate than provided for under that Article, this grant to be subject to such conditions as the Minister of Pensions may determine and to cease on re-marriage.

18. The child of a seaman or marine who has died in the circumstances set forth in Article II of these Regulations may be awarded a pension not exceeding—

(I) IOS. a week where the child is or becomes motherless, or has been removed from the control of its mother. In the event of two or more children being maintained by one person in the same household or institution, the amount will be reduced to 9s. 2d. for each child after the first ; and

(2) 6s. 8d. a week where an affiliation order was in force on account of a child at the time of the death of the seaman or marine, or in the case of a child of a woman who was not married to or supported by the man, where there is satisfactory proof that he was its father.

This pension may continue in either case while the child is under the age of 16, and beyond that age in the circumstances set forth in sub-section (2) of Article 2 of these Regulations, and shall be administered subject to such conditions as the Minister of Pensions may determine.

19. The separated wife of any seaman or marine who has died in the circumstances set forth in Article II of these Regulations may, provided the marriage took place at a time entitling the widow to a pension and the man contributed to her support, be granted a pension equal to the amount due to her under a separation order or otherwise paid by her husband, or both, but not less than 3s 6d. a week and not exceeding I3s. 9d. a week, and allowances for her children, if maintained by her, as in Article I2 of these Regulations. Allowances for children as in Article I2 may also be granted to the separated wife of a seaman or marine where he did not contribute to her support.

20. Any woman who has lived as his wife with a seaman or marine who has died in the circumstances set forth in Article II of these Regulations may, if she had been wholly or substantially dependant on that man and has been drawing separation allowance as for a wife, or was eligible for such allowance, be granted a pension as follows:—

(I) If and for so long as she has children of the seaman or marine in her charge, IOS. a week and allowances for the children as in Article 12 of these Regulations.

(2) If she has no children of the seaman or marine, or has ceased to have them in her charge (otherwise than from their being removed from her control on account of her misconduct), IOS. a week for the period of the war, and I2 months afterwards, or for I2 months after ceasing to have any child of the deceased man in her charge, whichever be the later date, and for any subsequent period during which from infirmity or age, she is wholly or partly incapable of supporting herself.

2I.—(I) The parent (or parents) of a seaman or marine who has died in the circumstances set forth in Article II of these Regulations may be granted a pension under the following conditions:

(a) If dependent on the man, a pension equal to the amount of pre-war dependence or 3s. 6d. a week, whichever is the greater, but not exceeding 15s. a week; or

(b) If at any time either or both of the parents is or are wholly or partly incapable of self-support from age or infirmity, and they are in pecuniary need, a pension of not less than 3s. 6d. and not exceeding 15s. a week.

(2)—(i) A pension under sub-section (I) (a) of this Article may be granted on account of each son who has died in the circumstances set forth in Article II, but the total of the pensions shall not exceed 15s. a week for each surviving parent.

(ii) If the amount of pre-war dependence Pensions may determine. Al on two or more sons was greater than 15s. a dren under Articles 19 and week (or than 30s. a week in the case of two after marriage or re-marriage.

surviving parents), a gratuity not exceeding that under Article 22 (2) may be given, under such conditions as the Minister may determine, in respect of the balance of pre-war dependence not represented in the pension.

. (iii) If either parent is in receipt of a pension in respect of a son who has died as an officer, the pension or pensions which may be granted under this Article in respect of other son or sons shall not, together with that pension, exceed the pension which has been or could have been awarded to the widow of the officer son under Article II (I) or (2) and the Second Schedule of the Regulations annexed to the Order in Council of 29th September 1917, or where there are two parents, 30s. a week if greater.

(3) Subject to sub-section (2) of this Article, the pension shall be the same whether both parents are concerned or there is only one parent, and on the death of one parent payment may be transferred to the surviving parent, but so that no parent receives a pension of more than 15s. a week.

(4) A pension shall not be granted to the mother of a seaman or marine under sub-section (I) (a) of this Article if she marries or re-marries after his death.

(5) The parent (or parents) of a seaman or marine who has died in the circumstances set forth in Article 15 may, if they would have been eligible for a pension had his death taken place in the circumstances set forth in Article 11, be awarded a grant as in Article 22 (2) at the discretion of the Minister of Pensions.

22.—(1) Any dependant of a seaman or marine who has died in the circumstances set forth in Article II, not coming under Articles 18, 19, 20, or 21 of these Regulations, but in respect of whom separation allowance has been paid, or who was eligible for such allowance, may, provided he or she is wholly or partially incapable of self-support and in precuniary need, be granted a pension equal to the amount of pre-war dependence but not exceeding 13s. 9d. a week, so long as the incapacity continues. If it ceases, a terminal gratuity may be given not exceeding the amount of 26 weeks' pension, or the balance of such gratuity as might have been issued under the following sub-section, if there had been no incapacity, whichever is the greater.

(2) Any dependant of a seaman or marine who has died in the circumstances set forth in Article II, but not including a woman who has lived with a seaman or marine as his wife, may, if not entitled to a pension under the preceding Articles, receive a grant by way of gratuity or weekly payment, not exceeding in all a year's pay of the deceased seaman or marine, or a year's allowance at the rate at which separation allowance and allotment were last paid or payable, whichever is the greater, to be awarded at the discretion of the Minister of Pensions.

23. Any pension granted to the separated wife or to a female dependant of a seaman or marine under Articles 19, 20, 21, and 22 of these Regulations shall cease on her marriage or re-marriage, and she may then be given a gratuity not exceeding 26 weeks of that pension subject to such conditions as the Minister of Pensions may determine. Allowances for children under Articles 19 and 20 may be paid after marriage or re-marriage.

PART III.—GENERAL PROVISIONS.

24. In these Regulations unless the context otherwise requires—

(1) "Seaman or marine" means any seaman or marine, including Chief Petty or Petty Officer and Warrant Officer and Noncommissioned Officer of the Royal Marines, except a Royal Marine Gunner, who has served or been in receipt of naval or marine pay as such during some period of the present war, and shall extend to men belonging to the Naval and Marine Reserves, as well as to a seaman or marine specially enlisted or deemed to be specially enlisted for the purpose of the present war and transferred forthwith to the Reserves, provided that he shall have been called into actual service and have served and been in receipt of naval or marine pay as such during some period of the present war, but shall not include any seaman or marine of the Royal Indian Marine, or of Dominion, Colonial, or Protectorate Forces, whether raised for local or general service.

(2) "Widow" means the widow of any seaman or marine, but shall not include a widow whose marriage took place after the end of the war, or after the man's discharge, or, if during his service, after the receipt of the wound or injury which caused his death, or after removal from duty on account of the contraction (if contracted during the war) or aggravation of the disease which caused his death, or a widow who was separated from her husband at the time of his death.

(3) "Child" means the child of any seaman or marine, born before or within nine months after the man's discharge, and may include any child regularly maintained by him at the commencement of the war or at the date of his enlistment, whichever was the later, but shall not include the child of a wife or widow who was married to the seaman or marine after the end of the war, or after his discharge, or after the receipt of the wound or injury in consequence of which he was discharged or which caused his death, or after removal from duty on account of the contraction (if contracted during the war) or the aggravation of the disease in consequence of which he was dis-charged or which caused his death : provided that in Article 6 (1) (a) the word "child" and in Article 7 (2) the word "children " shall also include the child of any seaman or marine born after nine months after the man's discharge, without regard to the date of his marriage.

(4) "Parent" includes a grandparent or other person who has been in the place of a parent to a seaman or marine, and has wholly or mainly supported him for not less than one year at some time before the commencement of the war.

(5) "Dependant" means any person other (than a widow or child as defined above) who is found as a fact to have been wholly or in part dependant upon a seaman or marine for a reasonable period immediately before the commencement of the war, or before enlistment if subsequent to the commencement of the war, and in the case of a deceased seaman or marine up to the death of the man unless he shall have been prevented from contributing by circumstances beyond his control. "Dependant" means so dependent as aforesaid.

(6) "Pre-war Earnings" means the average weekly earnings of a seaman or marine during the 12 months preceding the commencement of the war, and, so far as regards a man who was in employment before the war, shall be computed generally in the same manner as for the purposes of the Workmen's Compensation Act, 1906. In the case of a man in a trade, business or profession, the average profits of the last three years preceding the commencement of the war shall be taken, or of such lesser period as he engaged therein.

In the calculation of the pension payable to or on account of a seaman or marine, who at the commencement of the war was serving and had served not less than one year as an apprentice in any recognised trade, the standard rate of wages of that trade in the district at the time of the commencement of the war may be substituted for pre-war earnings, provided enlistment took place before the age of 26, and the man is by reason of his disablement incapable of completing or has completed his apprenticeship.

In the calculation of the pension payable to or on account of a seaman or marine, who, for the purpose of qualifying for any profession or employment, had, after the age of 16, attended regularly any school, college, university or hospital, or had been articled in accordance with the recognised practice of any profession, an amount equivalent to what would have been the man's disablement pension for the highest degree of disablement, with an addition of 5s. for each completed year of such attendance or "articles" before the age of 23, may be substituted for pre-war earnings, up to a maximum of 50s. a week, provided enlistment took place before the age of 26 and the man is by reason of his disablement incapable of qualifying or has qualified for such profession or employment.

(7) "Pre-war Dependence" means the amount, expressed as a weekly or annual sum, representing the value of the support afforded to, or of benefits conferred upon, a dependant by a seaman or marine for a reasonable period immediately preceding the commencement of the war (or entry into service or enlistment, if subsequent to the commencement of the war), exclusive, however, of any increase thereof due to circumstances arising out of the war in the case of entry into service or enlistment subsequent to the commencement of the war, and shall include the following :—

(a) Amount regularly contributed by the man if he received no material benefits in return therefor.

(b) Amount regularly contributed by the man in excess of expenditure incurred on his account.

(c) Money value of any benefit conferred upon the dependant by the man.

(8) "Certified" means, in respect of any medical certification, certified by a medical officer or Board of Medical Officers appointed

, for the purpose by the Board of Admiralty or by the Minister of Pensions.

(9) "Disablement Pension" means a pension under Article (1) of these Regulations, together with any additions thereto under Article 1 (4).

(10) "Discharged as medically unfit for further service" includes demobilisation prior to 11th November 1918, of a man possessing a disability acquired since entry · in the Navy or Marines.

(11) "Service" in Article 1 (4) of these Regulations shall mean any service which counts for long service pension or any mobilised service.

25.-(1) Any provisions at present obtaining in the King's Regulations and Admiralty Instructions, or in any Orders in Council re-lating to the pensions or grants to disabled seamen or marines, or to the pensions, allow- as if made under these Regulations.

ances, and gratuities to the widows, children, relatives and other dependants of deceased seamen and marines, shall remain in force, except in so far as they are modified by these Regulations and by the substitution, so far as these pensions and grants are concerned, of the Minister of Pensions for the Lords Commissioners of the Admiralty; and the provisions of Her late Majesty's Order in Council of the 15th March 1893 shall apply to the dependant of a seaman or marine in the same way as to the seaman or marine.

(2) Nothing in these Regulations shall be held to affect the existing Orders in Council or Regulations in regard to service pensions or other grants, the administration of which continue to be vested in the Board of Admiralty.

(3) Any instructions made under the Re-gulations annexed to the Order in Council of 30th March 1917 shall have the same effect

PRESENT.

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable John Hodge, Minister of Pensions, of the 31st of December 1918, in the words following,

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, wages, pensions, bounty money, grants, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an officer, seaman, or marine, or to the widow or any relative of a deceased officer, seaman, or marine, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council :

"And whereas under Section 2. subsection (1), of the Ministry of Pensions Act, 1916, it is enacted, inter alia, that there shall be trans-ferred to the Ministry of Pensions the powers and duties of the Admiralty with respect to pensions and grants to persons who have served as officers or men and to their widows, children, and other dependants, other than service pensions as far as such pensions and grants are payable out of moneys provided by Parliament and not provided exclusively for the purpose of Greenwich Hospital, and that Your Majesty may, by Your Order in Council, make such adaptations in the enactments relating to such powers and duties as aforesaid as may be necessary to make them exerciseable by the Minister of Pensions and his officers, and may fix the time or times as from which the several powers and duties are to be transferred to him :

"And whereas I am of opinion that it is desirable to make further provision in regard to the pensions of seamen and marines who are disabled in consequence of former wars, and to the pensions or allowances of widows of seamen and marines whose deaths have resulted from former wars :

"I beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the following Regulations :-

"1. The pension which is being paid under the Regulations for the government of Your Majesty's Naval Service to any seaman or marine on account of wounds or injuries received in action or in the performance of naval or military duty in former wars, or on account of blindness caused by naval or military service in former wars, or of disease due directly or wholly to service in former wars, and who by reason of the disablement on account of which he was discharged is now or shall hereafter be totally incapacitated from earning a livelihood, may be increased by the difference between his present rate of pension and the minimum pension which he might have received for the highest degree of disablement under the Order in Council of the 30th March 1917, or any Order in Council amending the same, as if he had been subject to the provisions of the said Order in Council of the 30th March 1917, or any such amending Order in Council as aforesaid.

the Regulations for the government of Your Majesty's Naval Service to any seaman or marine on account of wounds or injuries specified in the First Schedule to the Regulations annexed to the Order in Council of the 30th March 1917. and received in action or in the performance of naval or military duty in former wars, notwith-standing that he is not totally disabled from earning a livelihood, may be increased by the difference between his present rate of pension and the minimum pension which he might have received corresponding to his wound or injury under the said Order in Council of the 30th March 1917, or any Order in Council amending the same, as if he had been subject to the provisions of the said Order in Council of the 30th March 1917, or any such amending Order in Council.

"3. The pensions which are being paid under the Regulations for the government of Your Majesty's Naval Service to the widows of seamen and marines who-

(i) Have been killed while in the performance of Naval or Military duty in former wars, or have died of wounds or injuries received in the performance of such duty within seven years after the receipt of the wound or injury, or

(ii) Have died of disease, medically certified as contracted or commencing while on active service in former wars, within seven years of their removal from duty on account of such disease.

may be increased by such sums as will ensure to the widow by way of pension or allowance a total sum of 13s. 9d. a week, including therein any pension or allowance she may be receiving from the Funds of the Royal Patriotic Fund Corporation or from any other Fund or Funds which, in the opinion of the Minister of Pensions. may have been raised by public subscription : Provided that when the widow attains the age of 45, the pension or allowance may be further increased by the weekly amount of 1s. 3d.

Any allowances for children which may still be in course of issue may be continued under former arrangements in addition to the widow's pension.-

"4. The increases to pensions granted under the foregoing Articles shall be subject to the same conditions as the original pensions.

"5. The increases to pensions under the foregoing Articles shall take effect as from the 1st May 1918.

"The Lords Commissioners of Your Majesty's Treasury have signified Their concurrence in these proposals."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Minister of Pensions for the time being is to give the necessary directions herein accordingly.

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the effect that the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to Order, and it is hereby Ordered,

That the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

Note (1). — All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidated List, No. 68A) consolidating all previous Lists, up to and including that of the 15th November 1918, together with List No. 69 of November 29th, List No. 70 of December 13th, List No. 71 of December 20th, 1918, List No. 72 of January 3rd, 1919, and the List herewith annexed, contain all the names which up to this date are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at a small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.

Note (2).—Where a firm is mentioned in the List, every partner in the firm is also included in the List, and all dealings with any partner in the firm, as well as all dealings with the firm, are prohibited : and conversely, all dealings with a firm, any partner in which is mentioned in the List, are also prohibited.

NOTE (3).—Where a person or firm mentioned in the List has more than one address in the country, or group of countries under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited, even in cases where one only of the addresses or one only of the countries is specially mentioned.

Nore (4).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia, or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List. Note (5).—In order to minimise as far as

Note (5).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of information is already available at the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes for individual firms on the Lists, without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants in making inquiries would specify the particular trade or trades for which substitutes are required. General enquiries for new connections abroad should be addressed to The Comptroller-General, Department of Overseas Trade (Development and Intelligence), 73 Basinghall Street, London, E.C. 2.

Note (6).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as The names on the Lists for all they appear. countries in Central or South America are also notified to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

NOTE (7).-It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with de-scriptive terms such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name, followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."
