ORDER BY THE LORDS OF COUNCIL AND SESSION, in pursuance of the Bankruptcy and Judicial Factory Statutes.

Edinburgh, 29th January 1919.

THE Lords of Council and Session, having received the Reports of the Accountant of Court, being the Sixty-first Annual Report on Bankruptcy Cases to 31st December 1917, and Sixty-eighth Annual Report on Judicial Factories to 31st December 1917, Do hereby Direct that the said Reports shall be published, by being made patent to all concerned, at the Office of the Accountant, New Register House, Edinburgh, for one year from this date, and shall, after the expiry of that period, be transmitted to the Deputy-Keeper of the Records: And the Lords Direct this Order to be published by the Accountant in the Edinburgh, London, and Dublin Gazettes, and in one of the Advertising Newspapers in Edinburgh, London, and Dublin: And the Lords Direct this Order to be engrossed in the Books of Sederunt.

REGISTRATION EXPENSES-SCOTLAND.

In pursuance of the powers conferred upon us by Section 15 of the Representation of the People Act, 1918, We, being Two of the Lords Commissioners of His Majesty's Treasury, hereby prescribe that the scale of registration expenses framed by Us on 19th April 1918, shall be modified as follows, viz.:—

(1) For the purpose of estimating the Registration Officer's Salary and Expenses under Part 1 of the aforesaid scale, the number of Absent Voters included in the Absent Voters' Lists may be counted in addition to the number of Electors appearing in the Registers.

(2) The Treasury Order of 16th September 1918 is hereby revoked.
