At the Council Chamber, Whitehall, the 31st day of January 1919.

By the Lords of His Majesty's Most Honourable Privy Council.

WHEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade :

And whereas by a Proclamation, dated the 10th day of May 1917, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited :

And whereas by subsequent Orders of Council and by a Proclamation, dated the 18th day of December 1918, the said Proclamation was amended and added to in certain particulars :

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect :—

That the Proclamation, dated the 10th day of May 1917, as amended and added to by subsequent Orders of Council, and by the Proclamation, dated the 18th day of December 1918, should be further amended by making the following amendments in and additions to the Schedule to the same :—

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, the Director of the War Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

The KING has been pleased to award the Albert Medal to Sister Gertrude Walters Carlin and Staff Nurse Harriet Elizabeth Fraser, both of the Territorial Force Nursing Service; and to Sister Gladys White, of the British Red Cross Society, in recognition of their gallantry in saving life at a Casualty Clearing Station in Belgium in October last.

Early in the morning of the 1st October 1918, a serious fire occurred in No. 36 Casualty Clearing Station at Rousbrugge, in Belgium. At the time some of the patients were undergoing serious operations in the abdominal and general operating theatres, the walls of which were composed of wood. The first intimation of danger in the theatres was the extinction of the electric light accompanied by volumes of smoke, and almost immediately the wooden walls burst

into flames. The two sisters and the staff nurse assisted in carrying the unconscious patients to safety, and returned to the burning wards to assist in carrying out other patients. During this time ether bottles and nitrous oxide cylinders were continually exploding, filling the air with fumes and flying fragments of steel.

THE PETROLEUM PRODUCTS (WHOLESALE PRICES) ORDER, 1919, DATED JANUARY 31, 1919, MADE BY THE BOARD OF TRADE UNDER REGULATIONS 2F and 2JJ OF THE DEFENCE OF THE REALM REGULATIONS.

The Board of Trade, deeming it expedient to make further exercise of the powers conferred upon them by Regulations 2F and 2JJ of the Defence of the Realm Regulations as respects Petroleum Products, hereby order as follows:—

1. In this Order the expression "wholesale dealer" means any person, firm or company whose business or a part of whose business it is to sell to retailers for resale any of the petroleum products mentioned in the schedule hereto.

2. No wholesale dealer shall sell, deliver or supply any of the petroleum products mentioned in the schedule to this Order at prices exceeding those shown against such products.

3. Infringements of this Order are summary offences against the Defence of the Realm Regulations.

4. The Petroleum Products (Wholesale Prices) No. 2 Order, 1918, the Petroleum Products (Contracts) Order, 1918, the Petroleum Products (Wholesale Prices) No. 3 Order, 1918, the Petroleum Products (Wholesale Prices) No. 4 Order, 1918, and the Notice, dated the 18th December 1918, issued under the Petroleum Products (Wholesale Prices) Amendment Order, 1918, of 13th December 1918 are hereby revoked.

5. This Order may be cited as the Petroleum

Products (Wholesale Prices) Order, 1919, and comes into effect on 1st February 1919.

INSURANCE OF ENEMY MERCHANT SHIPS.

Whereas by Royal Proclamation relating to Trading with the Enemy, dated the 9th day of September 1914, and issued with reference to the state of war with the German Empire and the Dual Monarchy of Austria-Hungary, it was declared that from and after the date of the said Proclamation the persons therein referred to were prohibited from doing certain acts therein more specifically mentioned:

And whereas it was further declared by the said Proclamation as follows:—

“ Nothing in this Proclamation shall be taken
“ to prohibit anything which shall be expressly
“ permitted by Our Licence, or by the licence
“ given on Our behalf by a Secretary of State,
“ or the Board of Trade, whether such licences
“ be especially granted to individuals or be
“ announced as applying to classes of persons ”:

And whereas by Proclamation, dated the 5th

day of November 1914, it was declared that the provisions of the Proclamations and Orders in Council then in force issued with reference to the state of war with the Emperor of Germany and the Emperor of Austria, King of Hungary, should be extended to the war with Turkey subject to the exception in such Proclamation mentioned:

And whereas by Proclamation, dated the 16th day of October 1915, it was declared that the Proclamations and Orders-in-Council then in force, issued with reference to the state of war with the German Emperor, or with reference to the state of war with the German Emperor and the Emperor of Austria, King of Hungary, or with reference to the state of war with the German Emperor and the Emperor of Austria, King of Hungary, and the Sultan of Turkey, should be extended to the war with Bulgaria, subject to the exception in such Proclamation mentioned:

And whereas certain enemy merchant ships are or may be under the control of the Allied Maritime Transport Council:

Now, therefore, the Board of Trade, on behalf of His Majesty, and in pursuance of the powers reserved in the said Proclamations and all other powers thereunto them enabling, do hereby give and grant licence to all persons residing, carrying on business or being in the United Kingdom to insure the hull, machinery and cargo of any enemy merchant ship that is for the time being under the control of the Allied Maritime Transport Council, provided that any such insurance is made subject to the following warranties, namely:—

1. Warranted trading under the control of the Allied Maritime Transport Council:
2. Warranted that no claim shall be paid under this policy unless and until the name of the payee shall have been submitted to and approved by the Board of Trade.

The King has been graciously pleased to approve of the award of the Albert medal for gallantry in saving life at sea to:—

Lieutenant George Devereux Belben, D.S.C., R.N.

Sub-Lieutenant David Hywel Evans, R.N.V.R.

P. O. Albert Ernest Stoker, O.N. 227692, and

Able Seaman Edward Nunn, O.N. J.15703.

The account of the services, in respect of which these decorations have been conferred, is as follows:—

On the 16th September 1918, a serious explosion occurred amidships on board H.M.S. "Glatton" whilst lying in Dover Harbour. This was followed immediately by an outbreak of fire, the oil fuel burning furiously and spreading fore and aft. Efforts were made to extinguish the fire by means of salvage tugs. The foremost magazines were flooded, but it was found impossible to get to the after magazine flooding positions. The explosion and fire cut off the after part of the ship, killing or seriously injuring all the officers who were on board with one exception. The ship might have blown up at any moment.

Lieutenant Belben, Sub-Lieutenant Evans, Petty Officer Stoker, and Able Seaman Nunn were in boats which were rescuing men who had been blown, or who had jumped, overboard. They proceeded on board H.M.S. "Glatton" on their own initiative, and entered the superstructure, which was full of dense smoke, and proceeded down to the deck below.

Behaving with the greatest gallantry, and contempt of danger, they succeeded in rescuing seven or eight badly injured men from the mess deck, in addition to fifteen whom they found and brought out from inside the superstructure.

This work was carried out before the arrival of any gas masks, and though at one time they were driven out by the fire, they proceeded down again after the hoses had been played on the flames. They continued until all chance of rescuing others had passed, and the ship was ordered to be abandoned, when she was sunk by torpedo, as the fire was spreading, and it was impossible to flood the after magazines.

His Majesty The KING has been graciously pleased to approve of the award of the Victoria Cross to the undermentioned Officers and Non-Commissioned Officers:—

Lt. (A./Maj.) Brett MacKay Cloutman, M.C., 59th Fld. Coy., R.E., T.F.

For most conspicuous bravery on the 6th November 1918, at Pont-Sur-Sambre.

Maj. Cloutman, after reconnoitring the river crossings found the Quartes Bridge almost intact but prepared for demolition. Leaving his party under cover he went forward alone, swam across the river, and, having cut the "leads" from the charges, returned the same way, despite the fact that the bridge and all approaches thereto were swept by enemy shells and machine-gun fire at close range. Although the bridge was blown up later in the day by other means the abutments remained intact.

T./Lt. Frederick William Hedges, Bedf. R., att'd. 6th Bn., North'n R.

For most conspicuous bravery and initiative during the operations north-east of Bousies on the 24th October 1918.

He led his company with great skill towards the final objective, maintaining direction under the most difficult conditions. When the advance was held up by machine-gun posts, accompanied by one Serjeant and followed at some considerable distance by a Lewis gun section, he again advanced and displayed the greatest determination, capturing six machine guns and 14 prisoners.

His gallantry and initiative enabled the whole line to advance, and tended largely to the success of subsequent operations.

Capt. Coulson Norman Mitchell, M.C., 4th Bn., Can. Engrs.

For most conspicuous bravery and devotion to duty on the night of 8th-9th October 1918, at the Canal de L'Escaut, north-east of Cambrai.

He led a small party ahead of the first wave of infantry in order to examine the various bridges on the line of approach and, if possible, to prevent their demolition.

On reaching the canal he found the bridge already blown up. Under a heavy barrage he crossed to the next bridge, where he cut a number of "lead" wires. Then in total darkness, and unaware of the position or strength of the enemy at the bridgehead, he dashed across the main bridge over the canal. This bridge was found to be heavily charged for demolition, and whilst Capt. Mitchell, assisted by his N.C.O., was cutting the wires, the enemy attempted to rush the bridge in order to blow the charges, whereupon he at once dashed to the assistance of his sentry, who had been wounded, killed three of the enemy, captured 12, and maintained the bridgehead until reinforced.

Then under heavy fire he continued his task of cutting wires and removing charges which he well knew might at any moment have been fired by the enemy.

It was entirely due to his valour and de-

cisive action that this important bridge across the canal was saved from destruction.

Lt. Wallace Lloyd Algie, late 20th Bn., 1st Central Ontario R.

For most conspicuous bravery and self-sacrifice on the 11th October 1918, north-east of Cambrai, when with attacking troops which came under heavy enfilade machine-gun fire from a neighbouring village.

Rushing forward with nine volunteers, he shot the crew of an enemy machine gun, and, turning it on the enemy, enabled his party to reach the village. He then rushed another machine gun, killed the crew, captured an officer and 10 enemy, and thereby cleared the end of the village.

Lt. Algie, having established his party, went back for reinforcements, but was killed when leading them forward. His valour and personal initiative in the face of intense fire saved many lives and enabled the position to be held.

No. 10864 C.S.M. Martin Doyle, M.M., 1st Bn., R. Muns. Fus. (New Ross, Co. Wexford).

For most conspicuous bravery on the 2nd September 1918, near Riencourt, when as Acting Company Serjeant-Major, command of the company devolved upon him consequent on officer casualties.

Observing that some of our men were surrounded by the enemy, he led a party to their assistance, and by skill and leadership worked his way along the trenches, killed several of the enemy and extricated the party, carrying back, under heavy fire, a wounded officer to a place of safety. Later seeing a Tank in difficulties, he rushed forward under intense fire, routed the enemy who were attempting to get into it, and prevented the advance of another enemy party collecting for a further attack on the Tank. An enemy machine gun now opened on the Tank at close range, rendering it impossible to get the wounded away, whereupon C.S.M. Doyle, with great gallantry, rushed forward, and, single-handed, silenced the machine gun, capturing it with three prisoners. He then carried a wounded man to safety under very heavy fire.

Later in the day, when the enemy counter-attacked his position, he showed great power of command, driving back the enemy and capturing many prisoners. Throughout the whole of these operations, C.S.M. Doyle set the very highest example to all ranks by his courage and total disregard of danger.

No. 472168 Serjt. Hugh Cairns, D.C.M., late 46th Bn., Saskatchewan R.

For most conspicuous bravery before Valenciennes on 1st November 1918, when a machine gun opened on his platoon. Without a moment's hesitation Serjt. Cairns seized a Lewis gun and single-handed, in the face of direct fire, rushed the post, killed the crew of five, and captured the gun. Later, when the line was held up by machine-gun fire, he again rushed forward, killing 12 enemy and capturing 18 and two guns.

Subsequently, when the advance was held up by machine guns and field guns, although

wounded, he led a small party to outflank them, killing many, forcing about 50 to surrender, and capturing all the guns.

After consolidation he went with a battle patrol to exploit Marly and forced 60 enemy to surrender. Whilst disarming this party he was severely wounded. Nevertheless, he opened fire and inflicted heavy losses. Finally he was rushed by about 20 enemy and collapsed from weakness and loss of blood.

Throughout the operation he showed the highest degree of valour, and his leadership greatly contributed to the success of the attack. He died on the 2nd November from wounds.

No. 355014 Cpl. (L./Serjt.) William Waring, M.M., late 25th Bn., R. Welsh Fus., T.F. (Welsh-pool).

For most conspicuous bravery and devotion to duty at Rossnoy, on 18th September 1918. He led an attack against enemy machine guns which were holding up the advance of neighbouring troops, and, in the face of devastating fire from flank and front, single-handed, rushed a strong point, bayonetting four of the garrison and capturing 20 with their guns.

L./Serjt. Waring then, under heavy shell and machine-gun fire, reorganised his men and led and inspired them for another 400 yards, when he fell mortally wounded.

His valour, determination, and leadership were conspicuous throughout.

No. 422047 Cpl. James M'Phie, late 416th (Edinburgh) Fld. Coy., R.E., T.F. (Edinburgh).

For most conspicuous bravery on the 14th October 1918, when with a party of sappers maintaining a cork float bridge across the Canal de la Sensée near Aubencheul au Bac.

The further end of the bridge was under close machine-gun fire and within reach of hand grenades. When Infantry, just before dawn, were crossing it, closing up resulted and the bridge began to sink and break. Accompanied by a sapper, he jumped into the water, and endeavoured to hold the cork and timbers together, but this they failed to do. Cpl. M'Phie then swam back, and, having reported the broken bridge, immediately started to collect material for repair. It was now daylight. Fully aware that the bridge was under close fire and that the far bank was almost entirely in the hands of the enemy, with the inspiring words "It is death or glory work which must be done for the sake of our patrol on the other side," he led the way, axe in hand, on to the bridge and was at once severely wounded, falling partly into the water, and died after receiving several further wounds. It was due to the magnificent example set by Cpl. M'Phie that touch was maintained with the patrol on the enemy bank at a most critical period.

No. 307817 Lance-Corporal William Amey, 1/8th Bn., R. War. R., T.F. (Birmingham).

For most conspicuous bravery on 4th November 1918, during the attack on Landrécies, when owing to fog many hostile machine-gun nests were missed by the leading troops.

On his own initiative he led his section against a machine-gun nest under heavy fire, drove the garrison into a neighbouring farm, and finally captured about 50 prisoners and several machine guns.

Later, single-handed, and under heavy fire, he attacked a machine-gun post in a farmhouse, killed two of the garrison, and drove the remainder into a cellar until assistance arrived.

Subsequently, single-handed, he rushed a strongly held post, capturing 20 prisoners. He displayed throughout the day the highest degree of valour and determination.

No. 58062 L./Cpl. Allan Leonard Lewis, late 6th Bn., North'n R. (Whitney, Hereford).

For most conspicuous bravery at Rossnoy on the 18th September 1918, when in command of a section on the right of an attacking line held up by intense machine-gun fire. L./Cpl. Lewis, observing that two enemy machine guns were enfilading the line, crawled forward single-handed, and successfully bombed the guns, and by rifle fire later caused the whole team to surrender, thereby enabling the line to advance.

On 21st September 1918, he again displayed great powers of command, and, having rushed his company through the enemy barrage, was killed whilst getting his men under cover from heavy machine-gun fire. Throughout he showed a splendid disregard of danger, and his leadership at a critical period was beyond all praise.
