A PROCLAMATION

RELATING TO THE IMPORTATION OF CERTAIN ARTICLES INTO THE UNITED KINGDOM.

GEORGE R.I.

Whereas by Section forty-three of the Customs Consolidation Act, 1876, it is provided that the importation of arms, ammunition, gunpowder, or any other goods may be prohibited by Proclamation:

And whereas by certain Proclamations entitled Prohibition of Import Proclamations the importation of certain goods has been prohibited accordingly:

And whereas it expedient that the importation into the United Kingdom of certain other goods should be prohibited:

Now, therefore, We, by and with the advice of Our Privy Council, in pursuance of the said Act and of all other powers enabling Us in that behalf, do hereby proclaim, direct, and ordain as follows:—

As from and after the date hereof, subject as hereinafter provided, the importation into the United Kingdom of the following articles is hereby prohibited, viz.:—

All derivatives of coal tar generally known as intermediate products capable of being used or adapted for use as dye-stuffs, or of being modified or further manufactured into dye-stuffs.

All direct cotton colours, all union colours, all acid wool colours, all chrome and mordant colours, all alizarine colours, all basic colours, all sulphide colours, all vat colours (including synthetic indigo), all oil, spirit, and wax colours, all lake colours, and any other synthetic colours, dyes, stains, colour acids, colour bases, colour lakes, leuco acids, leuco bases, whether in paste, powder, solution, or any other form.

Provided always, and it is hereby declared, that this prohibition shall not apply to any such goods which are imported under licence given by or on behalf of the Board of Trade, and subject to the provisions and conditions of such licence.

This Proclamation may be cited as the Prohibition of Import (No. 29) Proclamation, 1919.

HEREAS by the Summer Time Act, 1916, as amended by the Time (Ireland) Act, 1916, it is provided that during the prescribed period in each year in which the former Act is in force the time for general purposes is to be one hour in advance of Greenwich Mean Time; and it is further provided that His Majesty may, in any year subsequent to the year 1916, by Order in Council made during the continuance of the Present War, declare the former Act to be in force during that year, and in such case the prescribed period for that year shall be such period as may be fixed by Order in Council:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to declare, and it is hereby declared, that the Summer Time Act, 1916, as so amended as aforesaid, shall be in force during the year 1919, and the prescribed period in that year shall be from two o'clock in the morning Greenwich Mean Time on Sunday the 30th day of March until two o'clock in the morning Greenwich Mean Time on Monday the 29th day of September.

The KING's Most Excellent Majesty in Council.

HEREAS by the Aliens Restriction Order His Majesty, in exercise of the power conferred upon Him by the Aliens Restriction Act, 1914, has been pleased to impose restrictions on aliens and to make various regulations for the carrying of those regulations into effect:

And whereas it is expedient further to amend the said Order in manner hereinafter appearing:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:-

At the end of the definition of "Belgian Refugee" in Article 31 of the Aliens Restriction Order there shall be inserted the words, "Provided that no person shall, for the purposes of this Order, be deemed to be a Belgian refugee who has entered the United Kingdom since the first day of February nineteen hundred and nineteen.'

And whereas by Section one, sub-section two, of the said Act, it is provided that any List of persons and bodies of persons, incorporated or unincorporated, with whom such trading is prohibited by a Proclamation under the said Act may be varied or added to by an Order made by the Lords of the Council on the recommendation of a Secretary of State:

And whereas the Statutory List contained in the last-mentioned Proclamation has been varied and added to by subsequent Orders of Council:

And whereas there was this day read at the Board a recommendation from the Secretary of State for Foreign Affairs to the effect that the Statutory List should be further varied and added to as set forth in the Schedule hereto.

Now, therefore, Their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered,

That the Statutory List be varied and added to as set forth in the Schedule hereto.

Whereof the Right Honourable Arthur James Balfour, one of His Majesty's Principal Secretaries of State, the Controller of the Foreign Trade Department, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

Note (1). - All persons or firms resident, carrying on business or being in the United Kingdom are prohibited from having, with any person or firm mentioned in this List, or in any List issued under the Trading with the Enemy (Statutory List) Proclamation, any dealings other than such as are expressly authorised by paragraph 5 of the Proclamation. A List (The Consolidated List, No. 76A) consolidating all previous Lists revised to date and including the amendments in the Schedule annexed hereto is issued concurrently with this Order. This Consolidated List contains all the names which, up to this date, are included in the Statutory List.

Additions to and variations in these Lists will be published at intervals approximately of two weeks.

The Lists are published in the London Gazette and reproduced in the Board of Trade Journal, and separate copies of all Lists may be obtained at small cost from the Superintendent of Publications, His Majesty's Stationery Office, Imperial House, Kingsway, W.C.
Note (2).—Where a person or firm men-

tioned in the List has more than one address in the country, or group of countries, under which the name of the person or firm appears, all dealings in that country, or in any country in the group, with such person or firm are prohibited even in cases where one only of the addresses or one only of the countries is specially mentioned.

Note (3).—Trading is prohibited under the Trading with the Enemy Proclamations of 25th June and 10th November 1915, with any person or firm of enemy nationality resident or carrying on business in China, Siam, Persia, Morocco, Liberia or Portuguese East Africa. Persons or firms in the United Kingdom are therefore prohibited from trading with any person or firm of enemy nationality in any of those countries, even though such person or firm is not mentioned by name in the Statutory List.

Note (4).—In order to minimise as far as possible any inconvenience which may be caused to British traders by the dislocation of export trade owing to the inclusion in the Statutory List of a former connection, the Foreign Trade Department is collecting and classifying the names of non-enemy firms who may be able to act as substitutes for firms mentioned in the Statutory List. A considerable amount of in-

formation is already available in the Foreign Trade Department, and it is in many cases possible to suggest the names of satisfactory substitutes for individual firms on the Lists, without the necessity of referring the matter abroad. The Department is, however, prepared on application to inquire of His Majesty's Representatives abroad for the names of suitable substitutes. When the applicant wishes this done by telegraph he is required to undertake to pay the cost of telegraphic correspondence. It would greatly facilitate the work of the Foreign Trade Department if applicants, in making inquiries, would specify the particular trade or trades for which substitutes are required. General enquiries for new connections abroad should be addressed to The Comptroller-General, Department of Overseas Trade (Development and Intelligence), 73 Basinghall Street, London, E.C. 2.

Note (5).—The Statutory List for each country is telegraphed, on the day of issue, to His Majesty's representative in that country, who is instructed to notify accordingly British Consular Officers, to whom persons abroad should apply for information as to names on the List. Persons and firms in the United Kingdom with agencies or branches abroad would, however, be well advised to furnish such agencies or branches with issues of the List as they appear. The names on the Lists for all countries in Central or South America are also notified to His Majesty's Ambassador at Washington, who transmits them to H.M. Consul-General at New York and to other centres in the United States likely to be interested.

NOTE (6).—It is not unusual for firms in Holland and the Netherland East Indies to be registered under names commencing with descriptive terms such as "Handel Maatschappy" (Trading Company) or "Naamlooze Venootschap" (Limited Liability Company). In such cases it has been found more convenient to publish the firm under its proper name followed by the general descriptive term "Handel Maatschappy" or "Naamlooze Venootschap" (N.V.) as in the case of an English company. For instance, Handel Maatschappy van den Berg & Company, and Naamlooze Venootschap de Komeet v/h Dumonceau Frères will be found under "Berg" and "Komeet" respectively, and not under "Handel" or "Naamlooze."

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an

Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by a Proclamation, dated the 10th day of May 1917, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act, 1900, and Section 1 of the Customs (Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited:

And whereas by subsequent Orders of Council, and by the Proclamation, dated the 18th day of December 1918, the said Proclamation was amended and added to in certain particulars:

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect:—

That the Proclamation, dated the 10th day of May 1917, as amended and added to by subsequent Orders of Council, and by the Proclamation, dated the 18th day of December 1918, should be further amended by making the following amendments in and additions to the Schedule to the same:—

- (1) That the following headings should be deleted:—
 - (A) Asbestos, raw, crude and opened fibre;
 - (A) Bones (except fish bones) in any form and bone ash;

Chemicals, drugs, dyes, dye-stuffs, and medicinal and pharmaceutical preparations, the following:—

- (A) Radium and its compounds;
- (A) Deerskins;
- (A) Fats, all animal and vegetable, and articles and mixtures containing such fats, not otherwise specifically prohibited;

 - (A) Felt, roofing;
- (A) Fibres, vegetable, not otherwise specifically prohibited, except China grass (ramie fibre);

Leather goods of the following descriptions:--

- (A) Leather Waste;
- (A) Manures, organic;
- (A) Molasses and feeding stuffs containing molasses;

Provisions and victuals which may be used as food for man, the following:—

- (A) Syrups which may be used as food for man;
- (A) Kattans;
- (A) Sealskins, fur and hair;

Seeds, the following:-

- (A) Beet;
- (A) Broccoli;
- (A) Brussels sprouts;
- (A) Carrot;
- (A) Chicory;
- (A) Kale;
- (A) Kohl rabi;

DEFENCE OF THE REALM (LIQUOR CONTROL).

ORDER (FURTHER AMENDMENT) OF THE CENTRAL CONTROL BOARD (LIQUOR TRAFFIC) FOR THE SCOTLAND, NORTHERN, AREA.

We, the Central Control Board (Liquor Traffic), in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm, hereby make the following Order:—

COURTS OF REFEREES.

Constitution of Panels to represent Employers and Workmen.

1. These Regulations may be cited as the Unemployment Insurance (Courts of Referees) Regulations, 1919, and shall come into force on the date hereof.

2. Regulation 20 of the Unemployment Insurance Regulations, 1912, the Unemployment Insurance (Courts of Referees) Emergency Regulations, 1915, and Regulation 2 of the Unemployment Insurance (Supplementary No. 2) Regulations, 1916, are hereby repealed.

3. Subject and without prejudice to the provisions of Regulation 3 (v) hereof, the panels of persons to represent employers and workmen respectively required to be constituted under sub-section (2) of Section 90 of the National Insurance Act, 1911, shall be constituted as follows:—

(i) The number of the members of the panel shall be such as the Minister of Labour thinks fit.

(ii) The members of the panels to represent the employers and workmen respectively in a district shall be appointed by the Minister of Labour, but the Minister, before making the appointment, shall take into consideration the names of any persons suggested for appointment by the Advisory Committees, if any, constituted for that district under subsection (5) of Section 2 of the Labour Exchanges Act, 1909.

Provided that if in any district an Advisory Comm ttee, as aforesaid, is

not in existence, the Minister, before making the appointments, shall take into consideration the names of any persons suggested for appointment by or on behalf of any employers or workmen or any associations of employers or workmen who appear to him to be interested.

(iii) The term of office of the members of a panel shall be for one year or such longer term as the Minister may direct.

(iv) Casual vacancies on a panel representing either employers or workmen may be filled by the Minister of Labour in like manner as above, and any person appointed to fill a vacancy shall hold office until the expiration of the period during which the person in whose place he is appointed would have held office.

Provided that the Minister shall not be bound to fill any casual vacancy unless he think fit to do so, and a panel shall not be deemed to be improperly constituted by reason only that a casual vacancy on a panel has not been filled.

(v) Notwithstanding anything in these Regulations the members of the first panels of Referees constituted under the National Insurance Act, 1911, shall continue to hold office until such time as their office is terminated by the Minister of Labour.

Did most useful service prior to the operations in fixing positions north of Gaza, thus enabling a map to be drawn up. Rendered every assistance to R.A. Egypt from the 6th to 12th November 1917, when the Rear-Admiral's flag was flown in Enterprise.

Cdr. Cecil James Crocker, R.N., H.M. Monitor M.31.

Was senior officer of the M. class Monitors. After the capture of the Sheikh Hassan position, in the early morning of the 2nd November

1917, the monitors and destroyers operated to cover this position whilst it was being consolidated. When the enemy made a strong and determined counter-attack, lasting from about 3 to 4.30 p.m., Cdr. Crocker closed his squadron inshore and maintained a heavy fire upon the enemy, which went far to break up the attack. He displayed great tact and resource, and maintained close relations with the military on the sea flank of the Expeditionary Force, and it was largely due to his personality that the naval co-operation was so successful.

Cdr. Edmond Alan Berners Stanley, M.V.O., R.N., H.M.S. Staunch.

Senior officer of destroyers employed guarding the flank of the Army during the Gaza operations, and rendered valuable service during the enemy's counter-attacks upon Sheikh Hassan.

Lieut.-Cdr. (now Cdr.) Francis Edmund Blechynden Haselfoot, R.N., H.M.S. Grafton.

This officer's previous experience, coupled with his energy and originality, was of the greatest value. He prepared observation posts and arranged communications from them to the signal stations, designed and constructed spotting clocks, placed landmarks and fixed them by triangulation, produced special squared maps for naval bombarding purposes, and assisted in the survey north of Gaza. During the operations he was attached to the XXIst Corps as Liaison Officer, in which capacity he did excellent work.

Maj. and Bt. Lieut.-Col. (tempy. Lieut.-Col.) Trant Bramston Luard, R.M.L.I., H.M.S. Hannibal.

Was employed with Lieut.-Cdr. Haselfoot to establish observation posts before Gaza for naval use. He was in charge of the spotting officers and men, and rendered valuable services in authorising fire. The accuracy and success of the sea bombardment was largely due to Major Luard's organisation.

Cdr. George Gregory, O.B.E., R.D., R.N.R.

Was Naval Transport Officer in charge of the landing of stores and ammunition on the coast. The victualling of the Army and the supply of ammunition was largely dependent on the landing of stores upon an open coast under unfavourable conditions; it reflected great credit on Cdr. Gregory and his staff that this work was so well performed, and that such excellent results were obtained from the Egyptian labourers employed on it.

Lieut.-Cdr. (act. Cdr.) Vaughan Alexander Edward Hanning-Lee, R.N., H.M.S. Ladybird.

Senior officer of river gunboats. vessels replaced the destroyers on flank guard when the latter were absent fuelling, and were also employed cutting wire defences before the attack upon Sheikh Hassan, and in firing on trenches and observation posts. The Ladybird's fire upon Askelon, about 3.30 p.m. on the 8th November 1917, disorganised the enemy's spotting arrangements and reduced the casualties of our troops.

Commanded the Drifter Flotilla which laid and maintained indicator nets off the beaches, on which stores were landed. Owing to the strength of the current off the coast, the nets frequently dragged out of position, necessitating their being weighed and relaid. That this defence was kept in so satisfactory a state was due to the unremitting care and attention paid by Lieut. Brand and the hard work done by the drifter crews.

In recognition of his services in going into a burning ammunition dump to assist in extinguishing a fire, on the 16th October 1917.

The KING has been graciously pleased to approve of the award of the Albert Medal for gallantry in saving life at sea to

Commander Henry de Beauvoir Tupper, R.N., and

Able Seaman Edward Thomas Spalding, O.N. J55883 (Ch.).

The account of the services in respect of which these decorations have been conferred is as follows :-

On the 4th August 1918, H.M.S. "Comet," under the command of Commander Tupper, was seriously damaged in collision. The ship was badly holed on the starboard side, the deck and all compartments eventually filled with water as far as the engine-room bulkhead, and the stern was at any moment liable to fall off. On being informed that the hydraulic release depth-charge was set to "fire," Commander Tupper sent away a man in a whaler to remove the primer. It was only possible to remove the primer from one of the charges, leaving the other depth-charge about 15 feet under water, still at "fire." Commander Tupper then went away in a dinghy himself, and by repeated diving operations tried to render it safe. After a rest he returned to complete the operation, in which Able Seaman Spalding, who was a passenger on the ship at the time and was a good swimmer, volunteered to assist. Commander Tupper at first refused to allow Spalding to assist him, as the latter had no knowledge of depthcharges, and Commander Tupper did not consider it safe for him to go down. Ultimately Com-mander Tupper and Able Seaman Spalding swam to the spot beneath which the depth-charge was submerged, and alternately gave a turn to the iron bar which Commander Tupper had placed in the handle, until the primer was eventually unscrewed and taken out of the depth-charge, thus rendering it safe. This operation was of the most dangerous nature, as at any moment the stern of the ship might have dropped off before the depth-charge was removed and would have carried down both the officer and the man, who would have inevitably lost their lives. The explosion would also have destroyed the remaining portion of the ship, with loss of life to those of the crew who were on board.
