At the Court at Buckingham Palace, the 11th day of July 1919.

#### PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 25th day of June 1919, in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed by Order in Council:

"And whereas by Your Majesty's Orders in Council bearing date the 29th October 1914, the 10th January 1917, the 13th March 1917, and the 19th May 1917, Colour Sergeants of Royal Marines borne on the books of Your Majesty's Ships are placed in Class II. of the Navy Separation Allowance Scale:

"And whereas we consider it advisable that these Non-Commissioned Officers should be placed in Class III. of that Scale:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the amendment of the Scale accordingly with effect from the 3rd April 1919.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

The KING's Most Excellent Majesty in Council.

WHEREAS by the Weights and Measures Act, 1878, it is (among other things) provided that the Board of Trade shall, from time to time, cause such new Denominations of Standards, being either equivalent to or multiples or aliquot parts of the Imperial weights and measures ascertained by the said Act, as appear to them to be required in addition to those mentioned in the Second Schedule to the said Act, to be made and duly verified, and that those new Denominations of Standards, when approved by His Majesty in Council, shall be Board of Trade Standards in like manner as if they were mentioned in the said Schedule:

And whereas it has been made to appear to the Board of Trade that the new Denominations of Standards set forth in the Schedule hereto, being multiples of the Imperial measure of one gallon, ascertained by the said Act, are required, in addition to the Denominations of Standards mentioned in the Second Schedule to the said Act:

And whereas the Board of Trade have caused the said new Denominations of Standards to be made and duly verified:

Now, therefore, His Majesty, by virtue of the power vested in him by the said Act, by and with the advice of His Privy Council, is pleased to approve the several Denominations of Standards set forth in the Schedule hereto as new Denominations of Standards, and doth direct that the same, on and after the first day of August 1919, shall be Board of Trade Standards in like manner as if they were mentioned in the Second Schedule to the Weights and Measures Act, 1878.

It is no longer necessary for travellers who may wish to proceed to the Orkneys to obtain permits from the Officer Commanding Troops, Lerwick.

The KING has been graciously pleased to confer the Decoration of the Albert Medal upon Trumpeter Mangal Sain, 2nd Lancers, Indian Army.

On the 15th March last, while some Turkish prisoners-of-war were bathing at Beirut under a guard of British soldiers, one of them got into difficulties. Two members of the escort went to his assistance but failed to rescue him. On hearing of the man's danger, Mangal Sain at once swam out through the surf and even-

tually with great difficulty brought him ashore. Shortly afterwards two British soldiers who were bathing were seen to have been caught in a current and to be in danger of drowning, and Mangal Sain, although still exhausted on account of his rescue of the first man, again swam out

to the assistance of the two others. He succeeded in bringing one man ashore, and, although he was completely done up, he immediately started without hesitation to the rescue of the other soldier. He was, however, called back, as it was seen that the man had drifted so far out that it was impossible to save him.

Both men who were rescued were in the last state of collapse and must inevitably have been drowned had it not been for the gallantry displayed by Mangal Sain, who incurred great risk in rendering the services, owing to the violent surf and the dangerous currents beyond.

and 1918, should apply to that trade:
And whereas the Trade Boards Acts, 1909 and 1918, do not apply to the trade specified in the appendix to this Order, and the Minister of Labour as respects that trade is of the opinion aforesaid:

Now, therefore, I, the Minister of Labour, in pursuance of the powers given to me by Section One of the Trade Boards Act, 1918, and by any other statute in that behalf, do hereby make a Special Order that from and after the 18th day of July 1919, the following provision shall have effect (that is to say):

Article 1.— The Trade Boards Acts, 1909 and 1918, shall apply to the trade specified in the appendix of this Order.

Article 2.—This Order may be cited as the Trade Boards (Rope, Twine and Net) Order, 1919.

#### TRADE.

The Rope, Twine and Net Trade, that is to say-

1. The making or re-making of (a) rope (including driving rope and banding), (b) cord, (including blind and window cord, but excluding silk, worsted, and other fancy cords), (c) core for wire ropes; (d) lines, (e) twine, (including binder and trawl twine), (f) lanyards, (g) net and similar articles.

- 2. The bleaching, teazing, hackling, carding, preparing and spinning of the materials required for the making or re-making of any of the articles (a) to (g) above when carried on in the same factory or workshop as such making or re-making.
- 3. The manufacture of packings, gaskins, and spun yarns, when carried on in the same factory or workshop as the making or re-making of any of the articles (a) to (g) above.
- 4. The braiding or splicing or articles made from rope, cord, twine or net.
- 5. The mending of nets and the winding, twisting, doubling, laying, polishing, dressing, tarring, tanning, dyeing, balling, reeling, finishing, packing, despatching, warehousing, and storing of any of the above articles, where these operations or any of them are carried on in a factory or workshop in which any of the articles (a) to (g) above are made or re-made.

#### But excluding-

the making of wire rope (unless made in the same factory or workshop as hemp or similar rope or core for wire rope), and also excluding the making of net in connection with the lace curtain trade, and the wearing of cloth.
