GENERAL LICENCE.

THE MOTOR CARS REGULATION (COUNTY OF PERTH) ORDER, 1919, DATED 19TH AUGUST 1919.

In pursuance of the powers vested in me by Sections 8 and 9, as read with Section 18 of the Motor Car Act, 1903, I, the Right Honourable Robert Munro, His Majesty's Secretary for Scotland, on the application of the County Council of the County of Perth, being the local authority of the said County, do hereby make the following regulations:—

1. This Order may be cited as "The Motor Cars Regulation (County of Perth) Order, 1919," and the regulations hereby prescribed shall take effect within the limits or places referred to therein on and after the respective dates at which, for the purpose of giving effect thereto, the local authority shall, in terms of Section 10 of the Motor Car Act, 1903, place notices in conspicuous places on or near such limits or places.

2. A person shall not drive any motor car exceeding two tons in weight unladen within the limits or places specified in the Schedule to this Order.

3. A person shall not drive any motor car at a speed exceeding ten miles per hour within the said limits or places.

4. Upon the preceding regulations taking effect, the regulations prescribed by the Motor Cars Regulation (County of Perth) (No. 1) Order, 1907, shall cease to have effect as regards such portions of the highways or parts of highways specified in the Schedule thereto as are included in the limits or places specified in the Schedule to this Order.
