LOCAL GOVERNMENT (SCOTLAND) ACTS. COUNTY COUNCIL ELECTORAL DIVISIONS OF FIFE. ORDER BY THE SECRETARY FOR SCOTLAND.

Whereas the Contents and Boundaries of the Electoral Divisions of Aberdour, Dalgety, and Inverkeithing, Oakley, and Kincardine, in the County of Fife were determined by Order of the Boundary Commissioners for Scotland, dated 3rd November 1891:

And whereas the Contents and Boundaries of the Electoral Divisions of Markinch North and Markinch South and of Ballingry North and Auchterderran North in the said County were determined, as regards the two first mentioned Divisions, by Order of the Secretary for Scotland, dated 17th August 1906, and as regards the two Divisions second mentioned, by Order of the Secretary for Scotland, dated 7th September 1915:

And whereas the County Council of the said County have represented to me that it is desirable to divide the said Divisions of Aberdour and Dalgety and Inverkeithing into three Electoral Divisions, and to divide each of the other said Divisions into two Electoral Divisions, thereby increasing by seven the number of County Councillors in the said County:

And whereas I am of opinion that it is expedient to give effect to the application of the County Council:

Now, therefore, I, the Right Honourable Robert Munro, His Majesty's Secretary for Scotland, in virtue of the powers conferred on me by Section 51 of the Local Government (Scotland) Act, 1889, do hereby order and determine as follows:—

- 1. The number of County Councillors for the County of Fife shall be increased from 66 to 73.
- 2. The aforesaid Order of the Boundary Commissioners for Scotland, dated 3rd November 1891, is hereby recalled in so far as concerns the Electoral Divisions of Aberdour, Dalgety, and Inverkeithing, Oakley, and Kincardine.
- 3. From and after this date-
 - (a) the Electoral Divisions of Aberdour and Dalgety and Inverkeithing shall be divided into three Electoral Divisions, having the following names and contents, that is to say:—

1. Combination of Authorities.

Article 1.-From and after the date of the coming into operation of this Order, the said Local Authorities (hereinafter referred to as the Combining Authorities") are authorised by Us to act together for the purpose of carrying out the Regulations contained in the said Order of 26th October 1916 aforesaid, or any further Regulations that We may make hereafter with reference to the diagnosis, treatment, and prevention of Venereal Diseases.

Administrative Committee.

Article 2 (1).—All things that may be necessary for the purpose of carrying out the aforesaid Regulations within the districts of the aforesaid

County Council of Kincardineshire acting through the Public Health Committee of the said County Council of the said County (hereinafter referred to as "the Committee").

Annual Meeting, &c.

(3) The Committee shall fix (a) the date in each year on or before which the proportions of the amount of the estimated expenditure for the year, or (b) the dates in each year on or before which instalments of the proportions of the estimated expenditure for the year are to be paid to them by the several Combining Authorities; and shall intimate such date or dates to these Authorities, who shall make payment of the amounts on or before the date so fixed and intimated.

(4) The Committee shall make up and transmit to Us claims for any Government Grant in aid payable in respect of the expenditure incurred by them or under their authority upon the diagnosis, treatment, and prevention of Venereal Diseases, and shall receive such Government Grant in aid payable in respect of such expendi-

Accounts and Audit.

Quorum.

Annual Meeting-Election of Chairman, &c.

(8) A general meeting of the Joint Committee shall be held annually on such date in the month of January or February as the Committee shall determine. At the general meeting or some adjournment thereof the members shall elect one of their numbers to be chairman for the year then ensuing and another to be vice-chairman for the same period; Provided that at the first meeting of the Joint Committee convened in terms of Article 2 (6) hereof, the members shall elect one of their number to be chairman for the period till the first annual general meeting in terms hereof and another to be vice-chairman for the same period.

Meetings and Powers of Joint Committee.
