DEFENCE OF THE REALM.

ORDER of the Secretary for Scotland, dated 2nd October 1919, under Regulation 11 of the Defence of the Realm Regulations as to Lights on Vehicles in Scotland.

In pursuance of the power conferred on me by Regulation 11 of the Defence of the Realm Regulations, I hereby make the following Order:—

REQUIREMENTS AS TO LIGHTS TO BE CARRIED ON VEHICLES AND AS TO LIGHTING-UP TIME.

- (1) Every vehicle on any street, highway, or road in Scotland to which the public have access, between half-an-hour after sunset and half-an-hour before sunrise, must carry lamps as follows:—
 - (a) at the front, two lamps displaying to the front a white light, except in the case of

bicycles, tricycles (other than motor tricycles), or hand-carts, on which only one such lamp need be carried. One lamp must be placed on the extreme off or right-hand side of the vehicle, and the second lamp in the corresponding position on the extreme near or left-hand side of the vehicle; and

(b) at the rear, a lamp displaying to the rear a red light. The lamp carried for this purpose on any vehicle except a bicycle or tricycle (other than a motor tricycle) must be placed on the off or right-hand side of the vehicle:

Provided that a hand-cart carrying on the right-hand side one lamp displaying a white light to the front and a red light to the rear shall be deemed to comply with the foregoing requirements of this paragraph; and this paragraph shall not apply in the case of a bicycle which is being wheeled by hand as near as possible to the edge of the roadway.

- (2) The lamp or lamps must be properly trimmed, lighted and attached, so that the light from each lamp is visible in the prescribed direction for a reasonable distance without obstruction by any part of the vehicle, its burden, the person in charge, the draught animal, or any animal led at the rear.
- (3) For the purposes of this Order the word "vehicle" shall include any bicycle, tricycle, or velocipede, and any handcart, and the word "handcart" shall include any vehicle drawn or propelled by hand.

(4) This Order may be cited as the Lights on Vehicles (Scotland) Order of the 2nd October 1919.

His Majesty the KING has been graciously pleased to approve of the following immediate awards for conspicuous gallantry and devotion to duty in North Russia conferred by Maj.-Gen. C. C. M. Maynard, K.C.B., C.M.G., D.S.O., in pursuance of the powers vested in him by His Majesty:—

MURMANSK COMMAND.

Awarded a Bar to the Military Cross.

Lt. (A./Maj.) William James Luck, M.C., 420th Btv., 6th Bde., R.F.A.

For conspicuous gallantry and initiative. On 7th June 1919, south of Medvyeja-Gora, he was in command of two howitzers supporting Russian infantry, when a strong enemy post held up the advance. He brought one of his guns into action close to the front line, and under intense fire maintained a rapid rate of fire for twenty minutes until the enemy was completely stopped from working round the flank.

Awarded the Military Cross.

Lt. Robert Leslie Bellhouse, 420th Bty., 6th Bde., R.F.A.

As F.O.O. he successfully registered the guns of his battery on to different points in the enemy's lines. On two occasions he was shelled out of his position and took up another. It was by his courage and devotion to duty that the guns of his battery were able to open a successful bombardment on the enemy position in the taking of Kapaselga on 5th July 1919.

T./Lt. James Grattan Cregan, 253rd Coy., M.G. Corps.

On 12th and 23rd June 1919, during actions south of Medvyeja-Gors, he displayed great initiative and boldness in handling his machinegun section, and did great service to the infantry. He showed great coolness, and set a fine example to his section under heavy fire. He has done consistently good work since he has been in Russia.

Lt. George Edmund Fullman, M.M., "A" Section, Mobile Column, 6th Bde., R.F.A.

He has commanded the 65 m.m. section during the operations from Urosozoro to Medvyeja-Gora, 1st to 21st May 1919, and has shown great gallantry and initiative in pushing forward his guns in close support of the infantry. On 3rd May, under heavy fire, he forced two armoured trains to withdraw, enabling our infantry to enter Maselga without further opposition. On 21st May he again did good work in dispersing the enemy, who were collected near Medvyeja-Gora station.

Lt. (A./Capt.) Arthur Bernard Glover, R.E., T.F.

As O.C. Signals, in all operations from the taking of the Onda Bridge and Segeja on 19th February 1919, to the occupation of Medvyeja-Gora on 21st May 1919, he has worked splendidly, directing the repair of broken lines under heavy fire and maintaining communication. This meant at times walking twenty miles in a night under severe Arctic conditions. He showed great pluck and devotion to duty.

Lt. Daniel Walter Thomas Gurney, No. 1 Spec. Coy., K.R.R.C.

He displayed consistent gallantry throughout several weeks' continuous fighting during the successful advance down the Murmansk railway in April and May 1919. On 15th May, when attacking the enemy north of Medvyeja-Gora his platoon came under exceedingly heavy machine-gun fire. He dashed forward with his front section and led his men splendidly till he fell severely wounded just prior to the capture of the position.

Lt. The Hon. John Cyril Carnegie Jervis, K.R.R.C.

On 19th May 1919, when his company suddenly encountered heavy fire and greatly superior numbers in thick woods between Maselga and Medvyeja-Gora, he formed his platoon as a rallying party and opened covering fire, enabling the wounded to be evacuated while the company re-formed. His cool courage and prompt action relieved a critical situation.

Lt. Francis Theodore Sobey, Midd'x R.

For conspicuous gallantry and dash during the operations 15th-23rd May 1919, between Maselga and Medvyeja-Gora. With his platoon he helped to turn the enemy's right flank, charging the last machine-gun post and putting the enemy to flight. Later, he made daring reconnaissances and brought back valuable information. His leadership and judgment have been consistently good.

T./2nd Lt. William Colston Wannell, R.A.S.C.

When carrying out a reconnaissance on Lake Onega on 8th July 1919, in close touch with enemy vessels, the motor-boat caught fire and a patrol tank exploded. Though badly shaken himself he assisted three wounded mechanics on to the upper deck, and then returned to the engine-room and drove the one engine, which was still working, until the boat was within a mile of the shore, when a second explosion wrecked her. His pluck and devotion to duty in driving the engine, at great risk to himself, got the boat near the shore and saved lives.

Lt. Charles Toller Whinney, Midd'x R.

For marked gallantry and good leadership. On the night 15th/16th May 1919, during operations which led up to the capture of a position north of Medvyeja-Gora, he was in charge of the advanced guard of two platoons sent out to exploit the success already obtained. Encountering an enemy armoured train he so manceuvred his men that they got within rifle-bombing range of it and forced it to withdraw. On the 12th June, south of Medvyeja-Gora, he secured the left flank of the attack, and handled his platoon with the skill he invariably displayed.

Awarded the Distinguished Conduct Medal. 49177 Pte. (L./Cpl.) E. Felton, 253rd Coy., H.G. Corps (Bermondsey).

On 12th June 1919, during the attack on a position south of Medvyeja-Gora, he advanced with his gun under heavy fire, and by effective fire from exposed positions did excellent work. When owing to a stoppage in his gun he had to expose himself to machinegun fire from an armoured train, his coolness was admirable. He had previously distinguished himself at Archangel in September.

20545 Sjt. C. A. Fletcher, 420th By., 6th Bde., R.F.A. (Newcastle-on-Tyne).

For conspicuous gallantry and devotion to duty. On 3rd May 1919, about two miles from Meselga, when the infantry were held up by two armoured trains, he got gun and ammunition up while the officer commanding section was forward reconnoitring, thereby enabling fire to be brought to bear on the trains, causing the enemy to retire into Meselga Station. The gun was then manhandled some 2000 yards forward, which again brought the trains in the station under fire and forced them back. Throughout the operations he did well.

560048 Sjt. C. T. Flinn, Syren Sig. Coy., R.E. (Harrow).

For conspicuous gallantry and good work in all operations from the capture of Segeja, on 19th February 1919, to the capture of Medvyeja-Gora on 21st May. Under severe arctic conditions and constant fire he repaired broken lines, and it was largely due to his energy and example that communication between the forward troops and brigade head-quarters was maintained.

11417 Sjt. F. W. Hammond, K.R.R.C. (posted No. 1 Spec. Coy., Syren, N.R.E. Fce.) (Portsmouth).

For marked gallantry and coolness on 15th May 1919, between Meselga and Medvyeja-Gora. When his platoon was held up by severe rifle fire from hidden positions, he led a section forward and opened rapid fire at close range. Again, on 19th May, near Medvyeja-Gora, after the company had retired, he went back under close-range rifle-fire and carried his wounded platoon commander to a place of safety.

L.16879 Sjt. D. Hogan, M.M., Midd'x R. (Templederry).

For conspicuous gallantry on 23rd June 1919, in command of his platoon south of Medvyeja-Gora. The company was held up by superior enemy forces. He maintained the position gained. It was due to his splendid behaviour that a critical situation was saved. He has throughout set a very high

example to his platoon, which he has led constantly with marked skill.

L/17393 Pte. R. Sheead, Midd'x. R. (Earlsfield).

For most marked gallantry and initiative on 19th June 1919 at Kartashi. Seeing several of the enemy getting a machine-gun into action outside a house, he at once charged and engaged them. He bayonetted one and shot another, and then was attacked by five others, being wounded in two places. His splendid action prevented the machine-gun being used against our troops, who captured the village without further casualties.

95609 Pte. (A./Sjt.) C. Smith, 10th Bn., R. Fus. (Int. Corps) (New York).

On 11th June 1919 he, finding a company of local troops wavering, went forward alone under heavy fire, and by his fine example encouraged them to advance. He led them forward two miles, and during the advance attacked and overcame enemy posts single-handed. His splendid courage and example saved a critical situation. On several occasions he has obtained valuable information.

65753 Cpl. R. J. Spencer, 13th Bn., York. R. (Chilcote Ashby).

Since joining the battery on 23rd December 1918 he has done exceptionally good work. At the taking of Segeja on 19th February, after his serjeant had been killed and his officer and two men wounded, he continued to work the gun under heavy fire from an armoured train, and got several direct hits on it, causing it to retire. He was also No. 1 on a gun in the advance of Medvyeja-Gora from 15th May until the town was occupied, and by his endurance and pluck held his team together during a strenuous advance.

36455 A./B./S./M. A. H. Tilbury, 420th By., 6th Bde., R.F.A. (Woking).

For conspicuous gallantry and devotion to duty. On 7th June 1919, south of Medvyeja-Gora, a howitzer, in close support of Russian infantry, came under heavy machine-gun and rifle fire. The ammunition was expended. He went back several times, and brought up ammunition from the G.S. wagons behind. He set a splendid example to all ranks. During subsequent operations, up to the capture of Kapaselga on 5th July, he has done particularly good work in action.

925587 Bdr. W. Wilson, 420th By., 6th Bde., R.F.A. (Warmborough).

For conspicuous gallantry, energy and resource throughout the operations from 10th June to 5th July 1919, particularly on 17th June, near Fedotova, on 22nd June at Fedotova, and on 30th June at Unitza. On the two first-mentioned occasions he got his gun into action under very heavy fire, and from exposed positions did excellent work with it. On 30th June he sank the enemy s.s. "Slutski" off Unitza, getting his gun into action with astonishing rapidity, and maintaining a remarkably accurate fire.

His Majesty the KING has been graciously pleased to approve of the following immediate awards for conspicuous gallantry and devotion to duty in North Russia conferred by Maj.-Gen. W. E. Ironside, K.C.B., C.M.G., D.S.O., in pursuance of the powers vested in him by His Majesty:—

ARCHANGEL COMMAND.

Awarded the Distinguished Service Order.

Maj. (T./Lt.-Col.) Henry Ernest Lavie, Durh. L.I., attd. 13th Bn., York. R.

For inspiring leadership and devotion to duty when in command of the Seletskoe Detachment. No exertion on his part has been too great in ensuring that proper defensive measures were being taken, and the entire lack of success of enemy attacks made on his front during April 1919, can be attributed in great measure to the change of morale in the defending troops owing to his personality and power of command.

Capt. (T./Lt.-Col.) Ivan Claude Montford, Rif. Brig., Spec. Res.

He conducted a very daring reconnaissance five miles behind the enemy's front, arriving within 1000 yards of a strong enemy position. The information he obtained was most valuable. He has for five months commanded the troops on both banks of the Dvina River, and by his personal courage and tact has pulled his troops of mixed nationalities through a difficult period.

SOUTH AFRICAN FORCE.

Capt. Thomas Girdwood Macfie, M.C., 4th Bn., South African Infy.

On 2nd June 1919, he was near the 18-pr. position on his way to the observation post. He collected and organised some infantry at this point. He then went back to Priluk, rallying and encouraging Russian infantry who were disorganised, and himself led a counter-attack against Priluk, which was recaptured, together with all the guns. This success was due to his marked gallantry and ability to command.

Awarded the Military Cross.

T./Capt. Tom Esmond Geoffrey Bailey, 6th Bn., York. R.

On 22nd March 1919, he organised his company for the attack on Bolshe-Ozerki next day. After a previous exhausting march he led his men in the attack with great gallantry in face of heavy fire to within 500 yards of Bolshe-Ozerki. On receiving orders to retire he skilfully extricated his command.

Capt. David Buik Barr, E. Lan. R., Spec. Res.

At Troitsa, on 7th July 1919, he fought his way out of a house under heavy machine gun and rifle fire. He held out until he was the only man left in the house, and though severely wounded in nine places, swam to a monitor which was lying several hundred yards away. He showed splendid pluck and endurance.

Rev. Wilfrid Roland Alexis Brown, T./Chap. to the Forces, 4th Class, R.A. Chap. D., attd. 6th Bn., York. R.

During the operations on 3rd March 1919, near Bolshe-Ozerki, he went forward with a company under heavy machine-gun fire, reorganised the stretcher-bearers, and attending to the wounded by pulling them out of the snow and dressing their wounds. It was chiefly owing to his energy and fine disregard for personal danger that all the wounded of this company were evacuated.

T./Lt. Cecil Dickson, Ches. R., attd. 2/7th Durh. L.I., T.F.

When in command of the British sector of the Allied Mission which left Archangel on the 8th March 1919, and arrived at Omsk 21st May, to establish communication with the Serbian Army of Admiral Koltchak, he showed great courage and initiative behind the enemy's lines, and in dealing with superior enemy forces, by which to a large extent the succession of the Mission was secured.

2nd Lt. James Ellis, York. R., attd. 13th Bn.

For marked gallantry and devotion to duty on 8th/9th June 1919, near Alexandrovo. Although the Russian flanking party had withdrawn, he attempted to rush a hostile post with eight men. On 15th June, with a patrol of twelve other ranks, he kept up a running fight for three hours with an enemy patrol about 100 strong. A splendid leader who can always get the best out of his men

2nd Lt. Frederick March, York. R., attd. 6th Bn.

On 23rd March 1919, when his company commander was killed, he led the company within 200 yards of the enemy in deep snow. He coolly walked up and down his lines under heavy fire, keeping his platoons in touch with each other. On being ordered to retire, he skilfully withdrew his command, bringing back all wounded. He showed cool courage and ability to command.

Lt. John Morrison, M.B., R.A.M.C., Spec. Res.

He has done exceptional work since joining the battalion. He superintended the successful evacuation of wounded on 12th October 1918 at Seltso under shell fire, at short notice. He accompanied the attacking forces when Topsa was attacked, and gallantly carried on his work under close enemy fire. By his energy and devotion to duty throughout these operations he was the means of saving many lives.

Capt. George Naylor, Oxf. & Bucks. L.I.

He led the party detailed to attack the enemy's advanced post south of Malo Beresnik, 26th/27th June 1919, through dense forest with complete success, capturing two machine guns and seventeen prisoners. On 3rd July he led another party with success,

killing several enemy and capturing a machine gun. On both occasions he displayed marked gallantry and able leadership.

T./Lt. Frederick Charles Plumbridge, D.C.M., 252nd Coy., Machine Gun Corps.

At Shred Mekrenga, from 2nd-5th April 1919, he in a very exposed position performed excellent work under heavy fire with two Vickers guns on the Alexandrova and Kodish roads; causing the enemy casualties and preventing an attack from those directions. He also visited the blockhouses under heavy shell fire, and by his example encouraged the men. He showed great gallantry and devotion to duty.

T./Lt. Edward Charles Toms, 252nd Coy., M.G. Corps.

At Tarassovo, from 24th-29th January 1919, he set an example to his men by conspicuous gallantry and devotion to duty. One Vickers gun was practically out of action, No. 1 being killed and No. 2 wounded. He took the place of No. 1, keeping the gun in action. He also visited the posts continually under heavy fire. His work at Certsovna and on the Kochmos road prior to this action showed leadership and great gallantry.

T./2nd Lt. Arthur William Warwick, R.E.

On 20th June 1919, near Troitsa, he volunteered to bring up ammunition from pack ponies to the firing line, and did so under heavy machine-gun fire after others had failed. During the withdrawal, after the transport officer had been wounded, he helped to get the pack ponies away. He showed great courage and devotion to duty throughout.

T./2nd Lt. (A./Capt.) John Thomas Whetton, 6th Bn., York R.

At Tulgas, on 18th May 1919, he displayed great gallantry in the attack on the Tuljas group of villages. He was amongst the first to enter each village, and by his coolness and courage set a fine example to the attacking Russian troops. He did good work again on the Tulgas road on 6th May. He has always displayed courage and energy since he has been with the column.

Capt. Alec. Noel Hawkes Whitcombe, R.F.A.

During the operations against Pocha, 1st and 2nd June 1919, he was continuously at the forward observation post, from which in an exposed position he directed the fire of all the artillery. He showed great coolness under fire, and great ability throughout. His work has consistently been of the highest character.

Awarded a Bar to the Distinguished Conduct Medal.

CANADIAN FORCE.

42253 B./S./M. A. H. Frame, D.C.M., Can. F.A.

When enemy gun-boats and infantry, assisted by guns from Tuljas and Topsa, attacked simultaneously, he, with his detach-

ment, was almost surrounded. He supported the infantry with men from his own subsection, who manned a block-house and two machine guns. Their fire inflicted heavy casualties on the enemy, and enabled the position to be held until relief arrived. The repulse of the enemy attack was largely due to his courage and initiative. (D.C.M. gazetted 1st January 1918).

64624 Sjt. H. Bland, 6th Bn., York. R. (Hampstead, N.W.).

When exposed to heavy machine-gun fire in front of Bolshe-Ozerki, he led his section with great spirit and gallantry, and by openly exposing himself inspired confidence in his men. He was the first to advance on an enemy machine-gun position, and throughout showed a very fine example to his men.

In Regulation 9AA after the words "motor cycle," in both places where those words occur, there shall be inserted the words "or motor car"; after the words "motor cycles" in both places where those words occur, there shall be inserted the words "or motor cars," and after the words " explosive substances," where those words lastly occur, there shall be inserted the words "motor cycles, motor cars."
- 2. After Regulation 12 D the following regulation shall be inserted :-
 - "13. In any area in respect of which the operation of section one of the Defence of the Realm (Amendment) Act, 1914, is for the time being suspended, the competent naval or military authority may by order require every person within any area specified in the order to remain within doors between such hours as may be specified in the order, and in such case, if any person within that area is or remains out between such hours without a permit in writing from the competent naval or military authority or some person duly authorised by him, he shall be guilty of an offence against these regulations.
