THE PROFITEERING ACT, 1919. MOTOR SPIRIT.

Whereas under the powers conferred upon them by the provisions of the Profiteering Act, 1919, the Board of Trade, by Order dated the 2nd day of October 1919 fixed maximum prices for the sale of Motor Spirit used or capable of being used for supplying motive power to vehicles whether taxed or not, both wholesale and retail, and such Order was entitled "The Profiteering Act, 1919, Maximum Prices Order (No. 2)":

And whereas the Board of Trade think fit to revoke such Order:

Now, therefore, the Board of Trade do hereby Order that the Profiteering Act, 1919, Maximum Prices Order (No. 2) shall as and from the date of the signing hereof be revoked, but without prejudice to any liability incurred under or any penalty, forfeiture, or punishment incurred in respect of any offence committed against such Order.

ORDER OF THE BOARD OF TRADE UNDER THE PROFITEERING ACT, 1919.

Whereas Section 1 of the Profiteering Act, 1919, provides that the Act may be applied by Order of the Board of Trade to any article or class of articles declared by the Order to be one or one of a kind in common use by the public, or being material, machinery or accessories used in the production of such articles, but that the Act shall not apply to any articles which are from time to time declared to be controlled articles.

Now, therefore, the Board of Trade do hereby declare that the articles or class of articles set out in the Schedule annexed hereto are articles of a kind in common use by the public, and are articles which are not controlled, and do hereby order that the Profiteering Act, 1919, shall apply to each and every article or class of articles contained in the Schedule to this Order.

This Order shall come into force forthwith, and may be cited as the Profiteering Act, 1919, Order (No. 2).
