PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Order in Council, dated the 10th day of January 1910, and known generally as the Civil Service (Consolidating) Order in Council, 1910, and hereinafter referred to as the "principal Order," it is provided that, with certain provisions and exceptions, the qualifications of all such persons as may seek or be proposed for appointment to any situation or employment in any of His Majesty's Civil Establishments shall, before they are so appointed, be tested by or under the directions of the Civil Service Commissioners, and that no person (save as excepted thereby) shall be appointed to any such establishment until a certificate of his qualification shall have been issued by the Civil Service Commissioners declaring that he has satisfied them, among other things, that he is free from any physical defect or disease which would be likely to interfere with the proper discharge of his duties :

And whereas the said requirement was modified by Clause (1) of the Order in Council of the 23rd October 1918, whereby it was provided that where an officer holding a pensionable situation, and having been appointed with a certificate of qualification, is nominated by the Head of a Department for the issue of a further certificate of qualification in respect

of his promotion in the same Department, or of his transfer to another Department, the said Commissioners may grant their said certificate of qualification on being satisfied that he is duly qualified in respect of age, character, knowledge, and ability, without requiring evidence that he fulfils the condition as to freedom from physical defect or disease specified in Clause 3 of the principal Order, provided that they are satisfied that the situation to which he is promoted or transferred does not require a higher degree of physical capacity than the situation which he already holds :

And whereas it is expedient that the above provision should apply where the said Commissioners think fit to officers who hold pensionable situations in any of His Majesty's Civil Establishments whether they were appointed thereto with a certificate of qualification or otherwise :

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows :—

Clause (1) of the Order in Council of the 23rd October 1918 shall be modified by the substitution of the words "in any of His Majesty's Civil Establishments" for the words "and having been appointed with a certificate of qualification" and by the omission of the word "further," and by the insertion of the words "at their discretion, if they see fit," after the words "the Commissioners may," and accordingly the clause shall run as follows :—

(1) Where an officer holding a pensionable

situation in any of His Majesty's Civil Establishments is nominated by the Head of a Department for the issue of a certificate of qualification in respect of his promotion in the same Department, or of his transfer to another Department, the Commissioners may, at their discretion, if they see fit, grant their certificate of qualification on being satisfied that he is fully qualified in respect of age, character, knowledge, and ability, without requiring evidence that he fulfils the condition as to freedom from physical defect or disease specified in Clause 3 of the principal Order, provided they are satisfied that the situation to which he is promoted or transferred does not require a higher degree of physical capacity than the situation which he already holds.

WHEREAS by sub-section (3) of Section seven of the Housing, Town Planning, &c., Act, 1919, it is provided that every Regulation made by the Minister of Health under that Section shall be laid before both Houses of Parliament, and that if within 21 days thereafter an address is presented by either House, praying that the Regulation may be annulled, His Majesty in Council may annul the Regulation :

And whereas on the 19th day of November 1919 a humble address was presented to His Majesty by the Commons House of Parliament in pursuance of the said Section, praying that Articles 2, 5, and 6 of, and Schedule B to, the Housing (Assisted Scheme) Regulations, 1919, might be annulled :

Now, therefore, His Majesty, in pursuance of all powers enabling Him in that behalf, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, that the said Articles 2, 5, and 6 of, and Schedule B to, the Housing (Assisted Scheme) Regulations, 1919, shall be annulled.

WHEREAS at Versailles, on the 28th day of June 1919, a Treaty of Peace with Germany (hereinafter referred to as "the

Treaty") was signed on behalf of His Majesty ; and

Whereas it was provided in the Treaty that the property of German nationals within the territory or under the control of an Allied or Associated State might be constituted a pledge for enemy liabilities upon the conditions laid down in the Treaty ; and

Whereas by the Treaty of Peace Act, 1919, it was provided that His Majesty might make such appointments, establish such offices, make such Orders in Council, and do such things as appeared to Him to be necessary for carrying out the Treaty, and for giving effect to any of the provisions thereof ; and

Whereas by Treaty, grant, usage, sufferance, or other lawful means His Majesty has power and jurisdiction in China : and

Whereas there is now in China certain property of German nationals under the control of His Majesty, and it is expedient to make provision for charging such property with the payment of the liabilities for which it may be constituted a pledge by the Treaty in the manner hereinafter provided :

Now, therefore, His Majesty, by virtue and in exercise of the powers in this behalf by the Foreign Jurisdiction Act, 1890, or otherwise in Him vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows :—

1. All property rights and interests in China belonging to German nationals at the date when the Treaty comes into force (not being property rights or interests acquired under any general licence issued by or on behalf of His Majesty) and the net proceeds of their sale, liquidation, or other dealings therewith, so far as such property rights and interests or such net proceeds are vested in or otherwise under the control of the Custodian of enemy property or other British authority under the Trading with the Enemy Acts or the Trading with the Enemy Regulations, are hereby charged :—

(a) First, with payment of the amounts due in respect of claims by British nationals with regard to their property rights and interests, including companies and associations in which they are interested in German territory, or debts owing to them by German nationals, and with payment of any compensation awarded by the Mixed Arbitral Tribunal or by an arbitrator appointed by that Tribunal in pursuance of paragraph (e) of Article 297 of the Treaty, and with payment of claims growing out of acts committed by the German Government or by German authorities since the 31st July 1914, and before the 4th August 1914.

(b) Secondly, with payment of the amounts due in respect of claims by British nationals with regard to their property rights and interests in the territories of Austria-Hungary, Bulgaria, and Turkey in so far as those claims are not otherwise satisfied.

Provided that any particular property rights or interests so charged may at any time, if the Minister thinks fit, be released from the charge so created.

2. In the application and enforcement of the charge created by this Order the claims of or debts owing to British nationals resident or carrying on business in China shall enjoy priority

over the claims of or debts owing to other British nationals.

3. With a view to making effective and enforcing such charge as aforesaid :—

(a) No person shall, without the consent of the Custodian, transfer, part with, or otherwise deal in any property, right, or interest subject to the charge, and if he does so he shall be liable, on summary conviction, to a fine not exceeding one hundred pounds, or to imprisonment for a term not exceeding three months, or to both such imprisonment and fine.

(b) Every person owning or having the control or management of any property right or interest subject to the charge (including where the property right or interest consists of shares, stocks, or other securities issued by a company, municipal authority, or other body, or any right or interest therein, such company, authority, or body) shall, unless particulars thereof have already been furnished to the Custodian in accordance with the Trading with the Enemy Acts, 1914 to 1918, or the Trading with the Enemy Consolidation Regulations, 1918, within one month from the date when this Order comes into operation, by notice in writing communicate the fact to the Custodian, and shall furnish the Custodian with such particulars in relation thereto as the Custodian may require, and if any person fails to do so he shall, on summary conviction, be liable to a fine not exceeding one hundred pounds.

(c) Where the property charged consists of inscribed or registered stock, shares, or other securities, any company, municipal authority, or other body by whom the securities were issued or are managed shall, on application being made by the Custodian, enter the Custodian in the books in which the securities are inscribed or registered, as the proprietor of the securities subject to the charge, and the Custodian shall, subject to the consent of the Minister, have power to sell or otherwise deal with the securities as proprietor of which he is so registered or inscribed.

(d) The Minister may by order vest in the Custodian any property rights and interests subject to the charge, or the right to transfer the same, and for that purpose section 4 of the Trading with the Enemy (Amendment) Act, 1916, shall apply as if such property rights and interests were property belonging to an enemy or enemy subject.

(e) If any person called upon to pay any money or to transfer or otherwise to deal with any property rights or interests has reason to suspect that the same are subject to such charge as aforesaid, he shall, before paying, transferring, or dealing with the same, report the matter to the Custodian, and shall comply with any directions that the Custodian may give with respect thereto.

4. All decisions of the Mixed Arbitral Tribunal constituted under Section VI. of Part X. of the Treaty, if within the jurisdiction of that Tribunal, shall be final and conclusive, and binding on all courts.

5. For the purpose of enforcing the attendance of witnesses before the Mixed Arbitral Tribunal, whether sitting in China or not, and compelling the production before the Tribunal of documents, the Minister shall have power to issue orders

which shall have the like effect as if the proceedings before the Tribunal were an action in the court, and the order were a formal process issued by that court in the due exercise of its jurisdiction, and shall be enforceable by that court accordingly, and disobedience to any such order shall be punishable as contempt of court.

6. Sections IV., V., and VI. of Part X. of the Treaty relating to property rights and interests, to contracts, prescriptions and judgments, and to the Mixed Arbitral Tribunal, and all provisions of the said Treaty affecting or relating to the charge created by this Order shall have full force and effect as law.

7. The time at which the period of prescription or limitation of right of action referred to in Article 300 of the Treaty shall begin again to run shall be at the expiration of six months after the coming into force of the Treaty, and the period to be allowed within which presentation of negotiable instruments for acceptance or payment, and notice of non-acceptance or non-payment or protest may be made under Article 301, shall be six months from the coming into force of the Treaty.

8. Rules made during the war by any recognised exchange or commercial association providing for the closure of contracts entered into before the war by an enemy, and any action taken thereunder are hereby confirmed, subject to the provisos contained in paragraph 4 (a) of the Annex to Section V. of Part X. of the Treaty.

9. The power under Article 155 of the China Order in Council, 1904, or under any Order amending the said Order, to make King's Regulations, shall extend to the issue of regulations for the purpose of enforcing the charge created by this Order, and for making such arrangements as may be required for establishing and assessing the claims and debts for the payment of which the property charged is rendered liable, and for the payment, in whole or in part, of the sums due.

10. This Order may be cited as the China (Treaty of Peace) Order in Council, 1919, and shall be read as one with the China Order in Council, 1904, and with any Order amending the same.

11. This Order shall come into operation on the date when the Treaty of Peace comes into force.

On the 17th June last a fire occurred on a Russian motor-launch in the Harbour of Archangel, and a Russian tug and a picket boat from an American Man-of-War proceeded to render assistance, Mr. Haines going in the tug.

Just before the tug reached the launch an explosion took place on board the latter. Immediately the tug got alongside, the crew of the launch abandoned her.

Mr. Haines at once went on board the launch and endeavoured to extinguish the fire, but being unable to do so, he ordered the other boats to lay off, while he went down into the magazine and brought up on deck a quantity of ammunition and a large quantity of gasoline and some rifles. Then calling the picket boat alongside, he passed these stores aboard her.

While Mr. Haines was alone on board the launch, the cabin abaft the engine room and before the magazine took fire.

The fire was ultimately got under, but not before the launch had been gutted.

Mr. Haines displayed great gallantry in rendering the service, for had the fire reached the magazine an explosion would undoubtedly have occurred, and he would have had no chance of saving his life.

ORDER OF THE SCOTTISH BOARD OF HEALTH in terms of Section 83 of the Public Health (Scotland) Act, 1897, authorising a combination of certain Local Authorities for the carrying out of a scheme for the diagnosis, treatment, and prevention of Venereal Diseases.

Whereas certain Regulations in terms of Section 78 in Part IV. of the Public Health (Scotland) Act, 1897, were made by the Local Government Board for Scotland in their Order, dated the 26th day of October 1916, with a view to the diagnosis, treatment, and prevention of Venereal Diseases which are endemic and infectious diseases ;

And whereas Section 83 of the aforesaid Public Health (Scotland) Act, 1897, empowered the said Board by Order to authorise or require any two or more Local Authorities to act together for the purposes of Part IV. of the aforesaid Act, and to prescribe the mode of such joint action and of defraying the costs thereof ;

And whereas in terms of the Scottish Board of Health Act, 1919, the powers and duties of the Local Government Board for Scotland have been transferred to the Scottish Board of Health ;

And whereas the following Authorities are Local Authorities within the meaning of the aforesaid Public Health (Scotland) Act, 1897, *videlicet* ;

- (1) The District Committee of the Aberdeen District of the County of Aberdeen ;
- (2) The District Committee of the Alford District of the County of Aberdeen ;
- (3) The District Committee of the Deer District of the County of Aberdeen ;
- (4) The District Committee of the Deeside District of the County of Aberdeen ;
- (5) The District Committee of the Ellon District of the County of Aberdeen ;
- (6) The District Committee of the Garioch District of the County of Aberdeen ;
- (7) The District Committee of Huntly District of the County of Aberdeen ;
- (8) The District Committee of Turriff District of the County of Aberdeen ;
- (9) The Town Council of the Burgh of Fraserburgh ;
- (10) The Town Council of the Burgh of Peterhead ;
- (11) The Town Council of the Burgh of Rosehearty ;
- (12) The Town Council of the Burgh of Ballater ;
- (13) The Town Council of the Burgh of Ellon ;
- (14) The Town Council of the Burgh of Inverurie ;
- (15) The Town Council of the Burgh of Kintore ;

- (18) The Town Council of the Burgh of Turriff ;

And whereas it is expedient that a combination of the aforesaid Local Authorities be effected for the purposes specified in the Order of 26th October 1916, aforesaid ;

Now therefore we, the Scottish Board of

Health, in pursuance of the powers vested in Us as aforesaid, do make the following Order :—

COMBINATION OF AUTHORITIES.

Article 1.—From and after the date of the coming into operation of this Order, the said Local Authorities (hereinafter referred to as the "Combining Authorities") are authorised by Us to act together for the purpose of carrying out the Regulations contained in the Order of 26th October 1916, aforesaid, or any further Regulations that We may make hereafter with reference to the diagnosis, treatment, and prevention of Venereal Diseases.

ADMINISTRATIVE COMMITTEE.

Article 2 (1).—All things that may be necessary for the purpose of carrying out the aforesaid Regulations within the districts of the aforesaid Local Authorities shall be undertaken by the County Council of Aberdeenshire acting through the County Sanatorium Benefit Committee of the said County Council of the said County (hereinafter referred to as "the Committee.")

ANNUAL MEETING, &C.

(2) A General meeting of the Committee shall be held annually on such date in the months of June or July as the Committee shall determine.

MEETINGS AND POWERS OF COMMITTEE.

(3) The Committee shall meet for the despatch of business at such other times and at such place or places as they may from time to time fix. They shall have power (1) to appoint such officers and servants as may be considered necessary and to pay them such salaries as the Committee may from time to time think proper ; and (2) to delegate to the officers so appointed such of their powers as they may see fit.

(4) The decisions of the Committee shall not be subject to the review of any of the Combining Authorities.

FINANCE—BASIS OF CONTRIBUTIONS—
REQUISITION FOR FUNDS.

Article 3 (1).—The whole expenditure incurred by or under the authority of the Committee in carrying out the Regulations referred to in Article 1 hereof, under deduction of the sums received by them from Government Grant and other sources, shall be defrayed by the Combining Authorities in proportion to the population of their respective districts according to the latest available census returns.

(2) The Committee shall, between the 15th day of May and the 15th day of July in each year, prepare an estimate of their expenditure under this Article during the year to the 15th day of May succeeding, and shall, not later than 15th July, transmit a copy of such estimate to each of the Combining Authorities, and shall at same time certify to each of such Combining Authorities the proportion of the total estimated expenditure falling to be defrayed by them.

(3) The Committee shall fix (a) the date in each year on or before which the proportions of the amount of the estimated expenditure for the year, or (b) the dates in each year on or before which instalments of the proportions of

the estimated expenditure for the year, are to be paid to them by the several Combining Authorities; and shall intimate such date or dates to these authorities, who shall make payment of the amounts on or before the dates so fixed and intimated.

(4) The Committee shall make up and transmit to Us claims for any Government Grant-in-aid payable in respect of the expenditure incurred by them or under their authority upon the diagnosis, treatment, and prevention of Venereal Diseases, and shall receive such Government Grant-in-aid payable in respect of such expenditure.

ACCOUNTS AND AUDIT.

Article 4 (1) The accounts of the Committee shall be included in and form part of the accounts of the Council of the County of Aberdeen and shall be annually submitted to audit by the Auditor appointed by the Secretary for Scotland to audit the accounts of the said County Council.

(2) The audited accounts shall show the sums payable during the year by each of the Combining Authorities under Article 3 of this Order. A copy of the audited accounts shall be transmitted to each of the Combining Authorities, and any necessary adjustment in the accounts between the Committee and these authorities shall thereafter be made and intimation of the same shall be transmitted by the Committee to these authorities. A copy of the audited accounts shall also be transmitted to Us by the Committee.

POWER TO AMEND ORDER.

Article 5.—This Order may be amended by Us after consultation with the Committee from time to time as We may deem necessary.

GRANT-IN-AID.

Article 6.—Nothing in this Order shall affect Our powers in connection with the administration and distribution of any Grant-in-aid of the cost of the diagnosis, treatment, and prevention of Venereal Diseases.

APPEAL TO SCOTTISH BOARD OF HEALTH.

Article 7.—Any dispute or difference arising among the Combining Authorities as to the interpretation or implement of the terms of this Order may be submitted to Us for Our determination by the Committee or by any of the Combining Authorities and Our decision in regard thereto shall be final and binding on all parties.

DATE OF ORDER COMING INTO OPERATION.

Article 8.—This Order shall notwithstanding the date hereof be held to have come into operation as from the first day of September in the year One thousand nine hundred and seventeen.

And whereas the Local Government Board for Scotland were empowered by Article 5 of the principal Order to amend the said Order from time to time as they might deem necessary after consultation with the Committee authorised by the principal Order to carry out the said Regulations;

And whereas in terms of the Scottish Board of Health Act, 1919, the powers and duties of the Local Government Board for Scotland have been transferred to the Scottish Board of Health;

And whereas it is now expedient that Article 3 (2) of the principal Order shall be amended so as to allow a longer period for the preparation of estimates by the said Committee;

Now therefore, We, the Scottish Board of Health, in pursuance of the powers vested in Us as aforesaid, do by this Our Order amend the principal Order as provided herein:—

ARTICLE 1.—Article 3 (2) of the principal Order shall read as follows, *videlicet*:—

The Committee shall, between the 15th day of May and the 15th day of October in each year, prepare an estimate of their expenditure under this Article during the year to the 15th day of May succeeding, and shall not later than the 31st day of October transmit a copy of such estimate to each of the Combining Authorities, and shall at the same time certify to each of such Combining Authorities the proportion of the total estimated expenditure falling to be defrayed by them.

ARTICLE 2.—Notwithstanding the date hereof, this Order shall be held to have come into operation on the Fifteenth day of May in the year One thousand nine hundred and nineteen, provided that for the purposes of the application of the immediately preceding Article to the year to 15th May 1920 there shall be substituted for the dates 15th and 31st October the dates 15th and 31st December.
