3. Gentlemen who have been presented, and who wish to attend this Levée, should make a written application, as detailed below.

4. No applications can be received from gentlemen wishing to be presented. Their names must be forwarded by the gentleman making the presentation.

5. Officers, other than those referred to in para. 2, whether on the active or retired lists of the Royal Navy and the Royal Marines, of whatever rank, will communicate with and obtain their cards from the Private Secretary to the First Lord of the Admiralty. All Civil Officers of the Admiralty will follow the same rule.

6. Officers, other than those referred to in para. 2, whether on the active or retired lists of the Army, except those on the Indian and Colonial Establishments, will communicate with and obtain their cards from the Secretary, the War Office, but officers of the Household Cavalry or the Brigade of Guards should communicate with the Lord Chamberlain at St. James's Palace.

TRADE BOARDS ACTS, 1909 AND 1918. FLAX AND HEMP TRADE BOARD.

(GREAT BRITAIN.)

PROPOSAL TO FIX MINIMUM RATES OF WAGES FOR FEMALE AND MALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October 1918, the Trade Board established in Great Britain under the Trade Boards Act, 1918, for the Flax and Hemp Trade as specified in the Trade Boards (Flax and Hemp) Order, 1919, hereby give notice as required by Section 3 (5) of the Trade Boards Act, 1918, that they propose to fix General Minimum Time-Rates and Overtime Rates for Female and Male Workers and to declare the normal number of hours of work in the Trade for the purpose of the application of the Overtime Rates, as set out in the Schedule below.

SCHEDULE.

PART I.

PROPOSED GENERAL MINIMUM TIME-RATES.

SECTION I.—Female Workers—

- Workers of 18 years of age and upwards, 32s. per week.
- Workers of 17 and under 18 years of age, 28s. per week.
- Workers of 16 and under 17 years of age, 24s. per week.
- Workers of 15 and under 16 years of age, 21s. per week.

Workers under 15 years of age, 17s. per week.

SECTION II.-Male Workers-

- Workers of 21 years of age and upwards, 54s. per week.
- Workers of 20 and under 21 years of age, 46s. per week.
- Workers of 19 and under 20 years of age, 42s. per week.
- Workers of 18 and under 19 years of age, 38s. per week.

- Workers of 17 and under 18 years of age, 28s. per week.
- Workers of 16 and under 17 years of age, 24s per week.
- Workers of 15 and under 16 years of age, 21s. per week.

Workers under 15 years of age, 17s. per week. SECTION III.--

The weekly rates set out in Sections I. and II. above are based on a week of 48 hours, and shall be subject to a proportionate deduction according as the number of hours of employment in any week is less than 48.

Provided that in the case of whole time workers employed by the week or longer period, where the normal number of hours per week in the establishment as agreed between the employer and his workers is less than 48, but not less than 44:

- (i.) The weekly wage payable for such shorter normal working week shall be not less than the weekly rates set out in Sections I. and II. of this Part of this Schedule.
- (ii.) The weekly rate set out in Section I. and II. of this Part of this Schedule shall be subject to a proportionate deduction according as the number of hours of employment in any week is less than the agreed normal number of hours in the establishment.

PART II.

OVERTIME RATES FOR MALE AND FEMALE WORKERS (All Ages).

SECTION I.—In accordance with Section 3 (1) (c) of the Trade Boards Act, 1918, the Trade Board propose to declare the normal number of hours of work in the trade to be :—

In any week, 48.

On any day, the number agreed for this purpose between an employer and his workers or a Trade Union acting on behalf of such workers, but so that the aggregate number does not exceed 48 in the week.

Provided that all hours worked on Sundays and on Customary Public and Statutory Holidays shall be regarded as Overtime, to which the Overtime Rates shall apply.

Section II.—

The Trade Board propose to Fix Overtime Rates in respect of male and female workers to apply in respect of hours worked by a worker whether employed on Time-work or on Piecework in excess of the declared normal number of hours as follows, that is to say :---

- of hours as follows, that is to say :---(a) For the first two hours' Overtime on any day except Sundays and Customary Public and Statutory Holidays, the Overtime Rate shall be equivalent to Time and a Quarter, that is to say, One and a Quarter times the minimum rate otherwise applicable.
 - (b) For all Overtime after the completion of two hours' Overtime on any day except Saturdays, Sundays, and Customary Public and Statutory Holidays, and for all Overtime on Saturdays, the Overtime Rate shall be equivalent to Time and a Half, that is to say, One and a Half times the minimum rate otherwise applicable.

- (c) For all time worked on Sundays and on Customary Public and Statutory · Holidays, the Overtime Rate shall be equivalent to Double Time, that is to say, twice the minimum rate otherwise applicable.
- (d) For all hours worked in any week in excess of 48, the Overtime Rate shall be Time and a Quarter for the first two hours, and Time and a Half thereafter, except in so far as higher Overtime Rates are payable under the provisions of paragraphs (b) and (c) of this Section.

SECTION III.-

In The provisions set out in this Part of this Schedule are without prejudice to any agreement between an employer and his workers, providing for the payment at Overtime Rates of all hours in excess of the normal number of hours in the establishment, notwithstanding that such normal number of hours is less than 48 per week.

Note .- The hours which female workers and young persons are allowed to work are subject to the provisions of the Factory and Workshop Act, 1901.

PART III.

The above Minimum Rates of Wages shall apply subject to the provisions of the Trade Boards Acts to all workers in Great Britain who are employed during the whole or any part of their time in any branch of the trade specified in the Trade Boards (Flax and Hemp) Order, 1919, namely :-

The preparing, spinning, and weaving (a) of scutched flax, (b) of hemp, (c) of a mixture of scutched flax and any other fibre, or (d) of a mixture of hemp and any other fibre.

Including :-

(1) The preparing and spinning of waste re-

(2) All packing, despatching, warehousing, storing, or other operations incidental to or appertaining to any of the abovementioned work;

But excluding :--

SECTION I.--

- (1) The calendering, bleaching, dyeing or finishing of any of the above-mentioned materials; and
- (2) The preparing or spinning of materials required for the making or re-making of (a) rope (including driving rope and banding), (b) cord (including blind and window cord, but excluding silk, worsted, and other fancy cords), (c) core for wire ropes, (d) lines, (e) twine (including binder and trawl twine) (f) lanyards, (g) net and similar articles when such spinning or preparing is carried on in the same factory or workshop as the said making or re-making; and
- (3) The making or repair of sacks or bags; and also
- (4) The weaving of carpets, rugs, and mats.

PART IV.

The above General Minimum Time Rates and Overtime Rates shall be paid clear of all deductions other than deductions under the National Insurance Act, 1911, as amended by Special Reserve, which was gazetted on the any subsequent enactments or deductions 25th August 1916, shall be cancelled, and his

authorised by any Act to be made from wages in respect of contributions to any superannuation or other Provident Fund.

SECTION II.—The above Minimum Rates are without prejudice to workers who are earning higher rates of Wages.

The Trade Board will consider any objections to the above Proposals which may be lodged with them witnin two months from the 6th March 1920. Such Objections should be in writing, and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Flax and Hemp Trade Board (Great Britain), 5 Chancery Lane, London, W.C.2. It is desirable that the Objections should

state precisely, and so far as possible with reasons, what is objected to.

The Civil Service Commissioners hereby give notice that the following Regulations are published with the consent of the Lords Commissioners of His Majesty's Treasury, viz. :-

SPECIAL REGULATIONS respecting a Competitive Examination for the situation of Woman Clerk (Higher Grade) in the Ministry of Labour.

1. The limits of age for these situations are 25 and 35. Candidates must be of the prescribed age on the first day of March 1920. A Candidate born on March 1st would be admitted on the 25th but not on the 35th anniversary of her birth.

No exception on any grounds will be made to this rule.

2. No Candidate will be eligible who has not rendered two full years' approved service prior to the 1st March 1920 in an established or temporary post in one or more of His Majesty's Civil Departments, or as an enrolled member in the clerical sections of Queen Mary's Army Auxiliary Corps, the Women's Royal Naval Service, the Woman's Royal Air Force, or the Voluntary Aid Detachments General Service; or in a temporary clerical post in the War Department Establishments, or in National Factories, Stores, Bonds, Depots, &c., where the services were remunerated direct from public funds.

3. Candidates will be required to satisfy the Civil Service Commissioners-

(a) That they are unmarried, or widows,(b) That they are duly qualified in respect of health and character.

No person will be eligible who is not a naturalborn British subject, and the daughter of a father who is a natural-born British subject.

4. The Examination will be in the following subjects, viz. :-

1. English Composition (including Spelling).

2. Handwriting.

3. Précis Writing.

4. Arithmetic.

5. General Knowledge.

5. Candidates must obtain such an aggregate of marks in the examination as a whole as may indicate in the judgment of the Civil Service Commissioners a sufficiently high standard of general proficiency.

If the number of Candidates who attain the necessary aggregate of marks is insufficient to fill the vacancies, the candidates next in order on the list will be summoned for interview by a Selection Board, the number of such candidates to be determined by the Commissioners; and appointments may be offered to those who appear to the Selection Board to be best qualified.

The Selection Board will give marked preference to candidates who have had adequate experience in administrative, higher clerical, or responsible executive work.

6. WARNING .- Any attempt on the part of a candidate to enlist support for her application through Members of Parliament or other influential persons, will disqualify her for appointment.

7. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to attend the Examination, dated before the commencement of the competition.

8. Persons who have entered upon or completed a course of education or training for the occupation of teacher, on account of which grants are payable from the Exchequer, will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury, has been notified to the Civil Service Commissioners.

9. Application for permission to attend an Examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.

10. A fee of 5s. will be required from every candidate upon application; and a further fee of 10s. from every candidate attending the Examination.

The Civil Service Commissioners further givenotice that a Competitive Examination will be held in London, Birmingham, Bristol, Cardiff, Leeds, Manchester, Newcastle on - Tyne, Nottingham, Plymouth, Southampton, Edinburgh, Aberdeen, and Glasgow, under the foregoing Regulations, commencing on the 6th July 1920.

III.—Plymouth.

PART I.-MOVEMENTS WITHIN THE PORT.

1. The movements of all merchant ships, fishing vessels, or boats of any kind, are subject to the direction of the King's Harbour Master, Plymouth, for the Sound, and the King's Harbour Master, Devonport, for the Hamoaze, whose orders are to be immediately obeyed.

Approach to Government Vessels and Establish-Establishments.

4. A limited number of moorings for yachts may be laid in the following places and nowhere else :--

On West Hoe—on application to King's Harbour Master, Plymouth; in the Cattewater above Turnchapel—on application to the Harbour Master of Cattewater.

PART II.—VESSELS LEAVING THE PORT. Prohibition.

5. Merchant vessels (including those engaged in the coastal trade) must on no account leave the

Dockyard ports of Devonport and Plymouth without permission.

Vessels in the Hamoaze must obtain such permission from the King's Harbour Master, Devonport, at his office in the Dockyard ; those at berths in the waters of the sound, Cawsand bay, Cattewater, Sutton pool, or Milbay docks must obtain permission from the King's Harbour Master, Plymouth, at Longroom, Stonehouse.

It is also necessary for ships to obtain permission from the Collector of Customs, at the Barbican, Plymouth.

PART III.-BOOM DEFENCE AND NAVIGATION OF NARROW WATERS.

6. A mooring-buoy, which is situated 286° (N. 58° W. Mag.), 575 yards from Cremyll obelisk, is now being used by two vessels; these vessels being moored out of the fairway, no lights will be displayed on them by night, and all vessels and boats are cautioned to keep well clear of them.

7.
