WHEREAS it is provided by Section 2 of the Customs (Exportation Prohibition) Act, 1914, that any Proclamation or Order in Council made under Section 8 of the Customs and Inland Revenue Act, 1879, as amended by the Act now in recital, may, whilst a state of war exists, be varied or added to by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas it is provided by Section 2 of the Customs (Exportation Restriction) Act, 1914, that any Proclamation made under Section 1 of the Exportation of Arms Act, 1900, may, whether the Proclamation was made before or after the passing of the Act now in recital, be varied or added to, whilst a state of war exists, by an Order made by the Lords of the Council on the recommendation of the Board of Trade:

And whereas by a Proclamation, dated the

10th day of May 1917, and made under Section 8 of the Customs and Inland Revenue Act, 1879, and Section 1 of the Exportation of Arms Act. 1900, and Section 1 of the Customs Exportation Prohibition) Act, 1914, the exportation from the United Kingdom of certain articles to certain or all destinations was prohibited:

And whereas by subsequent Orders of Council, and by the Proclamations dated respectively the 18th day of December 1918, and the 12th day of March 1919, the said Proclamation was amended and added to in certain particulars:

And whereas there was this day read at the Board a recommendation from the Board of Trade to the following effect :-

That the Proclamation, dated the 10th day of May 1917, as amended and added to by subsequent Orders of Council and by the Proclamations dated respectively the 18th day of December 1918, and the 12th day of March 1919, should be further amended by making the following amendments in and additions to the Schedule to the

- (1) That the following headings should be deleted :-

Raisins (except Californian seeded raisins); Sultanas;

(A) Fruit, preserved other than dried fruits preserved in sugar;

(B) Milk, condensed or preserved (other than Milk Powder).

(2) That the following headings should be added:—

Provisions and Victuals which may be used as Food for Man or Cattle, the following:—

- (A) Fish except the following: Tinned, preserved or frozen fish, chinchards, crabs, oysters, sprats, herrings, crayfish, prawns, shrimps, scallops, lobsters, fresh salmon and salmon trout;
 - (A) Salmon, tinned;

(A) Fruit preserved, the following :-

(1) Fruit, canned or bottled in water, the following:—

Pears;

Pineapples;

Peaches;

(2) Fruit canned or bottled in syrup, except Cherries;

(3) Fruit Pulp;

(4) Jam and Marmalade;

(A) Milk, condensed or preserved (other than Milk Powder).

Now, therefore, their Lordships, having taken the said recommendation into consideration, are pleased to order, and it is hereby ordered, that the same be approved.

Whereof the Commissioners of His Majesty's Customs and Excise, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of His Majesty's Treasury, viz.:—

SPECIAL REGULATIONS RESPECTING AN OPEN COMPETITIVE EXAMINATION FOR THE SITUATION OF ASSISTANT INSPECTOR OF TAXES, INLAND REVENUE DEPARTMENT.

- 1. The limits of age for this Examination are 18 and 21. A Candidate must have attained the age of 18 and must not have attained the age of 21 on the 1st July 1920.
- 2. A Candidate must be a natural-born British subject and the son of a father also a natural-born British subject; provided that exception to the latter condition may be made in the case of Candidates who have served in His Majesty's Armed Forces during the War.
 - (i.) The following persons are ineligible, viz.:—

Members of the Royal Irish Constabulary of less than five years' service.

(ii.) The following classes of persons are eligible under certain conditions only, that is to say:—

(a) Persons actually serving in the Army.(b) Persons actually serving in the Navy.

(c) Persons holding situations in the Civil Service.

(d) Members of the Royal Irish Constabulary of more than five years' service.

(e) Apprentices in His Majesty's Dock-yards.

(f) Persons who have entered upon or completed a course of education or training for the occupation of teacher, on account of which grants are payable from the Exchanger

No person actually serving in the Army will be eligible unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the examination, dated before the commencement of the competition and given in accordance with such orders as may from time to time be issued by or under the authority of the Army Council.

No person actually serving in the Navy will be eligible unless he produces to the Civil Service Commissioners, when called upon to do so, the permission of his Commanding Officer to attend the examination, dated before the commencement of the competition and given in accordance with such orders as may from time to time be issued by or under the authority of the Lords Commissioners of the Admiralty.

Persons comprised in the classes (c), (d), (e) must obtain the permission of the authorities of their Department to attend the examination before the commencement of the competition.

Persons comprised in class (f) will not be qualified to receive appointments until the consent of the Board of Education in England, the Committee of Council on Education for Scotland, or the Commissioners of National Education, Ireland, as the case may be, given in conformity with rules sanctioned by the Lords of the Treasury has been notified to the Civil Service Commissioners.

All the subjects in Class I. must be taken up. From Classes II. and III. Candidates may select subjects, one of which must be a language, carrying marks up to a maximum of 10,000, making with the subjects in Class I. 15,000 in all. The same subject may not be selected both in Class II. and in Class III.

No Candidate will be eligible who fails to pass a qualifying examination in Arithmetic and English, and to obtain such an aggregate number of marks in the examination as a whole as to satisfy the Civil Service Commissioners.

- 4. Application for permission to attend an Examination must be made in the writing of the Candidate, at such times and in such manner as may be fixed by the Civil Service Commissioners.
- 5. A fee of £3 will be required from each Candidate attending an Examination.

The Civil Service Commissioners further give notice that an Open Competitive Examination for situations as Assistant Inspector of Taxes in the Inland Revenue Department will be held in London, Edinburgh, and Dublin on the 13th July 1920, under the foregoing Regulations.

Appointments will be offered to not fewer than 100 of the Candidates highest on the list, provided they obtain the necessary aggregate of marks and are duly qualified in other respects,

No person will be admitted to Examination from whom the Secretary of the Civil Service Commission has not received, on or before the 20th May, an application on the prescribed form, which may be obtained from the Secretary at once.

* Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the local inspector of Corn Returns in any other measure than the imperial bushel or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

ROPE, TWINE AND NET TRADE BOARD (GREAT BRITAIN).

MINIMUM RATES OF WAGES FIXED FOR FEMALE AND MALE WORKERS, EFFECTIVE AS FROM 2nd April 1920.*

- In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October 1918, the Trade Board established under the Trade Boards Act, 1918, for the Rope, Twine and Net Trade as specified in the Trade Boards (Rope, Twine and Net) Order, 1919, having given due notice on 22nd December 1919, of Proposal to Fix General Minimum Time-rates, Piece-work Basis Time-rates and Overtime Rates for Female and Male workers, hereby give notice, as required by Section 3 (5) of the Trade Boards Act, 1918, that they have fixed. General Minimum Time-rates, Piece-work Basis Time-rates and Overtime Rates for Female and Male Workers, and have declared the normal number of hours of work in the trade for the purpose of the application of the Overtime-Rates, and that the Minimum Rates of Wages as fixed are as shown in the Schedule set out below.

And the Trade Board further give notice that they have received notification from the Minister of Labour that he has made an Order dated 31st March 1920, under Section 4 (2) of the Trade Boards Act, 1918, confirming the by 1d per hour than the minimum rate applicminimum rates of wages fixed by the Trade able under the above scale.

* Should this date not correspond with the beginning of the period for which wages are paid by an employer who pays wages at intervals not exceeding seven days the rates shall become effective as from the beginning of the next full-pay period, but in any case not later than 8th April 1920.

- (iii) General Minimum Timerate to operate as from 2nd April 1921, 8½d. per hour.
